REPORT ON BALANCES AND AVAILABILITY OF RESOURCES

Introduction

1. This document presents a summary of the financial adjustments indicated by the bilateral and implementing agencies as agreed by the Fund Secretariat. The document includes statistical data, as required by decisions 28/7 and 56/2, from projects for bilateral and implementing agencies with balances that have been held for over the allowable 12-month period following completion of the project. The data presented are based on the reporting format that has been developed pursuant to decision 31/2 and include both obligated and un-obligated balances. Further to decision 41/92(b), this document also indicates the level of resources available to the Executive Committee in cash and promissory notes as recorded in the Status of contributions and disbursements (UNEP/OzL.Pro/ExCom/62/3). The total funds to be returned addressed in this report amount to US \$1,443,667 including support costs.

Funds being returned to the 62nd Meeting by Implementing Agencies

2. Information provided by the Implementing Agencies (IAs) indicates that a total of US \$1,337,444 excluding agency support costs will be returned to the 62nd Meeting, as set out in Table 1.

Pre-session documents of the Executive Committee of the Multilateral Fund for the Implementation of the Montreal Protocol are without prejudice to any decision that the Executive Committee might take following issuance of the document.

- 3. At the 57th and 58th Meetings, UNDP had requested and was granted project preparation funds of US \$30,000 each for the preparation of investment projects in the refrigeration and foam sector for Kyrgyzstan. However, after a field visit supported with project preparation funds to collect baseline information and discuss technology options with enterprises, it was concluded that no projects could be formulated in the foam and refrigeration manufacturing sectors for Kyrgyzstan. Since some funds had been spent, these projects could not be cancelled. UNDP advised the Secretariat that these two preparatory projects will be operationally closed and funds will be returned through the balances report to the 63rd meeting.
- 4. Table 1 includes the World Bank's transfer of funding associated with the third, fourth and fifth tranches of the National Phase out Plan (NPP) for Ecuador to UNEP and UNIDO as a follow-up to decision 61/36(c)(i) that requests the World Bank to return the funding associated with these tranches to the 62^{nd} Meeting.

Projects with balances by year of completion

5. Table 2 presents the number of projects with balances that are still being held by the IAs and the years in which those projects were completed. It shows that for projects completed up to and including 30 September 2009 (at least over the last 12 months) and 1 ongoing project, IAs had balances that totalled US \$4,727,017 excluding support costs.

- 6. At its 47th Meeting, the Executive Committee requested the Fund Secretariat to continue to monitor multi-year annual tranches in the context of documents on implementation delays and project balances (decision 47/50(b)(ii)).
- 7. UNEP holds the highest level of balances with US \$1,476,042 of which US \$153,516 is attributable to the multi-year agreement (MYA). It also has the highest number of projects with balances (78) followed by UNDP (66), UNIDO (35) and the World Bank (4). The World Bank reported a balance of US \$1,115,227 of which the whole amount is attributable to (MYA) annual tranches. UNDP holds a total balance of US \$1,077,767 of which US \$268,454 is attributable to MYAs, and UNIDO holds a total balance of US \$1,057,981 of which US \$814,633 is attributable to MYAs.
- 8. All agencies have projects that were completed over two years ago and have remaining balances. Approximately forty percent of the funds (US \$1,115,227 out of US \$2,854,199) are attributed to the World Bank's four reported MYA projects that were completed over two years ago. UNEP has the largest number of projects (48) that were completed over two years ago, with balances totalling US \$769,433 followed by UNDP with 44 projects totalling US \$665,302.
- 9. In its explanation of why balances of US \$665,302 are still obligated for projects completed over two years ago, UNDP reiterated the fact that its financial procedures require that a final budget revision is issued to mark the formal closure of a project between UNDP and the executing agency before closing the project in UNDP's systems. It should be noted that at the 61st Meeting UNDP's balance on completed projects amounted to US \$678,003, US \$12,701, of which has been returned since the last meeting from projects completed over two years ago.
- 10. UNEP's balance of projects completed over two years ago has decreased from approximately US \$870,000 to US \$770,000 however; the number of projects completed over 2 years has remained at the same level of 48. Of the US \$769,433 balance against projects completed 2 years ago,

US \$258,220 relates to IS and MYA projects. In response to the Secretariat's query on the slow progress in closing projects completed over two years ago, UNEP advised that it is still working with its Government implementing partner to financially close the projects and report all the expenditures against them. It also reiterated that projects can only be closed once all the legal requirements are met including expenditure reports, inventory reports and in some of the projects audit reports.

- 11. The balance held by UNIDO for projects completed over two years ago shows a slight decrease since the 61th Meeting of the Executive Committee from US \$332,569 to US \$304,237 but the number of projects stands at the same level. Out of the 14 projects, 11 are MYAs with US \$136,464 in obligated and US \$136,999 in unobligated balances. UNIDO explained that the remaining funds for the MYA projects are pending financial completion of the tranches and un-obligated funds are not returned in the event that remaining disbursements would still be required.
- 12. The World Bank's overall number of projects with balances completed over two years ago remains at 4 however the amount balance has decreased substantively since the 61th Meeting from US \$2,052,501 to US \$1,115,227.

Obligated and un-obligated balances

13. The level of balances classified as obligated and un-obligated for the four implementing agencies is as follows:

- 14. Of the total obligated of US \$4,727,017 from completed and ongoing projects, US \$4,318,015 is obligated (which means that these funds are expected to be spent) and US \$409,002 has not been obligated. Implementing agencies are required to report reasons why any un-obligated balances could not be returned within the required time-frame, and to indicate when they will be returned as per decision 31/2(a)(ii).
- 15. UNDP has no un-obligated balances. Its overall number of projects with balances shows a substantive decrease from 78 projects reported to the 61th Meeting to 66 reported to the 62nd Meeting. The overall level of balances has decreased from US \$1,151,802 to US \$1,077,767. UNDP's obligated balance of US \$1,077,767 includes US \$268,454 for 10 MYAs. As explained at previous meetings these balances are obligated in the light of UNDP's internal financial procedures requiring a final budget revision to mark the formal closure of a project.
- 16. UNEP has 78 completed projects, and holds US \$1,476,042 in obligated amounts and has no un-obligated balances. The overall number of projects with balances has decreased from 81 projects reported to the 61th Meeting to 78 reported to the 62nd Meeting. The overall level of balances decreased from US \$2.3 million to US \$1.48 million. When requested to explain why obligated balances of projects completed over two years ago are still obligated instead of being returned to the Fund, UNEP explained that in most of the cases the Implementing Partners have been provided with cash advances through legal agreements to implement the activities. The projects can only be closed

once all the legal requirements are met including expenditure reports, inventory reports and in some of the projects audit reports. Over the last one year, since reporting to the 59th Meeting of the Executive Committee, the obligated balance reported by UNEP has reduced from US \$1,061,888 to US \$769,433. Of that balance, US \$353,275 relates to 25 new projects that have been placed under the category of "Projects completed over 2 years ago" since the report of last year.

- 17. UNIDO has 35 completed projects, and holds US \$648,979 in obligated and US \$409,002 in un-obligated balances. The overall number of projects with balances has increased from 33 projects reported to the 61th Meeting to 35 reported to the 62nd Meeting, and the overall level of balances has decreased from US \$1.19 million to US \$1.06 million. Out of the 35 projects, 19 are MYAs with US \$482,475 in obligated and US \$332,158 in unobligated balances. UNIDO advised the Secretariat that it would return remaining funds to the MLF once remaining obligations are cleared, and the projects financially completed. UNIDO is the only agency with un-obligated balances not returned to the Fund.
- 18. The World Bank has no un-obligated balances, and holds US \$1,115,227 in obligated balances for completed projects, all of which are for MYAs. The World Bank explained that these obligated balances are attributed to the annual programmes of MYAs for Philippines (PHI/PHA/38/INV/69, PHI/PHA/41/INV/71) and Thailand (THA/PHA/41/INV/140 and THA/PHA/42/INV/141).
- 19. The World Bank recalled that the balance on the projects in the Philippines is made up of funds for the last foam manufacturing activities and savings in the foam and commercial refrigeration manufacturing sector. Since balances are yet to be disbursed as originally planned, the World Bank advised the Secretariat that the Philippines project management unit has identified areas to reallocate the savings and submitted a proposal to reallocate funds in the 2010 annual implementation programme as approved by decision 60/8(i)). With respect to the projects in Thailand, the Government proposed to use some of the savings for the MAC servicing and project management, as put forward in the 2010-2012 annual implementation plan approved at 60th Meeting of the Executive Committee by decision 60/14.
- 20. All four tranches are related to the earliest annual programs (APs) of the two multi-year projects. As explained previously to the Secretariat the assumption had been that, when countries met respective performance targets according to the agreement with the Executive Committee, the next tranche/AP would be approved.

Agency support costs

21. At its 35th Meeting, the Executive Committee requested implementing agencies to return all agency support costs associated with remaining funds from completed projects. If expenditures had been incurred from these costs, the IAs should provide an explanation and return the balance of funds (decision 35/13(k)). Table 4 indicates that a total of US \$106,223 in agency support costs will be returned at the 62nd Meeting.

Funds being returned to the 62nd Meeting from bilateral agencies

- 22. By decision 56/2 bilateral agencies were requested to report to the Executive Committee in their proposed disposition on balances from completed projects. There is no return from bilateral agencies of balances against completed projects to the 62nd Meeting.
- 23. Historically, the Executive Committee has addressed returns from bilateral contributions either as an offset against a future approval or with the return of cash that results in a commensurate reduction in bilateral contributions and an increase in cash contributions. In cases where contributions are made in US dollars, the returns always offset the approved levels. In cases where contributions are made according to the Fixed Exchange Rate Mechanism (FERM), there may be losses or gains resulting from the return of balances.
- 24. By decision 57/3 e(ii) the Executive Committee decided to request the Treasurer to record the amount of US \$41,624 in exchange rate gain on bilateral agency returns as miscellaneous income to the Fund, on receipt of the equivalent amount in cash, as it was expected that this would have been a one-off event and therefore might be covered under miscellaneous income. However, with the return of additional balances from the same bilateral contributing country, and returns from other bilateral agencies using the FERM, the Secretariat is suggesting that the Executive Committee addresses this matter as a policy issue. In this respect, the Committee may wish to assign any gains or losses from balances returned from completed bilateral activities to exchange rate losses/gains due to the FERM including those funds returned to the 57th 59th and 60th Meetings.

Bilateral projects with balances by year of completion

25. Table 6 presents the balances that are being held by bilateral agencies and the years in which those projects were completed. It shows that for projects completed up to and including 30 September 2009 (at least over the last 12 months) bilateral agencies had balances totalling US \$182,459 including support cost. Finland holds balances for 1 project completed over two years ago.

26. The Government of France advised the Secretariat that it will not return the balance on completed projects to the 62^{nd} meeting. The Government of Japan also advised the Secretariat that it would not be returning any funds at the 62^{nd} Meeting and it would be using the unspent balance for future projects. The response of the Government of Finland on the return of the balance on its completed projects is pending confirmation from the Government.

COMMENTS

- 27. Annex I presents additional information on obligated and un-obligated balances by agency. Of the US \$4.7 million in projects with balances in this report, about US \$2.0 million is for MYAs. Of the US \$4.7 million UNEP holds the largest amount of balances, with US \$1,476,042 in obligated balances followed by the World Bank with US \$1,115,227. UNEP's large obligated amounts could be explained by the fact that UNEP is now obligating cash advances to implementing partners. In addition, with the exception of UNIDO, all the agencies have cleared their un-obligated balances.
- 28. The status of contributions and disbursements as of 19 October 2010 indicates that the Treasurer has an available balance amounting to US \$170,909,029 in cash and promissory notes. The total net balance returned by implementing agencies including agency support costs is US \$1,443,667. The total level of resources available for approvals by the Executive Committee at its 62nd Meeting, after taking into account the Fund balance as contained in document UNEP/OzL.Pro/ExCom/62/3 and the total returned by implementing agencies, is US \$172,352,696.
- 29. Considering the total level of funding for projects and activities being considered by the Executive Committee as at 20 October 2010 amounting to US \$225,717,513 including support cost there are insufficient resources available for approvals at the 62nd Meeting.

RECOMMENDATIONS

- 30. The Executive Committee may wish:
 - (a) To note the report on balances and availability of resources contained in document UNEP/OzL.Pro/ExCom/62/4;
 - (b) To note the net level of funds being returned by the implementing agencies to the 62nd Meeting was US \$1,337,444 against projects, which included the return of US \$54,908 from UNDP, US \$74,282 from UNEP, from US \$712,925 UNIDO and US \$ 495,329 from the World Bank;
 - (c) To note the net level of support costs, being returned by the implementing agencies to

- the 62nd Meeting was US \$106,223 against projects, which included the return of US \$5,977 from UNDP, US \$9,657 from UNEP and US \$53,470 from UNIDO and US \$37,119 from the World Bank;
- (d) To note that implementing agencies had balances totalling US \$2,854,199 excluding support costs, from projects completed over two years previously, which included US \$665,302 for UNDP, US \$769,433 for UNEP, US \$304,237 for UNIDO, and US \$1,115,227 for the World Bank;
- (e) To note that bilateral agencies had balances totalling US \$34,022 excluding support costs from projects completed over two years previously, solely attributed to Finland; and
- (f) To request the Treasurer to assign any gains or losses from balances returned from completed bilateral activities to exchange rate losses/gains due to the Fixed Exchange Rate Mechanism (FERM) including those funds returned to the 57th, 59th, and 60th Meetings.
