Note on the organization of the document

- 1. This document provides an overview of requests from bilateral agencies, and whether these requests are eligible for approval by the Executive Committee in light of the maximum level of bilateral cooperation available for 2010. It cross-references relevant meeting documents that include a discussion on the bilateral requests, and contains the standard recommendation on the year of assignment for bilateral cooperation.
- 2. A total of eleven projects for bilateral cooperation with a value of US 6,549,336 (including agency fees) have been received by the Secretariat for approval at the 62^{nd} Meeting. Four from the Government of Germany and seven from the Government of Japan as shown in Table 1.

REQUEST FROM THE GOVERNMENT OF GERMANY

Introduction

3. Table 2 provides a summary of the requests for bilateral co-operation from the Government of Germany. The methyl bromide accelerated phase-out plan in Jordan (US \$687,100) has a policy issue which is considered under document UNEP/OzL.Pro/ExCom/62/10 "Overview of issues identified during project review", and is therefore not included in Table 2. The values of their requests (US \$2,849,955) exceed 20 per cent of Germany's contribution for 2010 (US \$2,776,808). Germany bilateral approved amounts for 2009 (US \$1,974,067) plus Germany's 2010 approvals at the 60th Meeting (US \$305,008), if added to Germany bilateral submission to the 62nd Meeting would result into an overall amount of US \$5,129,030 and would not exceed 20 per cent of Germany's contribution for 2009-2010.

Introduction

7. Table 3 provides a summary of the requests for bilateral co-operation from the Government of Japan. The demonstration project on HCFC management and phase-out in the refrigeration servicing sector in China (US \$230,520) has a policy issue which is considered under document UNEP/OzL.Pro/ExCom/62/10 "Overview of issues identified during project review", and is therefore not included in Table 3. The value of their requests (US \$2,781,761) together with projects approved at the 60th and 61st Meetings (US \$600,143) does not exceed 20 per cent of Japan's contribution for 2010 (US \$5,382,029).
