BUDGET DU PROGRAMME D'AIDE A LA CONFORMITE POUR L'ANNEE 2011

OBSERVATIONS ET RECOMMANDATIONS DU SECRETARIAT DU FONDS

Description du projet

- 1. Dans le contexte des amendements à son Programme de travail pour 2010, le PNUE a présenté à la 62^{ème} réunion le projet de budget de son Programme d'aide à la conformité (PAC) pour 2011, qui s'élève à \$US 9 007 000, plus des frais d'appui d'agence de 8% d'un montant de \$US 720 560. Cette communication fait suite à la décision 47/24 qui limitait à 3% par an l'augmentation du budget du PAC du PNUE et invite cette organisation à affiner le classement par priorités des fonds alloués aux différentes rubriques du PAC afin de prendre en compte les changements de priorités.
- 2. Le PNUE précise encore que son programme s'inscrit dans la triple approche présentée dans sa version de l'année dernière. Pour 2011, le PNUE veillera tout particulièrement à ce que les pays tiennent compte des mesures de conformité prévues pour 2010 et des mesures de règlementation applicables au bromure de méthyle et autres SAO prévues pour 2015, il renforcera la capacité institutionnelle des pays à poursuivre l'élimination des CFC en l'année 2010, et il améliorera leur capacité à éliminer les HCFC, en prenant en compte d'autres questions pertinentes telles que le climat.
- 3. Le PNUE a également fourni un résumé des résultats obtenus cette année dans le cadre de la mise en oeuvre du PAC. Comme pour les communications précédentes, ces réalisations ont été mises en évidence par région et elles ont concerné plus spécialement certains domaines tels que le soutien en matière de communication des données, l'aide spéciale aux pays en matière de non-conformité, les activités engagées au titre de la coopération Sud-Sud, l'aide en matière d'élaboration de politiques et de législations, la ratification d'amendements au Protocole de Montréal, le renforcement des moyens des nouveaux administrateurs des Bureaux de l'ozone, et les actions de sensibilisation menées à l'échelle régionale. Ces réalisations sont présentées de manière détaillée à l'Annexe II intitulée "Highlights of CAP's activities for the period 1 January-30 September 2010" (Aperçu des activités déployées dans le cadre du PAC pour la période allant du 1er Janvier au 30 Septembre 2010), qui est jointe au présent document. Conformément à la décision 60/6 b)i), le PNUE a également présenté une liste complète des activités spéciales d'aide à la conformité, mises en oeuvre au moyen du budget du PAC figurant à l'Annexe III.
- 4. Le PNUE a appelé l'attention sur les défis pour 2011 prévus par le PAC, dont un résumé de ceux qui sont communs à toutes les équipes régionales, figure ci-après:
 - a) Poursuivre l'élimination au delà de l'horizon 2010 et empêcher le commerce illicite, en particulier des CFC ;
 - b) Veiller à ce que tous les pays, notamment les nouvelles parties et les nouveaux pays qui sont en proie à une instabilité politique, atteignent l'objectif concernant l'élimination totale des principales substances appauvrissant la couche d'ozone (SAO) pour l'année 2010 ;
 - Achever les plans de gestion de l'élimination des HCFC actuellement en préparation afin de s'assurer que les pays tiennent compte des premières mesures de règlementation des HCFC en 2013, 2015 et 2020;
 - d) Faire en sorte que les pays instaurent et exécutent une politique/règlementation en matière de HCFC prenant en compte les objectifs pour 2013 et 2015 ;

- e) Encourager les pays à adopter des solutions technologiques idoines pour remplacer les HCFC en tenant compte des questions liées au climat ;
- f) Etablir des relations solides et renforcer la coopération avec les entreprises et le secteur privé ainsi qu'avec les institutions nationales/régionales compétentes, afin de faire en sorte que l'élimination de HCFC intervienne dans les délais prescrits;
- g) S'assurer que dans les réunions et les instances nationales, régionales et sous-régionales, le Protocole de Montréal suscite un vif intérêt et une attention soutenue dans ses aspects politiques et autres;
- h) Inscrire le Protocole de Montréal dans le contexte plus vaste des politiques nationales et sous-régionales relatives au développement et aux procédés durables;
- i) Développer et gérer les capacités nationales afin d'encourager la gestion écologiquement rationnelle des déchets de SAO et des SAO indésirables ainsi que leur élimination finale;
- j) Tenir les responsables de l'application du Protocole de Montréal informé sur les questions techniques, économiques et autres -, qui ont trait à l'élimination des SAO.

Changements concernant le budget et l'approche du PAC.

- 5. Le projet budget du PAC pour 2011 s'élève à \$ US 9 727 560, y compris 8% de frais d'appui d'agence, soit une augmentation de 3% par rapport au budget 2010, autorisée en vertu de la décision 47/24. Le PNUE a indiqué que le projet de budget était fondé sur les tendances et les expériences enregistrées dans l'exécution des budgets précédents. Les ajustements des dépenses de personnel sont fondés sur des coûts salariaux courants indiqués par le Siège des Nations Unies et ils prennent en compte les décisions de la Commission de la fonction publique internationale. Pour mieux répondre aux besoins du Programme, l'exécution du budget pour 2010 et les projections pour 2011 ont été analysées afin que soit établi un nouveau classement des priorités financées au moyen du budget.
- 6. Les éléments et les coûts afférents au projet de budget du PAC pour 2011 sont semblables à ceux qui ont été approuvés en 2010 pour permettre au PNUE de fournir ses services en matière d'aide à la conformité. Les principaux changements entre le budget approuvé pour 2010 et le projet de budget du PAC pour 2011 sont résumés ci-dessous.

Dépenses de personnel

- 7. Des changements tout à fait négligeables ont été observés dans les dépenses totales concernant le personnel affecté au projet (rubrique 1199). Cependant, les dépenses concernant les agents des services généraux et l'aide au programme (rubrique 1399) ont augmenté de 9.5% en raison de la création de 4 nouveaux postes d'assistants régionaux en vulgarisation (rubrique 1322-1325). Les majorations apparaissant dans ces rubriques ont été obtenues en réaffectant le montant alloué au financement du poste d'Administrateur, Information (rubrique 1106) qu'il est proposé de supprimer, et les tâches qui vont être réparties entre les titulaires de ces 4 nouveaux fonctionnaires régionaux.
- 8. Les dépenses de personnel appellent les quelques observations ci-après :
 - a) Les dépenses concernant l'Administrateur, Surveillance et Administration (rubrique 1105) sont désormais absorbées par le budget ordinaire du PNUE; seules les dépenses

- correspondant à deux mois de travail de cet agent, sont prises en charge par le budget du PAC;
- b) Comme indiqué au paragraphe 7 ci-dessus, le poste d'Administrateur, Information (rubrique 1106) sera supprimé pour permettre la création de 4 nouveaux postes d'assistants régionaux ;
- c) La rubrique 1109, Administrateur de programme, Technologie de l'information/appui aux activités d'élimination des HCFC, sera désormais financée à 100% par le budget du PAC, tandis que dans les budgets précédents les dépenses liées à ce poste n'étaient pris en charge qu'à 50%; et
- d) Les dépenses concernant l'adjoint administratif (rubrique1304), devant désormais être prises en charge à 100% par le budget ordinaire du PNUE, aucune allocation n'est prévue dans le présent budget;

Dépenses des services d'exécution et dépenses se rapportant au programme.

9. Le budget qui a été présenté ne fait apparaître que très peu de changements dans les différentes rubriques concernant les dépenses des services d'exécution et celles se rapportant au programme et tous les montants qui ont été réaffectés l'ont été dans le cadre de l'enveloppe totale des crédits budgétaires alloués au PAC, qui n'a pas été dépassée.

Changements concernant le programme.

10. Le PNUE a souligné que le PAC était un programme régional de prestation de services et qu'en adoptant un nouveau classement des priorités et une nouvelle affectation des dépenses, il avait fait des besoins régionaux son principal élément moteur. Les retours d'information provenant des réunions du réseau régional ainsi que des réunions du groupe consultatif du PAC ont permis de définir les activités et les actions à engager, et toute modification du cap du PAC s'inspire de cette remontée d'informations.

Exécution du budget en 2009

11. A partir des informations figurant dans son rapport d'activité pour 2009, le PNUE a indiqué que le budget global du PAC affichait un solde de \$ US 813 924 dont un montant de \$US 810 404 correspondait à des engagements non réglés, ce qui amenait le solde effectivement non dépensé du PAC à \$US 3 520. Le PNUE a indiqué que ses réserves de fonds avaient été restituées à la 61ème réunion, conformément à la décision 35/36 d).

OBSERVATIONS DU SECRETARIAT.

Projet de budget d'ensemble.

12. Le projet de budget du PAC du PNUE pour 2011 englobe une demande de crédits budgétaires s'élevant à \$ US 9 727 560 (y compris les frais d'appui), qui représente une augmentation de 3% par rapport à l'enveloppe budgétaire de 2010. S'il est vrai qu'un certain nombre de postes font ressortir une majoration des coûts, la demande est conforme à la décision 47/24 du Comité exécutif selon laquelle le PNUE devrait limiter à 3% ses augmentations.

- 13. Lors de ses concertations avec le PNUE sur l'enveloppe budgétaire du PAC, le Secrétariat a sollicité des éclaircissements sur la procédure suivie par le PNUE pour s'assurer que la demande du Comité exécutif concernant l'établissement d'un nouveau classement des financements par priorités et la régionalisation serait prise en compte lors de l'élaboration de la version définitive du plan de travail et du budget. Il a noté que s'il était vrai que ces deux éléments étaient présentés comme tels dans le document soumis, le programme qui en découlait ne faisait que très rarement apparaître des changements significatifs quant à l'orientation et au fond, bien que certaines rubriques fassent l'objet d'ajustements. Dans sa réponse, le PNUE a indiqué qu'il mettait à profit cette marge de manœuvre pour réaffecter vers certaines rubriques, des montants alloués dans le budget précédent à d'autres rubriques pour tenir compte de nouvelles priorités. D'après le PNUE, cette réaffectation est intervenue après que les pays ont envoyé des informations en retour, que d'autres éléments intervenant dans l'établissement du budget du PAC ont été pris en compte, et que l'on se soit demandé si le niveau et le type de services correspondaient à cette situation nouvelle. En outre, il a indiqué que l'ampleur des changements en matière de redéfinition des priorités intervenant d'une année sur l'autre, était fonction des besoins du programme. Le PNUE a aussi fait valoir qu'il n'était pas tenu de redéfinir ces priorités mais qu'il avait été encouragé à le faire par le Comité exécutif et que ce processus était prévu dans son mode de fonctionnement
- 14. En réponse à la demande d'éclaircissement du Secrétariat sur la création des 4 postes d'assistants de vulgarisation dans les 4 équipes régionales du CAP, le PNUE a répondu que la création de ces postes soutenait directement et de manière significative la régionalisation des ressources du PAC en ce sens qu'elles permettaient de déplacer les ressources humaines de Paris vers les équipes régionales afin de prendre en compte les domaines d'assistance prioritaires. Ces assistants travailleront sous la supervision générale des coordonnateurs de réseaux régionaux dans les régions et de l'Administrateur, Information en poste à Paris, pour contribuer à la prestation de services d'information, de communication et d'éducation, conformément à la nouvelle Stratégie de communication mondiale. Le PNUE a indiqué qu'au vu de ces concertations, cette utilisation des ressources était plus efficace que celle qui consistait à n'avoir qu'un Administrateur, Information qui serait en poste à Paris et n'aurait qu'un accès limité aux affaires régionales.
- 15. Le Secrétariat a également pris note de l'Annexe III récemment jointe aux texte, qui a été présentée par le PNUE, conformément à la décision 60/6 b)i), dans laquelle figure une liste, pays par pays, des activités spéciales de conformité à engager en 2001. Il a demandé au PNUE comment il décrivait "les activités spéciales de conformité", en particulier la différence par rapport à celles qui sont actuellement menées puisque la liste contient un panachage de plusieurs activités dont l'exécution ne doit pas être nécessairement soumise à conformité (c'est à dire l'inventaire des déchets de SAO, des douanes vertes, etc....). Le PNUE a répondu que la principale différence était qu'elles correspondaient à des services ne se rapportant pas à des projets (par opposition à celles qui relèvent de projets spécifiques approuvés), qui étaient fournis par l'équipe du PAC du PNUE qui répond à des besoins formulés ou perçus dans les pays visés à l'Article 5 qui sont dans une situation de non-conformité effective au potentielle. En outre, il a présenté ses activités de conformité courantes qui englobent, par exemple, l'aide du PAC à un renforcement rapide de la capacité des nouveaux administrateurs nationaux de l'ozone, l'aide permettant de comprendre et de donner suite aux prescriptions en matière de communication des données pour les programmes de pays visés à l'Article 7 du Protocole de Montréal, la collaboration avec le Secrétariat de l'ozone afin de promouvoir la ratification des amendements, etc.
- 16. Se référant en outre à l'Annexe III, le Secrétariat a également sollicité l'avis du PNUE sur la façon dont il classait par rang de priorité les pays en matière d'assistance, considérant le grand nombre d'entre eux qui bénéficiait du soutien de chaque équipe régionale du PAC. Le PNUE a indiqué que la liste des activités visées à l'Annexe III avait été compilée à partir des consultations menées par le PAC avec les pays au cours du second semestre 2010 et que par conséquent, cette liste était purement indicative. Le PNUE a également fait savoir que le PAC pouvait être invité à répondre à d'autres demandes d'aide

ad hoc au cours de 2011, y compris à celles qui ne figurent pas actuellement en tant que telles dans la liste. Il a précisé que le PAC avait déjà répondu à des demandes ad hoc urgentes émanant de pays visés à l'Article 5 en plus des services prévus du PAC. Le PNUE a accepté de réviser l'Annexe III afin que celle-ci prenne davantage en compte ces concertations et qu'elle précise davantage les activités spéciales.

Recommandations

- 17. A la lumière des informations communiquées par le PNUE et des observations ci-dessus, le Comité exécutif peut souhaiter envisager de prendre les mesures suivantes :
 - a) Approuver le budget du Programme d'aide à la conformité (PAC) pour 2010, s'élevant à \$US 9 007 000, plus frais d'appui d'agence de 8% d'un montant de \$US 720 560 figurant à l'Annexe I du document UNEP/OzL.Pro/ExCom/62/16;
 - b) Demander au PNUE, lors des prochaines présentations du budget du CAP de :
 - i) Continuer de communiquer des renseignements détaillés sur les activités pour lesquelles les financements mondiaux seront utilisés ;
 - ii) Continuer d'affiner le classement par priorités des fonds alloués aux différentes rubriques du CAP de manière à tenir compte de l'évolution des priorités ; et donner des précisions sur les nouvelles affectations de crédits budgétaires, conformément aux décisions 47/24 et 50/26 ; et
 - iii) Continuer de rendre compte sur les niveaux actuels des postes du tableau des effectifs et informer le Comité exécutif de tout changement, en particulier s'agissant de toute augmentation des crédits budgétaires.

INTRODUCTION

1. This document presents a proposal for the annual budget of the Compliance Assistance Programme (CAP) for the year 2011 for the consideration of the 62nd meeting of the Executive Committee of the Multilateral Fund. This budget is submitted as part of UNEP's 2011 Work Programme.

To deliver the planned comprehensive compliance assistance services to Article 5 countries during 2011, UNEP is requesting a budget of US\$ 9,007,000 plus agency support costs of 8 per cent amounting to US\$ 720,560.

- 2. This budget request corresponds to a 3% increase compared to the approved 2010 CAP budget.
- 3. This document is structured as follows:
 - Narrative, which comprises six sections: Vision, Approach, Methodology, Budget Details, Global Awareness and Justification for budget increase.
 - Annex I and I(b): 2011 CAP budget proposal.
 - Annex II: Highlights of CAP's activities for the period 1 January 30 September 2010, which includes sections on:
 - 1. CAP's achievements,
 - 2. Challenges ahead,
 - 3. Global and regional awareness activities during this period as per Decisions 50/26 and 53/21
 - 4. CAP's use of programmatic.
 - Annex III: Special compliance assistance services proposed for 2011 as per Decision 60/6.

UNEP seeks the Executive Committee's approval of this 2011 CAP budget.

VISION FOR CAP IN 2011

5. The OzonAction CAP established in 2002 reflected the needs of Article 5 countries at that time to support those countries during the initial compliance period of the Montreal Protocol. In 2009, the Executive Committee approved a re-alignment of CAP to respond to Article 5 country needs in the current and changing landscape of the Montreal Protocol. UNEP's strategy for CAP was based around three parallel tracks of assistance for Article 5 countries, and this approach and vision will continue to guide and further strengthen CAP's activities in 2011.

Track 1: Ensure 2010 compliance is achieved and maintained and enable compliance with the 2015 control measures for relevant ODS including methyl bromide

6. Vision: At the time of this budget's submission, the 2010 deadline for Article 5 countries to comply with the 2010 chlorofluorocarbon (CFC), halon and carbon tetrachloride (CTC) phase out targets has passed, however due to the timing of the Article 7 data reporting, the actual compliance status of Article 5 countries cannot be assessed until 2011. UNEP will work with countries to ensure that the data reporting for 2010 is complete and timely so that this situation can be assessed. There are also a small number of countries which still have ongoing activities to complete, notably those under Total Phase out Management Plans (TPMPs), which must be incorporated into their HCFC Phaseout management plans (HPMPs). Compliance with the Methyl Bromide control measures has its unique challenging dimension due to the fact that part of its production and consumption for QPS use is not controlled and likely to reamin so for years to come. The 'Reality check' of its compliance would need assistance in close monitoring. UNEP's vision is to continue the strong collaborative arrangements with the Implementing Agencies and Secretariats to help specific Article 5 countries complete as quickly as possible their ongoing CFC phase out activities and avoid a situation of non-compliance.

CAP approach to implement that vision: Provide collective assistance to "at risk" Article 5 countries through the Montreal Protocol family of institutions i.e. Implementing agencies, Bilateral Agencies, Secreteriats and global, regional and nations institutes. As it has during preceding years, UNEP will continue to accord the 2010 compliance target as a high priority for CAP staff and resources during 2011. UNEP in consultation with the Implementing Agencies, bilateral agencies and Secretariats had set up a common tracking mechanism in 2009 to identify and track interventions needed by different agencies to assist Article 5 countries in actual or potential noncompliance. With its partners, CAP will continue to use and update this mechanism on an ongoing and intensified basis from now until the compliance issues are resolved. **Track 2: Strengthen the institutional capacity of Article 5 countries to ensure sustainable compliance beyond 2010**

7. Vision: The challenge of ensuring that the phase out already achieved in Article 5 countries will sustain after 2010 continues, in particular for ensuring adequate management approaches and availability of CFCs for servicing existing refrigeration and air conditioning equipment until the end of useful life, the CFC metered dose inhaler (MDI) manufacturing phase out in countries, end of life management for ODS, and ensuring high-level awareness and political support for the Montreal Protocol. There will also be a need to assists some

countries/regions with meeting their upcoming methyl bromide reduction targets. UNEP's vision is that Article 5 countries sustain the existing phase out successes already achieved with minimal disruptions.

8. CAP approach to implement that vision: CAP will use its full range of Networking, capacity building and information services to continue preparing Article 5 countries to sustain the 2010 achievements and prepare for their next compliance period, including raising awareness in the NOU and other critical segments of society of the deadlines and conditions that are coming. CAP will work with countries to develop their own national strategies for internalizing the Montreal Protocol objectives into national policies, agendas and institutions to help ensure long-term sustainability. CAP will continue using existing services such as thematic meetings and South-South cooperation to share experiences and best practices, and the tools and services of the Information Clearinghouse (including social media tools). UNEP will also seek arrangements with other Implementing Agencies and NOUs for possible CAP roles in cases where the other agency has completed its job in specific countries. Institutionalizing the compliance measures and the sustained enforcement of the licensing and other policy measures would be strengthened. The approach would be to develop new and strengthen existing partnerships with national and regional initiatives, mechanisms and institutes.

9.

Track 3: Enhance the capacity for implementing new responsibilities related to the HCFC phase out by taking other environmental advantages including climate change into account.

- 10. Vision: Having helped countries initiate a "quick start" on the HCFC job in 2009-2010, CAP will focus on supporting Article 5 countries to prepare their HPMPs and to meet the 2013 freeze and 2010 reduction target. CAP has a key role to play in helping to design policies, create high level awareness, build the capacity of the NOUs to address the HCFC challenge, and help mobilize co-financing for the climate benefit of the HCFC phase out. Early actions to reduce the steep growth curb in HCFC consumption and reducing future demand for HCFCs for servicing are both priorities, both of which will reduce future costs to the Multilateral Fund and protect the environment. UNEP will apply the expertise of CAP staff developed over the years and the lessons learned from the CFC phase out experience to the HCFC challenge.
- 11. *CAP approach to implement that vision:* The challenge in addressing HCFC phase out has three critical dimensions. The short time available for the phase out, the present steep growth of HCFCs and the the large quantities of the HCFCs to be phased out. On the other hand, there is substantive experience of CFC phase out and Executive Committee has now finalized the policies to proceed. UNEP will concentrate and re-double its focus of CAP assistance based on these challenges and opportunities.. In particular, it will assist Article 5 countries with HPMP preparation and establishing HCFC licensing and quota systems and other HCFC control policies. The latter will be particularly crucial for low volume consuming countries (LVCs) in meeting the 2013 HCFC freeze and 2015 reduction step. Following on the successful approval of the HPMPs for the Maldives (the first HPMP for a low volume consuming country) and Cambodia, in 2011 UNEP will continue assisting 90 countries with the preparation and

submission of their HPMPs in its capacity as either a Lead Agency or Cooperating Agency. The HPMPs will establish accurate and comprehensive baseline data, and create the base of awareness and knowledge in the country needed as a precursor to the HPMP initiation. There will be an emphasis on helping countries identify about low-GWP technology options and mobilizing co-financing for the climate benefits of the HCFC phase out. CAP will continue promoting communication between NOUs and their national climate change focal point counterparts to explore opportunities for synergies, cooperation and co-financing the climate dimension of the HCFC phase out. CAP will continue promoting information sharing and experience exchange about non-HCFC technologies and policies through the Regional Networks and Information Clearinghouse to help NOUs finalise and submit their HPMPs and control the growth of HCFC consumption. CAP will use its Regional Network and thematic meetings to continue sharing information on HCFC alternatives, HPMPs and the associated climate benefits, but also as platforms for international experts to interact with the NOUs, HPMP consultants, and other HCFC stakeholders.

APPROACH

12. With the vision and focus described above as the framework, UNEP developed this proposal according to identified needs and a reprioritisation of resources.

Needs analysis

13. The proposed budget is based on the current and anticipated needs of Article 5 countries as assessed by the CAP teams, drawn from various sources including *inter alia* direct feedback collected during Network meetings and through consultations with NOUs, other Implementing Agencies and executing partners. It also reflects compliance-related decisions taken through the 21st Meeting of the Parties, 44th Implementation Committee, 30th Open-ended Working Group and 61st Executive Committee meeting, and the Multilateral Fund Secretariat's *Prospects of Article 5 Countries in Achieving Compliance with the Next Control Measures of the Montreal Protocol.* While developing this proposal, UNEP also took into account the advice of the experts who participated in the 2010 CAP Advisory Group Meeting held in Paris in 8-9 September 2010.

Reprioritisation of resources

14. The budget proposal reflects an internal analysis of the CAP structure, staff roles and responsibilities, the distribution resources within CAP (between the individual Regions, as well as between Regions and Paris), and whether the level and type of services provided by the current CAP team match the new circumstances. An overview of these analyses is as follows (the specific changes appear in the "Budget Details" section).

Roles and responsibilities of staff

15. UNEP has reviewed the responsibilities of staff and determined that adjustments are needed to reflect various changing circumstances, notably the creation of Outreach Assistant Posts at then regions to work closely with the Article 5 countries on outreaching technical information on HCFC phase out.

Distribution of human and financial resources

16. UNEP has considered the requirements of each of the CAP teams in the Regions and Paris, and proposes a redistribution of allocations between budget lines that meets the requirements of the individual CAP teams and is also in line with Executive Committee decisions on regionalization of CAP resources.

Leveraging the expertise and financial resources within CAP

- 17. UNEP has assessed the priorities and anticipated needs of countries for 2011-2012, and there will clearly be a need to add additional capacity to CAP work over the next 2-3 years to account for the increase in work, and for HPMP preparation and implementation. UNEP has continued to extend the prioritization of funding among CAP budget lines so as to accommodate changing priorities, as permitted by the Executive Committee.
- 18. <u>Leveraging resources from UNEP's Programme Support Funds.</u> The UNEP CAP team studied in detail the comprehensive independent assessment of the administrative costs study undertaken by the Multilateral Fund and requested support from the UNEP Core Accounts to reduce the CAPs administrative costs. UNEP is co-funding the Administrative posts within the budget thus availing more resources to activities in support of Article 5 countries.

METHODOLOGY

19. In addition to the assessment of Article 5 country needs and reprioritization indicated above, UNEP developed the 2011 CAP budget using three other key inputs, namely the current UNEP Business Plan, Executive Committee decisions and guidance related to CAP, and a financial analysis based on the previous CAP budget and projected requirements.

Business Plan

20. This budget request is consistent with the priorities and funding levels established in UNEP's revised business plan for the years 2010-2014. It also takes into account UNEP's planned CAP activities in cooperation with the other Implementing Agencies and bilateral agencies decided through the Business Planning process, and through multilateral and bilateral consultations.

Executive Committee decisions related to CAP

- 21. While preparing this proposal, UNEP took into account the specific Executive Committee decisions related to CAP, which are:
- Decision 60/6 (i), which requests UNEP to submit a complete list of special compliance assistance activities with the CAP budget (submitted to the last Meeting of the Executive Committee each year) so that the Executive Committee would be able to examine and approve the budget in a more holistic manner.

<u>Action:</u> The special compliance assistance services proposed for 2011 are presented in Annex III.

Prior to the 60th Executive Committee meeting UNEP submitted its list of proposed Special Compliance Assistance Services as part of the Business Plan. Henceforth as a result of this decision UNEP will submit those proposals as part of its Budget and Work Programme.

Decision 56/43, which reiterated the previous Decision 53/21 by requesting UNEP in future submissions for the CAP budget to continue: (a) To provide detailed information on the activities for which the global funds would be used; (b) To extend the prioritization of funding between CAP budget lines so as to accommodate changing priorities and to provide details on the reallocations made in its budget following Executive Committee decisions 47/24 and 50/26; and (c) To report on the current staff post levels and to inform the Executive Committee of any changes therein particularly as they related to increased budget allocations.

<u>Action:</u> This budget (a) presents information on the activities for which the global awareness funds would be used appears in paragraphs 27 (b) reflects UNEP's reallocations of funding between CAP budget lines to accommodate changing priorities, as indicated in paragraphs 24 (c) reports on current staff post levels in paragraphs 23.

- Decision 52/7, which followed the Final Report on the Evaluation of the CAP Programme,² and which requests UNEP to consider further regionalization of CAP resources and to focus the CAP on specific priority areas and activities.
 Action: This budget reflects a further regionalization of CAP resources in paragraphs 26.
- Decision 50/26 (c), which requires that the CAP budget should only be spent in accordance with the terms of reference for the financial mechanism contained in Article 10 of the Montreal Protocol and therefore resources should not be spent on inter-multilateral environmental agreement coordination activities.
 Action: The CAP budget continues to be spent by UNEP in accordance with the terms of
- Decision 47/24, which requires that (a) Requests for future increases in the CAP budget would be limited to 3 per cent, unless the Executive Committee was given evidence that inflationary pressures justify otherwise; and (b) UNEP was encouraged to continue to extend the prioritization of funding between CAP budget lines so as to accommodate changing priorities.
- *Action: The present budget proposal adheres to 3% limit.*

reference for the financial mechanism.

Financial analysis

22. The proposed budget is based on the trends and experiences of the previous budgets. A review of the budgeted personnel costs was done to evaluate if indeed they are sufficient to cover the cost of staff. For staff cost adjustments, these are based on standard salary cost formulated by United Nations Headquarters, these take into account decisions of the International Civil Service Commission on a variety of staff entitlements (such as dependency allowance and education grant) as well as other factors affecting the costs including inflation and variation in exchange rates. A review of the budget performance for 2009 as well as the projections for the year 2010 was done in order to reprioritize the budget to better address the needs of the programme .

BUDGET DETAILS

23. The elements and costs for the 2011 CAP budget proposal are similar to those approved for UNEP in 2010 to delivery its compliance assistance services. This section describes the changes in the context of the applicable Executive Committee decision.

Staffing lines

24. In accordance with Decision 53/21, UNEP is reporting on current staff post levels and inform the Executive Committee of any changes therein, particularly as they related to increased budget allocations. The staff lines have been adjusted to reflect the estimated standard staff cost in 2011. The following Budget Lines (BLs) have been modified.

<u>BL 1105 – Monitoring and Administration Officer</u>. More funding of post's costs will now be absorbed by UNEP core resources as part of the leveraging of funds detailed in paragraph 18. The programme support budget will fund 10 months of this post. The balance of 2 months will be funded out of the Multilateral Funds. The balance of funds from this line has been reprioritized to fully fund Programme Officer – Information Technology/HCFC Support BL 1109.

<u>BL 1106 – Information Officer (Paris).</u> Based on the anticipated needs for more support at the regional level for assistance to Article 5 countries, this P-post in Paris will be cancelled to allow for the creation of the information-related Regional Outreach Assistant G-posts in the region (BL 1321-1324). This regionalization of human resources reflects the growing emphasis on the regional delivery of information, communication and education services (particularly related to the HCFC phase out), rather than through a centralized clearinghouse. This reflects a significant reprioritization of human resources and programme emphasis from Paris to the regions.

<u>BL 1109 – Programme Officer – Information Technology/HCFC Support This budget line,</u> which was previously funded at 50% and named "Programme Officer – Information Technology", is now proposed for full funding using reprioritized allocations from other budget lines. Article 5 countries are currently experiencing an extremely challenging situation of having a very short time to meet upcoming time targets related to HCFC controls, and with a much larger physical quantity of HCFCs to phase out. Experience sharing between countries and regions about the preparation and implementation of HCFCs is absolutely critical for ensuring compliance with the HCFC controls. Whereas, the CFC implementation process had the luxury of nearly two decades of time to undertake such experience exchange, NOUs currently have two years before their first targets. Sharing of cross-network information on technology and policies was extremely valuable and effective in the case of the CFC phase out. In the HCFC phase out, there is a need for additional aspects to share, i.e. the climate benefit and co-financing options.

This post will help promote timely inter-regional cross-fertilisation and exchange of experiences and information related to HPMP preparation and implementation. There is an enormous quantity of information currently being generated in HPMP preparation and in upcoming implementation activities, which will need to be shared efficiently between countries and regions to inform their own strategies and actions. This sharing will be done most efficiently through online databases on technologies particularly low GWP and energy efficient alternatives, information systems designed to share the information across the regions and countries and other IT products. The use of IT to compile and share such information is essential considering the enormity of data that exists and that would be generated as well as the short time available for the compliance. The traditional methods of the exchnnage of the information would not be useful due to unique challenges under the HCFC phase out. This post will be responsible for developing, deploying and maintaining such services, which could address e.g. topics related to non-HCFC technologies, policies, lessons learned from countries during HPMP preparation and

implementation, and co-financing of the climate benefit, etc. Such sharing of information would lead to speedy and effective compliance by the countries.

This officer's work will also help CAP manage, monitor and speed up the flow of HPMP documents through the draft, comment, submission and implementation phases, which involve a complex flow between for example CAP Regional offices and CAP Paris, between CAP and consultants, and between CAP Paris and the Secretariat. Thus, this post will also support the working processes related to CAP's HPMP preparation and implementation processes.

<u>BL 1304 – Assistant Monitoring and Administration</u>. this post's costs will now be absorbed by UNEP core resources as part of the leveraging of funds detailed in paragraph 18. The balance of funds from this line has been reprioritized to fully fund Programme Officer – Information Technology/HCFC Support BL 1109.

<u>BL 1321 to 1324 Regional Outreach Assistant</u> These are new posts at G6 level funded from the cancellation of the post Information Officer (BL 1106) in Paris which has enable UNEP to free up staff costs, which have then be reprioritized for the creation of the Outreach Assistant G-posts in the regions.

The creation of these posts directly and significantly support the regionalization of CAP resources, in that they shift human resources from Paris to the regional teams to address prioritized areas of assistance.

These posts will work closely with the Article 5 countries with the implementation, monitoring and reporting of the Communication Strategy for the Global Compliance with the Montreal Protocol and targeted information outreach to support the accelerated HCFC phase out.

They will assist those supervisors with the regional delivery of information, communication and education services in line with the new Global Communication Strategy. The Regional Outreach Assistant G-posts will work under the overall supervision of both the Regional Network Coordinators (RNCs) in the regions and the Information Manager in Paris and in close cooperation with the UNEP Regional Information Officers, who support the CAP's Montreal Protocol objectives without receiving financing from the Multilateral Fund.

The main functions are the following:

- To provide technical assistance, including suggesting materials in planning and implementing the communication strategy.
- To use the Regional Network and thematic meetings to outreach information on HCFC alternatives, and the associated climate benefits.

- To support on promoting information exchange about non-HCFC technologies, particularly low GWP and energy efficient sustems, technology transfer, as well as policies through the Regional Network.
- To use the Information Clearinghouse to help NOUs control consumption through information, communication and education activities.
- To draft the regional communication and outreach strategy and assist in its implementation.
- To coordinate and manage the implementation, monitoring and reporting of the outreach activities as approved in the HPMPs for countries in this region.

Activity Lines

BL 2305 – Targeted information materials on HCFCs. This budget allocation will be used by the Information Clearinghouse to produce technical and policy information for National Ozone Units that can be easily used, adapted and/or translated in accordance with new Communication Strategy for the Global Compliance with the Montreal Protocol. These materials will be outreached in different events throughout the year. The emphasis in 2011 will be on the implementation of the communication strategy developing information, communication and education products related to (a) global phase out of CFCs and compliance of Article 5 countries (b) HCFC phase out (c) climate and ozone linkages.(d) Co-financing and carbon financing opportunities (e) low GWP and energy efficient technologies, (f) special needs of the systems working in the high ambient temperature.

Reallocations

25. In accordance with Decision 53/21, UNEP is providing the following details on the reallocations made in its budget following Executive Committee decisions 50/26and 47/24 by which the Executive Committee encouraged UNEP to "continue to extend the prioritization of funding between CAP budget lines so as to accommodate changing priorities.".

After receiving feedback from countries and from the other inputs into the CAP budget process, the final budget proposal reflects an internal analysis of the CAP structure, staff roles and responsibilities, the distribution resources within CAP (between the individual Regions, as well as between Regions and Paris), and whether the level and type of services provided by the current CAP team match the new circumstances. UNEP has continued extending the prioritization of funding among CAP budget lines so as to accommodate changing priorities in the following budget lines.

Funds from BL 1105 – Monitoring and Administration Officer and BL 1304 – Assistant Monitoring and Administration have been reallocated to fully fund Programme Officer – Information Technology/HCFC Support BL 1109.

Reprioritisation

26. <u>In accordance</u> with Decision 53/21, UNEP has extended the prioritization of funding between CAP budget lines so as to accommodate changing priorities.

<u>BL 2206 - ECA Sub-contracts with supporting organizations.</u> ECA network countries agreed on activities as part of the ECA work programme 2010/2011 which required an increased fund allocation for programmatic assistance including strengthening and networking of RAC associations, ECAcool website and awareness materials. Additional budget on this line have been prioritized from the BL 3306 - ECA network meetings/thematic workshops

<u>BL 2216 - ECA Regional awareness raising</u> - ECA network countries agreed on activities as part of the ECA work programme 2010/2011 which required an increased fund allocation for regional awareness raising including side events and exhibitions during ministerial meetings and the update of an multimedia CD-ROM. Additional budget on this line have been prioritized from the BL 3306 - ECA network meetings/thematic workshops

Regionalisation

27. In accordance with Decision 52/7, UNEP has further regionalization CAP resources by affecting a net increase in the Regional activity budget lines, with a corresponding decrease in the share of the budget allocated to Paris.

Since CAP's inception, prior budgets have shown a significant and steady trend of regionalization to reflect shifting priorities over the years. This strategic regionalization has included the movement of posts, activity budget and other costs from Paris to the Regions. Much has already been done and it is questionable the extent to which UNEP can further regionalize staff and resources without impinging on the effectiveness of the overall delivery of services and projects to Article 5 countries.

In 2010, the need for the further regionalization is felt like never before. HCFC phase out has regional characteristics i.e. level of the development, number of emerging economies, countries with very high ambient temperatures, proximity to the producers, existing trade agreements, energy related policies of the refrigeration, air conditioning and building codes. Based on feedback collected via the Regional Networks and consistent with strategic advice received from the CAP Advisory Group in September 2010, UNEP is emphasizing in this budget the immediate need to concentrate on regional information activities related to HCFC phase-out as a way to support the HPMP preparation and implementation processes, and to help reduce the curve of HCFC consumption through non-investment activities. In close consultation with all regional network coordinators and information manager, it was decided that the new positions in the

regions would improve the overall reach and impact of information activities and promote compliance with the HCFC controls, as well as other long term compliance sustainability issues.

<u>BL 1106 – Information Officer (Paris).</u> Based on the anticipated needs for more support at the regional level for assistance to Article 5 countries this post is being cancelled and the budget being used to put in place G6 level posts at each regional office.

GLOBAL AWARENESS

28. In accordance with Decision 53/21 and 50/26, UNEP is providing detailed information on the activities for which the global awareness-raising funds would be used.

The information, communication and education activities will substantively changed for 2011. There will be no more general awareness activities performed by the information clearinghouse in this year and the focus on International Ozone Day celebrations will be shifted towards HCFC issues. All information materials will be in future technicaland muti dimensional i.e. technologies with energy and climate advantage, low GWP alternatives and with other environmental benefits. The information clearinghouse is present in all regional network meetings to allow direct contact with NOUs. For the strategy development, a substantive survey was made in 2009 in order to know the needs of the NOUs and it identified the strengths and weaknesses of OzonAction's information services.

<u>BL 2301 - Technical and information technology</u>. This budget allocation will be used to address the information technology needs expressed by the National Ozone Units. The main priority for 2011 is to revamp the OzonAction website. This budget line is also used to develop databases for internal and external uses, such as updating contact database. The technological innovations and social media is also covered by this line.

<u>BL 2302 - OzonAction Special Issue.</u> The budget allocation provides NOUs and others with the key information about major ozone protection developments in industry, governments, NGOs, and international organisations by producing an OzonAction special issue. Articles authored by key figures in the global ozone protection community reflect on the achievements and future challenges. The Special issue is published annually on the International Ozone Day and the hard copies will be distributed at the Meeting of the Parties in English. The electronic versions of this issue will be distributed through OzonAction website in Arabic, Chinese, French, Russian and Spanish. The production of the Chinese version will be done in cooperation with the NOU of China.

<u>BL-2303 - Illustration/graphics/layout design.</u> This budget allocation is used to illustrate and design different information, communication and education materials for National Ozone Units in all UN languages in accordance to new communication strategy. These materials are distributed through OzonAction website or at the Meeting of the Parties.

Part 1. CAP's achievements

ECA

- Follow-up on timely reporting of Article 7 and Country Programme implementation data all 12 ECA network countries reported data for 2009. Follow-up was also done with the associated CEIT countries (Azerbaijan, Kazakhstan).
- Analysis of Article 7 date for 2009 indicates that all 12 ECA network countries are currently in compliance with their phase-out obligations.
- ECA network countries should be congratulated for the early phase-out of CFC, halon, CTC and in some cases MeBr. All 12 ECA network countries reported zero halon consumption in for 2009, 10 countries reported zero MeBr consumption and 9 countries zero CFC and zero CTC consumption for 2009.
- In terms of HCFC consumption, Turkey was the main HCFC consumer in 2009 with 609.9 ODP tons. None of the other countries exceeded 10 ODP tons of HCFC consumption in 2009. The consumption trends show significant fluctuation and differ from country to country. Eight countries reported significant increases in HCFC consumption between 2007-2009 up-to 175% increase in Kyrgyzstan, 155% in Georgia and Turkmenistan or 116% in Albania. Other countries and in particular the accession countries to the European Union reported their peak consumption inbetween 2005-2008 and reduced their HCFC consumption from 2007-2009 by up-to-43% in Moldova, -40% in Croatia and -34% in Turkey. This demonstrates the importance of early awareness raising, policy setting and legislation.
- The joint meeting of the South Asia and the ECA network in Istanbul allowed for the exchanged of experience between both regions and enhanced cross-regional cooperation
- Managers of national refrigeration and air-conditioning (RAC) associations met for the second consecutive year to share their experience on HCFC phase-out, certification, training, etc. and the ECAcool.org website was created as a communication platform between these associations. Strengthening national RAC associations will facilitate HPMP implementation, provide access to technology information and remove barriers to technology transfer. This will be achieved by initiating regional cooperation between these organizations and linking them up with regional and international organizations like AREA, ASHREA, Centro Galileo, IIR, Shekko as well as technology providers.
- Since 2008, the ECA network organized a series of thematic meetings on HCFC policy measures, zero or low GWP technology options as well as HPMP preparation and guidelines. 6 out of 12 ECA network countries opted for UNEP as cooperating

- agency for the non-investment components (Albania, Armenia, Kyrgyzstan, Serbia, Turkey, Turkmenistan).
- High-level awareness on synergies between ozone- and climate protections, existing
 zero- and low-GWP alternatives and important of preventing illegal trade with
 controlled substances is being prepared during the Ministerial Conference on
 Environment & Development in Astana and press briefings for the International
 Ozone Day will be delivered by the Information Officer of UNEP's Regional Office
 for Europe at Palais des Nations in Geneva.
- Private sector has been involved in ECA network activities including reclamation and disposal companies, manufacturers of refrigerant identifiers, national RAC associations as well as multinational companies like Carrefour and Pepsico which were demonstrating case studies on using natural refrigerants in Article 5 countries (CO2 supermarket refrigeration, HC display coolers, ammonia meat plants).
- Co-funding for ECA network activities was secured through co-funding approaches
 e.g. from the Green Customs Initiative, with GEF-supported CEIT countries and
 Czech funded ECA enforcement network meetings.
- For the first time, virtual meetings and application sharing (via internet with web-cam and headsets) was tested with 10 out of 12 ECA network countries and the communication with most countries was reasonably good.

Special assistance to countries in actual or potential non-compliance

- ECA conducted detailed assessment of the individual situation of the Article 5 countries regarding compliance with the Montreal Protocol provisions and clarification of data reporting e.g. whether uses are exempted (laboratory use, QPS, CTC etc.).
- Conducted detailed review of ODS import / export licensing systems related to HCFCs and analysed which mandatory or recommended policy measures are in place or planned to be put in place.
- Compliance sessions are arranged with all countries facing compliance issues in the margin of network meetings and in cooperation with the secretariats and agencies.
- Bosnia & Herzegovina: Banned import of CFC in 2009 and reported zero CFC imports for 2009. However, the refrigeration training and R&R operation is delayed because no equipment could be imported in the past years (VAT issue) and the contract for the IS project with UNIDO has not yet been signed. However, the NOU was optimistic to solve both issues shortly. Since compliance has been enforced by legislation rather than reducing the demand, there will be an increased risk of illegal trade in ODS.
- Several countries reported imports of CTC for laboratory analysis of mineral oil in drinking water for 2009 including Croatia (0.4 ODP tons) and Serbia (1.5 ODP tons). Turkmenistan had reported 0.3 ODP tons imports of CTC for 2008. Contamination of drinking water in these countries seems to be a serious health issue. For that reason, CTOC member was invited by CAP toattended the ECA network meeting in Istanbul and presented alternatives to CTC for such analysis. This is not yet compliance relevant but may become so in future if national laboratories are not able to use alternative analytical methods. MOP decision XXI/6 allows Article 5 Parties to deviate from existing analytical and laborarory use bans in individual cases until 31 December 2010.
- Kazakhstan (CEIT country) did not yet report Article 7 data for 2009 and did not ratify Copenhagen, Montreal and Beijing amendments. It therefore does not have obligations

- with regard to MeBr and HCFC consumption yet. Once ratified, they would be in immediately in potential non-compliance with 62.8 ODP tons HCFC consumption reported for 2008 against a HCFC baseline of 39.5 ODP tons and with 66.0 ODP tons MeBr consumption reported for 2008 against a MeBr baseline of 15.6 ODP tons.
- In addition, Kazakhstan entered into a Customs Union with the Russian Federation and Belarus without border controls. Thus there is currently no control of movements of ODS within the Customs Union although the Russian Federation and Belarus are not supposed to trade HCFCs or MeBr with Kazakhstan as a non-Party to the Copenhagen, Montreal and Beijing amendments. It is unclear how the 3 countries will establish their Article 7 data for 2010.
- Central Asian countries in general may face the risk of illegal trade since ODS is widely and cheaply available on the local market in China. Awareness raising and training of Customs Officers has been initiated for the first time during the China ECA Dialog but more needs to be done. In this context, the use of the Chinese stockpiles should be closely monitored and illegal production prevented. A joint awareness operation between China, Kyrgyzstan and potentially other Central Asian countries has been prepared.
- Turkmenistan did not receive TPMP support and has to phase-out their remaining CFC consumption with legislation and IS support only. If they manage to phase-out CFCs in 2010, there will be an increased risk of illegal trade in ODS. Country reported CFC imports of 3.3 ODP tons for 2009. CAP provides priority assistance to the country in terms of country-to-country and programmatic assistance.
- Armenia did not receive TPMP support and has to phase-out their remaining CFC consumption with legislation and IS support only. If they manage to phase-out CFCs in 2010, there will be an increased risk of illegal trade in ODS. Country reported CFC imports of 18.1 ODP tons for 2009. CAP provides priority assistance to the country in terms of country-to-country and programmatic assistance.
- Serbia is in full compliance and reported 76.7 ODP tons of CFC consumption for 2008 and 19,2 ODP tons of CFC consumption for 2009. This illustrates that there is still significant need for CFC which may trigger illegal trade once CFC imports are banned in 2010. At the same time the country makes enormous efforts to control ODS trade and participates in the iPIC initiative.

Other assistance modalities, such as South-South cooperation

- Country-to-country or bilateral cooperation took place on an informal basis as well as being part of network and thematic meetings organized in Istanbul, Chisinau and Novi Sad in 2010.
- ECA network agreed to provide assistance to Turkmenistan to organize stakeholder consultation on CTC alternatives.

Facilitation of communication with the Implementation Committee

 In preparation of Implementation Committee meetings, ECA prepared summary reports for those countries which faced compliance issue to facilitate the discussions and also reminded countries to respond to ImpCom recommendations in time e.g. ECA assisted Turkmenistan in submitting their response related to CTC use to the Ozone Secretariat.

Assistance in policy and legislation development and implementation

- Since 2008, the ECA network organized a series of thematic meetings on HCFC policy measures and developed 20 fact sheets on policy measures in support of HCFC phase-out which were used to produce a global policy guide on HCFC policy measures. These fact sheets were also translated into Russian.
- Based on this global policy guide, ECA reviewed the policies and legislation of all ECA network countries and analysed which of the mandatory or recommended measures are already in place or planned to be put in place.
- CAP organised a special thematic meeting for accession countries on harmonization of ODS legislation with EU regulations is being organized in Novi Sad and a detailed checklist for each policy measure included in the EU legislation has been prepared.

Assistance in ratification of the Amendments and MP

- ECA network countries show high level of ratification of the Vienna Convention, the Montreal Protocol and its amendments – ECA followed-up on the ratification status of Montreal Protocol amendments in Georgia and Bosnia & Herzegovina – 10 out of 12 ECA network countries have ratified all Montreal Protocol amendments. Follow-up was also done with the associated CEIT countries Azerbaijan and Kazakhstan which did not yet ratify all Amendments.
- Creation of peer pressure through regular presentations of the ratification status during network meetings
- UN administered territories do not have country status and thus are not covered by the Montreal Protocol

Support to new Parties

• There were no new Article 5 Parties in ECA in 2010. Although recognised by the EU and many other countries, Kosovo is considered as a UN administered territory and thus is not in a position to ratify UN conventions.

Capacity Building of new National Ozone Officers

- Turkey's Ozone Officer recently changed and the meeting in Novi Sad will allow identifying any need for NOU training. ECA provided some initial guidance to whom to submit Article 7 and Country Programme implementation reports and which formats to use for that purpose. Otherwise, the new Ozone Officer seems to be aware of Montreal Protocol related activities. The change of Ozone Officer may affect HPMP preparation and implementation.
- Romania has become EU member and changed their Montreal Protocol focal point who will participate at their own costs in the forthcoming thematic meeting for candidate countries on harmonization of ODS legislation with EU regulations.

Additional CAP capacity-building activities

- CAP Involved of managers of national refrigeration & air-conditioning associations in ECA network meetings in Yerevan and Istanbul in order to promote networking between these national associations and to facilitate HPMP implementation.
- Approval of the ECA enforcement network and involvement of Customs Officers in ECA enforcement network meetings and regional Green Customs workshops in Hungary and Ashgabat in order to promote regional Customs cooperation.
- CAP facilitated ECA network countries participation in the Global Chillers conference in Cairo as part of UNEP's Global Chiller project.
- Involvement of ECA in the preparation of the Manual for Refrigeration Servicing Technicians to provide information on alternative refrigerants.

Combating illegal trade in ODS

- The ECA enforcement network is being organized for the second consecutive year with participation of Ozone & Customs Officers and the project resulted in the designation of Customs focal points, enhanced the participation of ECA network countries in the informal Prior Informed Consent initiative, promoted the analysis of discrepancies between reported exports and reported imports and close cooperation between Russian and Chinese authorities to prevent illegal trade in CFCs.
- Nine potential candidates for the ECA Ozone Protection Award 2010 for Customs & Enforcement Officers were identified and the award ceremony took place during the second ECA enforcement network meeting in Ashgabat. The major case concerns the prevention of illegal trade of CFCs from China to Russia which were mislabelled as recycled substance. The selection panel included WCO, Ozone Secretariat, OzonAction as well as representatives from Czech Republic, Macedonia FYR and Poland.
- The regional Green Customs workshop for all ECA network and associated CEIT countries is being organized for the second consecutive year back-to-back with the ECA enforcement network meeting and will focus on technical training and case studies rather than general awareness raising.

Institutionalizing CAP activities

• While CAP has been instrumental in establishing national refrigeration associations in many countries in the ECA region through implementation of the TPMP activities, it has recently been behind the creation of a regional association of Russian speaking national associations. It is an open association currently consisting of 5 national associations, and 2 observing parties.

ROA

In the framework of networking activities, the Africa CAP team guided countries in reporting data to both Secretariats following the latest reporting formats. Presentations on the latest reporting formats were made at all thematic meetings and joint meeting of the Regional Networks. Specific guidance was given during bilateral discussions with National Ozone Units that required specific assistance. The Multilateral Fund Secretariat and Ozone Secretariat were invited to the 2010 network meetings and were requested to make presentations on data reporting and other issues. Ozone Secretariat attended all meetings and the MLF Secretariat sent presentations that were delivered by the CAP team. CAP teams prepared and circulated an update on each country's compliance status and the benchmarks for subsequent compliance requirement.

During thematic meeting in 2010, the focus was on the preparation of HPMPs where the HPMP guidelines were presented and debated. The CAP guided the NOU accompanied by their national refrigeration experts.

Special assistance to countries in actual or potential non-compliance

Throughout the year 2010, the ROA CAP team has been reviewing the countries' compliance status in order to guide the NOUs on the way forward. CAP has been liaising with the OS on cases of countries where feedback was required. Network meetings throughout the year 2010 were used as forums to discuss separately with countries at risk of non-compliance. Bilateral discussions were held effect with several NOUs, among them, **Angola, Botswana Ethiopia, Eritrea, Somalia.** Follow-ups done by the team led to most countries reporting their 2009 data based on these data. So far no African country was found in non-compliance with regards to level of consumption of any ODS. Those subject to action plan have complied with the phase out schedule set by such action plans.

Other assistance modalities, such as South-South cooperation

In 2010 the ROA CAP team organized 3 sub-regional thematic meetings on HPMP preparation and one sub-regional training workshop for customs officers under the Green Customs Initiative. Those meetings involved refrigeration experts and customs officers from all 53 African countries. The team also promoted south-south cooperation by facilitating the participation of experts from countries advanced in their HPMP preparation and TPMP implementation.

- An Expert from Burkina Faso conducted training to refrigeration technicians in Central African Republic and Equatorial Guinea.
- A refrigeration expert from Senegal conducted training of technicians in CAP Verde and Guinea Bissau.
- An Expert from Malawi conducted training of refrigeration technicians in Mozambique.
- A refrigeration expert from Comoros conducted training of technicians in Djibouti. The training sessions were focused on retrofitting of refrigeration equipments from CFC to Hydrocarbon. These experts also guided the receiving countries on data collection for HPMP preparation.

Facilitation of communication with the Implementation Committee

The team liaised with the Ozone Secretariat and the concerned countries to ensure updates are provided in line with the recommendations of the Implementation Committee. Special

assistance was provided in preparation for the 43rd and 44th ImpCom meetings and thereafter to the following countries: **Angola, Botswana Ethiopia, Eritrea, Somalia.**

Assistance in policy and legislation development and implementation

In 2010 the Africa CAP team made further progress in the development of harmonized ODS regulations for the ECOWAS sub-region. The draft regulations that were adopted by experts at the year 2010 is undergoing internal process at ECOWAS secretariat before their formal endorsement by the council of Minister. The CAP team has been providing the ECOWAS with all necessary details related to the substances and equipment controlled by regulations.

ECOWAS member countries are Benin, Burkina Faso, Cap Verde, Cote d'Ivoire, Ghana, Guinea (Conakry), Guinea Bissau, Liberia, Mali, Mauritania, Niger, Nigeria, Sierra Leone, Senegal and Togo.

UNEP regional Director for Africa bilateral consultations during several meeting organized by UNEP in 2010 to discuss with representatives of Eritrea on the adoption of ODS regulation. Similar consultations were held with the Minister of Environment of Angola on the ratification of the amendments to the Montreal protocol and adoption of ODS regulations.

UNEP held consultations with representatives of SADC and SACU secretariats on the options for harmonization of the ODS regulations for the Southern African countries falling under the umbrella of these two organizations.

Assistance in ratification of the Amendments and MP

The CAP has been guiding NOUs on the process for preparing ratification documents for the pending amendments and the procedures of sending the documents to the depositary. In 2010 ratification of various amendments to the Montreal Protocol was recorded for **Lesotho.** Two more countries (**Mozambique and Angola**) have reported completion of the process and are awaiting the deposit of ratification documents.

Support to new Parties

There are no new parties in Africa. The latest African country to ratify the Ozone treaties was **Equatorial Guinea** in 2007.

Capacity Building of new National Ozone Officers

Special attention is being provided to newly appointed ODS Officers in **Burundi**, **Lesotho**, **Swaziland** and including country visits organized in July 2010 in Swaziland and September 2010 in Burundi. Besides the aforementioned NOUs, the CAP continues to facilitate sharing of experiences among several NOUs across the region.

Additional CAP capacity-building activities

The Regional CAP team was involved in the facilitation of workshops on Environmental crimes involving customs officers Interpol National Officers from **Southern Africa region** held in Mach 2010 in Lilongwe (Malawi) and from **Western** Africa in June 2010 in Abidjan in cooperation with the RILO and Interpol regional Offices.

Combating illegal trade in ODS

No incidences of illegal trade of ODS were formally reported in 2010 but several NOU reported situations were contaminated refrigerants were imported and put on the local market. Refrigeration identifiers were then used to check the qualities and the refrigerants found unfit to use. The Africa CAP team continues to cooperate with the RILO Regional Office and the WCO Regional Capacities Building Centres in Nairobi in view of monitoring activities of the customs officers in the region on the control of ODS and ODS-based equipment. The CAP team participated in a regional RILO meeting held in June 2010 in Lilongwe (Malawi) and a regional Interpol meeting held in June 2010 in Abidjan (Cote d'Ivoire). CAP participation to those meetings was focused on identifying ways to strengthen capacities of countries in the region to effectively combat illicit trade of ODS and obsolete equipment.

Institutionalizing CAP activities

- After the meeting on combating environmental crime in Abidjan in June, CAP has
 initiated discussion with the Interpol regional office for West Africa to include
 monitoring of illegal trade of ODS in the ECOWAS sub-region.
- Similar arrangements will be considered with RILO and Interpol in other sub-regions in Africa.
- The draft regulations that were adopted by experts at the year 2010 is undergoing internal process at ECOWAS secretariat before their formal endorsement by the council of Minister. The CAP team has been providing the ECOWAS with all necessary details related to the substances and equipment controlled by regulations.

ROAP

Compliance assistance – achieving ODS phaseout targets

Assistance was provided to the following countries for compliance with their Action Plans: Fiji Plan of Action for methyl bromide (Decision XVII/33), Iran non compliance with CTC (Decision XIX/27), Maldives Plan of Action for CFC (Decision XVI/37), Nepal Plan of Action for CFC (Decision XVI/27), Pakistan Plan of Action for halon (Decision XVI/29), Pakistan Plan of Action for CTC (Decision XVIII/31), and Vanuatu non compliance with CFC and request for Plan of Action (Decision XXI/26). For Vanuatu, UNEP organized a high-level mission in February 2010 met the President and the Minister, and also assist in preparing the Plan of Action which was submitted to the Ozone Secretariat in March 2010. UNEP also organized south-south cooperation between Fiji and Vanuatu to strengthen capacity of the government on the implementation of the the Montreal Protocol such as data collection and report.

Assistance to Timor Leste

Timor Leste became the latest and last Party to accede to the Vienna Convention and the Montreal Protocol after the Instrument of Accession was submitted to the UN Depository in September 2009. Since then, CAP had assisted Timor Leste to strengthen their capacity to implement the Montreal Protocol through CAP mission in December 2009 and by organizing training for Timor Leste new ozone officers in Indonesia in March 2010.

Data reporting

CAP assisted the country prepared the Article 7 data report, and it was submitted to the Ozone Secretariat in early March 2009. CAP also assisted the country prepared clarification letter concerning its licensing system following the side meeting with the Tonga, Australia, and New Zealand. Recommendation 42/1 of Implementation Committee acknowledged that Tonga submitted all standing data as per Montreal Protocol and Decision XX/12. CAP assisted the country prepared explanation letter and submitted to the Ozone Secretariat in March 2009 to clarify its 2006 CFC consumption.

Assistance to PIC Network

- CAP has worked with Micronesia to clarify its 2007 consumption deviation from its obligation under the Montreal Protocol, and reconfirm its return to compliance in 2008 following the implementation of the licensing system by end of 2007. CAP assisted the country to submit the required clarification letter in October 2009 to the Ozone Secretariat as per Recommendation 42/30 at the 42nd meeting of Implementation Committee.
- CAP assisted Tonga to clarify its licensing system status and sent a letter to the Ozone Secretariat in July 2009.
- CAP assisted the data collection and capacity building for the National Ozone Officer of Nauru in 2009. Under South-south cooperation framework, an 4 days attachment programme was initiated for the ozone officer to work with the NOU of Solomon Islands, and later, the NOU of Solomon Islands visited Nauru to meet the stakeholders

including Minister and private sectors on the ozone layer issue in December 2009. The country submitted its pending Article 2008 data reports and CP Progress Report 2008 in April 2010.

- CAP assisted country with the data reporting obligations, and Recommendation 42/1 of Implementation Committee acknowledged that Solomon Islands submitted all standing data as per Montreal Protocol and Decision XX/12. The country had reported 2005, 2006 and 2007 data, as well as explanation letter to the Ozone Secretariat after CAP follow up with the NOU.
- CAP assisted Cook Islands to organize a refreshing training workshop for technicians and customs officer under the south-south cooperation framework by inviting the trainer from Fiji during 8-10 December 2009
- CAP assisted Tuvalu to recruit the new ozone officer in 2009 and provided assistance to build the capacity of the new Ozone Officer, and assisted the country to get the ODS Regulation put in place;
- In Vanuatu, UNEP also facilitated the NOO from Solomon Islands whom joined the mission under south-south cooperation. The mission met the national stakeholders for the licensing system setting up, as well as the operation of the NOU, ratification of the Amendments, assisted the country to conduct survey of ODS import. Following the mission, Vanuatu, with assistance of SPREP, and input of UNEP, has drafted the following documents: ODS Order under Customs Act to restrict and prohibit ODS and Ozone Layer Protection Act. UNEP arranged the Officer in charge of the Environment Unit of Vanuatu, who is also charge the ozone issue to join the HPMP inception workshop of Fiji in December 2009 to build his capacity on the ozone issue. The customs training workshop was organized with resource person from Fiji under the south-south cooperation during 5-7 May 2010. UNEP has been keep regularly follow up on the ratification of the Montreal and Beijing Amendment and provided comments on the draft internal documents for parliament consideration.

NPP and CFC MDI phaseout projects

In addition, assistance was provided with high priority to Bangladesh during the year 2009 to expedite implementation of NPP activities and CFC MDI phaseout project (Recommendation 40/6 and 41/3 of Implementation Committee) through Joint Mission with UNDP and Joint Compliance Mission (Ozone Secretariat, Multilateral Fund Secretariat, President, Implementation Committee, Chairman, Executive Committee, MTOC, UNDP and UNEP) Dhaka, Bangladesh held on 22-24 October, 2009. During the first half of 2010, responding to a request of China, UNEP collected information from 12 countries on CFC MDI requirements from China for the period of 2011-2012.

The 3rd MEA Regional Enforcement Network workshop organized on 12-15 October 2009; Desk study on HCFCs, Used Lead Acid Battery and PCB conducted. MEA REN website completed in October 2009; Environmental Crime Media Updates issued weekly; MEN REN newsflash issued biannually; Cooperation between Asian countries and IMPEL on addressing waste traffic started in January 2009. Green Customs workshops organized in India, May 2009, Mongolia, April 2009, Jeju, November 2009. Informal Prior Informed Consent helped countries to prevent illegal trade. 64 countries joined iPIC, and 36 Information Sheet on ODS licensing circulated.

Border Dialogues held in 2009 and 2010:

- China ECA Dialogue on Cooperation in Border Enforcement, 23-25 June 2009, Urumqi, China with the National Ozone Unit and Customs officers from China, Kazakhstan, Kyrgyzstan, Mongolia, Tajikistan, Turkmenistan and Uzbekistan. The meeting agreed some 25 recommendations related to the implementation of policy measure. One-day training for Customs officers of Urumqi Customs was conducted after the border dialogue. It was the first time that such training was conducted in the Western part of China addressing the issues related to illegal trade of ODS.
- Border Dialogue on Monitoring and Controlling Trade in ODS, 10-11 August 2009, Birgunj, Nepal with the National Ozone Unit and Customs officers from India and Nepal. One-day training for Customs officers from India and Nepal was conducted. Following the training, the meeting reviewed recommendations of previous dialogue and practice of implementation of Protocol in the two countries were informed. Participants discussed several important issues regarding better inspection and control of ODS gases such as destruction of CFCs in Nepal according to decision of MOP, capacity building for Customs officers, future mechanism in implementation of Montreal Protocol as well as future arrangement of such border dialogue, etc.
- November-2 December 2009, Sravasti, Uttar Pradesh, India with the National Competent Authorities working on Multilateral Environmental Agreements, Customs officers and border enforcement officers from India and Nepal. Representatives from India and Nepal joined hands in a border dialogue within the framework of *Green Customs Initiative*. This was the first Green Customs Workshop held at real border between two countries for the front line border enforcement officers.
- Border Dialogue on Monitoring and Controlling Trade in ODS and Training for Border Enforcement Officers, 7-8 April 2010, Chalsa, West Bengal, India.

Status of TPMP Implementation:

For Cambodia, they have completed the implementation and submitted the final progress report to the 60th ExCom meeting.

Bhutan completed their training programme in March 2010, Maldives in July 2010, and Samoa in August 2010. Afghanistan and DPR Korea are to complete their training by December 2010.

In the current context, UNEP ROAP CAP team is implementing activities to address the immediate ODS phase-out challenges to achieve 2010 targets, this involves prioritizing country level activities to address the above through completion of ongoing NPP/ TPMP activities and expeditiously creating institutional structures and processes for managing HCFC phase-out. This would form the core of the future strategic approach of UNEP CAP and would be well aligned with the global CAP approach.

Others

- Government of Timor Leste submitted the Instrument of Accession to UN Depository on 11 September 2009.
- Consultative Meeting on EUNs for CFCs for MDI Manufacturing in Article 5 Countries beyond 2009 was held on 19-20 January 2009, Bangkok, Thailand. The meeting was attended by the NOO, MDI industry and health sector representatives from Bangladesh, China, India, Iran, and Pakistan. Medical Technical Options Committee (MTOC) members Implementing Agencies UNEP, UNDP and UNIDO.
- National Awareness Workshop on MDI issues was organized in October 2009 at New Delhi, India as part of India's MDI transition strategy.
- Consultations on Policy & Enforcement strategy for ODS Phase out in India was held on 12-13 February 2009, Bangkok, Thailand. In addition, Online Training System was launched on August 2009 in presence of Ozone Cell and UNEP officials. The Online Training System has been included in the curriculum of Training for Customs Officers in the National Academy of Customs, Excise and Narcotics (NACEN). For face-to-face training programme, 39 workshops have been conducted and a total of 976 identified target officers have been trained by NACEN on Monitoring and Control of Ozone Depleting Substances from February 2005 to October 2009.
- Sub-regional Workshop on ODS Phase-out in Military Applications was held on 16-17 April 2009, Colombo, Sri Lanka which encourages North-South and South-South cooperation between Defence establishments attended by representatives from Bangladesh, India, Indonesia, Iran and Pakistan.
- Bangladesh Cabinet approved the Beijing Amendment in May 2010. Subsequently, the Ministry of Foreign Affairs issued Instrument of Ratification.

Awareness Activities:

- The first UNEP DTIE OzonAction Journalist Competition in Asia and the Pacific Region was organized and the winner and honourable mentions were selected by the experts in the region. The Award Ceremony was organized during the Media Seminar on ozone protection and climate benefit which took place during the Asia Media Summit, 24 May 2010 in Beijing.
- The Media Seminar on Ozone Protection and Climate Benefit was organized as a Pre-Summit event on 24 May 2010 in Beijing, China prior to the 2010 Asia Media Summit. The seminar was organized in collaboration with the Asia Pacific Broadcasting Union (AIBD), UNESCO, Institute for Governance and Sustainable Development (IGSD)

- and the State Administration of Radio, Film and Television (SARFT), China. Around 60 key media professionals from Asia and the Pacific region and other regions participated in the seminar.
- The electronic version of the Strategic Action Plan for Information, Education and Information (IEC) activities for Asia and the Pacific Region: 2008-2010 has been uploaded on the UNEP DTIE OzonAction website.
- The brochure entitled "Stand Up for the ozone layer and MDGs" has been produced in collaboration with the UN Millennium Campaign and it will be launched during the Joint Meeting of SA and SEAP Network of ODS Officer in Beijing, China in September 2010.
- The film Earth Report: Perfectly Cool which was produced in collaboration among TVE, UNEP, UNDP, World Bank, GTZ Proklima, IGSD and has been screened in various ozone-related meetings in the region. Since the film focuses on HCFCs phase-out challenges in the Asia and the Pacific region, it would be used as part of the Communication Strategy for HCFC Phase out in all countries in the region.
- In collaboration with Ruamrudee International School (RIS), UN Millennium Campaign and the Sweden's Environmental Secretariat for Asia (SENSA), 2010 International Ozone Day Celebration is being organized at the Foreign Correspondents' Club of Thailand (FCCT) with the presence of Ms. Tata Young, International Recording Artist who has long been helping UNEP DTIE OzonAction raising awareness on ozone-related issues in Asia and the Pacific Region in September 2010.
- 2010 International Ozone Day Celebration is being organized during the Joint Meeting of SA and SEAP Network of ODS Officers with the participation of all national ozone officers, the implementing agencies and high level government officials in China.
- 3 Factsheets relating to Policies and Enforcement have been drafted and designed. They will be launched and uploaded on UNEP DTIE OzonAction website during the Joint Meeting of SA and SEAP Network of ODS Officer which will take place in Beijing, China in September 2010.
- As part of the Music and the Environment Initiative, UNEP DTIE OzonAction is
 drafting a plan with Tata Entertainment on how to engage Tata Young in the CAP
 ROAP's awareness activities and how to utilize music industry to outreach ozonerelated issues to the public.
- Publication "Towards Zero: Success Stories of the Montreal Protocol in Asia and the Pacific Region" is being finalized. It is planned to be launched during the Meeting of the Parties of the Montreal Protocol in Kampala, Uganda in November 2010.
- A template for the Communication Strategy for HCFC Phase out has been produced for use in all countries in Asia and the Pacific Region.
- An Interactive CD ROM on ozone layer and climate is being produced and it is lead by the NOU Sri Lanka.
- A collection of ozone stamps is being collected from all countries in Asia and the Pacific Region. The collection is planned to be finalized at the end of 2010 and would be available for distribution in early 2011.

ROLAC

Improvement on the quality of Article 7 and Country Programme Reporting

The CAP/ROLAC team continually communicates with the 33 countries of the LAC region with reminders on the deadline to report to the MLF and OS. These communications are done during the meeting of NOOs, emails, phone calls and on the e-forums and during sub-regional network meetings. In the communications to countries, reminders are given on the respective and correct formats. This is especially useful in the case of the CP report new format introduced, because some NOOs did not perceive changes clearly or might have doubts about the requirements. Often countries will send draft reports to the CAP/ROLAC for review before final submission to the respective secretariats

- A half day session has been allocated in the Joint Network Meeting of 2010 for
 providing extra support to all NOOs on new challenges on ODSs data reporting for
 refrigerant blends and pre-blended polyols. Also training and sensitization is given to
 on possible common mistakes to that results in errors in ODS data reporting such as
 mis- declarations at the point of issuing licenses and to identify and report correctly
 the Harmonized Customs Codes of World Customs Organization.
- Closer follow up to the mandatory dates of reporting: the CAP liaises regularly with the MLF and OS Secretariats on countries that may not yet have submitted data. The CAP then works with such countries in getting the data submitted to the respective Secretariats.
- Follow-up on submissions: the CAP team coordinates on any queries that the respective Secretariats may have. For example, when the OS receives data, an email is sent to the NOO (with copy to the CAP) for accuracy verification. There were cases in which the country's request changed before the data was officially tabled. The team assists in the coordination and quality review on these requests.
- CAP team assists countries with specific needs for preparation and reporting of data. Details of this service could include country mission to work with the NOO, customs, importers and distributors on the analysis for raw data, preparation of data forms, cross checking that the data, in the formats required by the OS and MLF, are concurrent. This process also entails training and retraining of the NOO and Customs in the process of data management and reporting. Based on special requirement needs, particular data management and reporting assistance was provided to Antigua and Barbuda, St. Kitts and Nevis, Barbados, The Bahamas, Haiti and Peru for the reporting year 2009
- With the increased number of refrigerant ternary blends in the market, an excel sheet
 to transform refrigerant blends import data to pure substance was developed by CAP
 team last year and it was distributed through networks meeting and email. This tool
 provided support NOOs to help increase the quality of reporting on HCFCs and
 Blends containing ODS.
- At the 2010 sub-regional meeting of LAC held in Costa Rica, a special presentation was delivered by the MBTOC/QPS Co-chair Ms. Marta Pizano to highlight the relevance of MeBr data reporting in QPS uses.

Special assistance to countries in actual or potential non-compliance

- For 2009, no countries of the region reported non-compliance with targets for compliance agreement benchmarks.
- 21 of 29 reporting countries have reported zero level consumption of CFCs and methyl bromide in 2009. All countries of the region has reported zero of Halons, methyl-chloroform, HBFCs, other CFCs and BCM for 2009. Only Colombia and Ecuador reported small amounts of carbon tetrachloride.

Assistance in policy and legislation development and implementation

- A working file on the status of licensing system for each country of the LAC is maintained. This file is updated annually through bilateral meetings with NOOs during main network meetings and on country missions. The objective is to enable the licensing system to control all ODS and to give adequate monitoring and control capabilities for ODS containing technologies. This enforcement support service is linked and joined to the support countries received from individual projects such as TPMP and HPMP preparation.
- HCFC trade control is included in 5 out of 33 ODS license systems in the LAC countries. Dominica HCFC license system was approved in September 11, 2010 meanwhile other countries are in the initial stage of preparation i.e. Ecuador and Peru. CAP team members did close follow up to each of these three cases. Furthermore, comments and suggestions were provided to draft Decrees prepared by the National Ozone Units of Bolivia, Panama, Barbados, Guyana and Saint Kitts and Nevis.
- HCFC Quota system with the approval from Brazil was translated to Spanish and English, and then shared with all NOOs for analyzing or adapting same to each particular country circumstances.

Assistance in ratification of the Amendments and MP

• There are only a few countries where Montreal Protocol amendments are pending for ratification. Nicaragua has not yet ratified the Montreal and Copenhagen Amendments. The Beijing Amendment is still not ratified by Bolivia, Ecuador, Haiti and Peru. In order to provide support to those NOOs, regular presentations during network meetings and during the network meetings' compliance sessions to review the status of ratification have been carried out. Also during the Regional Meeting of Ministers of the Environment for the LAC, the CAP staff use this opportunity to sensitize participating Ministers and Ministerial representatives. In current year, guidance in the process of preparing ratification documents to start the National Congress approval was provided to the NOO of Peru.

Facilitation of communication with the Implementation Committee and Ozone Secretariat

• The team liaised with the Ozone Secretariat and the concerned countries to ensure updates are provided in line with the recommendations of the 43 and 44th Implementation Committee as well as for decisions of the MOP XXI.

Network meetings and other workshops

• The following network meetings and other workshops were conducted in the year 2010 with the support of ROLAC/CAP team:

Other assistance modalities, such as promotion of South-South cooperation

- Due to the communication links created as a result of the Networks, country-tocountry or bilateral cooperation took place on an informal and country to country basis to solve common or individual queries. Additionally the CAP team organised regional workshops to discuss different topics related to ODS phase-out with technical support provided by CAP team:
 - o Natural refrigerants for end-users and refrigeration and air conditioning service sector (RAC).
 - Promotion of refrigeration technician's association cooperation and harmonization certification process in the CARICOM country members.
 - o RAC sub-regional association of enterprises for the English Speaking Caribbean.
 - o Border Dialogue on Monitoring and Controlling Trade in ODSs in:
 - o Paraguay with South American countries of MERCOSUR (Argentina, Bolivia, Chile, and Uruguay).

- o Suriname with the English Speaking Caribbean Countries, French Guyana, Venezuela and Brazil
- o Central América: El Salvador, Guatemala, Honduras and Nicaragua

Status of TPMP Implementation and HPMP preparation

- In the current state of sustaining and completing the total CFC phase-out, the CAP team has been providing support to governments to implement TPMP or NPP as a key factor to achieve the 2010 compliance. This involved prioritizing country level activities to address the CFC completion by means of adopting longer term definitive alternatives as far as possible in order to be one step forward to manage the HCFC phase-out.
 - O In 2010, the last tranche of TPMP for Dominica, Grenada, Nicaragua, Paraguay, and Saint Vincent and the Grenadines as well as Ecuador NPP were submitted. Since UNEP is the Lead Agency in these countries, regional teams provided support to NOUs for reviewing reports and inputs to the annual planning.
- Expertise created at national level on refrigerant alternatives, ODS's survey and policy
 making is an added value for the HCFC phase-out preparation. Advantages of those
 national capacities were taken in the country driven approach and the ownership
 encouraged by the regional team and in cooperation with the cooperation of UNIDO and
 UNDP. A summary of current year achievements is as follow:
 - Belize, Dominica, Grenada and Guyana HPMP proposals were completed by August 2010. In those countries, UNEP was the only IA in charge of the project preparation.
 - Developing Guatemala, Honduras, Nicaragua, Paraguay, Saint Vincent & the Grenadines and Suriname HPMPs received support of the CAP team. These proposals are still being drafted but they will be completed by December of 2010.
 - o HPMP policy components in Colombia, Chile and Venezuela were developed with the support of the CAP. This was done taking into consideration that UNEP was chosen by these countries as the Cooperating Agency in implementation phase . UNDP and UNIDO were the IAs for HPMP preparation.
- As part of the HPMP preparation steps following national consultation workshops were held with the technical support of the team.

Capacity Building of new National Ozone Officers

- The CAP uses a multitude of tools for the training and capacity building of NOU teams depending on country-specific needs. Some are as follows:
 - Use of the e-forum in two languages to provide updates on the developments of the Montreal Protocol and other communications from the OzonAction Information Clearinghouse, intelligence information on potential illegal trade of ODS, etc.
 - Training at Network Meetings for specific topics such as data management, project reporting and implementation, addressing decisions of the Executive Committee and of the Meeting of Parties, etc.
 - Mentoring: the CAP facilitate that new NOO are mentored by more senior NOO.
 This allow for more rapid integration of the new NOO into the business of being a NOO and as a Member of the Network of Ozone officers.
 - o In 2010, a workshop on the Montreal Protocol relates theme and challenges for Article 5 countries (evolution of Amendments up to now, main MOP decisions, Multilateral Fund and Ozone Secretariat mandate, etc) was co-organized with NOU of Venezuela targeting main national stakeholders. Due to the potential enrichment for other National Ozone Units, new Coordinators from Bolivia and Paraguay, together to the Technical Assistance of Ecuador attended that workshop as special guests.

Support to new Parties

• All counties of the LAC are Parties to the Montreal Protocol

Additional CAP capacity-building activities

- Involvement of national consultants together to international consultants in the Caribbean sub- regional network meetings in order to facilitate a common understanding of the HPMP development processes and looking for cooperation amongst countries with differing level of developmental needs and approaches and technological adaptation
- Participation of three regional experts (from Brazil, Jamaica and Mexico) in Global Chillers conference in Cairo as part of UNEP's Global Chiller project.

Combating illegal trade in ODS

- Work very closely with countries for the completion of the iPIC
- Assist countries with the follow-up on queries for export of ODS from the EU and Asia to the LAC.
- The CAP assisted in the coordination of queries to confirm permission for exports. For the
 period under review queries were received for Belize, Uruguay, Colombia, Costa RIca,
 Trinidad and Tobago, Ecuador, The Bahamas and Panama. These processes allowed the NOO
 to make decision and give permission for imports before leaving country of export.
- Coordination with the USEPA and the National Ozone Office of the region of the cases of
 published illegal trade in R22 to encourage bi-lateral discussions. This is necessary taking into
 consideration that in the published case of illegal trade of R22, the US EPA indicated that the
 shipment was from one of the Caribbean countries
- Include the trade control of ODS as an agenda item for training of Customs and other enforcement officers at the national and regional levels.
- Make presentation to the CARICOM and the Caribbean Customs Law enforcement of the need and risk to have control of the trade of ODS and ODS containing technologies

Green Custom Initiative Workshops

- Presented on the objective of the GCI approach as tool to enforcement to the CARICOM Annual Head of Customs Meeting and the Caribbean Customs Law Enforcement Council
- Assisted in the translation into Spanish and required review of the Green Customs Manual
- Assisted in the Co-ordination and delivery of the GCI/WCO Regional and GCI/UNODC/Panama
- Provided feedback on the review of the approaches and lessons learnt and recommendations on the further development of the GCI
- Integrate the GCI methodology into the National Training of Customs officers as a subcomponent of the Training under the Montreal Protocol
- Integration regional and national partners into the GCI methodology

- A series of thematic workshops were organized in cooperation with Kuwait NOU, under the Kuwait Terminal Phase-out Management Plan (TPMP) March 2010
- Several meetings and capacity building workshops were conducted in Jeddah, Jizan and Yanbou cities of Saudi Arabia for customs officers, under the National Phase-out Plan (NPP) of Saudi Arabia April 2010

Saudi Arabia reported 2009 data of Annex-A (CFC) within the 15% allowable consumption level.
- Continue support Iraq, as new party, to meet the compliance targets through expediting the implementation of funded projects and enacting national measures to control ODS trade.
- CAP organized UNEP/UNIDO high level missions to Saudi Arabia and United Arab Emirates, as the two large HCFC consumers in West Asia, to highlight challenges, cooperation opportunities and assistance of IAs

- NOU of Qatar utilized the expertise of Kuwait NOU in reviewing the national survey of the servicing sector and in preparing criteria and plan to distribute R&R equipment.
- Jordan, Syria and Yemen benefited of Egypt experience in MDIs phase-out plans.
 Special joint meeting for ROA & ROWA countries was organized on non-CFC MDIs and development of MDIs transitional strategies.

Assistance in policy and legislation development and implementation

- Started work with GCC Secretariat on the review of the GCC Unified ODS Regulation in consultation with the GCC Ozone Group (ODS Officers of GCC countries)
- Support Bahrain, Iraq, Kuwait, Oman, Qatar, Saudi Arabia and Yemen in reviewing their national ODS licensing systems and in updating/developing comprehensive ODS legislations to incorporate HCFC related concerns. CAP participated in several meetings of the national legal committees and provide policy and technical advice\
- Organize special meeting for the Iraqi Legal Committee to review the draft of the comprehensive ODS Legislation developed by the national legal team

Support to new Parties

 Close cooperation and support to Iraq in starting up Montreal Protocol business in the country including efficient implementation of funded projects, managing new NOU, prepare national awareness raising program and regularly collect data on ODS trade and use in the country

Capacity Building of new National Ozone Officers

• Introduce support to new Directorate responsible of Montreal Protocol at Ministry of Environment & Water of UAE including furnishing them with policy and technical materials and provide guidance in issues related to reporting and compliance.

Additional CAP capacity-building activities

• Involvement of managers of national refrigeration & air-conditioning associations in ECA network meetings in Yerevan and Istanbul in order to promote networking between these national associations and to facilitate HPMP implementation.

Combating illegal trade in ODS

- Promote the participation in the IPIC amongst West Asia member states. Jordan, Lebanon, Oman, Saudi Arabia and UAE benefited of the prior informed mechanism to prevent illegal or suspicious shipments.
- Cooperate with WCO and GCI Secretariat in conducting regional training for Customs Officers in Arab countries in cooperation with WCO regional training centre in Lebanon
- Coordinate with RILO/Riyadh and GCC Secretariat in developing regional cooperation agreement for combating illegal trade in ODS and exchanging information about illegal and counterfeited shipments

Institutionalizing CAP activities

- Maintain Montreal Protocol at agenda of high-level and Ministerial fora of League of Arab States and GCC ensuring that relevant emerging concerns and challenges are adequately addressed during those meetings
- Cooperate with the League of Arab States to develop the Arab Refrigeration & Air-Conditioning Code through participating in the respective code formulation meetings and introduce special chapter in the code addressing environmental and MP concerns
- Continue work with regional universities/institutions to develop and update special course on ODS management for under-graduates

Paris - Information Clearinghouse

UNEP provided an Information Clearinghouse service to National Ozone Units and other key stakeholders in Article 5 countries as per Article 11 of the Montreal Protocol. The emphasis of this service was on delivering or supporting information, communication and education (ICE) services that create action-oriented support to national compliance objectives related to the Montreal Protocol. UNEP delivered this service within the framework of the *Communication Strategy for Global Compliance with the Montreal Protocol* developed by UNEP, and wherever possible, in support of the *Information Strategy* of the Multilateral Fund. The Communication Strategy was updated in 2009 and presented to Executive Committee in March 2010. It is available at http://www.unep.fr/ozonaction/information/mmcfiles/7440-e-Communication_Strategy.pdf. It identified for ICE services eight priority action areas:

- a. **Consolidating inter-linkage** investigate and promote scientific based linkages between ozone and other multilateral environmental agreements (MEAs) e.g. climate, hazardous waste, chemicals, biodiversity.
- b. **Promoting the Montreal Protocol HCFC phase-out** campaign for and enhance ICE assistance to MP parties for complying to the for gradual HCFC control measures to be applied from January 2010 onwards;
- c. **Lobbying/Mobilising** Advise governments and foster knowledge exchange for communicating the overall benefits of the MP, adding to the *Green Economy* and the *Climate Change* initiatives led by UNEP in conjunction with other organizations worldwide:
- d. **Facilitating information development and dissemination** respond to the requests at regional level, support ICE local initiatives and re-orient the deployment, distribution and replication of materials to MP parties;
- e. **Strengthening capabilities** enforce the role of ICE and build up capacities at regional and country levels for disseminating ozone related messages/materials and content through the use of governmental multiplying channels and media outlets;
- f. **Fostering partnerships** enhance the use of strategic partnerships with the media groups, educational networks, NGOs, sector associations, governments, public/private institutions and industry in order to increase ICE outreach;
- g. **Defining educational objectives** assess A5 needs and provision of education programmes to facilitate communication of key messages to different age groups in a way that promotes dialogue and action to support MP principles.
- h. **Sustaining the MP momentum** improve channels for sustainable message delivery, granting access to the MP relevant information and securing compliance to ODS phase out.

This strategy serves as a blue print - a basis for action - for next ten years primarily to OzonAction staff and CAP teams, but also to UNEP's regional information officers who have very important role in promoting and acting in different regions for ICE efforts. All activities proposed below are linked to the blue print.

The Clearinghouse helped promote the overall visibility of the Montreal Protocol and Multilateral Fund implementation achievements through its core services (OzonAction Special Issue, websites and outreach activities) and it played a major supporting role for national and regional celebrations of the International Day for the Preservation of the Ozone Layer (16 September).

The Clearinghouse services were performed by the Paris-based CAP team consisting of an Information Manager, Information Officer (vacant), a Website Assistant (50%), a Clearinghouse Assistant, and a Documentation assistant. Their work was conducted in close cooperation with the other CAP teams (particularly the regional networks) as well as with UNEP's Division of Communication and Public Information (DCPI) which reflects a reorientation of its ICE activities and related budget allocations following advice provided to UNEP by the CAP Advisory Group meeting on September 2010.

Core Clearinghouse Services

Assisting National Ozone Units with Ozone Day celebrations. In 2010, the Information Clearinghouse supported national, regional and international efforts to celebrate International Ozone Day through the provision of attractive awareness materials that were easily adapted by NOUs for national use. The Information Clearinghouse devoted a substantial portion of its overall staff resources to the Ozone Day support. The theme of the day was "Ozone Layer Protection: Governance and Compliance at their Best". The services provided to NOUs included:

- Ozone Day web page. The Clearinghouse developed, outreached and maintained a web page devoted to the International Ozone Day, which included information on national celebrations in various countries. In addition to supporting national celebrations, the Clearinghouse also participated in several global celebrations e.g. organizing radio interviews that reached millions of listeners. See www.unep.fr/ozonaction/events/ozoneday.
- Developed new <u>mini-website for the International Ozone Day</u>. This site includes publications, videos, images, maps, RSS feeds. It is available at http://www.unep.fr/ozonaction/events/ozoneday/2010web.htm. This site templete will be used for all future information activities.
- Vital Ozone Graphics 2.0 Climate Link is a Resource Kit for Journalists provides the essential visuals, facts, links and contacts to develop ozone story ideas. Graphics and figures can be downloaded and included in articles. - <u>Journalist competition</u>. It was also launched a competition for young environmental journalists working in print media in 2009 but in Africa region the journalist competition was held in summer 2010.

Supporting regional awareness activities. The Clearinghouse continued to assist the Regional CAP teams with the conceptualization, review, production and outreach of the video, audio, media and published materials produced in all regions as part of the Regional Awareness facility. Electronic versions of the final awareness products were outreached through the OzonAction web site and the OzonAction Special Issue. The Information Management Team participated in regional workshops related to information, communication and education issues.

Giving a voice to the Montreal Protocol community through the OzonAction Special Issue. The Clearinghouse provided NOUs and others with the key information about major ozone protection developments in industry, governments, NGOs, and international organisations by producing "Out of the Maze: Montreal Protocol, Climate Benefits and the Green Economy", an OzonAction special issue. Articles authored by key figures in the global ozone protection community reflect on the achievements and future challenges of this multilateral environmental agreement. It was launched on International Ozone Day in English and will be distributed at MOP-22. This hardcopy newsletter was produced in English. The electronic versions of this issue were distributed through OzonAction website in Arabic, Chinese, French, Russian and Spanish. <u>Disseminating information to support capacity building</u>. The Clearinghouse reproduced and provided training manuals, guidelines and other information tools that (a) facilitated capacity building and training of new Ozone Officers and their assistants to ensure their quick understanding of Montreal Protocol requirements (b) serviced the national and regional workshops organized by the Regional CAP teams. In 2010, the Clearinghouse has not dispatched many hardcopy documents as some new publications as available an e-books.

Collecting and sharing ozone protection publications through the Multi-media Collection. The Clearinghouse obtained, processed and catalogued 58 new items sourced from around the world. Keeping key members of the Montreal Protocol community up-to-date on breaking news through E-news services. The Clearinghouse provided the latest ozone protection news to Ozone Officers and other stakeholders via "direct delivery" email news services, which included 18 issues f OzoNews and 1 issue of Regular Update on Methyl Bromide Alternatives (RUMBA). The earlier E-news service Climate and Ozone Update (CLIO3) was changed to JumpStart HCFC Phase-Out for Ozone and Climate Benefit under EU project.. Three issues of JumpStar newsletter was publiched. The Clearinghouse distributed all new publications on a USB-key.

Special initiatives in 2010

In 2010, as in previous years, the Information Clearinghouse continued to seek co-financing (both direct and in-kind contributions) by encouraging countries, organisations and companies to translate and adapt existing information, communication and education materials produced under the Multilateral Fund into national languages at their own cost. The Information Clearinghouse secured funding and initiated a strategic partnership with UNESCO in order to maintain the long-term sustainability of Montreal Protocol in information, communication and education activities.

Part 2: Challenges ahead

ECA

- In the coming years, National Ozone Units will focus on HPMP preparation and implementation and the challenge will be to promote non-HCFC and low GWP technologies by identifying the obstacles to technology transfer and to inform on new technology developments.
- Providing access to policy-related and technical information in sub-regional or local languages is a priority to sustain the phase-out in ECA network countries and allow them to develop their relevant economic sectors in a sustainable and competitive manner.
- Prevention of illegal trade of ODS including HCFC and dumping of second hand equipment relying on HCFCs may become a priority. This also requires increasing awareness of the Parties to the Copenhagen Amendment that they must not export MeBr to non-Parties. Parties to the Beijing Amendment must not export HCFC to non-Parties. Parties to the Protocol should not export ODS-based equipment if the importing countries included in the list of countries that do not wish to import such equipment.
- Enhanced inter-regional and intra-regional information exchange and cooperation in the implementation of the Montreal Protocol. This also includes overcoming language barriers between ECA / CEIT countries through joint meetings and simultaneous interpretation and integrated activities with MLF-funded Article 5 and GEF-funded CEIT countries through co-funded approaches.

ROA

The main challenges foreseen by the CAP team are:

- Ensuring all countries meet the 2010 total phase out of the major ODS, especially for new parties and countries with political instabilities.
- Ensuring sustainability of phase out beyond 2010.
- A few countries are still unable to adopt ODS regulation or ratify key amendments to the Protocol leading to the non approval of their TPMP or TPMP approved with conditions (case of Angola, and Botswana).
- Ensuring that NOU remained focus on the 2010 target while preparing the HPMPs.
- Ensuring the HCFC surveys are done with more accuracy than was the case for the CFCs and that HPMPs included activities that will ensure actual freeze in consumption by 2013 and 10% reduction by 2015.
- Prevention of illegal trade of ODS including HCFC and dumping of cheap AC equipment relying on HCFCs may become a priority

• Initiating activities in the HPMP that will help country freeze the consumption of HPMP and start reduction earlier than due.

ROAP

The main challenges foreseen by the CAP team are:

- Ensuring assistance to countries in setting up and enforcing workable HCFC control policy/regulation to comply with the 2013 and 2015 targets.
- Finalizing the HPMP development and initiating activities to implement HPMPs;
- Ensuring to sustain the CFC compliance especially the stockpiled CFCs are still widely available in this region, and the needs are still there in countries;
- Ensuring that the country returned to compliance maintaining its achievement;
- Preventing and combating illegal trade of HCFCs;
- Promoting the climate friendly technology/products for manufacture as well as endusers during the phaseout of HCFC;
- Assisting countries to seek co-funding under HPMP for the climate and environment benefit:
- Assisting the EUN submission and the monitoring the EUA application at the country level:
- Addressing the increasing needs of the countries for properly disposal of the ODS banks in the region; and
- Supporting countries in improving the precision and effectiveness of the licensing system enforcement as well as the quality of trade information exchanged between the NOU and the Customs.

ROLAC

Major challenges foreseen for the coming years in LAC countries are:

- Maintain political and other high level interest and attention to the MP for example briefing on the status of the Montreal Protocol implementation to Ministers both at national missions and at regional and sub-regional meetings and forums
- Increased involvement of the private sector in the decision making for purchasing choice of technologies. In particular and for the Small Islands Developing States, encourage a more sub-regional approach with the private sector and Refrigeration Association for the selection of technologies
- Increased involvement of the Technical colleges and University for the training and capacitating in new and emerging technologies, encourage research, syllabus reviews and development to technologies that are suitable to regional and national conditions such as developmental and other socio-economic challenges for technology adaptation
- Building on wider partnership with other UN agencies for example with the FAO on QPS applications, regional Climate Change and Basel centers, IADB and other regional developmental banks on climate and energy policies for the region and with linkages to ODS phase out. For example the Caribbean Energy Efficiency Project working with the Hotel and Tourism sectors
- Investigate and find financing mechanisms that will ensure the proper HCFC phaseout with low GDP technology.

- Main streaming the Montreal Protocol into wider national and sub-regional policies of Sustainable development and processes. For example for the CAP to participate on the CARICOM ACP Project for MEAs and in the UNDAF processes,
- Maintain the total phase-out of Annex A Group (CFC, CTC and Halon) further 2010
- Manage compliance to maintain zero level of MB consumption in countries where immediate neighbours have a high MB consumption level.
- Comply with the Action Plan approved by MeBr when applicable
- Completion of ratification of all Amendments to the Montreal Protocol.
- Ensure continuity of the application and enforcement of the ODS licensing system, especially for HCFCs.
- Facilitate the inclusion and required implementation of HCFC as part of ODS licensing/quota national systems where it is required.
- Development and management of national capacities regarding unused ODS management and final disposal.

Consequently, ROLAC/CAP team will be reorienting the regional activities towards providing support to overcome mentioned barriers and building capacity of NOOs to address new challenges.

Paris - Information Clearinghouse

UNEP provided an Information Clearinghouse service to National Ozone Units and other key stakeholders in Article 5 countries as per Article 11 of the Montreal Protocol. The emphasis of this service was on delivering or supporting information, communication and education (ICE) services that create action-oriented support to national compliance objectives related to the Montreal Protocol. UNEP delivered this service within the framework of the *Communication Strategy for Global Compliance with the Montreal Protocol* developed by UNEP, and wherever possible, in support of the *Information Strategy* of the Multilateral Fund. The Communication Strategy was updated in 2009 and presented to Executive Committee in March 2010. ROWA

In 2010-2012, ROWA will follow up with countries to ensure; Countries sustain compliance with 2010 phase-out; Countries achieve their MeBr phase out in 2015; and ensure that countries have already taken required measures for HCFCs to be in compliance with the 2007 adjustments. In line with this, the following are the priorities for ROWA CAP team:

Institutionalization and legislation

- Maintain MP issues on Agenda of high-level fora
- Continue assisting countries through provision of technical advice to review and develop comprehensive legislations; CAP is invited to meetings of national legal committees
- Continue lead work with GCC Secretariat to update the GCC Unified ODS Regulation as control tool for 6 countries
- Initiatives for cooperation with RILO, GCC and LAS on monitoring illegal trade and promoting Green Customs Initiative as well as developing regional customs tools

Methyl Bromide

- West Asia region is considered as a high producer for Dates, which consumes MeBr in Date fumigation. It is expected to have increase of demand on MeBr for Dates in the next few years, due to issues related to harvesting/consumption sectors. In addition ROWA discovered through regional activities organized over the last 3 years, unnecessary consumption of some date sectors/operation. This will put some countries in the region at risk of being in non-compliance for MeBr.
- CAP ROWA will therefore focus on continuing provision of assistance to countries through Regional Expert services and
- Submission of proposal to establish MB/Date HelpDesk to reduce demand on MB particularly for unnecessary sectors/operation

HCFCs

- The West Asia region faces issues related to available feasible technologies particularly for A/C applications in high-ambient temperature countries, particularly with promotion of low-GWP alternatives
- Private sectors in West Asia region hesitate to shift to alternatives unless there is a tight time frame for the region (all Gulf Cooperation Council (GCC) member countries) as well as ban importation of HCFC based technologies; in order not to lose market
- Therefore CAP will focus on strengthening cooperation with private sectors and relevant national/regional institutions to introduce further assessment and ease information dissemination
- Proposal for a Technical Assistance project to promote/adopt low GWP HCFC alternatives for air-conditioning sectors in high ambient-temperature countries
- Organizing special sessions and thematic meetings/workshops for introducing up-to-date information (e.g. Regional Meeting on Future of Residential A/C (2009) and Foam Symposium (2010) with UNIDO, Seminar on Future of Buildings' A/C (2010))

ROA

The Africa CAP team with the support of the ROA information team published a booklet on the implementation of the Montreal Protocol in Africa with the main target being the decision makers.

In 2009 the ROA CAP team continued its cooperation with the African Environmental Journalist Network with the participation of 21 African Journalists to 2010 English-speaking Africa Network meeting held in May 2010 in Malawi and 7 other African journalists to the 2010 Joint network meeting held in September 2010 in Abidjan.

The Africa CAP team with the support of ROA information team initiated a media competition awarding African journalists in 5 categories in print and electronic media with stories related to the Ozone Layer. The competition is planned to be held annually.

ROAP

- Undertook information exchange and communication activities for publicising ODS phase-out. This would included:
- (a) Production of "Towards Zero: Success Stories of the Montreal Protocol in Asia and the Pacific Region", the brochure "Stand Up for ozone layer and MDGs", new factsheets, a template for a communication strategy for HCFC phase out for regional use and an interactive CD on ozone layer and climate change;
- (b) Organization of 2010 International Ozone Day Celebration during the Joint Meeting of SA and SEAP Network of ODS officers in Beijing, China and at the FCCT, Bangkok, Thailand in September 2010.

ROA

The regional CAP team is using the programmatic budget funds for preparation of a series of publications including training kits and media packages on Methyl Bromide Alternatives with the support of lecturers from University of Nairobi and from Zimbabwe.

A documentary was also produced on methyl bromide alternative in cooperation with farmers from Kenya and Malawi.

ROAP

- UNEP ROAP continues using these funds to work closely with international technical experts on HCFC phase out support activities specifically relating to HPMP preparation and technical support to countries in fast track HPMP preparation. In addition to this, specific last-mile ODS phase out needs such as ODS phase out in Military applications are supported with these funds.
- **Peer-to-Peer capacity-building**. Countries with greater experience in the Montreal Protocol implementation assist new national ozone officers (NOOs) come up to speed with basics of the Protocol implementation as quickly as possible. New NOO for the Government of Pakistan:
- Cooperation to avoid non-compliance. e.g. a bilateral agreement established between the Maldives and China concerning the trade in CFCs. The agreement allowed Maldives to import acceptable limits of CFCs from China ensuring that Maldives is not at risk of non-compliance due to over-import; the Republic of Korea agreed to continue exchange of information with Pakistan on exports of CTC to Pakistan from Samsung. This facilitated achievement of compliance of Pakistan with their CTC phaseout plans as per decision XVIII/31.
- Sharing of expertise in specialized areas. Trade control assistance from the Philippines customs to the customs of Laos; India's assistance to Bhutan on servicing and retrofit issues as well as on enforcement of trade control.
- Information sharing. Through informal Prior Informed Consent (iPIC), countries communicate information that help them better monitor and control trounsboudary ODS movements thus facilitating compliance.
- Institutional capacity-building. The Korea International Cooperation Agency (KOICA) in Afghanistan has established the refrigerant technicians training center at the Afghan Korean Vocational Training Centers. The National Ozone Unit has equipped the training center with Recovery and Recycling machines and other equipment for training refrigeration technicians on Good Practices. The Afghan Korean Vocational Training Centers (both Korean Advisors and Afghan Instructors) have agreed to incorporate the syllabus of Good Practices in Refrigeration and Use of Recovery and Recycling Machine into training syllabus;

- Cooperation on implementation of trade regulations/ licensing systems/ combating illegal trade. Border dialogues are facilitated by UNEP among countries with needs of better ODS monitoring control/ significant illegal trade cases. e.g. a Quadrilateral Meeting among Cambodia, Lao, Thailand and Vietnam, a Teheran Dialogue led by Iran and participated by Afghanistan, Pakistan and countries of Central Asia.
- Initiation of sector-targeted cooperation. Sub-regional Workshop on ODS Phase-out in Military Applications was held at Colombo, Sri Lanka, to encourage South-South cooperation among defense establishments in Bangladesh, India, Indonesia, Iran and Pakistan.
- Facilitating Public-Private Partnership. Consultative Meeting on EUNs (Essential Use Nominations) for CFCs for Meter Dose Inhaler (MDI) Manufacturing in Article 5 Countries beyond 2009 was held in Bangkok, Thailand, gathering NOOs and representatives of the MDI industry and health sector representatives from Bangladesh, China, India, Iran, and Pakistan, Medical Technical Options Committee (MTOC) members, and the Implementing Agencies of the Montreal Protocol; planned assistance from large refrigeration associations from China (e.g. CRAA) and India (RAMA) to other countries, such as the Maldives, in getting an association established or strengthened.
- Inter-agency Joint SSC activity. The World Customs Organization (WCO) Regional Intelligence Liaison Office for Asia and the Pacific (RILO A/P) will share with UNEP the cost of organizing a regional training of the customs officers in September 2010. RILO A/P is currently hosted by China and receives its resources from the government for their regional capacity-building activities; The multiple agency project to combat illegal trade, i.e. PATROL, has been launched in 2010. The project promotes collaboration in border areas of six Greater Sub-Mekong countries to improve their monitoring and control over illegal transboudary movements.
- Consultations on Policy & Enforcement strategy for ODS Phase out in India was held on 12-13 February 2009, Bangkok Thailand. In addition, Online Training System was launched on August 2009 in presence of Ozone Cell and UNEP officials. The Online Training System has been included in the curriculum of Training for Customs Officers in the National Academy of Customs, Excise and Narcotics (NACEN). For face-to-face training programme, 39 workshops have been conducted and a total of 976 identified target officers have been trained by NACEN on Monitoring and Control of Ozone Depleting Substances from February 2005 to October 2009.
- Sub-regional Workshop on ODS Phase-out in Military Applications was held on 16-17 April 2009, Colombo, Sri Lanka which encourages North-South and South-South cooperation between Defence establishments attended by representatives from Bangladesh, India, Indonesia, Iran and Pakistan.

<u>BL-2304 - Exhibition/outreach.</u> This budget line is used to organise, design panels and rent equipment for exhibitions in different Montreal Protocol meetings. Specific information materials will be produced for different target groups, such as workshops and training. It is also used to outreach information on new OzonAction products and services.

<u>BL 2305 - Targeted information materials on HCFCs.</u> This budget allocation will be used to produce technical and policy information for National Ozone Units that can be easily used, adapted and/or translated in accordance with new Communication Strategy for the Global Compliance with the Montreal Protocol. These materials will be outreached in different events throughout the year. The emphasis in 2011 will be on the implementation of the communication strategy developing information, communication and education products related to (a) global phase out of CFCs and compliance of Article 5 countries (b) HCFC phase-out (c) climate and ozone linkages.

2306 - Regional Capacity Building and Tech support on HCFC phaseout This budget line addresses the need for the capacity building needed for National Ozone Units (NOUs) for priority policy and technical subjects as per the specific needs expressed during the 2010/2011 Meetings of Regional Networks of ODS Officers. The emphasis will be on producing specific capacity building materials related to compliance with the 2013 and 2015 HCFC targets (including issues identified in recommendations of the TEAP/TOC assessments), however this item will also address other upcoming issues which Network meetings have identified as priority capacity building issues for NOUs (e.g. mobilizing co-financing for the climate benefit of HCFC phase out). To the extent feasible, UNEP will engage TEAP/TOC and industry experts in the network and thematic meetings to provide technology and policy support to NOUs.

COOPERATION WITH IMPLEMENTING AGENCIES AND BILATERAL AGENCIES:

OzonAction would strengthen its cooperation with

- 1. World Bank: on technology round tables and assistance to the LVCs on carbon financing, providing the technology trends. Technical assistance in the production sector based on country's request.
- 2. UNIDO: Sustaining Methyl Bromide phase out, HPMPs for LVCs. Enhanced support to African, ECA and Arab speaking countries including special assistance to Iraq.
- 3. UNDP: HPMPs in larger countries and in LVCs.

JUSTIFICATION FOR INCREASE

29. In accordance with Decision 47/24, UNEP is not requesting more than 3 per cent increase in the 2011 CAP budget. The increase reflects additional costs due to inflation and annual increases in staff salaries.
