REPORT ON BALANCES AND AVAILABILITY OF RESOURCES

Introduction

1. This document presents a summary of the financial adjustments indicated by the bilateral and implementing agencies (IAs) as agreed by the Fund Secretariat. The document includes statistical data, as required by decisions 28/7 and 56/2, from projects for bilateral and IAs with balances that have been held for over the allowable 12-month period following completion of the project. The data presented are based on the reporting format that has been developed pursuant to decision 31/2 and include both obligated and un-obligated balances. Further to decision 41/92(b), this document also indicates the level of resources available to the Executive Committee in cash and promissory notes as recorded in the Status of contributions and disbursements (UNEP/OzL.Pro/ExCom/66/3). The total funds to be returned addressed in this report amount to US \$1,038,911 including support costs, which consist of US \$3,028,410 returned by the IAs less the amount of US \$1,989,499 to be transferred from the World Bank to UNEP. It also does not include the interest accrued of US \$260,777 returned by one bilateral agency as additional income to the Fund and the bilateral agencies intent to return in cash a balance of US \$78,331 to the 66th meeting.

Funds being returned to the 66th meeting by Implementing Agencies

2. Information provided by the IAs indicates that a total of US \$2,773,074 excluding agency support costs will be returned to the 66^{th} meeting, as set out in Table 1.

Pre-session documents of the Executive Committee of the Multilateral Fund for the Implementation of the Montreal Protocol are without prejudice to any decision that the Executive Committee might take following issuance of the document.

3. Table 1 shows that UNDP will return US \$676,933 to the Fund from completed project costs, UNEP and UNIDO US \$52,098, US \$105,643 respectively from completed projects. UNIDO will also return US \$24,451 from ongoing projects. The World Bank will return US \$102,239 from 3 completed projects and US \$1,811,710 from 3 ongoing projects resulting into a total return of US \$1,913,949. This amount includes US \$1,835,205 to be transferred to UNEP for the following 4 projects, PHI/PHA/47/INV/79, PHI/PHA/41/INV/71, PHI/PHA/51/INV/81 and PHI/PHA/54/INV/82 as a follow up to decision 65/10(e)(iii) to request the World Bank to return the remaining balance of the Philippine's national phase out plan to the 66th meeting.

Projects with balances by year of completion

4. Table 2 presents the number of projects with balances that are still being held by the IAs and the years in which those projects were completed. It shows that for projects completed up to and including 31 December 2010 (at least over the last 12 months), IAs had balances that totalled US \$2,867,625 excluding support costs.

- 5. At its 47th meeting, the Executive Committee requested the Fund Secretariat to continue to monitor multi-year annual tranches in the context of documents on implementation delays and project balances (decision 47/50(b)(ii)).
- 6. UNDP holds a balance amounting to US \$1,059,230, of which US \$235,254 is attributable to 21 multi-year agreements (MYA). It also has the highest number of projects with balances (67) followed by UNIDO (42), UNEP (33) and the World Bank (2). The World Bank reported a balance of US \$311,814 of which US \$215,000 is attributable to 1 MYA. UNEP holds a total balance of US \$435,915 of which US \$12,723 is in respect of 3 MYAs. UNIDO holds a total balance of US \$1,060,666 of which US \$785,240 is attributable to 19 MYAs.
- 7. Three of the four agencies have projects that were completed over two years ago and have remaining balances. UNDP has the largest number of projects (23), completed over two years ago, which has increased from 22 to 23 projects. The level of balances on UNDP's projects over two years old has increased from US \$257,492 to US \$362,381. UNDP maintained the explanation provided in the past meetings that balances over 2 years are considered still obligated because the financial procedures of UNDP require that a final budget revision be issued to mark the formal closure of a project between UNDP and the executing agency and to close the project in UNDP's systems. Until this step is taken the executing agency is considered to have access to these funds and therefore these are considered obligated.
- 8. The number of UNEP projects completed over two years ago remains at 13. UNEP's balance on completed projects has slightly decreased from US \$277,674 reported to the 65th meeting to US \$266,972. UNEP explained that two year old balances are still obligated because the agency works with its implementing partners through legal agreements and only when the projects are financially closed and all obligations cleared, the balance of funds would be returned.
- 9. The balance held by UNIDO for projects completed over two years ago has increased since the 65th Meeting of the Executive Committee from US \$526,072 to US \$606,446 and the number of projects increased from 13 to 16. Out of the 16 projects, 10 are MYAs with US \$528,954 in obligated balances. UNIDO advised the Secretariat that for the remaining obligations, they will either initiate financial completion or return the balances after all pending issues are settled. UNIDO maintained that balances that are over two years old cannot be returned until the financial completion of these projects in order to avoid risk of over-expenditures in the relevant project account.

Obligated and un-obligated balances

10. The level of balances classified as obligated and un-obligated for the four IAs is as follows:

11. Out of the total of US \$2,867,625 from completed and on-going projects, US \$2,770,811 is obligated (which means that these funds are expected to be spent) and US \$96,814 has not been

obligated. IAs are required to report reasons why any un-obligated balances could not be returned within the required time-frame, and to indicate when they will be returned as per decision 31/2(a)(ii).

- 12. UNDP has no un-obligated balances, and reported an increase in obligated balances on completed projects. Its overall number of projects with balances shows an increase from 41 projects reported to the 65th meeting to 67 reported to the 66th meeting. The overall level of obligated balances has decreased from US \$1,217,862 to US \$1,059,230. Nine UNDP projects (of which 4 are investment projects) were completed more than 5 years ago and still have obligated balances.
- 13. UNEP has 33 completed projects, and holds US \$435,915 in obligated amounts and has no un-obligated balances. The overall number of projects with balances has increased from 21 projects reported to the 65th meeting to 33 reported to the 66th meeting. The overall level of balances increased from US \$393,588 to US \$435,915. UNEP has 6 projects completed over 5 years ago with obligated balances. Out of the 6 projects with obligated balances, 3 were completed in 2005.
- 14. By decision 64/2(i) the Executive Committee decided to note UNIDO's commitment to return unobligated balances from individual completed projects in full by the 66th meeting of the Executive Committee, and in decision 65/2(b) it decided to reiterate decision 31/2(a)(i) and (ii) and to request UNIDO to update the Committee at the 66th meeting on the date at which the remaining un-obligated balances for completed projects would be returned in full. In its report on balances to the 66th meeting, UNIDO reported no un-obligated balances. A review of the balances reported to the 66th meeting shows that some of the un-obligated balances referred to in decision 64/2(i) and 65/2(b) have been obligated while others have been returned to the Fund.
- 15. UNIDO reported 42 completed projects with US \$1,060,666 in obligated funds. The overall number of projects with balances has increased from 29 projects reported to the 65th meeting to 42 reported to the 66th meeting, and the overall level of balances has increased from US \$858,009 to US \$1,060,666. UNIDO has 2 projects completed in 2007 (i.e. 5 years ago) with obligated balances.
- 16. The World Bank has US \$215,000 in obligated amounts and US \$96,814 in un-obligated balances for two completed projects that are less than 2 years old. It is the only agency with un-obligated balances. At the request of the Secretariat the World Bank explained that the un-obligated balance does not relate to an individual project but rather to a funding tranche for the China process agents sector plan. The tranche was marked as completed because the country met the required consumption obligations. However, the last payment to China is pending subject to the World Bank's internal clearances. The World Bank clarified that disbursement against this un-obligated balance is expected to be effected before the 66th Executive Committee meeting, at which point the World Bank would have no un-obligated balances.
- 17. At its 35th meeting, the Executive Committee requested IAs to return all agency support costs associated with remaining funds from completed projects. If expenditures had been incurred from these costs, the IAs should provide an explanation and return the balance of funds (decision 35/13(k)). Table 4 indicates that a total of US \$255,336 in agency support costs will be returned at the 66th meeting. This amount includes the World Bank's return of US \$9,060 from completed projects and US \$152,208 from on-going projects, UNDP's of US \$73,257, UNEP's US \$6,773 and UNIDO's of US \$13,866 from completed projects.

Funds being returned to the 66th meeting from bilateral agencies

18. By decision 56/2 bilateral agencies were requested to report to the Executive Committee on their proposed disposition of balances from completed projects. Table 5 provides the feedback received on returns of balances from projects completed by the Governments of Japan and Italy. It indicates that a total US \$78,331 comprising project costs and agency support costs will be returned to the 66th meeting.

- 19. The Government of Italy has advised the Secretariat of its intent to return US \$382 at the 66th meeting for one completed project in Serbia (YUG/SOL/56/INV/33) as shown in Annex II. It also advised the Secretariat of the refund of US \$363 in 2010 in accrued interest and the refund of accrued interest of US \$186,809 and US \$73,605 for TFCPR03001 and TFCPR05004 directly to the Treasurer by its IA as additional income to the Fund.
- 20. The Government of Japan has advised the Secretariat of its intent to return US \$77,949 at the 66th meeting for two completed projects CPR/REF/28/INV/302 and NIR/SEV/38/TAS/104, in project and support costs.

Bilateral projects with balances by year of completion

21. Table 6 presents the balances that are being held by bilateral agencies and the years in which those projects were completed. It shows that for projects completed up to and including 31 December 2010 (at least over the last 12 months) bilateral agencies had balances totalling US \$211,720 including support costs.

22. The Government of France advised the Secretariat that balances on completed projects are pending internal financial closure and would not be returned to the 66th meeting. All of the Government of France's balances are un-obligated and only one project is over two years old.

SECRETARIAT'S COMMENTS AND RECOMMENDATIONS

COMMENTS

- 23. Annex I presents additional information on obligated and un-obligated balances by agency. Of the US \$2.87 million in projects with balances in this report, about US \$1.2 million is for 44 MYAs. UNIDO has the largest amount of balances, US \$1,060,666 of which is obligated, followed by UNDP with US \$1,059,230, UNEP with US \$435,915 and the Word Bank with US \$311,814 in balances. The balance on projects completed over 2 years ago withheld by agencies amounts to US \$1,235,799, with UNEP holding balances for three projects completed from 2005 and UNDP holding balances for two projects completed from 2006. Immediate attention should be given to these long outstanding obligations with a view to returning the balances to the Fund as soon as possible. All the agencies have cleared their un-obligated balances of two year old and more. Two bilateral agencies have balances including support cost on completed projects: France with US \$160,881 and Japan with US \$50,839.
- 24. The status of contributions and disbursements as of 9 March 2012 indicates that the Treasurer has an available balance amounting to US \$30,390,979 in cash and promissory notes. The total net balance returned by IAs, including agency support costs but without interest accrued and the returns from bilateral agencies is US \$1,038,911. The total level of resources available for approvals by the Executive Committee at its 66th meeting, after taking into account the Fund's balance as contained in document UNEP/OzL.Pro/ExCom/66/3 and the total amount returned by IAs is US \$31,429,890.
- 25. Considering the total level of funding for projects and activities being considered by the Executive Committee as at 9 March 2012 amounting to US \$51.41 million including support cost there are insufficient resources available for approvals at the 66th meeting.

RECOMMENDATIONS

- 26. The Executive Committee may wish:
 - (a) To note the report on balances and availability of resources contained in document UNEP/OzL.Pro/ExCom/66/4;
 - (b) To note that the net level of funds being returned by the implementing agencies to the 66th meeting was US \$2,773,074 against projects, which included the return of US \$676,933 from UNDP, US \$52,098 from UNEP, US \$130,094 from UNIDO and US \$1,913,949 from the World Bank;
 - (c) To note that the net level of support costs being returned by the implementing agencies to the 66th meeting was US \$255,336 against projects, which included the return of US \$73,257 from UNDP, US \$6,773 from UNEP, US \$13,866 from UNIDO and US \$161,340 from the World Bank;
 - (d) To note that the return from the World Bank includes the transfer of US \$1,835,205, plus US \$154,294 in support cost from the World Bank to UNEP for the national CFC phase-out plan for the Philippines, in accordance with decision 65/10(e);
 - (e) To note that implementing agencies had balances totalling US \$1,235,799 excluding support costs, from projects completed over two years previously, which included US \$362,381 for UNDP, US \$266,972 for UNEP and US \$606,446 for UNIDO;
 - (f) To request agencies with long outstanding obligated balances on projects completed in 2005, 2006 and 2007 to return these balances as soon as possible;
 - (g) To note that the Government of France had un-obligated balances totalling US \$78,440 excluding support costs attributed to a project completed over two years previously;
 - (h) To note that UNIDO's report to the 66th meeting reflects nil un-obligated balances for completed projects as a follow up to decision 64/2(i) and 65/2(b);
 - (i) To note the net level of funds and support costs being returned by the Governments of Italy and Japan to the 66th meeting was US \$382 and US \$77,949, respectively, and to request the Treasurer to follow up with Italy and Japan on their return in cash to the Fund; and
 - (j) To note Italy's return of accrued interest of US \$260,777 as additional income to the Fund through UNIDO as its implementing agency (IA) and request the Treasurer to follow up with the IA on this return.
