2012-2014 BUSINESS PLANS AND TRANCHE SUBMISSION DELAYS

Introduction

- 1. This document considers business planning in light of approvals at the 66th meeting, submissions and recommendations for funding to the 67th meeting and allocations in the 2012-2014 business plans. Firstly, it addresses decisions taken at the 66th meeting with respect to the 2012-2014 business plans. It then indicates the extent to which approvals and submissions exceed the values in business plans for the year 2012 as well as for the planning period 2012-2014. It also covers those activities that were not submitted to the 67th meeting according to the categories required for compliance and those not required for compliance.
- 2. Pursuant to decision 53/3(c), information on submission delays is addressed in the context of the review of the implementation of business plans at the second and third Meetings of each year.
- 3. Pursuant to decision 66/6(c), the Executive Committee requested Germany to report to the 67th meeting of the Executive Committee on progress on adjusting its business plan to ensure that the total level of its activities was within the range of Germany's bilateral allocations for the 2012-2014 triennium. A section was added to this document to address this issue.
- 4. The document concludes with observations and recommendations.

2012-2014 BUSINESS PLANS OF THE MULTILATERAL FUND

Decisions taken on the 2012-2014 business plans

5. Table 1 presents the allocations for the 2012-2014 business plans as adjusted by the Executive Committee at its 66th meeting. It also includes information on multi-year agreements (MYAs) for which the Executive Committee has approved funding in principle after 2014.

Approvals at the 66th meeting and submissions to the 67th meeting

7. This section addresses the values of submissions against those in the business plans for 2012 as well as the total values of the MYAs submitted against the relevant values in the 2012-2014 business plans.

2012 business plans

8. Table 3 sets out the approvals at the 66th meeting and the submissions (excluding withdrawals) to the 67th meeting as at 5 June 2012. It indicates the extent to which these approvals and submissions either exceed, or are less than, the values assigned to them in the business plans. It shows that at its 66th meeting, the Executive Committee approved projects valued at a total of US \$6,474,834 more than that indicated in the 2012 business plans for these projects. This is due largely to the funds approved beyond the business plan values for the following HCFC phase-out management plans (HPMPs) by the amounts indicated: India (US \$2.1 million), Kuwait (US \$1.4 million), Algeria (US \$725,796) and Cote d'Ivoire (US \$594,710).

- 9. Submissions to the 67th meeting include project values amounting to US \$93,489,596 (including US \$491,636 that were not in the business plans), which is above the amount included for them in the 2012 business plans by US \$49.6 million. The submissions not included in the business plans are HCFC activities. The HCFC activities cover: an HPMP in one low-volume-consuming (LVC) country (Eritrea) where only UNIDO was listed in the business plans as the implementing agency and UNEP is now covering the non-investment components; two HPMPs in two LVC countries (Myanmar and United Republic of Tanzania (the)) where only UNEP was listed in the business plans as the implementing agency and UNIDO is now requesting the investment components; an HCFC investment project for the former Yugoslav Republic of Macedonia by UNIDO; a foam demonstration project for Turkey by UNDP; and an HPMP component for the refrigeration servicing sector and management/audit for Syrian Arab Republic by UNIDO.
- 10. Table 4 presents, by agency, the value of accounts included in the 2012 business plans and the balance of funds from projects in the 2012 business plans, which have not been submitted.

Value of projects not submitted

11. Table 5 addresses the account value remaining for activities not submitted to either the 66th or the 67th meeting, which were included in the 2012 business plans. It indicates that activities required for compliance valued at US \$86.3 million have not been submitted to either the 66th or the 67th meeting.

- 12. A detailed list of all the activities required for compliance that were not submitted this year is provided in Annex I. Annex I contains four main types of activities: HCFC activities, methyl bromide (MB) activities, institutional strengthening (IS), and project preparation activities. There are 56 HCFC activities for 24 countries valued at US \$61.6 million, and 60 IS activities valued at US \$7.3 million. There are also five project preparation activities amounting to US \$373,100, and two MB activities valued at US \$1.2 million.
- 13. A list of activities not required for compliance (with a total value of US \$1.86 million) is provided in Annex II. Annex II includes seven ODS destruction activities.

2012-2014 business plans

Table 6 sets out the approvals at the 66th meeting and the submissions (excluding withdrawals) to the 67th meeting as at 5 June 2012 for MYAs and other activities, against the values for them in the 2012-2014 business plans. It indicates the extent to which these approvals and submissions either exceed, or are less than, the values assigned to them in the business plans. It also shows that at its 66th meeting, the Executive Committee approved projects valued at a total of US \$21,327,625 more than that indicated in the 2012-2014 business plans for these projects. This is due largely to the HPMPs that had total values approved in principle more than that in the 2012-2014 business plans (including funding beyond 2014) for Argentina (8.4 million), India (US \$4.5 million) and Kuwait (4.1 million).

15. Submissions to the 67th meeting include project values amounting to US \$352,610,498, which is above the funding level included for them in the 2012-2014 business plans by US \$222,601,636. This is

due largely to the HCFC production sector in China for which US \$210 million of the total US \$280 million requested, excluding agency fees, exceeds the business plan allocation of US \$79.5 million by US \$200.5 million.

Forward commitments

16. The addendum that will be issued prior to the 67th meeting of the Executive Committee will cover this section, based on draft agreements currently under preparation. The addendum will further address the extent to which forward commitments submitted for approval at the 67th meeting correspond to the amounts associated with them in the 2012-2014 business plans.

TRANCHE SUBMISSION DELAYS

- 17. This report emanates from a history of late submissions of tranches of MYAs that resulted in delays in transferring funds and in fulfilling obligations to fund the activities required by the annual tranches. It is intended to enable the Executive Committee to encourage countries and relevant agencies to enhance their efforts to submit annual tranches as soon as possible and to address difficulties in meeting deadlines with respect to their submissions.
- 18. Seven of the 18 tranches due for consideration at the 67th meeting were submitted. Five HPMP tranches were submitted for three countries (Ghana, the former Yugoslav Republic of Macedonia and Venezuela (Bolivarian Republic of)). A methyl bromide tranche was submitted for China and the last CFC production sector tranche was submitted for India.
- 19. Table 7 presents the 11 tranches that were not submitted.

20. The reasons why the tranches were not submitted were either delays in signing the agreement for the lead agency or low disbursement/sufficient existing funds. The total value of the tranches that were not submitted was US \$14,831,567. The lead agencies indicated that these tranches will be forwarded to

the 68th meeting. The Executive Committee may wish to request the Secretariat to send a letter to these countries urging the submission of these tranches to the 68th meeting.

GERMANY'S ADJUSTED 2012-2014 BUSINESS PLAN

21. Germany's adjusted 2012-2014 business plan includes MYA activities. Twenty per cent of Germany's annual pledged contribution for 2012 amounts to US \$2,727,612. Table 8 presents a summary of the resource allocation in Germany's adjusted 2012-2014 business plan.

- 22. Germany has covered activities valued at US \$5.49 million in 2012 and a total value of US \$8.02 million over the period 2012 to 2014. The value associated with MYAs for the period 2012 to 2014 consists of US \$7.8 million for HCFC activities and US \$225,325 for MB activities. Twenty per cent of Germany's pledged contributions for the triennium is US \$8,182,837. Germany's business plan for the 2012-2014 triennium is therefore below the maximum level of bilateral contributions by US \$158,276.
- 23. The Executive Committee may wish to note that the total value of the German business plan for the 2012-2014 triennium is within Germany's allocation for bilateral activities.

OBSERVATIONS

Business plans

- 24. Table 3 indicates that the Executive Committee exceeded the allocations in the 2012-2014 business plans for the year 2012 by US \$6.5 million. These same projects exceeded the amounts for them in the business plan for 2013 and 2014 by US \$8.1 million. It should be noted that the total amount of funding available for new activities for the triennium is US \$169 million. This means that new activities in the 2012-2014 triennium that have not yet been considered will need to be reduced in total by US \$8.1 million to stay within the US \$450 million budget for the triennium.
- 25. It should also be noted that the value of projects submitted to the 67th meeting exceeds the 2012 allocation by US \$50 million, but US \$48.9 million of this is attributed to the production sector in China. Although the distribution of funding by tranche is not known, the total value of projects submitted to the 67th meeting exceeds that in the business plan for 2012 to beyond 2020 by US \$222.6 million, largely due to the production sector (over the budget by US \$200.5 million), but also a significant level for new HPMPs as well (over the budget by US \$22.1 million). The Secretariat recommends that the Executive Committee should consider that project submission values stay within business plan allocations for the 2012-2014 triennium as much as possible to enable it to provide HPMP funding for all remaining eligible countries that have not yet received funding during the current triennium.

RECOMMENDATIONS

- 26. The Executive Committee may wish to consider:
 - (a) Noting:
 - (i) The report on the status of the 2012-2014 business plans and tranche submission delays as contained in document UNEP/OzL.Pro/ExCom/67/5;
 - (ii) The information on tranche submission delays under multi-year agreements (MYAs) submitted to the Secretariat by UNDP, UNEP, UNIDO and Germany as contained in document UNEP/OzL.Pro/ExCom/67/5;
 - (iii) That seven out of 18 tranches of MYAs due for submission had been submitted on time to the 67th meeting;
 - (iv) That the total value of the German business plan for the 2012-2014 triennium is within Germany's allocation for bilateral activities;
 - (b) Staying within the business plan allocations for the 2012-2014 triennium as much as possible to enable it to provide HCFC phase-out management plan (HPMP) funding for all remaining eligible countries that have not yet received funding during the current triennium; and
 - (c) Requesting the Secretariat to send a letter to the relevant Governments to urge the submission of the second tranche of the HPMP to the 68th meeting for Brazil, Chile, Iran (Islamic Republic of), Mexico and Saint Lucia.
