## A1. Renewal of institutional strengthening projects

(a) Armenia (phase III): US \$120,000(b) Mexico (phase XI): US \$247,000

## **Project description**

3. UNIDO submitted the requests for the renewal of the institutional strengthening (IS) project for Armenia and Mexico. The description for these countries is presented in Annex I to this document.

## **Secretariat's comments**

4. The Fund Secretariat reviewed the IS terminal reports and action plans submitted by UNIDO on behalf of the Governments of Armenia and Mexico, which were provided using the revised format for IS renewals approved by decision 61/43 and noted that these countries are in compliance with the ozone depleting substances (ODS) phase-out targets and reporting requirements under the Montreal Protocol and have also submitted their country programme implementation reports for 2011, due on 1 May 2012. The Secretariat took into account decisions 59/17, 59/47(a) and 61/43 in considering these IS requests, particularly decision 61/43 where the Executive Committee decided "to maintain funding for institutional strengthening (IS) support at current levels, and to renew IS projects for the full two-year period from the 61st meeting".

#### Secretariat's recommendations

5. The Fund Secretariat recommends blanket approval of the IS renewal requests for Armenia and Mexico at the level of funding indicated in Table 1 of this document. The Executive Committee may wish to express to the Governments of Armenia and Mexico the comments which appear in Annex II to this document.

## Plan of action

3. The plan of action will include enhancing the legislation on HCFCs; collecting and analyzing ODS consumption data; improving the system of all ODS import permits by issuing more effective procedures in cooperation with Customs authorities; training and awareness activities regarding CFCs and HCFCs; training and awareness activities for the customs officers and importers; preparing reports properly and in time; and keeping the tradition of the Ozone Day annual celebrations.

## Progress report

5. Mexico reported Article 7 data to the Ozone Secretariat for the year 2011. Within the framework of the IS project, Mexico has achieved in 2011 - 2012 a remarkable phase out of its ODS consumption vis-à-vis 2005. The on-going regulatory efforts are being enhanced by the implementation of ODS monitoring system already put in place. Mexico is an active member of the Regional Ozone Network for Latin America and supports countries of the region by means of dissemination of achievements through the organization of workshops and technical visits.

## Plan of action

6. The programme of activities relating to the Montreal Protocol forms part of Mexico's commitment to phase out the consumption of ODSs in a controlled and cost-effective manner. The NOU is part of the Environmental and Natural Resources Secretariat (SEMARNAT) and cooperates closely with the General Directorate for Air Quality Management and Public Release and Transfer Registry. The NOU is the focal point for Montreal Protocol activities and these are included in the governmental system called DAS-G. The NOU mainly coordinates the whole Montreal Protocol programme in the country and prepares the basis for legislative and regulatory measures to be adopted by the responsible government authorities with a view to the HCFCs phase-out targets. The NOU is responsible for monitoring the ODS import and consumption data and has for this purpose developed the Information and Monitoring System (SISSAO). The NOU will follow-up with priority the issue of initiating measures to improve the HCFCs control, to freeze the HCFCs consumption in 2013, to achieve the 10 per cent reduction target in 2015 and to implement projects and quota system to allow meeting the 30 per cent reduction target in 2018, as per the approved phase-out schedule in the HPMP.

# VIEWS EXPRESSED BY THE EXECUTIVE COMMITTEE ON RENEWAL OF INSTITUTIONAL STRENGTHENING PROJECTS SUBMITTED TO THE 68<sup>th</sup> MEETING

#### Armenia

1. The Executive Committee reviewed the report submitted with the institutional strengthening project renewal request for Armenia and noted with appreciation that country reported 2011 Article 7 data to the Ozone Secretariat indicating that it is in compliance with the Montreal Protocol control measures. The Executive Committee also noted that within the framework of the Country Programme, Armenia has taken significant steps to control the HCFC consumption in different sectors and that illegal trade will further be pursued in close collaboration with customs, as well as awareness-raising for technicians on recovery and recycling techniques and practices, with a view to use the gained experience in the CFC phase-out programme. The Executive Committee greatly supports the efforts of the Government of Armenia and encourages it to continue its efforts with a specific view to the HCFC consumption freeze target in 2013 and 10 per cent consumption reduction to be achieved in 2015.

#### Mexico

2. The Executive Committee reviewed the report presented with the institutional strengthening project renewal request for Mexico and noted with appreciation that the country reported 2011 Article 7 data to the Ozone Secretariat indicating that it is in compliance with the Montreal Protocol control measures. The Executive Committee also noted that within the framework of the institutional strengthening project, Mexico has achieved in 2011 - 2012 a remarkable phase out of its ODS consumption vis-à-vis 2005. The Executive Committee noted with appreciation that the on-going regulatory efforts are being enhanced by the implementation of ODS monitoring system already put in place. The Executive Committee greatly supports the efforts of Mexico to meet the initial targets to freeze the consumption of HCFCs in 2013 and reduce them by 10 per cent in 2015.

## **Project Summary**

The project aims at **institutional strengthening and capacity building of the** Ministry of Nature Protection/ National Ozone Unit and will ensure helping the Government meet its obligations under the Montreal Protocol on the substances that deplete the Ozone Layer.

In this context, the National Ozone Office will be assisted in monitoring and identification of Ozone-depleting substances consumption and up-dating the needed national policies and regulations, with a focus on HCFCs consumption.

The National Ozone Unit (NOU) working within the Ministry of Nature Protection, namely within the Department of Environmental Protection, is the responsible organism in the country to carry out the activities related to the Montreal Protocol. Its activities are supervised by the First Deputy Minister of Nature Protection and the National Ozone Focal Point.

The National Ozone Unit within the Ministry of Nature Protection of Armenia (MNP) is responsible for and oversees the implementation of the project in accordance with the objectives and activities. It has a major role in the process of monitoring of the project activities. The NOU actively cooperate with ministries and inter-ministerial bodies as well as with advisory groups such as NGOs, RAC and others.

The NOU in México is considered as an integral part of the General Direction of Air Quality Management, and has a full commitment with the national administration, and has a direct contact with the vice ministry for environmental protection, mainly in order to direct the policies, strategies and priorities for México in the ozone layer protection activities.

NOU Mexico will continue to play a key role in achieving the ODS phase-out targets as well as the up-coming challenges for Art 5 Countries in view of HCFCs agreed phase-out schedule. The programme of activities relating to the Montreal Protocol forms part of Mexico's commitment to phase out the consumption of ODSs in a controlled and cost-effective manner. The National Ozone Unit is part of the Environmental and Natural Resources Secretariat (SEMARNAT) and cooperates closely with the General Directorate for Air Quality Management and Public Release and Transfer Registry.
