2013-2015 BUSINESS PLANS AND TRANCHE SUBMISSION DELAYS

Pre-session documents of the Executive Committee of the Multilateral Fund for the Implementation of the Montreal Protocol are without prejudice to any decision that the Executive Committee might take following issuance of the document.

Introduction

1. This document considers business planning in light of approvals at the 69th meeting, submissions and recommendations for funding to the 70th meeting and allocations in the 2013-2015 business plans. Firstly, it addresses decisions taken at the 69th meeting with respect to the 2013-2015 business plans. It then indicates the extent to which approvals and submissions exceed the values in business plans for the year 2013 as well as for the planning period 2013-2015.

2. It also covers those activities that were not submitted to the 70^{th} meeting according to the categories required for compliance and those not required for compliance and addresses requirements for the 2013-2015 triennium.

3. Pursuant to decision 53/3(c), information on submission delays is addressed in the context of the review of the implementation of business plans at the second and third Meetings of each year.

4. The document concludes with observations and recommendations.

BUSINESS PLANS

Decisions taken on the 2013-2015 business plans

5. Table 1 presents the allocations for the 2013-2015 business plans as adjusted by the Executive Committee at its 69th meeting. It also includes information on multi-year agreements (MYAs) for which the Executive Committee has approved funding in principle after 2015.

Approvals at the 69th meeting and submissions to the 70th meeting

7. This section addresses the values of submissions against those in the business plans for 2013 as well as the total values of the MYAs submitted against the relevant values in the 2013-2015 business plans.

2013 business plans

8. Table 3 sets out the approvals at the 69^{th} meeting and the submissions to the 70^{th} meeting as at 15 May 2013. It presents the extent to which these approvals and submissions either exceed, or are less than, the values assigned to them in the business plans. It shows that at its 69^{th} meeting, the Executive Committee approved projects valued at a total of US \$3,616,555 more than that indicated in the 2013 business plans for these projects. This is due largely to funds being approved beyond the business plan values for the HCFC production sector in China by the amounts of US \$7.7 million.

9. Table 3 also shows that at its 70th meeting, projects were submitted valued at a total of US \$541,616 below that indicated in the 2013 business plans for these projects.

Value of projects not submitted

11. Table 5 addresses the value remaining for activities not submitted to the 69^{th} or 70^{th} meeting, which were included in the 2013 business plans. It indicates that activities required for compliance valued at US \$115.5 million have not been submitted to either of these meetings.

12. A detailed list of all the activities required for compliance that have not been submitted yet this year is provided in Annex I. Annex I contains three main types of activities: HCFC activities, methyl bromide (MB) activities and institutional strengthening (IS). There are 91 HCFC activities for 58 countries valued at US \$94.5 million, three MB activities valued at US \$612,400 and 40 IS activities valued at US \$4.5 million that had not been submitted as planned during 2013. A list of activities not required for compliance (with a total value of US \$1.8 million) is provided in Annex II. Annex II includes three ODS destruction activities and one methyl bromide technical assistance activity.

2013-2015 business plans

13. Table 6 sets out the approvals at the 69^{th} meeting and the submissions to the 70^{th} meeting as at 15 May 2013 for MYAs and other activities, against the values for them in the 2013-2015 business plans. It indicates the extent to which these approvals and submissions either exceed, or are less than, the values assigned to them in the business plans. It also shows that at its 69^{th} meeting, the Executive Committee approved projects valued at a total of US \$40,712,352 below than that indicated in the 2013-2015 business plans for these projects.

2013-2015 BUSINESS PLANS, APPROVALS AND SUBMISSIONS IN 2013 (US \$)

14. Submissions to the 70th meeting include project values amounting to US \$11,438,105, which is below the funding level included for them in the 2013-2015 business plans by US \$142,937.

Forward commitments

15. Forward commitments consist *inter alia* of funding for MYAs and "other standard activities" such as IS, budget of the Fund Secretariat, Treasurer and Executive Committee meeting costs, UNEP's Compliance Assistance Programme (CAP), and the core unit costs for UNDP, UNIDO and the World Bank. Funding for "other standard activities" is based on 2013-2015 business plans taking into consideration the decisions from the 69th meeting of the Executive Committee.

16. There is no new agreement submitted to the 70^{th} meeting. The total amount of existing commitments for the period 2013 to 2031 is US \$460.35 million, including US \$176.07 million for the next triennium (2015-2017).

TRANCHE SUBMISSION DELAYS

Tranches not submitted to the 70th meeting

17. This report emanates from a history of late submissions of tranches of MYAs that resulted in delays in transferring funds and in fulfilling obligations to fund the activities required by the tranches. It is intended to enable the Executive Committee to encourage countries and relevant agencies to enhance their efforts to submit tranches as soon as possible and to address difficulties in meeting deadlines with respect to their submissions.

18. Forty-two of the 70 tranches due for consideration at the 70th meeting were submitted. Forty-one tranches of HPMPs were submitted for 28 countries. One methyl bromide tranche was also submitted.

19. Table 7 presents the 28 tranches that were not submitted.

20. The reason for delay for 15 of the 28 late tranches was the inability to meet the 20 per cent disbursement threshold. Changes in National Ozone Units (NOUs) have accounted for delays for four tranches. Delays in procurement/equipment delivery and political difficulties are the reasons for five of the delayed tranches. The methyl bromide tranche was delayed because the field tests were not completed in time for a second meeting submission. In the case of Zambia, UNEP indicated that the first priority was the completion of the terminal phase-out management plan (TPMP) before using the HPMP funds that have already been approved.

21. The World Bank indicated that it did not view the tranches for Indonesia and Viet Nam to be late since their agreements state that the tranches should be submitted not later than the last meeting of the year. The Secretariat has interpreted this to mean that the tranche may be submitted to the first meeting and that, if not, an explanation is needed.

22. The Executive Committee may wish to request the Secretariat to send a letter to these countries urging the submission of these tranches to the 71^{st} meeting, noting when the tranche was two meetings late, where applicable.

Tranches submitted but withdrawn after discussion with the Fund Secretariat

23. Table 8 presents those tranches that were submitted to the Fund Secretariat but withdrawn after review.

24. The Executive Committee may wish to note that the tranches for the HPMPs in Iran (Islamic Republic of) and Nigeria were withdrawn from consideration at the 70^{th} meeting after discussion with the Fund Secretariat. In both cases, the reason for the withdrawal was the inability to meet the 20 per cent disbursement threshold of funding for the previous tranche.

OBSERVATIONS

2013-2015 business plan and approvals at the 69th meeting

25. Approvals at the 69th meeting were US \$40,712,352 below their business plan level for 2013-2015 mostly due to the fact that the amount approved for the HCFC production phase-out management plan in China was below that indicated for it in the business plan.

2013-2015 business plans and submissions to the 70th meeting

26. Submissions to the 70th meeting include project values amounting to US \$11,438,105 which is below the funding level included for them in the 2013-2015 business plans by US \$142,937.

Forward commitments

27. The total amount of existing commitments for the period 2013 to 2031 is US \$460.35 million, including US \$176.07 million for the next triennium (2015-2017).

Tranche submission delays

28. Twenty-eight of the 70 tranches due for submission to the second meeting of the year were not submitted. The main reason for the delays was the inability to meet the 20 per cent threshold of disbursement. Information on the reason for not submitting the tranches for Indonesia and Viet Nam should be provided by the Bank during the 70^{th} meeting.

29. Four tranches were withdrawn from consideration at the 70^{th} meeting after discussion with the Fund Secretariat due to the countries' inability to meet the 20 per cent threshold of disbursement.

RECOMMENDATIONS

- 30. The Executive Committee may wish to consider:
 - (a) Noting:
 - (i) The report on the status of the 2013-2015 business plans and tranche submission delays as contained in document UNEP/OzL.Pro/ExCom/70/5;
 - (ii) The information on tranche submission delays under multi-year agreements (MYAs) submitted to the Secretariat by Germany, UNDP, UNEP and UNIDO;
 - (iii) That 42 out of 70 tranches of multi-year agreements (MYAs) due for submission had been submitted on time to the 70th meeting and that four of those tranches were withdrawn after discussion with the Fund Secretariat;
 - (b) Requesting:
 - (i) The World Bank, during the 70th meeting, to provide reasons why the tranches for Indonesia and Viet Nam had not been submitted to the 70th meeting;
 - (ii) The bilateral and implementing agencies to address those activities not submitted in 2013 as planned as contained in Annexes I and II to the current document in their 2013-2015 business plans;
 - (iii) The Secretariat:
 - a. To send letters to the governments of the countries indicated below to urge the submission of the next tranche of the MYA to the 71st meeting, noting where this is the second meeting to which the tranche could have been submitted but had not been, as applicable: Bolivia (Plurinational State of), Brazil, Central African Republic (the), Chile, China, Congo (the), Croatia, Cuba, Gabon, Guinea-Bissau, India, Indonesia, Mali, Mexico, Montenegro, Namibia, Papua New Guinea, South Africa, Togo, Trinidad and Tobago, Turkmenistan, Viet Nam and Zambia; and
 - b. To send letters to the governments of Iran (Islamic Republic of) and Nigeria to urge the submission of the next tranches of the MYA to the 71st meeting, noting that the tranches were withdrawn from consideration at the 70th meeting after discussion with the Fund Secretariat due to the countries' inability to meet the 20 per cent disbursement threshold of funding for the previous tranche.
