# SUMMARY NARRATIVE: FRANCE PROGRESS REPORT 2012



The annual progress report relates to projects implemented through the French bilateral contribution to the Multilateral Fund. It comprises an Excel database referred to as Annex 2, sent separately to the Multilateral Fund Secretariat in its second version and the current summary narrative report.

The Government of France's bilateral programme is monitored by the Secretariat of the French Global Environmental Facility (FFEM) on behalf of the Ministry of Economy, General Directorate of the Treasury and Economic Policy.

#### I. Project Approvals and Disbursements:

#### A. Annual Summary Data:

From 1994 until 31 December 2012, the Executive Committee approved 110 projects funded through the French bilateral contribution to the Multilateral Fund of the Montreal Protocol.

Expressed in their approved US\$ values, these activities amounted to US\$ \$13 972 047 and include the deduction of adjustments made through the transfer of certain activities to other implementing agencies and to the balance returns for completed projects back to the Multilateral Fund.

Support costs are not reflected in the following table, because on the one hand, they were not provided for France until July 1999. On the other hand, since support costs have been granted, the value of the disbursed support costs is calculated by applying the disbursement ratio for any given project.

The yearly distribution of the adjusted funds approved since 1994 is the following at 31/12/2012:

US\$ 12 972 047 have been disbursed, or 91 % of this total.

Of the US\$ 1 251 241 balance, it should be noted that US\$ 155 691 of completed project balances have been returned to the Multilateral Fund in February 2013, but will only be reported in the 2013 Progress report, in 2014. Other balances of completed projects will also be returned in 2013.

# II. Project Completions since the last Progress Report

One project was completed in 2012, namely Kenya's TPMP (KEN/PHA/57/INV/46).

19 projects were financially completed.

#### **IV.** Performance Indicators (INV, TAS and TRA):

Project preparation, country programs and institutional strengthening projects are not taken into account by performance indicators. Since 1994, the Government of France implemented 22 of them out of a total of 110 activities.

Finally, it was also very much involved in various meetings related to the OEWG and the Meeting of the Parties to the Montreal Protocol.
