UPDATE ON THE IMPLEMENTATION OF THE 2014-2016 BUSINESS PLAN AND CASH FLOW AVAILABILITY (DECISION 66/3)

Introduction

- 1. This document consists of:
 - Part I: An update on the status on the implementation of the 2014-2016 business plans;
 - Part II: Assessment of cash flow availability pursuant to decision 66/3(d)¹ including the extent to which funds have been allocated for the 2012-2014 triennium

PART I: STATUS ON THE IMPLEMENTATION OF THE 2014-2016 BUSINESS PLANS

Decisions taken on the 2014-2016 business plans

Table 1 presents the allocations for the 2014-2016 business plans as adjusted by the Executive Committee and the Secretariat at its 71st meeting². It also includes information on multi-year agreements (MYAs) for which the Executive Committee has approved funding in principle after 2016.

Status of implementation of the 2014 business plans

3. Table 2 sets out the submissions by agency to the 72^{nd} meeting (as at 14 April 2014), and the balance of funds from projects in the 2014 business plans. Of the total funding of US \$48,024,779 submitted to the 72^{nd} meeting, US $$1,136,650^4$ is not in the 2014 business plan.

6. A detailed list of all the activities required for compliance that have not yet been submitted is provided in Annex I to this document. These activities include: 104 HCFC activities for 49 countries valued at US \$71.8 million; three MB activities valued at US \$1.16 million; 57 IS activities valued at

US \$7 million; core unit costs for implementing agencies valued at US \$5.8 million; and 2015 CAP valued at US \$10.5 million. The list also includes three ODS destruction activities valued at US \$2.1 million and one MB technical assistance activity valued at US \$120,000, which are not required for compliance. In addition, the costs associated with the Secretariat/Executive Committee and the Treasurer have not yet been submitted.

2014-2016 business plans

7. Table 5 sets out the submissions to the 72nd meeting as at 14 April 2014 for MYAs and other activities, against the values for them in the 2014-2016 business plans. It indicates the extent to which these approvals and submissions either exceed, or are less than, the values assigned to them in the business plans.

Forward commitments

8. An addendum that will be issued prior to the 72^{nd} meeting of the Executive Committee will cover this section, based on draft agreements currently under preparation. The addendum will further address the extent to which forward commitments submitted for approval at the 72^{nd} meeting correspond to the amounts associated with them in the 2014-2016 business plans.

PART II: CASH FLOW AVAILABILITY

Payment of pledge contributions

- 9. As of 11 April 2014⁵, of the 47 non-Article 5 countries that have historically made contributions to the Multilateral Fund during the triennium, twelve countries (Azerbaijan, Belarus, Greece, Holy See, Hungary, Israel, Lithuania, Malta, Portugal, Tajikistan, Ukraine and Uzbekistan) had not made yet any payment on their 2012 and 2013 pledged contributions. These countries' pledges for the triennium amount to US \$10,797,508. The outstanding contributions of those 11 countries that were not paid in full at the end of the 2009-2011 triennium but were anticipated to be paid, were included in the calculation of the carryover of the 2012-2014 triennium⁶.
- 10. Countries that have paid contributions in the past still have contributions amounting to US \$119,563,345 (for the entire triennium, including the Russian Federation that has made for the first time a contribution amounting to US \$2,724,891 in 2013), which are expected to be paid. Part of these contributions is in promissory notes two-thirds of which may only be encashed after 2014.
- 11. Disputed contributions during the current triennium (2012 and 2013) amount to US \$3,040,288.

Fixed-exchange-rate mechanism

12. Through the end of the previous triennium, the fixed-exchange-rate mechanism (FERM) had resulted in a net gain of US \$26,752,405⁷, which had been reduced to US \$19,542,664⁸ (i.e., a reduction of US \$7,209,741).

Interest

13. US \$15.1 million from interest was included in the budget for the 2012-2014 triennium per decision XXIII/15 of the Twenty-third Meeting of the Parties⁹. The total amount of interest received from the Treasurer and the implementing agencies for the 2012 and 2013 amounts to US \$4,716,650¹⁰. In addition, the interest accrued by the Government of China from the funding approved for implementation of stage I of the HPMP amounts to US \$94,384 as of to 31 December 2012¹¹. Additional interest will be received in 2014 from undisbursed funds, which will depend upon the cash balances held as well as the interest rate obtained by the investments of the Treasurer and the implementing agencies.

Balances returned in 2012 and 2013 and expected in 2014

14. Funds from the return of unspent balances from cancelled or completed projects were not anticipated in the budget of the 2012-2014 triennium. So far a total of US \$9,878,530¹² has been returned in 2012 and 2013 for completed projects with balances. An additional US \$4,450,778 is to be returned to the 72nd meeting¹³. Additional balances will also be returned to the 73rd meeting¹⁴.

Funds approved in 2012 and 2013 and expected for 2014

15. The total funds approved for 2012 and 2013, plus the values of submissions to the 2014 and remaining activities in the business plan for 2014, and expected approvals for 2014, including Secretariat/Executive Committee and Treasurer costs amounts to US \$427.4 million as shown in Table 6.

Observations

- 16. The full budget for 2012-2014 triennium is US \$450 million. All outstanding pledges from the previous triennium that had been included in the carryover have been paid except US \$5,101,768. An additional US \$50,065,907 due from pledges for 2012 and 2013 remain outstanding as of this writing. The FERM could result in further adjustments to the value of the pledges in US dollars. Additional reductions from the business plan allocation are expected based on the process of project review.
- 17. If taking into account the approvals in 2012 and 2013, the value of submissions to the 72nd meeting and the remaining value for 2014 from the adjusted 2014-2016 business plans agreed at the 71st meeting, there remains an unallocated amount of US \$22.6 million for the 2012-2014 triennium. Although the level of interest received through 2013 is about US \$10 million less than anticipated in the budget for the triennium, project balances returned since 2012 including the 72nd meeting amount to US \$14.3 million that were not anticipated in the budget more than offset the shortfall in interest. Moreover, additional interest and balances are expected to be received during the course of 2014.
- 18. Through decision XXIII/15, the Parties of the Montreal Protocol decided "that the Executive Committee should take action to ensure, as far as possible, that the whole of the budget for 2012–2014 is committed by the end of 2014, and that parties not operating under paragraph 1 of Article 5 should make timely payments in accordance with paragraph 7 of decision XIX/6".
- 19. In this regard, the Executive Committee may wish to note that all Article 5 countries have received funding for the preparation of stage I of their HPMPs including funding for a licensing system to address HCFC control measures. The Executive Committee has also approved stage I of HPMPs for 138 countries to-date valued at US \$556.5 million (US \$393.6 million of which has been released), with implementation durations to enable the reduction levels from their baselines or starting points as follows:
 - (a) Twenty-seven countries (seven low-volume-consuming (LVC) countries, 20 non-LVC countries) address compliance for the period up to 2015;
 - (b) One-hundred and two countries (58 LVC countries and 32 non-LVC countries, plus the 12 Pacific Island Countries (PICs)) address compliance up to 2020;
 - (c) Nine LVC countries (Bhutan, Cambodia, Croatia, Maldives, Mauritius, Namibia, Papua New Guinea, Saint Vincent and the Grenadines, and Seychelles) have received funding for the complete phase-out of HCFCs well in advance of the 2040 phase-out, e.g. Croatia by 2014 and the others by 2020 or 2025.
- 20. Six of the seven remaining countries have not received HPMP funding other than for project preparation; one country (Syrian Arab Republic) received funding for a project for the phase-out of 12.9 ODP tonnes of HCFC in the refrigeration and air-conditioning sector outside its HPMP, representing 9.6 per cent of the baseline. South Sudan has ratified all of the amendments to the Montreal Protocol but has not submitted HCFC consumption data under Article 7 of the Montreal Protocol. The HPMP for Tunisia has been submitted to the 72nd meeting.¹⁵

RECOMMENDATIONS

 - (b) Requesting the Secretariat to continue to monitor cash flow availability in the update on the implementation of the 2014-2016 business plan to be submitted to the 73rd meeting.
