**INFORME SOBRE SALDOS Y DISPONIBILIDAD DE RECURSOS**

**Introducción**

1. En el presente documento se presenta una síntesis de los ajustes financieros indicados por los organismos bilaterales y de ejecución conforme a lo acordado por la Secretaría del Fondo. En atención a lo dispuesto en las decisiones 28/7 y 56/2 c), incluye datos estadísticos<sup>1</sup> de los proyectos de los organismos bilaterales y de ejecución que han mantenido saldos por un lapso superior a los 12 meses permitidos a partir de la finalización del proyecto. Así mismo aborda los saldos a reembolsar, confrontándolos con los proyectos, en cumplimiento de los incisos ii) y iii) del apartado b) de la Decisión 70/7 y del apartado b) de la Decisión 71/11, a los que en el presente se denomina como “proyectos obligados por decisión”. En consonancia con el apartado b) de la Decisión 41/92, este documento señala también el volumen de recursos a disposición del Comité Ejecutivo en efectivo y en pagarés conforme figuran en el documento<sup>2</sup> sobre la situación de las contribuciones y los desembolsos.

2. El presente documento recoge también los siguientes cinco anexos:

- Anexo V Una situación del estado en que se encuentra el reembolso de los fondos relativos a los tramos de los Planes de gestión de eliminación definitiva en curso y a los Planes nacionales de eliminación que se aprobaron antes de 2009, así como a la preparación de proyectos destinados a los Planes de gestión de eliminación de HCFC ya aprobados de los que existan saldos que no hayan sido aún reembolsados a la 72ª Reunión.

### Fondos a reembolsar a la 72ª reunión

3. La suma total de los fondos a reembolsar asciende a 4 450 778 \$EUA (es decir, 4 443 674 \$EUA a reembolsar por parte de los organismos de ejecución y 7 104 \$EUA por parte de los organismos bilaterales), suma que se deriva de proyectos ya terminados y de proyectos obligados por decisión.

### Fondos a reembolsar a la 72ª reunión por parte de los organismos de ejecución

4. Un total de 1 589 391 \$EUA, más un monto de 133 798 \$EUA en concepto de gastos de apoyo al organismo se reembolsarán de los proyectos ya terminados, y 2 490 466 \$EUA, más un monto de 230 019 \$EUA en concepto de gastos de apoyo al organismo se reembolsarán de los proyectos obligados por decisión, como figura en el Cuadro 1.

5. El Cuadro 2 recoge el número de proyectos terminados y de proyectos obligados por decisión con saldos a reembolsar en cumplimiento de decisiones y que siguen retenidos en el haber de los organismos de ejecución. Tres de los cuatro organismos de ejecución tienen en su haber saldos<sup>3</sup> remanentes de proyectos que se terminaron hace más de dos años; y todos los organismos de ejecución tienen en su haber saldos remanentes de los proyectos obligados por decisión que tendrían que haberse reembolsado a finales de 2013.

6. Las observaciones que se indican *infra* son pertinentes a los proyectos terminados hace ya más de dos años:
- El saldo del PNUD respecto de los proyectos terminados ha disminuido de 94 141 \$EUA hasta 8 332 \$EUA. El PNUD está procediendo al cierre financiero de los 10 proyectos cuyas operaciones se terminaron en 2011 y reembolsaría 8 332 \$EUA a la 73ª reunión;
  - El PNUMA tiene en su haber el mayor número de proyectos terminados hace ya más de dos años. El PNUMA es el único organismo que tiene en su haber saldos no comprometidos (65 608 \$EUA de 11 proyectos a cargo de anticipos en efectivo al PNUD y a la Comisión Económica y Social para Asia y el Pacífico (CESAP) a la espera de comprobantes entre oficinas). Estos saldos no pueden permanecer comprometidos, sino estar disponibles para poder hacer frente a las futuras facturas. El PNUMA tiene intención de reembolsar estos saldos no comprometidos cuando se produzca el cierre financiero de los proyectos;
  - La ONUDI ha terminado el proceso de cierre financiero de todos los proyectos de 2009 y 2010. Aunque la ONUDI notificó a la 71ª reunión de que cerraría el proyecto en China (CPR/PRO/INV/436) en la 72ª reunión, durante el proceso de análisis de la misma la ONUDI pasó por alto un contrato en curso sobre asistencia técnica, cuyo último pago vende en diciembre de 2015. Por ende, la ONUDI solicita la restauración del proyecto a una situación de proyecto en curso; y
  - El Banco Mundial no tiene proyectos terminados hace ya más de dos años, aunque sí retiene en su haber 2 106 228 \$EUA en saldos comprometidos de un proyecto en curso.

7. Las observaciones que se indican *infra* son pertinentes a los proyectos obligados por decisión:
- a) Todos los organismos de ejecución señalaron que el reembolso de los saldos a la 72ª reunión a cargo de algunos de los proyectos obligados por decisión, exige unos datos financieros actualizados de los que no se dispondrá antes de la preparación y presentación de los informes sobre la marcha de las actividades de 2013, que tiene que ver la luz el 1 de mayo de 2014;
  - b) Tanto el PNUMA como la ONUDI señalaron que los proyectos cuyas operaciones estén en curso están expuestos a posibles e imprevisibles cargas financieras en un futuro (por ejemplo, recibos tardíos procedentes de las oficinas locales del PNUD, reclamaciones, diferencias en los tipos de cambio de las divisas) que fueron imposible de prever en las fechas del cierre de las actividades. Por esta razón, los saldos se consideran comprometidos tras la terminación de las actividades, con objeto de asegurar que se puede hacer frente a tales cambios en consonancia con las reglas financieras de la Organización de las Naciones Unidas;
  - c) El PNUMA evocó además las restricciones a las cuentas definitivas de 2013, a cuyo cierre financiero aún no se había procedido en las fechas del requerimiento de reembolso de saldos de los proyectos en curso, así como a la carga administrativa que supone el cierre financiero de proyectos en curso; y
  - d) La ONUDI explicó que de conformidad con el párrafo h) de la Decisión 66/42, el saldo remanente de 800 000 \$EUA perteneciente al Plan nacional de eliminación para Argentina se reasignó al Plan de gestión de eliminación de HCFC; por ende, no se reembolsarán fondos correspondientes a dos proyectos (ARG/PHA/50/INV/150 y ARG/PHA/53/INV/152). El proyecto en Guatemala (GUA/FUM/59/INV/38) es un proyecto en curso por el que se reembolsan fondos parciales en respuesta al inciso iii) del apartado a) de la Decisión 71/7. De conformidad con el apartado d) de la Decisión 65/47, el Gobierno de Uruguay podría llegar a presentar un proyecto de inversión destinado a eliminar el consumo de HCFC-22 en el montaje de cámaras frías del sector de fabricación de equipos de refrigeración durante la ejecución de la etapa I del Plan de gestión de eliminación de HCFC; así pues, no se reembolsará saldo alguno respecto del proyecto (URU/REF/60/PRP/55).

8. La Secretaría pidió a todos los organismos de ejecución que presentaran la información financiera de los proyectos en curso con saldos a reembolsar que se encuentran en situación de mora y obligados por decisiones, y que lo hagan tan pronto como se actualice la información financiera de los informes sobre la marcha de las actividades que habrá de presentarse el 1 de mayo de 2014, con miras a reembolsar estos saldos a la 72ª reunión. La Secretaría pidió también a los organismos de ejecución que rellenaran un impreso de análisis de obligaciones si no fueran a reembolsarse los saldos de los proyectos obligados por decisión a las reuniones 72ª o 73ª.

#### **Fondos a reembolsar a la 72ª reunión por parte de los organismos bilaterales**

9. El Cuadro 3 recoge información sobre los reembolsos de los saldos de proyectos terminados por los Gobiernos de Italia y el Japón.

11. El Gobierno de Francia informó de que puede reembolsar en 2014 los saldos de dos proyectos terminados hace ya más de 2 años. En cumplimiento del inciso ii) del apartado d) de la Decisión 71/10, el Gobierno de Francia reembolsará los saldos remanentes del proyecto regional ejecutado en África (AFR/REF/48/DEM/36) en la primera reunión de 2015, a lo más tardar. El Gobierno de Francia está efectuando el procedimiento de verificación de los desembolsos correspondientes a dos proyectos ejecutados en la República Popular Democrática de Lao (LAO/PHA/54/INV/18 y LAO/PHA/61/INV/21) con miras al cierre financiero de las cuentas del Organismo Francés de Desarrollo y hará saber el monto definitivo una vez se haya presentado el informe de la marcha sobre las actividades.

12. El Gobierno de Italia informó de que procedía a reembolsar a la 72ª reunión el saldo remanente de un proyecto terminado en México (MEX/FUM/54/INV/137), y que obra en su haber el saldo remanente de un proyecto terminado hace ya más de 2 años.

13. El Gobierno del Japón informó de que procedía a reembolsar a la 72ª reunión los saldos remanentes de un proyecto terminado hace ya más de 2 años, pero que no reembolsará fondos de los proyectos obligados por decisión.

**Disponibilidad de recursos**

14. La situación de las contribuciones y los desembolsos indica un saldo disponible que asciende a 61 280 299 \$EUA a fecha del 11 de abril de 2014. El saldo neto total reembolsado por los organismos de ejecución, incluidos los gastos de apoyo al organismo, asciende a 4 443 674 \$EAU. El volumen total

de recursos disponible para las aprobaciones del Comité Ejecutivo en su 72ª reunión, habida cuenta del saldo en el haber del Fondo, conforme a lo que se recoge en el documento PNUMA/OzL.Pro/ExCom/72/3, y el volumen total reembolsado por los organismos de ejecución, asciende a 65 723 973 \$EAU.

## **OBSERVACIONES Y RECOMENDACIÓN DE LA SECRETARÍA**

### **OBSERVACIONES**

15. En el transcurso de la reunión de coordinación entre organismos celebrada en Montreal del 11 al 13 febrero de 2014, la Secretaría volvió a hacer hincapié en la necesidad de proceder al cierre financiero de todos los proyectos ajenos a la eliminación del consumo de HCFC o de bromuro de metilo (por ejemplo, planes de eliminación del consumo de CFC) y de reembolsar todos los saldos conexos a los proyectos ya terminados.

16. El reembolso de saldos por parte del PNUMA (989 100 \$EUA incluidos los gastos de apoyo) relativos a los proyectos ya terminados es atinente principalmente al Programa de Asistencia al Cumplimiento de 2013 (GLO/SEV/68/TAS/315). El PNUMA y la ONUDI fueron los únicos organismos que reembolsaron fondos de los proyectos obligados por decisión, tal y como sigue: ONUDI, 1 705 511 \$EAU (excluidos los gastos de apoyo al organismo) a cargo de 17 proyectos; y PNUMA, 784 955 \$EAU (excluidos los gastos de apoyo al programa) a cargo de 34 proyectos.

17. El monto de los saldos reembolsados de los proyectos obligados por decisión relativos a preparaciones de proyectos para la etapa I de los Planes de gestión de eliminación de HCFC asciende a 1 041 618 \$EAU, incluidos los gastos de apoyo al organismo. Estos saldos se distribuyen como sigue, a saber: PNUD, 291 280 \$EAU a cargo de 18 proyectos; PNUMA, 674 441 \$EAU a cargo de 53 proyectos; y ONUDI, 75 897 \$EAU a cargo de 15 proyectos. Los saldos en mora corresponden a: 15 proyectos del PNUD, 18 del PNUMA, 12 de la ONUDI y 2 del Banco Mundial.

18. Habida cuenta de que el volumen total de las finanzas destinadas a la financiación de proyectos y actividades, conforme a lo presentado a la 72ª reunión, asciende a un monto de 48 024 779 \$EAU, incluidos los gastos de apoyo, en la fecha de terminación del presente documento, se dispone de los suficientes recursos para hacer frente a las aprobaciones que tuvieron lugar durante la 72ª reunión, así como para los presupuestos de la Secretaría del Fondo y de la Oficial Superior de Supervisión y Evaluación.

### **RECOMENDACIONES**

19. El Comité Ejecutivo puede estimar oportuno:

- a) Tomar nota de:
  - i) El informe sobre los saldos y la disponibilidad de recursos que figura en el documento UNEP/OzL.Pro/ExCom/72/4;
  - ii) Que el volumen neto de fondos que los organismos de ejecución reembolsan a la 72ª reunión fue de 1 589 391 \$EUA a cargo de proyectos ya terminados, lo que incluye el reembolso de 377 453 \$EUA del PNUD, 1 088 529 \$EUA del PNUMA, y 123 409 \$EUA de la ONUDI;
  - iii) Que el volumen neto de fondos que los organismos de ejecución reembolsan a la 72ª reunión fue de 2 490 466 \$EUA a cargo de los proyectos obligados por decisión, lo que incluye el reembolso de 784 955 \$EUA del PNUMA, y 1 705 511 \$EUA de la ONUDI;

- iv) Que el volumen neto de fondos que los organismos de ejecución reembolsan a la 72ª reunión fue de 133 798 \$EUA a cargo de los proyectos terminados, lo que incluye el reembolso de 28 823 \$EUA del PNUD, 95 717 \$EUA del PNUMA, y 9 258 \$EUA de la ONUDI;
  - v) Que el volumen neto de fondos que los organismos de ejecución reembolsan a la 72ª reunión fue de 230 019 \$EUA a cargo de los proyectos obligados por decisión, lo que incluye el reembolso de 102 045 \$EUA del PNUMA, y 127 974 \$EUA de la ONUDI;
  - vi) Que los organismos de ejecución tienen saldos que ascienden a un total de 307 766 \$EUA, excluidos los gastos de apoyo, de proyectos terminados hace ya más de dos años, lo que incluye 8 332 \$EUA en el haber del PNUD, 138 187 \$EUA en el haber del PNUMA y 161 247 \$EUA en el haber de la ONUDI;
  - vii) Que el PNUD está procediendo al cierre financiero de 10 proyectos cuyas operaciones se terminaron en 2011 y tiene intención de reembolsar a la 73ª reunión los saldos remanentes de US \$8,332;
  - viii) Que el Gobierno de Francia tiene en su haber los saldos remanentes de dos proyectos terminados hace ya más de dos años y que aún no se han reembolsado al Fondo, por un total que asciende a 308 920 \$EUA, excluidos los gastos de apoyo, y que dichos saldos se reembolsarían en 2014;
  - ix) Que el Gobierno de Italia tiene en su haber los saldos remanentes de un proyecto terminado hace ya más de dos años y que aún no se ha reembolsado al Fondo, saldo que asciende a un total de 2 677 \$EUA, excluidos los gastos de apoyo;
  - x) Que el volumen neto de fondos y gastos de apoyo que los organismos de ejecución reembolsan a la 72ª reunión asciende a 7 104 \$EUA, lo que incluye el reembolso de 6 725 \$EUA del Gobierno de Italia y 379 \$EUA del Gobierno del Japón, lo que se compensará a cargo de futuros proyectos; y
  - xi) Que la ONUDI ha solicitado que se restaure el proyecto en China (CPR/PRO/INV/436) a una situación de “en curso” a raíz de tener aún vigencia un contrato sobre asistencia técnica cuyo último pago vence en diciembre de 2015; y
- b) Pedir a:
- i) Los organismos de ejecución que tengan proyectos terminados hace ya más de dos años que reembolsen los saldos remanentes a la mayor brevedad posible;
  - ii) Los organismos de ejecución que actualicen la información sobre los saldos a cargo de proyectos obligados por decisión antes de celebrarse la 72ª reunión, y faciliten a la 72ª reunión una actualización sobre los reembolsos de tales saldos; y
  - iii) Al PNUMA que reembolse a la 73ª reunión todos los saldos no comprometidos.
