TENTATIVE DATES AND VENUES OF EXECUTIVE COMMITTEE MEETINGS IN 2015

1. This document presents potential dates for Executive Committee meetings in 2015. The tentative dates of the meetings of the Executive Committee have been proposed based on two meeting per year scenario, and taking into account the tentative dates of other environment-related meetings, namely:

- The 12th meeting of the Conference of the Parties (COP) to the Basel Convention, 7th meeting of the COP to the Rotterdam Convention, and 7th meeting of the COP to the Stockholm Convention (Geneva, Switzerland, 3-14 May 2015);
- The 48th meeting of the Global Environment Facility (GEF) Council (Washington DC, United States of America, 2-4 June 2015);
- United Nations Framework Convention on Climate Change (UNFCCC). First sessional period in 2015 (Venue to be decided, 3-14 June 2015);
- 54th meeting of the Implementation Committee Under the Non-Compliance Procedure of the Montreal Protocol (Geneva, Switzerland, 10-11 July 2015);
- 35th meeting of the Open-Ended Working Group of the Parties to the Montreal Protocol (Geneva, Switzerland, 13-17 July 2015); and
- UNFCCC. 21st session of the Conference of the Parties and the 11th session of the Conference of the Parties serving as the meeting of the Parties to the Kyoto Protocol (Paris, France, 30 November - 11 December 2015).

2. The dates and venues for the 7th session of the Intergovernmental Negotiating Committee on Mercury (INC 7), and the 27th meeting of the Parties to the Montreal Protocol and related meetings have not been decided.

74th meeting of the Executive Committee:

3. The Secretariat considered the following three options for the dates of the 74th meeting:

Option 1: *15 to 19 June 2015:* Meeting facilities at the International Civil Aviation Organization (ICAO) are not available.

Option 2: *22 to 26 June 2015:* A tentative booking has been made at the ICAO premises. A final booking is pending a decision from the Executive Committee.

Option 3: *29 June to 3 July 2015:* Meeting facilities at ICAO are not available.

75th meeting of the Executive Committee:

4. The Secretariat considered the following two options for the dates of the 75th meeting:

Option 1: *23 to 27 November 2015:* A tentative booking has been made at the ICAO premises. A final booking is pending a decision from the Executive Committee.

Option 2: *30 November to 4 December 2015:* Meeting facilities at ICAO are not available.
