**État du Fonds au 8 octobre 2014  
Rapport du Trésorier**

1. Le présent document fournit des informations sur l'état du Fonds<sup>1</sup> enregistré au PNUE au 8 octobre 2014. Il contient les tableaux suivants:

2. Au 8 octobre 2014, le solde du fonds s'établissait à 76 544 874 \$US. Cette somme représente le solde net après avoir pris en compte tous les financements approuvés par le Comité exécutif jusqu'à la 72<sup>e</sup> réunion comprise.

<sup>1</sup> Le Comité exécutif a demandé que l'explication de la méthode et des hypothèses utilisées par le Trésorier soit publiée sur l'intranet (décision 40/2(b)(i)). Ce dossier des hypothèses et des méthodes, publié pour la première fois dans le rapport du Trésorier UNEP/OzL.Pro/ExCom/39/3/Rév.1, est encore à la disposition des membres du Comité exécutif, aux fins de référence, dans la zone d'accès restreint du site Internet du Fonds multilatéral.

3. En réponse aux décisions XI/6, paragraphe 7, (incitant les Parties à verser leur contribution aussi tôt que possible dans l'année civile), XVII/41, paragraphe 5, (incitant les Parties à verser la totalité de leur contribution le plus tôt possible), et XVI/37 (incitant certaines Parties qui n'avaient jamais versé leur contribution au Fonds, ou qui n'en avait versé qu'une partie, de la verser le plus tôt possible), le Trésorier a envoyé au début du mois d'octobre 2014 des factures de rappel à toutes les Parties dont les contributions étaient en souffrance, les informant de leurs contributions annoncées et en leur rappelant leurs obligations. Au 8 octobre 2014, 31 Parties avaient versé l'intégralité ou une partie de leur contribution de 2014, ce qui représentait 51 pour cent de la totalité des versements dus pour 2014. En accord avec la décision 41/2, la liste des contributions en souffrance pour certains pays dont l'économie est en transition sera disponible sur demande.

4. En réponse à la décision XXIII/16, paragraphes 1 et 2, (d'étendre le mécanisme de taux de change fixe à la période 2012-2014) et à la décision 66/1(b) (incitant les Parties à informer le Trésorier de leur intention d'utiliser le mécanisme de taux de change fixe), les données sur le mécanisme de taux de change fixe ont été mises à jour et elles indiquent un gain net de 19 335 876 \$US attribuable à ce mécanisme depuis sa création.

#### Suivi de la décision 71/2(d) sur les contributions en souffrance

5. En réponse à la décision 72/1(d)<sup>2</sup>, le Trésorier, en concertation avec le Secrétariat, a eu des entretiens avec les représentants du Saint-Siège et du gouvernement du Kazakhstan au sujet de leurs contributions au Fonds en souffrance, résumés ci-dessous:

- (a) Des entretiens ont eu lieu à Nairobi avec l'Observateur permanent du Saint-Siège auprès du PNUÉ et d'ONU-Habitat, lors desquels le représentant a fait savoir que cette question avait été transférée à leurs bureaux centraux, à Rome. Toutefois la réponse du Saint-Siège sur cette question demeure en souffrance; et
- (b) Plusieurs entrevues ont eu lieu avec le représentant du gouvernement du Kazakhstan, notamment en marge de 34<sup>e</sup> Groupe de travail à composition non limitée des Parties au Protocole de Montréal (Paris, 14-18 juillet 2014). Le 6 août 2014, le Trésorier a également fourni des clarifications en réponse à des questions soulevées dans une lettre du gouvernement reçue le 10 juillet 2014. On attend la réaction du gouvernement.

## **RECOMMANDATIONS**

6. Le Comité exécutif pourrait envisager de:

- (a) Prendre note du rapport du Trésorier sur l'état des contributions et des décaissements ainsi que des informations sur les billets à ordre contenus dans le document UNEP/OzL.Pro/ExCom/73/3;
- (b) Inciter toutes les Parties à verser l'intégralité de leurs contributions au Fonds multilatéral dans les meilleurs délais possibles; et
- (c) Demander au Trésorier, en concertation avec le Secrétariat du Fonds, de poursuivre avec le Saint-Siège et le gouvernement du Kazakhstan le suivi sur leurs contributions en souffrance et d'en rendre compte au Comité exécutif à sa 74<sup>e</sup> réunion.
