DATES AND VENUES OF THE 77TH AND 78TH MEETINGS OF THE EXECUTIVE COMMITTEE

77th meeting

1. By decision 75/75 the Executive Committee decided to hold its 77th meeting in Montreal from 28 November to 2 December 2016. Arrangements are being made to hold the meeting in a suitable meeting venue.

78th meeting

2. By decision 73/70(b), the Executive Committee decided to continue convening two meetings per year from 2015 onwards with the possibility of holding an additional brief meeting, if required, between those meetings to consider project proposals.

3. The document on the review of the operation of the Executive Committee¹ prepared pursuant to decision 73/70(h) proposes that the Committee continue convening two meetings from 2017 onwards, preferably in the second or third week of June for the first meeting, and in late November or the first week of December for the second meeting, with the possibility of holding an additional brief meeting if required to consider project proposals or specific requests from the Parties to the Montreal Protocol.

4. The Executive Committee may also wish to note the tentative dates for other environment related meetings taking place in 2017^2 , so far available on the website namely:

- 52nd meeting of the Global Environment Facility Council from 22 to 25 May 2017, Washington, D.C., United States of America; and
- 23rd session of the Conference of the Parties (COP 23) to the United Nations Framework Convention on Climate Change from 6 to 17 November 2017, Asia.

Option 2: 12 to 16 June 2017 in Montreal
