REPORT ON BALANCES AND AVAILABILITY OF RESOURCES

Introduction

1. This document presents a summary of financial adjustments indicated by the bilateral (BAs) and implementing agencies (IAs) as agreed by the Secretariat. It includes statistical data¹ from all projects with balances that have been held for over 12-month following completion of the project, as required by decisions 28/7 and 56/2(c). It addresses balances to be returned against projects as a follow-up to decisions 70/7(b)(ii) and (iii) and 71/11(b) (referred to as "by-decision" projects in this document). It also indicates the level of resources available to the Executive Committee in cash and promissory notes as recorded in the status of contributions and disbursements document², as required by decision 41/92(b).

2. This document also contains the following three annexes:

Funds to be returned

3. The total funds to be returned to the 77th meeting amount to US \$929,737 (i.e. US \$66,266 by BAs and US \$863,471 by IAs) from completed projects and by-decision projects. Annexes I and II include justifications submitted by the BAs and IAs on the delays in disbursing committed amounts or returning not-committed amounts.

Funds to be returned to the 77th meeting by IAs

4. The total funds to be returned by IAs amount to US \$863,471 from completed and by-decision projects as shown in Table 1.

- 8. With regard to balances held by BAs:
 - The Government of Germany is applying the not-committed balances of US \$1,989 (a) under one completed project, and of US \$149,090 under two ongoing projects in line with decision $76/8(a)(iii)^7$, against its bilateral projects submitted to the 77^{th} meeting if they were approved;
 - (b) The Government of Italy's not-committed balances of US \$17,327 of four completed projects will be returned in cash subject to update from the Government of Italy at the 77th meeting;
 - The Government of Japan's committed balances of US \$1,048,692 of two by-(c) decisions projects are pending futher consultation; and

(d) The Government of Spain's balances of two completed projects of US \$15,600 in support costs would be offset against bilateral projects that would be submitted to a future meeting.

Availability of resources

9. The status of contributions and disbursements indicates an available balance amounting to US \$100,819,568 as at 28 October 2016. The total net balance returned by IAs, including agency support costs is US \$863,471. The total level of resources available for approvals by the Executive Committee at its meeting, after taking into account the Fund's balance and the total amount returned by IAs is US \$101,683,039.

Secretariat's comments

10. During the Inter-agency coordination meeting⁸ the Secretariat reminded BAs and IAs that balances associated with completed and by-decisions projects should be returned to the Multilateral Fund no later than the 77^{th} meeting. BAs and IAs committed to continue with their efforts to return funds as soon as possible and to provide an update to the 77^{th} meeting with a view to returning additional balances.

11. Considering that the total level of funding for projects and activities as submitted to the 77^{th} meeting, amounts to US \$162,565,718 including agency support costs⁹, there are insufficient resources available for approvals at the 77^{th} meeting. However, this information will be updated during the 77^{th} meeting and will depend on the level of projects approvals at the 77^{th} meeting particularly with respect to stage II of the HPMP for China.

Recommendations

- 12. The Executive Committee may wish:
 - (a) To note:
 - (i) The report on balances and availability of resources contained in document UNEP/OzL.Pro/ExCom/77/4;
 - (ii) That the net level of funds being returned to the 77th meeting by the implementing agencies was US \$863,471, consisting of US \$244,115, plus agency support costs of US \$17,643 from UNDP; US \$126,301, plus agency support costs of US \$17,643 from UNEP; US \$42,829, plus agency support costs of US \$2,664 from UNIDO; and US \$411,441 of agency support costs of from the World Bank;
 - (iii) That the net level of funds being returned to the 77th meeting by the bilateral agencies was US \$66,266, consisting of US \$59,486, plus agency support costs of US \$6,544 from the Government of Italy and US \$209, plus agency support costs of US \$27 from the Government of Japan;
 - (iv) That UNEP had balances of US \$138,818, excluding support costs for nine projects completed over two years previously;

- (v) That UNIDO had balances of US \$137,311, excluding support costs for one projects completed over two years previously;
- (vi) That the Government of Germany's not-committed balances for one completed and two ongoing projects, totaling US \$1,989 and US \$149,090, including agency support costs, would be offset against bilateral projects submitted to the 77th meeting, if they were approved by the Executive Committee;
- (vii) That the Government of Italy's not-committed balances for four completed projects totaling US \$17,327, including agency support costs, would be returned in cash subject to update from the Governement of Italy to the 77th meeting;
- (viii) That the Government of Spain's balances for two completed projects over two years totaling US \$15,600 in agency support costs, would be offset against bilateral projects that would be submitted to a future meeting;
- (b) To request:
 - (i) Bilateral agencies and implementing agencies and with projects completed over two years previously to return the balances to the 78th meeting;
 - Bilateral and implementing agencies to disburse or to cancel commitments not needed for completed projects and project completed by-decision of the Executive Committee in order to return balances to the 78th meeting; and
 - (iii) UNEP to return not-committed balance to the 78th meeting.
