PROJECT DESCRIPTION

1. On behalf of the Government of Angola, UNDP as the designated implementing agency has submitted to the 77th meeting a request for funding for the fourth and final tranche of stage I of the HCFC phase-out management plan (HPMP), at the amount of US \$19,556, plus agency support costs of US \$1,760. The submission¹ includes a progress report on the implementation of the third tranche, and the tranche implementation plan for 2016 to 2017.

Report on HCFC consumption

HCFC consumption

2. The Government of Angola reported a consumption of 13.79 ODP tonnes of HCFC in 2015. The 2011-2015 HCFC consumption is shown in Table 1.

3. While the HCFC consumption has slightly increased in 2015 due to the continuous increase in the demand for refrigeration and air-conditioning equipment, it was already 10.34 mt (0.57 ODP tonnes) below the allowable level of consumption for the year.

Country programme (CP) implementation report

4. The Government of Angola reported HCFC sector consumption data under the 2015 CP implementation report that is consistent with the data reported under Article 7.

Progress report on the implementation of the third tranche of the HPMP

Legal framework

5. The HCFC licensing and quota system has been continuously enforced by the Ministry of Environment in collaboration with other stakeholders to ensure compliance with the Montreal Protocol.

Refrigeration servicing sector

- 6. The following activities have been implemented:
 - (a) The Government has established differentiated tariffs to create incentives for the introduction of refrigerants with low-global warming potential (GWP);
 - (b) Tools and equipment have been purchased for technicians to enable good servicing practices in refrigerant recovery and reuse. Equipment distribution and training in their use will be conducted during the fourth tranche; and

(c) Awareness-raising materials have been developed in Portuguese and distributed to technicians.

Project implementation and monitoring unit (PMU)

7. Project monitoring and coordination of activities were conducted to ensure efficient and effective implementation of the HPMP.

Level of fund disbursement

8. As of September 2016, of the US \$156,444 approved so far, US \$137,354 had been disbursed. The balance of US \$19,090 will be disbursed in the last quarter of 2016 (Table 2).

Implementation plan for the fourth tranche of the HPMP

- 9. The following activities will be undertaken:
 - (a) Launching the online licensing and quota system for HCFC imports/exports to strengthen the national capacity for ODS monitoring (US \$3,000);
 - (b) Training of 80 technicians in good practices and refrigerant recovery, reuse and recycling, servicing with alternatives refrigerantes (e.g., hydrocarbons (HCs) and HFOs); developing a training module for end-users; distributing the equipment previously purchased and providing training in their use; (US \$10,000);
 - (c) Developing and distributing awareness-raising materials to provide information on HCFC alternatives, good practices and the safe handling of flammable refrigerants (US \$5,556); and
 - (d) Project coordination, monitoring and reporting (US \$1,000).

SECRETARIAT'S COMMENTS AND RECOMMENDATION

COMMENTS

Progress report on the implementation of the second tranche of the HPMP

Legal framework

10. The Government of Angola has already issued HCFC import quotas for 2016 in accordance with the Montreal Protocol control targets. The quota in 2017 will remain the same as in 2016.

Refrigeration servicing sector

11. With regard to the increase in HCFC consumption in 2015, UNDP explained that although the import of HCFC-based equipment is licensed, the quota for their import has not been applied. The Govrnment is considering to control the import of HCFC-based equipment in the near future.

12. In responding to a query from the Secretariat, UNDP confirmed that drop-in or retrofit practices with flammable refrigerants are not being pursued at this stage in Angola. Training in servicing equipment using flammable refrigerants (HCs and HFOs) and equipment for personal protection, as well as equipment for detecting flammable gases will be provided to technicians to ensure a safe transition to these technologies; noting that new equipment based on HC-refrigerants might be imported into the country.

Conclusion

13. HCFC consumption in Angola was below the control targets set in the Agreement for 2015 and the import quota have been issued for 2016 and 2017. Angola has integrated the ODS issues into the customs training and the curriculum is reviewed regularly to integrate new requirements into the training manual; the launching of the online licensing and quota system will enhance the national capacity for ODS monitoring. The established training centers will provide on-going support to technicians to ensure sustainability. The disbursement rate has reached 88 per cent of overall funding. The progress achieved in implementation and the activities included in the proposed plan will enable the country to meet the Montreal Protocol targets. All the activities planned for stage I of the HPMP will be operational completed by the end of 2017 and an project completion report will be submitted in 2018. Stage II of the HPMP will be submitted in 2017.

RECOMMENDATION

- 14. The Fund Secretariat recommends that the Executive Committee:
 - (a) Takes note of the progress report on the implementation of the third tranche of stage I of the HCFC phase-out management plan of (HPMP) for Angola; and
 - (b) Requests the Government of Angola and UNDP to submit the project completion report to the second meeting of the Executive Committee in 2018.
- 15. The Fund Secretariat further recommends blanket approval of the fourth tranche of stage I of the HPMP for Angola, and the corresponding 2016-2017 tranche implementation plan, at the funding level shown in the table below, on the understanding that if Angola were to decide to proceed with retrofits and associated servicing to flammable and toxic refrigerants in refrigeration and air-conditioning equipment originally designed for non-flammable substances, it would do so assuming all associated responsibilities and risks and only in accordance with the relevant standards and protocols:
