**STATUS OF ADDITIONAL CONTRIBUTIONS TO THE MULTILATERAL FUND
(DECISION 79/42(c))
Report from the Treasurer**

1. The present document provides information on the status of additional contributions pledged by a group of donor countries intended to provide fast-start support for the implementation of the HFC phase-down, pursuant to decision 79/42(c).
2. As at 11 October 2017, the Treasurer has received US \$3,233,878 from seven countries. The list of countries' pledged amount together with payments received is attached as Annex I to this document.

Recommendations

3. The Executive Committee may wish:
 - (a) To note the report of the Treasurer on the status of additional contributions to the Multilateral Fund as contained in document UNEP/OzL.Pro/ExCom/80/53;
 - (b) To note with appreciation the seven non-Article 5 countries that had made payments to provide fast-start support for the implementation of the HFC phase-down; and
 - (c) To request the Treasurer to continue reporting the status of the additional contributions received for fast-start support separately from other pledged contributions to the Multilateral Fund to the 81st meeting.
