STATUS OF ADDITIONAL CONTRIBUTIONS TO THE MULTILATERAL FUND AND AVAILABILITY OF RESOURCES (DECISION 82/3(b))

Report from the Treasurer

- 1. As at 7 August 2018, the Treasurer has received US \$25,513,071 which represents the total amount of additional contributions paid by 17 non-Article 5 countries.
- 2. Following the approval of activities for fast-start support for HFC phase-down by the Executive Committee, the Treasurer disbursed US \$25,503,180 to implementing agencies including funding approved under bilateral cooperation from Germany and Italy, resulting in a balance of US \$9,891.
- 3. At its 79th meeting, the Executive Committee approved US \$100,000 to undertake an evaluation of cost effective and environmentally sustainable options of HFC-23 destruction from HCFC-22 production facilities (decision 79/47(e)). The evaluation has been completed at a total cost of US \$81,997, resulting in a balance of US \$18,003.
- 4. The accumulated interest accrued from the additional contributions up to 31 December 2018 amounts to US \$251,138. In line with standard accounting practices and the standard agreements between the Treasurer and the donor countries who opted to sign an agreement with the Treasurer, any interest revenue attributable to the additional contributions shall be credited as income to the Multilateral Fund and shall be utilized in accordance with the policies and guidelines of the Executive Committee.
- 5. Therefore, the total amount available for programming additional HFC phase-down activities is US \$279,032.

Recommendations

- 7. The Executive Committee may wish:
 - (a) To note the report of the Treasurer on the status of additional contributions to the Multilateral Fund and availability of resources contained in document UNEP/OzL.Pro/ExCom/83/5; and
 - (b) To request the Treasurer, to submit to the 84th meeting, as part of the 2018 accounts of the Multilateral Fund, a certified statement of income and disbursements of the additional contributions for fast-start support for the implementation of the HFC phase-down, separately from the regular contributions to the Multilateral Fund.
