EXECUTIVE COMMITTEE OF THE MULTILATERAL FUND FOR THE IMPLEMENTATION OF THE MONTREAL PROTOCOL Eighty-eighth Meeting Montreal, 15-19 November 2021¹

BILATERAL AGENCIES' BUSINESS PLANS FOR 2022–2024

Introduction

1. The following bilateral agencies submitted business plans for 2022–2024² to the 88th meeting: Germany, Japan and the United Kingdom of Great Britain and Northern Ireland.³ Although Australia, Austria and France did not officially submit a business plan, the present document has included a table with the allocation of resources for these countries based on activities associated with HCFC phase-out management plans (HPMPs) approved in principle.

2. Bilateral agencies intend to have activities in 15 Article 5 countries, namely: Brazil, Burkina Faso, China, Colombia, Honduras, India, Islamic Republic of Iran, Kenya, Lesotho, Liberia, Mauritius, Mongolia, Namibia, Papua New Guinea and Seychelles; and one regional activity for the Pacific Island countries (PIC) at a value of US \$5,660,768. An additional US \$859,226 would be requested for the period after 2024 as shown in Table 1.⁴

² Given the constraints imposed by the COVID-19 pandemic, the Secretariat's comments on the initial submission of the bilateral agencies' business plan for 2022-2024 were addressed through bilateral discussions and numerous exchanges of electronic messages. All issues were satisfactorily addressed.

³ Bilateral cooperation may be considered as a contribution to the Multilateral Fund up to a value of 20 per cent of a country's annual pledge to the Fund. The Executive Committee decided to allow flexibility in the year for which bilateral projects would be credited, provided that bilateral agencies submitted their work plans at the beginning of the year in time for consideration during discussions of the business plans at the Committee's first meeting of the year (decision 25/13(a)). Bilateral cooperation by other non-Article 5 Parties, such as Canada, the Czechia, Finland, Israel, Italy, Poland, Portugal, Russian Federation, Spain, Sweden, Switzerland and the United States of America did not submit bilateral business plans and the total value of bilateral activities could increase in the event of such submissions.

COMMENTS

3. The Secretariat reviewed each bilateral agency's business plan, provided comments on several of the proposed activities, and assessed the value of the activities against their annual pledged contributions.⁵

Australia

4. The resource allocation in Australia's business plan for 2022–2024 is presented in Table 2. Assuming the level of pledged contribution similar to the 2018–2020 period, 20 per cent of Australia's annual pledged contribution for 2022 amounts to US \$1,177,933.

Austria

5. The resource allocation in Austria's business plan for 2022–2024 is presented in Table 3. Assuming the level of pledged contribution similar to the 2018–2020 period, 20 per cent of Austria's annual pledged contribution for 2022 amounts to US \$362,900 or US \$1,088,700 for the 2021–2023 triennium. Taking into account the submission to the 88th meeting (US \$391,833) if approved as planned, and the adjusted business plans values for 2023 (US \$783,667), Austria would exceed 20 per cent of the pledged contribution for the 2021-2023 triennium by US \$86,800. The potential over-programming has been brought to the attention of the Government of Austria, and will be addressed once the Parties agree on the level of the replenishment of the Multilateral Fund for the 2021–2023 triennium.

France

6. The resource allocation in France's business plan for 2022–2024 is presented in Table 4. Assuming the level of pledged contribution similar to the 2018–2020 period, 20 per cent of France's annual pledged contribution for 2022 amounts to US \$2,449,100.

- 8. Germany's business plan included the following activities:
 - (a) Approved stages I and II of HPMPs amounting to US \$3.56 million, of which US \$2.98 million for 2022–2024; the Secretariat proposes an adjustment by increasing US \$666,018 for 2022-2024, to reflect the amounts approved in principle under the Agreements of the respective HPMPs;

- (b) Stage III of the HPMP for one non-low-volume-consuming country amounting to US \$422,650 in 2023, in line with decision 84/46(e);⁶
- (c) Preparation for a KIP⁷ for one country (Papua New Guinea) amounting to US \$85,000 in 2022; this country has not ratified the Kigali Amendment, but has submitted the required letter indicating the intent of the Government to make best efforts to ratify the Amendment;
- (d) KIPs for four countries (Burkina Faso, Liberia, Mauritius and Papua New Guinea), amounting to US \$400,000; in line with decision 84/46(g),8 one country (Papua New Guinea) has not ratified the Kigali Amendment and has been removed from the business plan;
- (e) An institutional strengthening project for one country (Papua New Guinea) amounting to US \$30,000 for after 2024; the Secretariat proposes an adjustment by decreasing US \$30,000 to remove values after 2024; and
- (f) HPMP verification for two countries (Mauritius and Papua New Guinea) amounting to US \$60,000 in 2023. Since the funding for these activities has already been included in the HPMP verification budget in the consolidated business plan for 2022-2024, he Secretariat proposes an adjustment by decreasing US \$60,000 in 2023.
- 9. Table 6 presents the results of the Secretariat's proposed adjustments to Germany's business plan.

⁷ Funding for the preparation of national implementation plans to meet initial reduction obligations for the phase-down of HFCs could be provided, at the earliest, five years prior to those obligations, after a country had ratified the Kigali Amendment and on the basis of guidelines to be approved in the future (decision 79/46(b)(iii)). In addition, decision 84/46(f) allowed the inclusion of HFC phase-down preparation activities in the business plan for countries that had not ratified the Kigali Amendment but had submitted a letter indicating their Government's intent to make best efforts to ratify the Kigali Amendment. The guidelines for the preparation of KIPs were approved at the 87th meeting (decision 87/50).

10. Assuming the level of pledged contribution similar to the 2018-2020 period, 20 per cent of Germany's annual pledged contribution for 2022 amounts to US \$3,220,267 or US \$9,660,800 for the 2021–2023 triennium. Taking into account approvals at the 87th meeting (US \$1,102,511), the submissions to the 88th meeting (US \$3,214,121 if approved as planned), and the adjusted business plans values for 2022 and 2023 (US \$3,968,632), Germany will not exceed 20 per cent of pledged contributions for the 2021-2023 triennium.

Japan

The resource allocation in Japan's business plan for 2022–2024 is presented in Table 7. Assuming 11. the level of pledged contribution similar to the 2018–2020 period, 20 per cent of Japan's annual pledged contribution for 2022 amounts to US \$4,879,033.

United Kingdom of Great Britain and Northern Ireland

The resource allocation in the United Kingdom of Great Britain and Northern Ireland's business plan for 2022-2024 is presented in Table 8. Assuming the level of pledged contribution similar to the 2018-2020 period, 20 per cent of the United Kingdom of Great Britain and Northern Ireland's annual pledged contribution for 2022 amounts to US \$2,249,500.

Adjustments to bilateral agencies' business plans for 2022–2024

The adjustments to the bilateral business plan for 2022–2024 were based on relevant decisions of 14. the Executive Committee. Further adjustments may be required pending a decision by the Parties on the level of the replenishment of the Multilateral Fund for the 2021-2023 triennium.¹¹

15. After making the adjustments proposed above, the total value of bilateral agencies' business plans for 2022–2024 is US \$6,166,786 as shown in Table 9. These adjustments have been introduced in the consolidated business plan of the Multilateral Fund for 2022–2024. 12
