DATES AND VENUES OF THE 93RD MEETING OF THE EXECUTIVE COMMITTEE

93rd meeting

1. At its 91st meeting, by decision 91/73(b) the Executive Committee decided to hold the 93rd meeting from 11 to 15 December 2023, in Montreal, Canada, at the International Civil Aviation Organization (ICAO).

2. After the confirmation of the venue and dates of the 28th Conference of the Parties to the UN Framework Convention on Climate Change which will take place in Dubai, United Arab Emirates, from 30 November to 12 December 2023, several members of the Committee had requested the Secretariat to explore alternative options for the 93rd meeting. The Secretariat therefore would like to present for the consideration of the Executive Committee the following alternative options on dates and venues for holding the meeting:

Option 1: 20 to 24 November 2023 in Montreal, Canada, at ICAO.

Option 2: 30 October to 3 November 2023 in Nairobi, Kenya, following the 35th Meeting of the Parties to the Montreal Protocol.

Other meetings

3. While noting that other meetings are yet to be confirmed, the Executive Committee may wish to take into consideration the dates for the following meetings taking place in the last quarter of 2023:

- 30 October to 3 November 2023: Fifth meeting of the Conference of the Parties to the Minamata Convention on Mercury (COP-5) in Geneva, Switzerland.
- 13 to 17 November 2023: Third session of the Intergovernmental Negotiating Committee on Plastic Pollution in Nairobi, Kenya.

Recommendation

- 4. The Executive Committee may wish to consider convening its 93rd meeting:
 - (a) In Montreal, Canada, at the International Civil Aviation Organization from 11 to 15 December 2023 in line with decision 91/73(b); or
 - (b) In Montreal, Canada, at the International Civil Aviation Organization from 20 to 24 November 2023; or
 - (c) In Nairobi, Kenya, at UNEP headquarters, from 30 October to 3 November 2023.
