SECRETARIAT ACTIVITIES

1. This document reports on the activities undertaken by the Fund Secretariat since the 26th Meeting of the Executive Committee.

Notification of the Decisions of the Twenty-sixth Meeting of the Executive Committee

Article 5 countries

2. Decisions taken by the Executive Committee at its 26th Meeting regarding project approvals and other relevant decisions were communicated to the governments of the Article 5 countries concerned.

Transfer of resources from the Multilateral Fund

3. Resources covering all funding requests approved at the Twenty-sixth Meeting were transferred to the implementing agencies in accordance with decision 26/35 on resource allocations.

Completion of the technical audit of the ODS production sector in India and China

4. The final reports on the technical audits of CFC production plants in China and India were received by the Secretariat in December 1998. The reports were subsequently dispatched to members of the Subgroup on the Production Sector for its consideration at the meeting which was held in Paris in January 1999.

Review of submissions to the 27th Meeting

Bilateral cooperation

5. The Secretariat processed 26 requests under bilateral co-operation and provided comments and recommendations where necessary.

Investment projects

6. 71 investment projects submitted by UNDP, UNIDO and the World Bank were evaluated by the Secretariat according to the established guidelines and criteria. Project evaluation sheets and recommendations, as appropriate, are submitted for consideration of the Executive Committee.

Country programmes

7. The Secretariat reviewed and commented on the country programmes of Bosnia and Herzegovina, Democratic Republic of Congo and Qatar.

Work programmes

8. The Secretariat reviewed and commented on the 166 activities included in the 1999 Work programme amendments of UNEP and the 1999 Work programmes of UNDP and UNIDO and the World Bank.

1999 business plans

9. The Secretariat reviewed and consolidated the 1999 business plans of UNDP, UNEP, UNIDO and the World Bank, as well as business plans of Belgium, Canada, Finland, France, Germany, Japan, New Zealand and Sweden.

Draft monitoring and evaluation work programme for 1999

10. This document was prepared by the Senior Evaluation Officer on the basis of the approved 1997-1998 work programme.

Project completion reports

11. The Senior Evaluation Officer prepared a status report on the project completion reports received from the implementing agencies since the 26^{th} Meeting.

China solvent sector plan

12. The Secretariat reviewed and commented on the draft Phase-out plan for the solvent sector in China submitted by UNDP.

15. The Secretariat participated in the UNEP Informal Advisory Group meeting in January 1999 and made a substantive presentation.

16. The Chief Officer attended the Governing Council meeting of UNEP in February 1999.

Preparation for the Twenty-seventh Meeting of the Executive Committee and its Sub-Committees

The Secretariat has arranged for the Meetings of the Sub-Committee on Project Review, the Monitoring, Evaluation and Finance Sub-Committee, the Subgroup on the Production Sector, and the 27th Meeting of the Executive Committee to be held in Montreal, Canada. Letters of invitation and meeting documentation have been dispatched to members of the Executive Committee, the President of the Bureau, the implementing agencies and to NGOs.

20. The Senior Monitoring and Evaluation Officer joined the Secretariat on 1 February 1999.
