EXECUTIVE COMMITTEE OF THE MULTILATERAL FUND FOR THE IMPLEMENTATION OF THE MONTREAL PROTOCOL Thirtieth Meeting Montreal, 29-31 March 2000

SECRETARIAT ACTIVITIES

1. This document reports on the activities undertaken by the Fund Secretariat since the 29<sup>th</sup> Meeting of the Executive Committee.

# Notification of the Decisions of the 29<sup>th</sup> Meeting of the Executive Committee

#### Article 5 countries

2. Decisions taken by the Executive Committee at its 29<sup>th</sup> Meeting regarding project approvals and other relevant decisions were communicated to the governments of Article 5 Parties concerned.

#### Transfer of resources from the Multilateral Fund

3. Resources covering all funding requests approved at the 29<sup>th</sup> Meeting were transferred to the implementing agencies; approved bilateral activities were credited to the contributions of the countries concerned as pertinent.

# Review of submissions to the 30<sup>th</sup> Meeting

#### **Bilateral co-operation**

4. The Fund Secretariat processed 13 requests under bilateral co-operation and provided comments and recommendations where necessary.

#### Investment projects

5. 11 investment projects submitted by UNDP, UNIDO and the World Bank were evaluated by the Fund Secretariat according to the established guidelines and criteria. Of the 11 projects, 7 projects were considered at the 29<sup>th</sup> Meeting and the Executive Committee agreed that they should be submitted to the 30<sup>th</sup> Meeting as part of the agencies' 1999 business plans. The remaining projects are for recovery and recycling components of refrigerant management plans, and for release of the second tranches for CFC production sector. Project Evaluation sheets and recommendations, as appropriate, are submitted for consideration of the Executive Committee.

#### Country programme

6. The Fund Secretariat reviewed and commented on 1 country programme and on the update of China's Country Programme.

#### 2000 business plans

7. The Fund Secretariat reviewed and commented on the 2000 business plans of UNEP, UNDP, UNIDO and the World Bank which were subsequently consolidated in the document titled "Consolidated 2000 business plan of the Multilateral Fund".

#### 2000 business plans for bilateral cooperation

8. The Secretariat reviewed and provided comments and recommendations on the 2000 business plans of Australia, Canada, the Czech Republic, Denmark, France, Germany, Japan, New Zealand, Sweden and the United Kingdom.

#### 2000 Work programme and amendments

9. The Fund Secretariat reviewed and commented on the 102 activities submitted by UNDP, UNIDO and the World Bank in their 2000 Work programmes and 43 activities submitted by UNEP as amendments to its 2000 Work programme.

### Monitoring and Evaluation

10. The Senior Monitoring and Evaluation Officer prepared final reports and draft follow-up action plans for the evaluations of refrigeration and institutional strengthening projects. The final reports drew on the discussions during the workshop held in accordance with Decision 29/14 in Montreal (6-8 February 2000) to review the formats of project completion reports.

11. A desk evaluation study on Regional Networks was prepared. An in-depth desk study on training projects was elaborated in order to prepare field missions that are scheduled for March and April 2000. Finally, a review has been carried out of the existing documentation concerning recovery and recycling projects. The results have been integrated into a paper on the possibility of preparing a desk study on recovery and recycling projects during the Year 2000, which has been presented to the Executive Committee as document 30/9.

#### Consolidated report on sectoral ODS consumption data

12. As a follow-up on Decisions 28/25 and 29/10 which requested data on sector distribution of ODS baseline consumption of Article 5 countries, the Secretariat consolidated the inputs submitted by the implementing agencies and is presenting the results to the  $30^{\text{th}}$  Meeting of the Executive Committee.

# Planning for the 30<sup>th</sup> Meeting of the Executive Committee

The Secretariat communicated to the implementing agencies the various actions required to be undertaken by them and by the Secretariat as a result of decisions taken at the  $29^{th}$  Meeting of the Executive Committee as well as actions outstanding from reports of earlier meetings of the Committee.

15. The Secretariat convened a coordination meeting in Montreal with the representatives of the Implementing Agencies (9-11 February 2000) to discuss, inter alia, their submissions to the  $30^{\text{th}}$  Meeting.

#### **Missions undertaken**

16. During the reporting period, the Secretariat participated in the Informal Advisory Group Meeting organized by UNEP (Paris, 19-21 January 2000) and in the Workshop on Refrigerant Management Plans organized by the facilitator of the contact group (Paris, 22 January 2000).

17. The Fund Secretariat reviewed and updated the following databases, documents and operational guidelines:

# Preparation for the meetings of the Executive Committee and its Sub-Committees during the year 2000

### <u>30<sup>th</sup> Meeting</u>

18. The Fund Secretariat has arranged for the Meetings of the Sub-Committee on Project Review, the Monitoring, Evaluation and Finance Sub-Committee and the 30<sup>th</sup> Meeting of the Executive Committee to be held in Montreal, Canada. Letters of invitation and meeting documentation have been dispatched to members of the Executive Committee, the President of the Bureau, the implementing agencies, the Ozone and GEF Secretariats and other observers.

#### 31<sup>st</sup> Meeting

19. The Secretariat, in cooperation with the Ozone Secretariat and the United Nations Office in Geneva, are finalizing arrangements for the possibility of holding the Thirty-first Meeting (3-7 July 2000) back-to-back with the Open-ended Working Group meeting (10-14 July 2000).

### 32<sup>nd</sup> Meeting

20. The Secretariat is coordinating with the Ozone Secretariat arrangements for holding the Thirty-second Meeting in conjunction with the Twelfth Meeting of the Parties in Burkina Faso.
