9. The Secretariat and UNIDO concluded discussions on the calculation of incremental operational costs of the project and reached agreement based on the following prices:

CFC-11:	US \$1.30/kg
HCFC-141b:	US \$2.40/kg
CFC-based polyol:	US \$1.32/kg
HCFC-based polyol:	US \$2.15/kg

However, in view of developments in the polyurethane industry in China it would be necessary to keep prices of polyurethane chemicals under periodic review.

10. The agreed project costs are as follows:
