EXECUTIVE COMMITTEE OF THE MULTILATERAL FUND FOR THE IMPLEMENTATION OF THE MONTREAL PROTOCOL Thirty-third Meeting Montreal, 28-30 March 2001

COMPLETED PROJECTS WITH BALANCES

#### Introduction

1. In its review of the progress reports submitted to the 28<sup>th</sup> Meeting of the Executive Committee, the Secretariat identified several projects that had been completed 12 months previously but had significant levels of remaining balances from the funds approved by the Executive Committee. The Executive Committee subsequently requested reports on these balances.

2. At its 31<sup>st</sup> Meeting, the Executive Committee adopted the following guidelines for the return of unobligated balances from completed projects:

- (a) Implementing agencies should return remaining unobligated (unencumbered) balances as soon as possible, but not later than one year following project completion, with the amount returned specified by project;
- (b) Implementing agencies should report on the reasons why any unobligated (unencumbered) balances could not be returned within the required time-frame and when they would be returned;
- (c) Full accounting of funds returned during the calendar year of reporting should be provided by project in the annual progress and financial reports (Decision 31/2 a))
- 3. A format was developed for applying the above guidelines.

4. This document provides a summary of the submissions of the implementing agencies and bilateral agencies on projects with completed balances and the return of funds from cancelled projects. It provides the submissions of the implementing agencies in the format required by the guidelines (see Annexes I through IV).

#### **Summary of Submissions**

5. All implementing and relevant bilateral agencies submitted information on projects that were identified in the progress reports submitted to the 31<sup>st</sup> Meeting, as completed projects that were completed over one year ago (December 1999) that had remaining unspent balances.

#### Implementing agencies

6. The implementing agencies have indicated that they will be returning a total of US 4,768,882 to the  $33^{rd}$  Meeting from completed projects with balances, and unobligated funds from cancelled projects. The following table indicates the level of funds being returned by agency.

7. Both UNDP and UNIDO had remaining balances from previously cancelled projects. UNDP indicated that it had remaining balances of US \$1,342,888 in three cancelled projects (CPR/REF/23/INV/233 (US\$731,205), EGY/FOA/15/INV/36 (US\$536,003), and PER/REF/15/INV/04 (US\$75,680)), but that all of these funds had been obligated.

8. For the project TUR/FOA/23/INV/31, UNIDO indicates that the remaining balance for this cancelled project is US \$363,535, but that all of these funds had been obligated. However, UNIDO indicated that for the project ARG/REF/22/INV/58, the remaining balances of US \$358,751 are unobligated. UNIDO indicated that these funds could be credited to the Fund only after settlement of all pending financial closure of the project, but that it expected to return unobligated funds to the 35<sup>th</sup> Meeting.

9. The total amount of unobligated balances is as follows for the four implementing agencies:

10. Implementing agencies had unobligated balances totalling US 2,344,560 for projects completed through 1999, US 2,180,740 of which was attributed to UNIDO. The level of unobligated balances for projects completed 12 months previously was reduced from US 6.4 at the  $32^{nd}$  Meeting to US 2.3 million at the  $33^{rd}$  Meeting.

11. The World Bank has one project, completed in December 1999, with remaining unobligated balances. The Bank indicated that it was holding US \$163,820 in unobligated balances for the project IDS/REF/20/INV/48 pending the final determination of the incremental operating costs.

12. UNIDO has 98 projects, completed through 1999, with remaining unobligated balances. UNIDO indicates that the balances of 56 projects of these projects will be returned to the 35<sup>th</sup> Meeting. Balances from 27 projects will be returned to the 36<sup>th</sup> Meeting. UNIDO did not indicate when balances would be returned for 16 projects.

13. The main reasons UNIDO indicated that it could not return unobligated balances are as shown in the following table.

14. The Secretariat requested further clarification about the difference between the main three reasons. UNIDO provided the following definitions:

Reason 2: Financial completion initiated means that the process of financial completion is already underway—was initiated some days, weeks or months ago;

Reason 3: Financial completion being initiated means that all project activities were completed and the process of financial completion is being/will be initiated with the next few days; and

Reason 4: Financial completion to be initiated after satisfactory completion of pending/ongoing activities means that some activities are still to be carried out (e.g. nitrogen generator to be procured) or are underway (negotiations and interventions related to demurrage charges in Kenya).

15. Some other reasons for why unobligated balances are being held until satisfactory completion of pending activities include: post-conversion consultancy services for data collection and reporting (3 projects); safety issues being addressed (6 projects); and guarantee issues (6 projects). It should be noted that reporting requirements are normally part of the administrative costs of the implementing agencies.

#### Kenya demurrage issue

16. In its comment on the project KEN/ARS/19/INV/11, UNIDO indicates that there is a balance of US \$445 in unobligated funds for the project and the issue of tax exemption and demurrage charges is still not fully solved.

17. UNIDO informed the Government of Kenya and the Fund Secretariat prior to the 30<sup>th</sup> Meeting of the Executive Committee that equipment purchased with resources of the Multilateral Fund was being held at the Port of Mombassa. This was initially thought to be a result of confusion over the tax and duties exemption granted by the Government for the equipment. Demurrage charges were incurred pending the resolution of the exemption. Subsequently, UNIDO agreed to pay the demurrage charges out of its own resources, but then discovered that the equipment for which the demurrage charges were incurred, was sold.

18. At its  $30^{\text{th}}$  Meeting, the Executive Committee decided to withhold future funding for projects in Kenya pending resolution of the UNIDO demurrage charge issue (Decision 30/12). At its  $31^{\text{st}}$  Meeting, the Executive Committee requested UNIDO to pursue the demurrage charge issue in Kenya and report to the Executive Committee (Decision 31/3).

19. During his mission to UNEP's Governing Council Meeting in Nairobi in February, the Chief Officer and a representative of UNIDO met with the Minister of the Environment of Kenya. The Minister confirmed to the Chief Officer that the problem would be resolved within days.

20. Following an update from UNIDO on the matter, the Executive Committee may wish to consider if the issue has been resolved.

## Bilateral agencies

21. The Governments of Australia, Canada, and the United States of America provided reports on their completed projects with balances. All reports indicated that all remaining funds had been disbursed.

22. France indicated that, per its project completion report, the project LEB/REF/23/INV/22 had a remaining unobligated balance of US \$13,443 (FF 78,201). A report on Denmark's bilateral project CPR/REF/17/TAS/130 indicates that the project has a remaining unobligated balance of US \$43,947.

23. Both governments have been requested to indicate if these funds should be reduced from the amount of bilateral contributions or credited against future approvals. As of this writing, 22 February 2001, the Secretariat has not received an indication concerning the disposition of these balances.

## RECOMMENDATIONS

The Sub-Committee on Monitoring, Evaluation, and Finance may wish to consider recommending to the Executive Committee:

- 1. To note with appreciation the reports on completed projects with balances from the Governments of Australia, Canada, Denmark, France, and the United States of America and the four implementing agencies.
- 2. To note the levels of funds being returned to the 33<sup>rd</sup> Meeting as indicated in paragraph 9 above.
- 3. To request a report from UNIDO on the Kenya demurrage charge issue and determine if Decision 30/12 should continue to be applied.
