# 3. 2000 accounts of the Multilateral Fund

<u>Documents UNEP/OzL.Pro/ExCom/34/6</u>: This document summarises the audited accounts of the Fund for the years 1991-1999 and the certified accounts for the year 2000.

<u>Action expected from the Sub-Committee</u>: The Sub-Committee may wish to recommend to the Executive Committee to:

• take note of the Accounts of the Multilateral Fund for the years 1991-1999 and the certified accounts for the year 2000.

# 4. Completed projects with balances

<u>Document UNEP/OzL.Pro/ExCom/34/7 and Corr.1</u>: contains the submission of the implementing agencies on completed projects with balances and the return of funds from cancelled projects.

## Issues to be addressed:

- Agencies returning US \$6,567,895 of which US \$3,972,789 is from cancelled projects.
- UNEP did not provide an update and did not return the US \$98,228 it promised at the 33<sup>rd</sup> Meeting to return to the 34<sup>th</sup> Meeting.
- UNDP did not specify the level of unobligated projects in its report.
- UNIDO reported that 53 per cent of its unobligated balances totalling US \$1,331,636 would be returned after completion of ongoing activities.
- Implementing agencies may have additional announcements about funds to be returned.

- 1. Note the reports on completed projects with balances submitted by UNDP, UNIDO and the World Bank contained in UNEP/OzL.Pro/ExCom/34/7.
- 2. Request UNEP to ensure that an updated report is submitted to the 35<sup>th</sup> Meeting and return the approved funding to the Multilateral Fund.

## 5. Project Implementation delays

<u>Document UNEP/OzL.Pro/ExCom/34/8</u>: contains an assessment of progress on projects which the Executive Committee requested to be closely monitored at the 33<sup>rd</sup> Meeting as well as those projects for which deadlines were established and those for which letters of possible cancellation were sent to Governments concerned. It also presents additional requests for project cancellations.

### Issues to be addressed:

- Removal of projects from the list of projects with implementation delays or their continued monitoring.
- Actions on projects with some progress but were approved over three years ago.
- Cancellation of projects for not achieving the deadlines established by the Committee.
- Establishment of deadlines or notices of cancellation for some projects.
- Cancellation of projects recommended for cancellation.
- UNEP's request to cancel its SME training modules project.

<u>Action expected from the Sub-Committee</u>: The Sub-Committee may wish to recommend to the Executive Committee to:

- 1. Note the Consolidated Progress Report of the Multilateral Fund contained in UNEP/OzL.Pro/ExCom/34/9.
- 2. Request the implementing agencies to provide reports to the 35<sup>th</sup> Meeting on the projects with implementation delays indicated in the annex of the Consolidated Progress Report.
- 3. Urge the following countries, for which their ongoing projects are projected to be delayed over two years, to take actions to expedite their projects' implementation: Kiribati, Solomon Islands, Vanuatu, Papua New Guinea, Marshall Islands, Tuvalu, Mozambique, Bahamas, Botswana, Egypt, Cameroon, Guyana, Central African Republic, Mauritius, and Bolivia.

1. Noting with appreciation the progress reports submitted by the Governments of Australia, Belgium, Canada, Finland, France, Germany, Japan, Sweden, the United Kingdom, and the United States of America contained in UNEP/OzL.Pro/ExCom/34/10.

- 2. Requesting the Government of Switzerland to provide its progress report to the 35<sup>th</sup> Meeting of the Executive Committee in the context of projects with implementation delays.

- 2. - Change of ownership for the Whirlpool of India refrigeration project (IND/REF/27/INV/204).
- Implementation delays for the pilot concessional loan project with EGAT in Thailand.
- China halon sector plan--exceeding 2000 work programme consumption agreement.
- Delayed submission of CFC national phase-out plans.
- Changes to completed status.

<u>Action expected from the Sub-Committee</u>: The Sub-Committee may wish to recommend to the Executive Committee to:

1. Note the World Bank's progress report contained in (UNEP/OzL.Pro/ExCom/34/14).

- 2. Note the late submission of the World Bank's revised progress report and request the World Bank to adhere to the deadline for submission.
- 3. Request the World Bank to remove all indirect phase-out from its progress report in the future and request it to resolve all issues raised by the Secretariat concerning data inconsistencies and report back to the 35<sup>th</sup> Meeting on their resolution and the impact on its progress report.
- 4. Note that the World Bank will report to the 35<sup>th</sup> Meeting on up to 73 projects with implementation delays including 8 projects that were so classified last year.
- 5. Request the World Bank to provide an additional status report on the institutional strengthening project with slow implementation in Turkey.
- 6. Note that the World Bank should offset US \$6,057 against its administrative costs and request the Bank to adjust the (US \$54,861 to US \$224,861) overrun for the Jordan line of grant in the light of Decision 17/22.
- 7. Set deadlines for the following projects:
  - (a) "Zhengshou Plastic foam project in China" (CPR/FOA/15/INV/86)—deadline of 1 September 2001 for the resolution of the legal issues of the Huayuan Group related to the implementation of the project.
  - (b) "BPL refrigeration project in India" (IND/REF/25/INV/183)—deadline of 1 September for the signature of the sub-grant agreement.
  - (c) "Candi Swadaya Sentosa aerosol project in Indonesia" (IDS/ARS/22/INV/61)—deadline of 1 September 2001 for the procurement of equipment with the automatic refund of remaining balances if the deadline is not achieved.
  - (d) "Sea Horse Maspion foam project in Indonesia" (IDS/FOA/23/INV/76)—deadline of 1 September 2001 for the submission of progress reports to the Government of Indonesia or the automatic cancellation of this project and full return of approved funds if the deadline is not achieved.
  - (e) "Umbrella rigid foam project in Pakistan" (PAK/FOA/23/INV/20)—set an appropriate milestone deadline following a report from the Bank on its June 2001 mission;

- 9. Request the World Bank to implement Decision 19/38(b) concerning the "Whirlpool of India refrigeration project" (IND/REF/27/INV/204) and reduce the grant component accordingly and return the funds to the 35<sup>th</sup> Meeting.

- 10. Request the World Bank to provide the Executive Committee with a report, at its 34<sup>th</sup> Meeting on the EGAT project in Thailand (THA/REF/26/INV/104) including how it can achieve its targeted refund by December 2002 and request an updated report to the 35<sup>th</sup> Meeting on new project milestones for this project.
- 11. Note the agreement of the Government of China and the World Bank to reduce the 2001 quotas for the halon plan by the excess national consumption in 2000 to be determined by an independent technical audit and the agreement on measures to remedy the export issue with regard to the China halon sector plan.
- 12. Note the planned submission dates of the national CFC phase-out projects for Malaysia and Thailand.
- 13. Note the World Bank's explanations about its classification of projects as completed and the cancellation of projects without the return of project funding for the line of grant projects.

## 7. Evaluation of the implementation of the 2000 business plans

<u>Document UNEP/OzL.Pro/ExCom/34/15</u>: presents the evaluation of the 2000 business plans of the implementing agencies and the recommendations of the Secretariat.

## Issues to be addressed:

- Need to ensure investment projects in business plans are delivered in year of the plan.
- Missing indicator assessment for indicators unique to UNEP.
- Missing non-weighted non-investment project indicators from the implementing agencies.
- The increasing number of non-investment projects with implementation delays.
- Need for expedited project implementation.
- Contingency lists for non-investment projects.

- 1. Note UNEP's report on its missing indicators per Decision 26/6.
- 2. Note the report of the implementing agencies on their performance on their non-weighted non-investment performance indicators per Decision 26/5.
- 3. Not allow contingency lists for non-investment projects.
- 4. Note that the Multilateral Fund did not achieve its 2000 phase out target, decide, for the purposes of the 2002 draft business plans, to encourage the implementing agencies to concentrate on the implementation of approved but unimplemented projects and reduce the number of projects with implementation delays.

- 5. Request agencies presenting investment project proposals to the Executive Committee to ensure that the countries in their business plans are covered and present their proposals during calendar year of the plan.
- 6. Request agencies involved in non-investment activities to concentrate on project implementation to reduce the backlog of unimplemented projects.
- 8. Status of Article 5 Countries in Achieving Compliance with the Initial Control Measures of the Montreal Protocol, An Analysis by the Fund Secretariat as per Decision 32/76;

<u>Document UNEP/OzL.Pro/ExCom/34/16</u>: contains two parts that address Decision 32/76. Part I includes three sections. Section A presents an updated analysis of the status of compliance. Section B presents ODS consumption by sector as reported by Article 5 countries in their reports on the status of implementation of their country programmes. Part II address the impact of non-investment projects on the status of compliance of Article 5 countries.

## Issues to be addressed:

- Additional phase out is needed with remaining consumption mostly in the refrigeration foam, process agent and solvent sectors.
- Consumption increased from 1999 to 2000 despite the additional phase out from approved projects that were completed in 1999 for Colombia, Mexico, Peru, and Sri Lanka.

<u>Action expected from the Sub-Committee</u>: The Sub-Committee may wish to recommend to the Executive Committee to:

- 1. Note the report;
- 2. Request the following countries to clarify the increase in consumption from 1999 to 2000 despite the additional phase out from approved projects that were completed in 1999: Colombia, Mexico, Peru, and Sri Lanka; and
- 3. Request the implementing and bilateral agencies to take into consideration the sector analysis contained in this report for the purposes of planning activities for their 2002 draft business plans.

## 9. Report on evaluation of completed compressor projects in China;

<u>Document UNEP/OzL.Pro/ExCom/34/17</u>: The document presents the main findings and recommendations, resulting from an evaluation of seven completed compressor projects in China.

## Issues to be addressed:

- Insufficient production, capacity utilisation and indirect phase-out for commercial refrigeration compressor projects (COM); continued production of CFC compressors for domestic refrigeration compressor projects (DOM);
- Oversized capacity of funded equipment for COM projects;
- Difficult search for technology supplier and problems of cooperation and communication;
- Implementation delays for COM projects and first DOM conversion to hydrocarbons;
- Missing government actions for creating favourable incentives for conversion;
- Incorrect data in some PCRs;
- Unclear and insufficient information on overall situation in the sector.

<u>Action expected from the Sub-Committee</u>: The Sub-Committee may wish to recommend to the Executive Committee to:

- 1. Take note of the findings and lessons learnt contained in the evaluation report.
- 2. To request the Government of China to assess the additional needs for non-CFC domestic and commercial refrigeration compressors over and above the capacities already converted which are partly under-utilized. The assessment should take into account the pace of conversion of the refrigeration industry, the existing and future demand for CFC-compressors for servicing purposes, as well as the financial viability of the would be beneficiary enterprises.
- 3. To consider future proposals in this sector in the light of this assessment;
- 4. To request SEPA to examine, in cooperation with the World Bank, the possibilities for relocating idle or under-utilized machining centres in commercial refrigeration compressor projects to compressor companies with better prospects for achieving a satisfactory rate of capacity utilization and cost-effectiveness;
- 5. To request the implementing agencies to monitor continuously the conversion process of ongoing compressor projects and inform the Secretariat and the Executive Committee about any significant deviations in their progress reports;
- 6. To request the implementing agencies concerned to revise the PCRs and to resubmit them in cases where the evaluation found discrepancies between the PCR and project reality;
- 7. To urge the relevant implementing agencies to take into consideration the findings and lessons learnt presented in the evaluation report when preparing future proposals for compressor projects.
