## 5. Issues identified during project review

The issues are listed below, together with references to the relevant paragraphs in the Overview Paper, (UNEP/OzL.Pro/ExCom/35/20 and Corr.1):

- (a) Review of guidelines for liquid carbon dioxide (LCD) technology in foam projects (paragraphs 4 to 7)
- (b) Inclusion of additional projects in existing methyl bromide phase-out agreements (paragraph 8)

- (c) Unreported consumption from illegal imports (paragraph 9)
- (d) Funding for technology transfer and trials: implementation of Decisions 33/2 (j) and (k) and 34/16 (paragraphs 10 to 14)
- (e) Projects with data discrepancies: implementation of Decision 34/18 (paragraphs 15 and 16)
- (f) Format for reporting undertakings by countries: Decision 34/14 (d) (paragraph 17)
- (g) Thailand institutional strengthening project: change of implementing agency (paragraph 18)

The Sub-Committee may wish to make recommendations on the issues raised.

## 6. Bilateral co-operation (UNEP/OzL.Pro/ExCom/35/21 & Corr.1)

Eight proposals have been reviewed by the Secretariat and recommended for blanket approval (UNEP/OzL.Pro/ExCom/SCPR/24/2). Four proposals from the Governments of Germany have been referred for individual consideration or are still under discussion. The issues concerning each proposal are outlined in the Secretariat's comments contained in the above document.

The Sub-Committee may wish to recommend the 8 proposals for approval and make further recommendations as appropriate on the other 4 proposals.

#### 7. Work programmes:

- (a) Work programme amendment of UNDP (UNEP/OzL.Pro/ExCom//35/22)
- (b) Work programme amendment of UNEP (UNEP/OzL.Pro/ExCom/35/23)
- (c) Work programme amendment of UNIDO (UNEP/OzL.Pro/ExCom/35/24)
- (d) Work programme amendment of the World Bank (UNEP/OzL.Pro/ExCom/35/25)
- (e) Work programme of UNEP for 2002 (UNEP/OzL.Pro/ExCom/35/26)
- (f) Work programme advances for UNDP, UNIDO, and the World Bank for the year 2002 (UNEP/OzL.Pro/ExCom/35/27)

All of the proposed activities are recommended for blanket approval (UNEP/OzL.Pro/ExCom/SCPR/24/2) except five activities in UNEP's work programme amendment which are referred for individual consideration and UNEP's 2002 work programme. The issues associated with these activities are described in the Secretariat's comments on the 2002 work programme and the work programme amendments of UNEP in the documents indicated above.

The Sub-Committee may wish to (i) endorse the recommendations for blanket approval for activities contained in the work programme amendments for UNDP, UNEP, UNIDO and the World Bank; (ii) make recommendations for the 5 activities with issues in UNEP's work programme amendments on the basis of the information provided in the documentation and the briefing provided by the Secretariat at the meeting; and (iii) consider UNEP's 2002 work programme in the light of information to be provided by the Secretariat on consideration of UNEP's 2002 business plan by the Sub-Committee on Monitoring, Evaluation and Finance.

## 8. Investment projects:

Investment projects, sectoral strategies and associated implementation plans from the governments of 29 countries are presented for consideration by the Sub-Committee on Project Review. The project descriptions and the comments and recommendations of the Fund Secretariat on these projects are contained in documents UNEP/OzL.Pro/ExCom/35/28 to 35/57.

(a) Investment projects recommended for blanket approval

115 activities are recommended for blanket approval in document UNEP/OzL.Pro/ExCom/SCPR/24/2. (Sub-Committee members might note that the document also contains those projects and activities arising from bilateral co-operation and from work programmes of the implementing agencies which were recommended for blanket approval. These activities were considered in the preceding agenda items)

The Sub-Committee is invited to recommend that the investment projects on the list be approved.

(b) Projects for individual consideration

Annex I to this paper contains 12 projects and 9 sector strategies/phase-out plans listed for individual consideration, with a total value of US \$37,315,926 as requested. Each issue is addressed in the Secretariat's evaluation sheet included in the relevant country project document.

The first projects on the list are 3 foam projects to install liquid carbon dioxide technology. These projects should be dealt with according to the conclusions reached on Agenda Item 5 (a) above.

Reviews of the next two projects, in the process agent sector in India and Pakistan, were not completed prior to dispatch of documentation. The incremental cost of each project has now been agreed with UNIDO. However, consistent with usual practice in the process agent sector, the projects have been maintained on the list of projects for individual consideration. The next two projects, in the solvent sector in DPR Korea, are referred for individual consideration on the basis of the comments outlined by the Secretariat in the evaluation sheet.

The remaining five projects are all in the in the fumigant sector (methyl bromide). There is one project for each of the following countries: Bolivia, Croatia, Costa Rica, Turkey and Zimbabwe. Cost and eligibility issues have been resolved in all the projects with the exception of the project for Costa Rica in which the export component has not been taken into consideration. The projects are being submitted for individual consideration consistent with usual practice in the methyl bromide sector. The draft agreements have also been completed for all the projects, except the project for Zimbabwe that has a policy issue on consumption levels. This issue was considered under Agenda Item 5(b) above. The project from Zimbabwe should be considered in the light of the Sub-Committee's conclusions on the policy issue.

This concludes the individual projects. The following sector strategies and plans, included in Annex I, are also for individual consideration:
