COMMENTS AND RECOMMENDATIONS FROM THE FUND SECRETARIAT

- 1. In its Work Programme for 2002, UNIDO is requesting approval from the Executive Committee of US \$2,280,000 for project preparation plus agency support costs of US \$296,400. A project preparation advance for UNIDO's 2002 work programme was approved at the Executive Committee's 35th Meeting in the amount of US \$199,163 (including support costs). The total amount of funds to be transferred to UNIDO will be adjusted by the amount of the advance.
- 2. The activities proposed in UNIDO's 2002 Work Programme are presented in Table 1 below:

3. The Fund Secretariat reviewed the 2002 Work Programme of UNIDO in light of the business plan for the year 2002 of UNIDO (UNEP/OzL.Pro/ExCom/36/12), the 2002 Work Programmes of UNDP (UNEP/OzL.Pro/ExCom/36/20) and the World Bank (UNEP/OzL.Pro/ExCom/36/22), and the 2002 Work Programme Amendments of UNEP (UNEP/OzL.Pro/ExCom/36/19).

SECTION A. ACTIVITIES RECOMMENDED FOR BLANKET APPROVAL

4. The Fund Secretariat <u>recommends</u> blanket approval of the projects listed in Section A of Table 1 above at the level of funding indicated in Table 1, with provisos as indicated in paragraphs 5 to 16 below for the following specific activities:

Albania: Preparation of a national ODS phase-out plan (US \$40,000)

5. The Secretariat pointed out that UNEP submitted for consideration by the Executive Committee at its 35th Meeting, the Albania country programme together with the RMP project proposal. The country programme was deferred based on policy issues raised by the Secretariat, and therefore, the RMP was also deferred (the RMP was prepared on the basis of Decision 31/48).

Recommendation

- 6. The Fund Secretariat recommends blanket approval of the above project with associated support costs at the funding level shown in Table 1, on the understanding that:
 - (a) The national ODS phase-out plan will be submitted together with the Albania country programme, and will address all ODSs used in the country, including the refrigeration servicing sector;
 - (b) Implementation of the projects and activities identified in the national ODS phase-out plan will be co-ordinated with UNEP;
 - (c) No additional funding will be requested from the Multilateral Fund for the preparation of project proposals.

Argentina: Strategy for the preparation of an RMP (US \$100,000)

- 7. The Secretariat pointed out that the Executive Committee has already approved a number of activities normally included in RMP projects, in particular policy assistance for the design and implementation of an ODS import/export licensing system; training programme for the refrigeration servicing sector and training programme for customs officers.
- 8. The training programme for service technicians was approved with the understanding that this project will mark the end of the training for service technicians (further training requirements, if any, would be expected to be minimal). The training programme for customs officers was also approved on the understanding that no further customs training project proposals would be approved for Argentina.

Recommendation

9. The Fund Secretariat recommends blanket approval of the above project with associated support costs at the funding level shown in Table 1, on the understanding that no assistance from the Fund will be requested for further training of refrigeration service technicians and customs officers.

Bosnia and Herzegovina:

(a) Preparation of two investment projects in the commercial refrigeration sector (US \$15,000)

(b) Preparation of an investment project in the rigid foam sector (US \$15,000)

(c) Preparation of a national ODS phase-out plan (US \$80,000)

- 10. The Secretariat questioned the requests for preparation of individual projects when a national ODS phase-out plan was to be prepared.
- 11. UNIDO advised the Secretariat that the economic situation in Bosnia and Herzegovina is now improving and an increase in ODS consumption could be expected from enterprises where the production had been very low. There was a need to move forward quickly with conversion projects. The resulting project proposals will be submitted to the 37th of the Executive Committee and no further requests for project preparation will be submitted.

Recommendation

12. The Fund Secretariat recommends blanket approval of the above projects with associated support costs at the funding level shown in Table 1, on the understanding that no further requests for project preparation will be submitted by the Government of Bosnia and Herzegovina.

<u>Iran: Preparation of 3 umbrella investment projects in the commercial and domestic refrigeration sector (US \$30,000)</u>

13. The Secretariat pointed out that UNDP has requested project preparation funding for a terminal refrigeration manufacturing project for Iran, and that the there is little reported consumption remaining in this sector in Iran. UNIDO indicated that there were no overlaps following its co-ordination with UNDP.

Recommendation

14. The Fund Secretariat recommends approval of the activity at the funding level indicated in Table 1 with the understanding that UNIDO and UNDP will jointly provide a profile of remaining enterprises in the sector and their consumption when the first project is submitted.

<u>Lebanon: Preparation of two umbrella investment projects in the commercial refrigeration sector (US \$15,000)</u>

15. The Secretariat pointed out that UNDP has submitted funding requests for a country programme update and a terminal CFC phase-out plan that would address refrigeration servicing, and the aerosol and foam sectors. In this regard, UNIDO indicated that it had been requested by the Government of the Lebanon to prepare these two projects, following which, UNDP would address the remainder of the refrigeration sector. There were no overlaps following its co-ordination with Lebanon and UNDP.

Recommendation

16. The Fund Secretariat recommends approval of the activity at the funding level indicated in Table 1 with the understanding that no further funding requests will be submitted for preparation of projects in the refrigeration sector in Lebanon.

SECTION B. PROJECTS WITH ISSUES

17. Section B of Table 1 lists activities for individual consideration. The activities have been arranged in three groups according to the issue associated with them.

B.1 Activities in the fumigant (methyl bromide) sector

China: Preparation of a sectoral strategy in the methyl bromide sector (US \$300,000)

- 18. The Government of China submitted a request for the preparation of a sectoral strategy in the methyl bromide sector. The request was submitted with a brief document describing, among others the criteria and scope of the proposal and the MB sub-sectors to be covered. UNIDO advised the Secretariat that the level of funding requested was based on a careful assessment of the activities to be implemented, the number of stakeholders involved, the number of different crops and applications where MB is used and their geographical location through out the country.
- 19. The Government of China has not yet ratified the Copenhagen Amendment. However, on 21 December 2001 the Government of China provided to the Multilateral Fund and Ozone Secretariats a letter of intent to ratify within 12 months. The revised strategy and guidelines approved by the Executive Committee at its 32nd Meeting (Decision 32/80) indicate that "in order to facilitate faster ratification of this amendment, funding for activities which enhance national capacity building, such as funding for information transfer and policy development, could be made available to countries which have not yet ratified the amendment, provided that a letter has been received from the appropriate agency of that country, indicating its intent to complete the ratification within a period of twelve months".
- 20. At its 35th Meeting, the Executive Committee approved a UNEP project for an awareness raising workshop to support ratification of the Copenhagen Amendment in China (US \$\$100,000) and a techno-economic evaluation of methyl bromide alternatives (US \$80,000). In total China has received almost US \$1 million (including a demonstration project) for activities which were eligible for funding prior to ratification of the Copenhagen Amendment.
- 21. UNIDO advised that it recognised funds for a phase-out project could not be approved prior to ratification, but if approved, project preparation activities would commence now, so that the phase-out plan could be submitted after China had completed the ratification process.

Recommendation

22. The Executive Committee might wish to consider the request for the preparation of a sectoral strategy in the methyl bromide sector based on the above comments.

B.2 Activities with data discrepancies

- 23. Sectoral data discrepancies were identified in relation to the activities in the above countries. Under Decision 30/23 such project preparation requests are to be referred for individual consideration. Additionally, in the context of UNIDO's 2002 business plan, the Secretariat pointed out that Decision 35/2(b) requested agencies to resolve data discrepancies before including projects in the final business plans. The Secretariat advised UNIDO to ensure that the country concerned was aware of the discrepancy but still wanted the projects put forward in the context of their aggregate national consumption eligible for funding under Decision 35/57, because all of the countries concerned had significant levels of fundable CFC consumption.
- 24. UNIDO indicated that Argentina, India and Syria were in the process of revising/reconciling their sectoral consumption data. It noted the Secretariat's comments about Yemen.

Recommendation

25. The Executive Committee may wish to consider whether to approve the above proposals at the level of funding indicated in Table 1, on the basis that the consumption in the resulting projects will be considered in the context of Decision 35/57.

B.3 Potential overlaps with other agencies' activities

- Syria: (a) Preparation of a national ODS phase-out plan (US \$60,000)
 - (b) Preparation of an investment project in the foam (EPS) sector (US \$15,000)
 - (c) Preparation of an investment project in the domestic refrigeration sector (US \$15,000)
- 26. The Secretariat pointed out that UNDP had requested funds for the preparation of a terminal project in the refrigeration sector in Syria. The Secretariat also questioned why project preparation funding should be requested for individual projects by UNIDO when a national phase-out plan was to be prepared. UNIDO informed the Secretariat that it planned to submit the individual investment projects to the 37th Meeting of the Executive Committee and that no more funding requests for preparation of individual projects will be submitted. UNIDO also advised the Secretariat that the Government of Syria had requested UNIDO to address the remaining consumption in the country while UNDP has been asked to complete conversion of enterprises

which manufacture refrigeration equipment. The Secretariat is concerned that the effectiveness of implementation of national phase-out plans could be adversely affected if another agency is simultaneously implementing a separate terminal plan for consumption that is, by definition, a component of the national aggregate consumption.

Recommendation

27. The Executive Committee may wish to consider the above project preparation requests in light of the above comments.

SECTION C. ACTIVITIES RECOMMENDED FOR DEFERRAL

- 28. Section C of Table 1 contains nine proposals which are <u>recommended</u> for deferral by agreement between the Fund Secretariat and UNIDO. For the information of the Executive Committee, the reasons for deferral are presented below.
- <u>Cameroon:</u> (a) Preparation of three investment projects in the commercial refrigeration sector (US \$30,000)
 - (b) Preparation of a national ODS phase-out plan (US \$50,000)
- 29. The Secretariat pointed out that the Executive Committee at its 24th Meeting approved for UNIDO funds for the preparation of the RMP project for Cameroon. The RMP project was submitted for consideration by the Executive Committee at its 32nd Meeting. However, based on the issues raised and observations made by the Secretariat on the RMP project, UNIDO withdrew the project proposal. The RMP project has not been re-submitted.
- 30. According to the progress report on the implementation of the country programme, the 1999 CFC in the refrigeration sector was only 6.9 ODP tonnes, while the projects to be prepared are indicated as consuming 40 ODP tonnes.
- 31. Based on the above comments, UNIDO agreed to defer the two requests for Cameroon until the issues related to data discrepancies are resolved.

China: Preparation of a sectoral phase-out project in the MDIs sector (US \$75,000)

- 32. The Executive Committee decided at its 35th Meeting to request the Secretariat, in co-operation with the implementing agencies, to prepare a paper for the Executive Committee's consideration on the issues associated with developing projects for the CFC metered-dose inhaler (MDI) sub-sector to give effect to Decision XIII/9 of the 13th Meeting of the Parties (Decision 35/4 (c)).
- 33. UNIDO agreed to defer submission of this activity pending the approval of the guidelines.

Egypt: Implementation of customs training in the framework of the RMP (US \$100,000)

34. The Secretariat noted that no project document was provided with the request, and that the level of funding requested appeared high. UNIDO agreed to defer this request pending preparation of a project proposal which would be submitted to the 37th Meeting.

India: Formulation of an MDI sectoral phase-out plan (US \$70,000)

35. UNIDO agreed to defer submission of this activity pending the approval of the guidelines for preparation of MDI projects (as per Decision 35/4 (c)).

<u>Indonesia</u>: <u>Preparation of three investment projects in the foam sector (rigid and integral skin)</u> (US \$20,000)

36. UNIDO agreed to defer submission of this activity until issues related to data discrepancies are resolved.

Iran: Formulation of a sectoral phase-out plan in the MDIs sub-sector (US \$70,000)

37. UNIDO agreed to defer submission of this activity pending the approval of the guidelines for preparation of MDI projects (as per Decision 35/4 (c)).

Mexico: Preparation of the closure of CFC production facilities of the company Quimobasicos (US \$100,000)

38. The Secretariat pointed out that the technical audit of Mexico's CFC production plant approved by Decision 34/68 had not been completed. Subsequently, UNIDO agreed to defer the project preparation request until the technical audit had been considered by the Executive Committee.

Romania: Preparation of a MDIs sector phase-out plan (US \$40,000)

39. UNIDO agreed to defer submission of this activity pending approval of the guidelines for preparation of MDI projects (as per Decision 35/4 (c)).

SECTION D. ACTIVITIES WITHDRAWN

40. Section D of Table 1 contains, for the information of the Executive Committee, one proposed activity in Argentina which was withdrawn by UNIDO.

UNIDO 2002 WORK PROGRAMME (Rev. February 2002)

Introduction

This Work Programme for the year 2002 has been prepared based on ongoing and foreseen activities and following government requests, taking also into account discussions and conclusions as well as the endorsement of the draft 2002 Business Plan of UNIDO by the $35^{\rm th}$ Executive Committee held in Montreal in December 2001.

It is meant to provide indication on where the UNIDO programme is moving in 2002, and to establish a financial resource estimate for implementing such a programme. This document was prepared along and in accordance with the decision 32/12 of the Executive Committee at its $32^{\rm nd}$ session, related to the business shares between the Implementing Agencies.

The document comprises the following sections:

Section 1,

gives in a tabulated form by country a consolidated list of activities foreseen in all sectors, both project preparation of investment projects and non-investment type of projects, amounting to US\$ 2,280,000 (without 13% Agency Support Cost). This section is prepared in line with Annex I and Annex IV of the 2002 Business Plan. No funds for project preparation have been requested in connection with investment projects contained in Annex V (contingency) of the UNIDO 2002 Business Plan. Should the preparation of those projects become necessary in the course of the current year, then the respective funds will be requested through an Amendment of the 2002 Work Programme.

Section 2.

provides the corresponding project concepts indicating details, such as project title, duration and summary of the concept.

All those activities are country-specific ones and the funds envisaged can be utilized to serve the distinct purpose they are to be approved for.

To enable the Organization to go forward with the implementation of this Work Programme from the beginning of the current year, an advance of US\$ 176,250 (without A.S.C.) was approved at the $35^{\rm th}$ session of the Executive Committee. Upon approval of the project preparation funds as per Annex 1 the advance will be distributed appropriately.
