Corrigendum

UPDATE REPORT ON THE STATUS OF ARTICLE 5 COUNTRIES IN ACHIEVING COMPLIANCE WITH THE INITIAL CONTROL MEASURES OF THE MONTREAL PROTOCOL

This corrigendum is issued to:

- 1. Specify that an RMP update has not been approved for Croatia which results in the following changes in:
 - Paragraph 21 **from** the number "23" **to** "22" in the last sentence to read "including support for 22 LVCs to meet their 85 per cent reductions in 2007".
 - Paragraph 36 **from** the number "14" **to** "13" in the first sentence to read "including 13 countries that have received RMPs to meet their 85 per cent reductions".
 - Annex I, page 1, column 12 **from** "Yes" **to** "No" for an RMP for an LVC to meet the 85% reduction for Croatia.
- 2. Indicate that Bahamas, Barbados, Grenada, Guyana, Jamaica, and Trinidad and Tobago have received halon banking through a regional Caribbean project which results in the following changes in:
 - Paragraph 48 **from** the number "23" **to** "25" in the penultimate sentence to read "25 of 45 countries have received support from the Multilateral Fund".
 - Paragraph 50 to **replace** the third sentence **with** "3 of those countries (Guyana, Qatar and Yemen) have already received support for halon banking from the Multilateral Fund".

- Paragraph 51(b) to **replace** the second sentence **with** "9 of these 15 countries have received support for halon activities from the Multilateral Fund including halon banking in 7 of them (Ethiopia, Guyana, Iran, Qatar, Tanzania, Vietnam and Yemen)".
- Paragraph 51(b) to **replace** the fourth sentence **with** "Of the remaining 4 countries that might not achieve their 50 per cent reduction targets, two have consumption below 10 ODP tonnes (Dominican Republic and Croatia)".
- Paragraph 53 to **delete** "Guyana and" in the last sentence.
- Paragraph 55 to **replace** the first sentence **with** "15 countries may need additional actions to achieve their 50 per cent reduction targets by the year 2005 including 7 countries (Ethiopia, Guyana, Iran, Qatar, Tanzania, Vietnam, and Yemen) that have halon banks, and four for whom halon bank proposals have been or will be submitted (Congo, Cameroon, Niger and Turkey)".
- Paragraph 56 to delete "Guyana".

• Annex II, columns 11 and 12 **from** "No" **to** "Yes" for halon banking approved and received assistance from the Fund for halon banking for Bahamas, Barbados, Grenada, Guyana, Jamaica, and Trinidad and Tobago.
