**SITUACIÓN DE LAS CONTRIBUCIONES Y DESEMBOLSOS**

**Informe del Tesorero  
Estado del Fondo al 20 de octubre de 2002**

1. Las tablas de las páginas siguientes proporcionan información acerca del Estado del Fondo y de las Contribuciones registradas en el PNUMA al 20 de octubre de 2002. El saldo del fondo es de **85,2 millones** \$EUA a esa fecha. Este estado ya ha tomado en cuenta las transferencias a los organismos de ejecución para las aprobaciones del Comité Ejecutivo, incluidas las de la 37ª Reunión.
2. A octubre de 2002, el porcentaje de contribuciones pendientes de 2002 respecto de los compromisos es de 46,2%. Al respecto, las Partes deben continuar recordando la importancia de la decisión XI/7, párrafo 7, que insta a las **“Partes”** a **“esforzarse por pagar sus contribuciones lo más temprano posible en el año calendario y antes del 1º de junio de cada año”** e indica que **“las Partes que no puedan hacer sus contribuciones antes del 1º de junio deberán informar al Tesorero en qué momento del año calendario o del ejercicio económico se realizará su pago; sin embargo, las Partes deben esforzarse por hacer sus contribuciones antes del 1º de noviembre del mismo año”**.
