PLAN D'ACTIVITES DU PNUD POUR L'ANNEE 2003

OBSERVATIONS ET RECOMMANDATIONS DU SECRÉTARIAT DU FONDS

1. Le PNUD a préparé son plan d'activités en se fondant sur les Décisions 38/66 et 38/67. Ce plan est joint en annexe aux présentes observations.

2. Ce document comporte un résumé des activités du PNUD prévues pour 2003, l'élimination des SAO durant cette période triennale, des observations générales, des indicateurs de performance du plan d'activités du PNUD et fournit des recommandations pour examen par le Sous-comité sur le contrôle, l'évaluation et les finances.

Activités prévues pour 2003-2005

3. Il s'agit d'un plan triennal d'activités continues puisqu'il y est question de trois années d'activités bien que celles des années 2004 et 2005 soient moins certaines, hormis les accords pluriannuels permanents.

Activités prévues pour 2003

4. Le montant total des projets que le PNUD envisage de soumettre, au titre de l'année 2003, s'élève à 51,58 millions de \$US. Ces projets devraient permettre l'élimination de 8 786 tonnes PAO. Ce plan comprend:

- 11 accords pluriannuels permanents, fondés sur la performance, pour l'élimination par secteur et par substance et dont le montant total est de 25,26 millions \$US. Une fois ces accords appliqués, ils résulteront en une élimination des SAO de l'ordre de 5 388 tonnes PAO.
- 7 accords pluriannuels, fondés sur la performance, s'élevant à 6,19 millions de \$US en 2003 (soit un total de 12,29 \$US) pour l'élimination des SAO, en 2003, d'un volume de 884 tonnes PAO (1 838 tonnes PAO au total).
- 12 projets d'investissement individuels, qui seront soumis en 2003, au montant de 8,67 millions de \$US, dont 9 projets qui permettront l'élimination finale du secteur ou de la substance.
- 26 projets de plan de gestion de frigorifères au coût total de 7,93 millions de \$US.
- Une préparation de projet au montant de 578 350 \$US.
- 13 projets hors-investissement au total de 2,96 millions de \$US dont huit projets de renforcement institutionnel au coût de 2,04 millions \$US et cinq projets d'assistance technique devant coûter 920 700 \$US.

Activités prévues pour 2004 et 2005

5. Le PNUD prévoit de soumettre des projets évalués à 30,14 millions de \$US en 2004 pour l'élimination de 5 059 tonnes PAO. Ce montant comprend 20,73 millions de \$US au titre d'accords pluriannuels permanents.

6. Le PNUD envisage de soumettre des projets estimés à 19,5 millions de \$US en 2005 pour l'élimination de 3 064 tonnes PAO. Ce chiffre comprend 13,91 millions de \$US au titre d'accords pluriannuels permanents.

Élimination de PAO pendant la période 2003-2005

7. Pendant la période triennale 2003-2005, le PNUD envisage d'éliminer 17 916 tonnes PAO dans le cadre de projets continus et d'accords pluriannuels. En outre, le PNUD a annoncé que 3 611 tonnes PAO seraient éliminées dans le cadre de projets qui seront soumis à approbation pendant cette même période.

8. Dans son plan d'activités, le PNUD a prévu une section, assortie d'une annexe descriptive organisée par pays, sur l'expédition de la mise en œuvre du projet. Le Programme a indiqué qu'il a réussi à terminer plusieurs projets en 2002 bien qu'initialement ils ne devaient être achevés qu'en 2003 ou 2004. Cette élimination accélérée a permis une réduction totale de 1282 tonnes PAO selon le PNUD. Par ailleurs, le Programme a annoncé, entre autres, qu'il affectera des membres de son personnel en Chine et au Nigeria dès juillet 2003 et qu'il recruterá des experts locaux pour aider à la mise en œuvre des accords basés sur la performance, renforçant le personnel de son unité « finances et opérations » en vue de mettre en œuvre les plans nationaux et sectoriels.

Observations

9. La plupart des activités inscrites dans le plan du PNUD reflètent les conditions et exigences du plan d'élimination triennal. Cependant, certains projets risquent de ne pas remplir ces conditions.

10. Le PNUD a énuméré des activités dans les pays à faible volume (PFV) qui ont reçu un PGF conformément à la Décision 31/48:

- a) Un projet de réfrigération commerciale en Bolivie (163 500 \$US pour éliminer 5,9 tonnes PAO); et
- b) Un projet de réfrigération pour utilisateurs finaux au Congo (130 800 \$US pour éliminer 11,4 tonnes PAO).

11. Le PNUD a prévu aussi des activités relatives aux inhalateurs à doseur en Inde et au Nicaragua. Pour l'Inde, le PNUD prévoit une activité d'assistance technique (300 000 \$US) et

une préparation de projet s'élevant à 32 350 \$US destinés à préparer un plan d'élimination du secteur des inhalateurs à doseur. Le PNUD a déclaré que le projet d'assistance technique permettra d'éliminer 24,8 tonnes PAO. La valeur totale du plan d'élimination du secteur des inhalateurs à doseur est estimée à 1,9 millions de \$US afin d'éliminer 250 tonnes PAO. Le plan d'élimination triennal indique qu'aucune élimination supplémentaire n'est nécessaire pour que l'Inde puisse satisfaire les mesures de contrôle des CFC aux échéances 2005 et 2007.

12. Le PNUD envisage de demander une préparation de projet (32 250 \$US) et un plan d'élimination des inhalateurs à doseur pour le compte du Nicaragua avec une valeur estimée à 70 000 \$US afin d'éliminer 5,8 tonnes PAO. Le Nicaragua a déjà reçu un PGF mais il a droit à un PGF actualisé que le PNUD envisage de préparer et soumettre en 2003. Conformément à la Décision 31/48, le PGF complet devrait permettre au Nicaragua de satisfaire les mesures de contrôle jusqu'à l'échéance 2007.

13. Le PNUD a également présenté un plan d'élimination du bromure de méthyle et une préparation de projet pour le Zimbabwe dans son plan d'activités 2003 (5 375 \$US pour la préparation de projet et 436 000 \$US pour éliminer 30 tonnes PAO, lesquels devraient être financés en 2003 et 2004). Se fondant sur l'accord entre le Comité exécutif et le Zimbabwe portant sur un projet approuvé à la 31^e Réunion, le Zimbabwe s'est d'ores et déjà engagé à respecter les mesures de contrôle à l'échéance 2005. Le Comité exécutif pourrait demander au PNUD d'insérer cette activité dans son plan d'activités à la fin de la période triennale si les fonds sont disponibles pour maintenir/accélérer le rythme d'élimination.

14. Le PNUD a également inclus un projet d'assistance technique sur le bromure de méthyle au profit du Kirghizistan (196 200 \$US en vue d'éliminer 12 tonnes PAO). Le Kirghizistan n'a pas encore ratifié l'Amendement de Copenhague selon les données les plus récentes émanant du Secrétariat de la Convention sur la protection de la couche d'ozone.

Indicateurs de performance

15. Le Tableau 1 ci-dessous fournit un résumé des indicateurs de performance du projet d'investissement du PNUD.

16. Selon la base de données de son plan d'activités, le PNUD prévoit d'éliminer 5 684 tonnes PAO dans les activités approuvées et en cours au titre de l'année 2003. Le PNUD cite l'objectif de 4 000 tonnes PAO comme indicateur de performance pour le volume de PAO à éliminer. Le Comité exécutif pourrait étudier l'approbation d'un objectif d'élimination de 5 684 tonnes PAO pour les projets d'investissement.

17. Le PNUD n'a pas indiqué d'objectifs pour un certain nombre de projets d'investissement qui seront achevés dans l'année du plan d'activités ni de rapport coût-efficacité pour les projets approuvés. La 39^e Réunion pourrait inviter le PNUD à quantifier ces cibles.

18. Le Tableau 2 ci-dessous fournit un résumé des indicateurs de performance du projet hors investissement du PNUD.

RECOMMANDATIONS

Le Secrétariat du Fonds recommande que le Sous-comité sur le contrôle, l'évaluation et les finances délibère pour:

1. Recommander au Comité exécutif d'appuyer le plan d'activités 2003 du PNUD, tel qu'il figure au document UNEP/OzL.Pro/ExCom/39/10, tout en notant que cet appui ne signifie pas approbation des projets identifiés dans ce plan ni des montants de financement, toute modification devant être basée sur l'examen des activités suivantes:
 - a) Les activités dans les pays PFV qui ont déjà reçu un PGF complet conformément à la Décision 31/48, y compris la Bolivie et le Congo;
 - b) Les activités relatives aux inhalateurs à doseur en Inde où aucune élimination supplémentaire n'est nécessaire pour atteindre les objectifs de contrôle aux échéances 2005 et 2007;
 - c) Les activités relatives aux inhalateurs à doseur au Nicaragua ou une actualisation du PGF est prévue afin de permettre à ce pays d'atteindre les objectifs de contrôle aux échéances 2005 et 2007;
 - d) Les activités relatives au bromure de méthyle au titre desquelles aucune élimination supplémentaire n'est requise pour atteindre les objectifs de contrôle de l'échéance 2005 au Zimbabwe; et
 - e) Les activités relatives au bromure de méthyle au Kirghizistan puisque ce pays n'a pas indiqué s'il avait ou non ratifié l'Amendement de Copenhague.

2. Demander au PNUD de fournir des objectifs pour les indicateurs de performance, le nombre de projets d'investissement à réaliser à l'échéance de l'année du plan d'activités ainsi que le rapport coût-efficacité pour les projets que la 39^e Réunion aura approuvés.
3. Recommander au Comité exécutif d'approuver les indicateurs de performance du PNUD fournis aux Tableaux 1 et 2 des observations du Secrétariat du Fonds, lesquels sont repris au document portant la cote UNEP/OzL.Pro/ExCom/39/10 tout en arrêtant l'objectif d'élimination de 5 684 tonnes PAO en 2003 pour l'indicateur de performance du projet d'investissement.

NARRATIVE

A. MULTILATERAL FUND TARGETS

1. Introduction

Over the course of 2003, UNDP will prepare 4 national CFC phase-out plans, 16 sectoral phase-out plans, 26 activities addressing needs in the refrigeration servicing sub-sector, 3 phase-out plans and 2 training activities in the fumigants sector, 8 requests for extension of institutional strengthening projects, plus approved multi-year (on-going Agreements) commitments of US\$ 25.261 million, project preparation (US \$578,000) and core unit funding of US \$1,500,000, for a total of US\$ 51.580 million.

2. Resource allocation

3. Geographical distribution

In 2003, UNDP will again cover all regions, with planned activities in various sectors in 50 countries (including on-going multi-year investment activities, non-investment activities and project preparation). Of the 50 countries, 13 are in Africa, 15 in Asia/Pacific, 2 belong to the Commonwealth of Independent States, 18 in Latin America and the Caribbean, and 2 in West Asia.

4. PROGRAMME EXPANSION

a. Background

UNDP's 2003 Business Plan has been developed drawing from the analysis provided by the Three Year Rolling Plan Business Plan model approved at the 38th ExCom meeting, through communication with countries that have expressed an interest in working with UNDP to address their compliance needs, as well through negotiation and discussion with the MLF Secretariat and other Implementing Agencies, during and post the Inter-Agency meeting held 8-10 January in Montreal. Activities proposed for funding over the course of the triennial period will yield ODS phase-out results over a five year period. As a result, funding requests approved during the 3 year period will contribute to phase-out during the 2003-2007 period.

Countries Contacted

Over the course of preparation of the 2003 Business Plan, communication was made with every one of the countries that figure in the plan. During this process, the importance of Decision 38/66 was stressed and where necessary, further explanation was provided. Correspondence, indicating an interest in working with UNDP, was received from each of the countries that figure in the Business Plan.

Coordination with other bilateral and implementing agencies

As it has done in the past, during 2003 UNDP will continue to collaborate with both bilateral and other implementing agencies. Collaborative arrangements in programming will be launched with the Government Canada, as well as with UNEP. The bulk of such partnerships will focus on provision of assistance to LVCs.

Relevant decision 38/66, 38/67, 38/68

In accordance with Decision 38/66, UNDP's Business Plan builds upon the guidance proposed by the Three-Year Rolling Plan and aims to assist Article 5 countries in meeting the ODS targets they face during the triennial period.

b. Impact of plan on 3-year Phase-out Plan

c. Project preparation

A comprehensive overview of the Project Preparation funds to be requested at 39th ExCom is contained in the Work Programme submitted by UNDP to this meeting.

The information below presents a comprehensive overview of the total Project Preparation funds (grand total US \$578,000, including support costs) to be requested by UNDP during 2003:

- a) Planned, Individual PRP new requests: Separate from the requests for preparatory funding in the refrigeration servicing sub-sector for 2003, UNDP has included 9 new planned individual activity requests for preparatory funding in 8 countries, amounting to US \$178,000 (including support costs) in its Work Programme;
- b) Planned, Multi-Year PRP new requests: 3 planned multi-year activity requests for preparatory funding in 3 countries, amounting to US \$64,000 (including support costs), are requested in 2003; and,
- c) Planned, servicing sub-sector PRP new requests: A total of 18 requests with a value of US \$336,000 in PRP will be requested over 2003 for preparatory activities in the refrigeration servicing sub-sector. In the case of new RMP-formulation, preparatory funding will be requested at the 39th meeting of the Executive Committee. In regard to RMP Update/TPMP development, requests for preparatory funding will be made over the course of 2003 when the necessary progress report on ongoing and completed RMP activities has been made available.

d. Non-investment projects

In 2003, UNDP will develop 5 individual non-investment projects with a total value of US \$921,000 and a 67.8 ODP T phase-out target. Completion dates for all are December 2005. These individual non-investment projects are highlighted in the table below:

5. MEASURES TO EXPEDITE IMPLEMENTATION OF APPROVED PROJECTS AND THOSE CRITICAL TO COMPLIANCE

Several projects due for completion in 2003 and 2004 were finalized in 2002. While UNDP's final progress report is not due until May, preliminary analysis indicates that early project completion has resulted in a total reduction of 1,282 ODP tonnes. Such early reductions were the result of phase-out in Argentina, Brazil, Colombia, India, Iran and Nigeria. UNDP expects that with the efforts mentioned below, additional phase-out resulting from early completion of

projects will also be realized in 2003. Table 6 below indicates the amount that will be phased out from approved but unimplemented projects.

Decisions 35/4, para 111(b) and 36/9, para 43(c), requested UNDP to provide information related to actions it would take to expedite the implementation of approved projects and those critical to compliance. In this regard, UNDP's Montreal Protocol Unit (MPU) is adjusting the way it operates so as to better assist countries to comply with the MP control measures under the strategic direction provided for the next triennium of the MLF.

Strengthening the Network of UNDP staff and Experts in the Field

- UNDP has increased the selection of national consultants/ national associations/ partners at the country level so as to better attend to the needs of countries and speed up response at the field level. Two additional MPU staff (P4 level) will be out-posted /recruited for supervisory roles in Asia (China) and Africa (Nigeria). The positions will be effective as of July 2003. In addressing follow-up for methyl bromide agreements, UNDP is recruiting national experts who will also assist MPU with monitoring of the ongoing agreements at the national level. With stronger presence in the field, supervision of activities will increase; having more technical experts in the field will help to speed up resolution of pending technical issues.
- UNDP/BDP is re-structuring its Finance and Operations Unit at headquarters, adding a Programme Support Unit (PSU), as well as one Finance Officer (P4 level) that will be dedicated to the MPU, in order to gear up to the changing needs encountered during implementation of national and sectoral plans so as to ensure adequate management of the financial reporting and follow up requirements for the MLF.
- UNDP's portfolio in several countries is either the largest or in some cases, the one which will impact significantly on the ability of that country to comply. In addition to the above, UNDP intends to expedite implementation by using its vast network of Country Offices, where Resident Representatives are in constant contact with senior government officials in various Ministries. This can be extremely valuable and influential in providing assistance to resolve pending issues and/or providing support in encouraging development and adoption of legislative and regulatory mechanisms.
- UNDP feels that by working more closely with its Country Offices, and by using the National Execution (NEX) modality in countries which have selected this option, it can make an important contribution in assisting article-5 countries to implement these types of projects and provide the sustained compliance assistance they require. In this regard UNDP has already shifted most of the daily management of its 2002 approved national and sectoral plans to be

implemented under this modality. This also serves to enhance the role of national experts and national institutions, thereby building national capacity.

- In addition, it is important to note that the Bureau for Development Policy, BDP, where the Montreal Protocol Unit is located, has been restructured to enable UNDP to provide global advocacy and policy advisory services. A network of around 60 policy advisers and specialists are now in situ in the 9 Sub-Regional Resource Facilities (SURFs) supported by BDP, providing knowledge based services which are relevant and practical across the practice areas, one of them Environment and Sustainable Energy. MPU is in contact with the SURFs and will use their services where additional assistance is needed, on a cost recovery basis.

Management and Supervision of National/Sector Plans

- UNDP has assisted the countries in which it is implementing national and sectoral phase-out plans to put in place the infrastructure for the National Implementation and Monitoring/ Management Units, approved under the national/sector Plans. The Government staff as well as UNDP staff will work closely and will operate under MLF and UNDP rules related to procurement of goods, data verification requirements, proper financial management and auditing, as well as required reporting on the progress of the Plans.
- As far as meeting agreed targets, UNDP and the Government staff are also working together to establish the mechanisms for preparing projects to be funded under the Plans (using MLF guidelines, independent technical reviews etc.) as well as monitoring their implementation (list of equipment to be destroyed, technology selection regulations, etc.).
- The financial databases being set-up within the Monitoring and Implementation Units are being developed so that they are compatible with the UNDP database in order to facilitate handling and retrieval of technical and financial information and to ensure accuracy.
- Licensing systems in place, if not adequate, will be revised so as to support and sustain the target reductions contained in a performance-base agreement. Monitoring CFC imports and distribution will be strengthened as a mechanism to prevent enterprises (who have converted) from again purchasing CFCs. A top-down, through the Licensing systems in place, as well as a bottom-up, through efforts such as government registries that include enterprises that purchase CFCs and those that have been assisted by the Fund, verification mechanisms will be put in place or will be strengthened.

UNDP believes that the above mentioned measures will be key in assisting countries to speed up implementation, as well as allow for a more comprehensive assessment of additional needs at the country-level, thereby more effectively contributing to the compliance-driven approach. Specific ODP related information on ongoing UNDP projects, on a country-by-country basis, have been provided as part of the BP tables. The measures above are intended to be extended to all programming, on-going and planned, so as to maintain momentum, accelerate implementation where required, improve supervision at the field level, as well as financial accountability.

Performance Based National and Sector Plans have been approved for UNDP in several countries: Argentina MB; Brazil Annex A, Group I; China solvents; Costa Rica MB, India foam and refrigeration manufacturing; Indonesia refrigeration, manufacturing and servicing; Kenya MB; Lebanon MB; Malawi MB; Mexico foam; Nigeria Annex A, Group I. Reports on Plans (excluding the ones approved at the last 38th ExCom) and recent 2002 data estimates indicate that the Agreed targets have all been met, including for those countries which were under difficulties due to economy, changes in Government, crop related pests, regional market pressures, among others.

UNDP efforts in countries addressed by the Implementation Committee and by the MOP.

UNDP is working to assist a number of countries address their compliance commitments, following issues raised by the Implementation Committee in 2002. These include countries where UNDP manages the Institutional Strengthening programmes, as well as countries where UNDP is playing a significant role in a particular sector. In addition to the measures mentioned above, the following efforts are being put in place:

- **Bangladesh** – Bangladesh's CFC baseline is 580.4 ODP T, however, it's 2000 reported consumption is 805 ODP T. As a result of completion of the ACI-Aerosol plant project in 2002, and in accordance with the Three-Year Rolling Plan analysis, a total of 150 ODP T CFC consumption remains to be eliminated. In order to assist the government of Bangladesh to address its Montreal Protocol objectives, UNDP will work with the government to develop a national CFC, TCA and CTC phase-out plan in 2003.
- **Bolivia** – Bolivia's CFC baseline is 75.7 ODP T, however, it's 2000 reported consumption is 78.8 ODP T. Significant portion of total CFC consumption in foam sector (44%) is in one individual foam project listed for possible cancellation (bilateral Belgium). The Foam Sector Phaseout Plan (66% of the consumption was recently approved (with UNDP) and it includes the commitment of the Government to phase out all remaining CFCs in foam. If the former project is cancelled, the enterprise will have to phase out without financial assistance from MLF. UNDP has alerted Government NOU several times and continues to follow up. In the refrigeration sector, consumption for servicing was addressed by RMP approved as per Dec 31/48 (Canada) but remaining consumption in refrigeration manufacturing (5.9 ODP tons) will be addressed as a terminal project (in UNDP's 2003 BP).
- **Nigeria** - Nigeria's CFC baseline is 3,650 ODP T, however, it's 1999 reported consumption was 4268.8 ODP T. Nigeria's compliance needs will be addressed through the implementation of the recently approved National CFC Phase-out Plan. UNDP is the lead agency and is taking action at the regional and country level to better assist Nigeria and speed up implementation of ongoing projects. Refer to bullet I in the above 'Strengthening the Network...' section, which highlights the establishment of a regional post in Nigeria.
- **Guatemala** – Guatemala's CFC baseline is 224.6 ODP T, however, it's 2000 reported consumption is 187.9 ODP T. The country has an RMP under implementation that was approved in accordance with Decision 31/48 (UNIDO). UNDP will assist the government of Guatemala in addressing its solvents sector needs in 2004. All previously approved UNDP projects have been completed.
- **Nepal** – Nepal's CFC baseline is 27 ODP T, however, it's 2000 reported consumption is 94 ODP T. According to model Nepal is eligible to receive assistance to phase-out 23 ODP tones. UNDP activities in-country will eliminate 13 ODP tonnes. UNEP and UNDP working in cooperation in Nepal.

UNDP efforts to sustain implementation of RMPs in countries where UNDP has received funds for implementation of RMPs and/or its components

UNDP has implemented, and continues to implement, many activities in the refrigeration servicing sector. These include: early MLF domestic and MAC sector recovery and recycling projects, full RMPs approved prior to Decision 31/48, recovery and recycling RMP components, both pre and post-Decision 31/48 and more recently, end-user incentive programmes. UNDP has collaborated actively with UNEP during RMP implementation, with UNEP managing non-investment components of UNDP-led RMPs, and UNDP managing investment components of UNEP-led RMPs.

UNDP will undertake the formulation and/or revision and update of RMPs in a number of countries during the 2003-2005 triennial period. These include: Costa Rica, El Salvador, Gabon and Niger. In addition, UNDP and UNEP will again collaborate in many LVCs during the 2003-2005 triennial period on refrigeration servicing activities to better assist such countries where consumption resides primarily in this sector. These include: Bahrain, Barbados, Brunei Darussalam, Burundi, Cambodia, Congo DR, Congo R, Fiji, Guinea Bissau, Haiti, Honduras, Mauritania, Moldova, Myanmar, Nepal, Nicaragua, Panama, Peru, Rwanda, Sao Tome, Somalia, and Suriname.

In line with the objectives of the Three-Year Rolling Plan, efforts will focus on allowing countries to meet the 2005 50% reduction target during this triennial period. In order to reinforce sustainability of efforts, UNDP plans, in cooperation with UNEP, to:

- address, during RMP revisions, additional conversion needs (both investment and non-investment) and identify barriers to sustain RMP activities specific to each country/region; and,
- enhance harmonization of policy and technology transfer activities by inviting UNEP/CAP regional staff to participate in UNDP missions to ensure legislation/licensing systems in place, as well as to assess their effectiveness. Such an enhanced collaborative approach will allow for the provision of precise and targeted guidance required to sustain and/or accelerate implementation.

Information, by country, on on-going UNDP projects and the measures being taken to expedite implementation are shown in Annex I.

7. POLICY AND ADMINISTRATIVE ISSUES TO BE ADDRESSED

MDI Transition Strategies

UNDP has received requests to prepare MDI Transition Strategies for countries both manufacturers and importers of MDIs. In addition, countries which manufacture CFC-MDIs have insisted that UNDP should include both the Transition Strategy and the Investment component in UNDP's BP for the triennium. Their main concern is that they need to address this conversion not only to comply with the MP control steps but to be able to attend the health needs of the people in their countries. Countries have heard the advice of the TEAP during several MOP that countries should move forward in this area. TEAP also indicated that availability of pharmaceutical grade CFCs will be a problem in the near future.

The ExCom, under Decision 37/61 indicates that only certain requests would be considered on a case-by-case basis, taking into account several factors, including the relevance of this phase-out to allow the country to achieve compliance. Since other sectors not so critical to compliance are being addressed and even funded for accelerated phaseout, some countries have come to UNDP

for clarification on when they can have their requests for conversion/funding submitted for approval. UNDP requests guidance on how to respond to countries in this regard.

Sector/National phase-out programmes

UNDP oversees the management of a number of national/sectoral multi-year phase-out plans, the bulk of which are performance-based in nature and thereby, governed by Government-ExCom Agreements. Such Agreements contain reduction schedules against which the disbursement of future funding tranches are contingent.

In order to secure approval for disbursal of additional funding tranches, UNDP has been working with partner governments to prepare progress reports that highlight results achieved over a given year, as per the terms of project Agreements. In certain cases, governments have had to face extraneous circumstances, ranging from economic crisis to agricultural pest infestations, that have had an impact on the overall national consumption of a substance targeted for multi-year phase-out under a particular Agreement. As a result, sustainable and permanent reductions achieved as a result of efforts associated with project implementation, get lost in the overall drop in consumption caused by extraneous circumstances, something which, in contrast with project reduction results, can rarely be said to be sustainable and permanent.

UNDP would therefore, like to request clarification from the Executive Committee regarding the issue of verification of phase-out reduction achievements. How are reduction achievements to be verified? Is this the responsibility of the Government in question, the implementing agency, or is independent audit expected, bearing in mind that many performance-based projects do not have funding provisions for independent audits? And lastly, what verification criteria is to be used to certify reductions in consumption?
