PLAN ADMINISTRATIVO DEL PNUMA PARA 2004-2006

COMENTARIOS Y RECOMENDACIONES DE LA SECRETARÍA DEL FONDO

- 1. El PNUMA preparó su plan administrativo sobre la base de las Decisiones 37/68, 38/66 y 41/93, y se lo adjunta como anexo a estos comentarios.
- 2. Este documento presenta un resumen de las actividades planificadas por el PNUMA para 2004–2006, enumera los indicadores de desempeño del plan administrativo del PNUMA y presenta recomendaciones para la consideración del Subcomité sobre Supervisión, Evaluación y Finanzas.

Actividades del PNUMA planificadas para 2004–2006

- 3. El plan administrativo del PNUMA para 2004–2006 contiene solicitudes para el año 2004 por un total de 16,08 millones \$EUA (incluidas las tasas de organismo). Este monto incluye:
 - 7,59 millones \$EUA para el presupuesto del PNUMA para el Programa de Asistencia al Cumplimiento de 2005 que se considerará en la última reunión de 2004;
 - 33 900 \$EUA para la preparación de programas de país;
 - 3,11 millones \$EUA para fortalecimiento institucional;
 - 474 600 \$EUA para preparación de proyectos;
 - 933 750 \$EUA para capacitación,
 - 2,25 millones \$EUA para la ejecución de planes de gestión de refrigerantes; y
 - 1,69 millones \$EUA para asistencia técnica.
- 4. El PNUMA presentará solicitudes de fortalecimiento institucional para 3 países (Islas Cook, Nauru y Niue), con un costo de 75 000 \$EUA, y renovaciones de fortalecimiento institucional para 43 países, con un costo de 3,04 millones \$EUA.
- 5. Las prioridades del PNUMA para 2004 son brindar asistencia a los países que se encuentran en situación real o posible de incumplimiento, permitir el cumplimiento de los controles para 2005 y 2007 por medio de asistencia técnica y sobre políticas, desarrollar y ejecutar un programa para asegurar que los países sin consumo de SAO que han logrado la eliminación mantengan sus niveles sin consumo o de consumo reducido, proporcionar asistencia por medio de la ejecución de planes de gestión de refrigerantes y agilizar la ejecución de los proyectos aprobados. El PNUMA ha obtenido fondos adicionales de Finlandia para apoyar la ratificación del Protocolo de Montreal por nuevas Partes y continua recibiendo apoyo adicional de Suecia para la Red Regional del Sudeste de Asia.
- 6. En el Plan administrativo del PNUMA se identifican nueve iniciativas especiales en el 2004. Además de lo mencionado precedentemente, el PNUMA promoverá una mayor cooperación Sur-Sur/Norte-Sur, brindará apoyo a la eliminación de metilbromuro por medio de

las escuelas en el terreno para agricultores, brindará asistencia a las dependencias nacionales del ozono para mejorar la presentación de informes de datos, promoverá la ratificación de las Enmiendas al Protocolo, promoverá el intercambio de información sobre comercio ilícito utilizando las reuniones de red, brindará asistencia a las dependencias nacionales del ozono respecto del consumo mínimo de CTC, TCA y metilbromuro y brindará apoyo a la gestión de halones a través del oficial de halones del Programa de Asistencia al Cumplimiento.

Comentarios

7. El PNUMA incorporó en su plan administrativo actividades para proyectos incluidos en la ventana para acelerar la eliminación/mantener el impulso, dos acuerdos plurianuales planificados (uno de los cuales es un proyecto de ventana), algunas posibles superposiciones con la ONUDI, actividades para proporcionar fondos para servicios adicionales complementarios al presupuesto del Programa de Asistencia al Cumplimiento y diversas actividades de planes de gestión de refrigerantes conforme a la Decisión 31/48.

Proyectos de ventana

8. Como se ilustra en la tabla siguiente, los proyectos de ventana incluidos en el plan administrativo del PNUMA corresponden a los criterios 3 y 4 de la Decisión 40/7, es decir, actividades planificadas para países de bajo volumen de consumo de SAO que han recibido financiación de conformidad con la Decisión 31/48 y proyectos planificados para los que se ha aprobado preparación de proyecto. El PNUMA también ha incluido preparación de proyecto para el desarrollo de un proyecto de ventana para Chad que ya ha recibido un plan de gestión de refrigerantes de conformidad con la Decisión 31/48 por un monto de 23 000 \$EUA.

- 9. La Secretaría indicó a los organismos que se podría presentar un plan de gestión para la eliminación definitiva para países que habían recibido planes de gestión de refrigerantes de conformidad con la Decisión 31/48 únicamente si se cumplía con las Decisiones 38/64 y 40/21. Esto se aplicaría a Mongolia y Sri Lanka, donde participan otros organismos. Uruguay ya ha recibido capacitación para refrigeración y capacitación aduanera de un proyecto de cooperación bilateral del Canadá y un proyecto para usuarios finales para el PNUD. El PNUMA indicó que este proyecto estaría destinado al sector de enfriadores sujeto a los resultados del informe del Grupo de evaluación técnica y económica (GETE) sobre enfriadores.
- 10. El PNUMA también prevé presentar tres proyectos conforme al criterio 4 de la Decisión 40/7, proyectos para los que se ha aprobado preparación de proyecto. En el caso del proyecto a ser presentado para la India, se trata de un compromiso de financiación plurianual que integraría el proyecto sectorial de servicio y mantenimiento a ser ejecutado con otros organismos bilaterales y de ejecución. Las dos actividades previstas para Marruecos para un programa de capacitación/taller de refrigeración serían parte de un plan de gestión de refrigerantes para Marruecos para el que el PNUMA recibió fondos de preparación de proyecto en la 27ª Reunión.

Posibles superposiciones

11. La Secretaría indicó al PNUMA que sus proyectos de asistencia técnica en metilbromuro para China y la India se podrían superponer con el acuerdo aprobado de eliminación de metilbromuro en China con la ONUDI y el acuerdo de eliminación de metilbromuro de dicho organismo con la India. El PNUMA indicó que estaba deliberando con las partes pertinentes para resolver la posible superposición.

Proyectos plurianuales planificados

12. Además de la participación del PNUMA en el proyecto plurianual para el sector de servicio y mantenimiento de la India, el PNUMA incluyó un acuerdo plurianual previsto para la India para proporcionar asistencia técnica en solventes por un costo total de 565 000 \$EUA, de los cuales 113 000 \$EUA están asignados para 2004, 226 000 \$EUA se incluyen para 2005 y otros 226 000 \$EUA para 2006. El plan de eliminación trienal indica que la India puede necesitar asistencia para asistencia para para eliminar 36,7 toneladas PAO de TCA a fin de cumplir con la reducción de 30 por ciento de consumo de TCA en 2005. El PNUMA es el único organismo que ha indicado actividades en el sector de solventes sin CTC; sin embargo, se debe tomar nota de que dichos acuerdos plurianuales pueden requerir gastos de inversión que pueden no encontrarse dentro del mandato del PNUMA.

Planes de gestión de refrigerantes conforme a la Decisión 31/48

13. El PNUMA prevé presentar actividades de planes de gestión de refrigerantes para 20 países de conformidad con la Decisión 31/48.

Actividades complementarias al Programa de Asistencia al Cumplimiento

14. El PNUMA ha incluido cuatro actividades que complementarían su Programa de Asistencia al Cumplimiento para 2004: 339 000 \$EUA para fumigantes en el nivel mundial

(escuelas en el terreno para agricultores), 28 000 \$EUA para taller sobre alternativas al metilbromuro en el Caribe, 226 000 \$EUA para asistencia técnica para la armonización de la legislación en África y otros 226 000 \$EUA adicionales para sensibilización del público en el nivel mundial.

- 15. En la 41ª Reunión, el Comité Ejecutivo tomó nota del informe sobre la marcha de las actividades de la ejecución de la capacitación nacional de agricultores y la creación de un proyecto de escuela en el terreno para agricultores e invitó al PNUMA a presentar solicitudes de financiación para actividades similares en otros tres países en 2004, uno en cada región, con el mismo nivel aprobado en la 27ª Reunión del Comité Ejecutivo (Decisión 41/78, párrafo e)). El PNUMA indicó que estaba coordinando con los organismos de ejecución para determinar dónde resultaría más eficaz que se ejecutara este tipo de proyecto. El proyecto aprobado en la 27ª Reunión se aprobó por un valor de 60 000 \$EUA. Los 28 000 \$EUA para un taller sobre alternativas al metilbromuro en el Caribe abordaría el pequeño consumo remanente en algunos países del Caribe, relacionado fundamentalmente con el uso de metilbromuro en canchas de golf, que puede estar sujeto a algunas cuestiones de propiedad transnacional.
- 16. El PNUMA ha asignado 226 000 \$EUA para África para abordar la armonización de la legislación relacionada con la supervisión del consumo de SAO en la región de la Comunidad del África Meridional para el Desarrollo (SADC)/Unión Aduanera del África Meridional (SACU) y la región de Cooperación de África Oriental (EAC). Este proyecto sería similar al proyecto ejecutado en África central y occidental, en el que participaron las uniones aduaneras y monetarias subregionales, aprobado en la 32ª Reunión en diciembre de 2000 (AFR/SEV/32/TAS/28). El PNUMA prevé realizar dos reuniones para el proyecto existente en mayo y junio de 2000 para África central y occidental. Este proyecto se está supervisando como proyecto con demoras en la ejecución.
- 17. Los fondos para la actividad prevista en África meridional y oriental se usarían para permitir la organización de reuniones de consulta en la que participarían ministros del medio ambiente y finanzas y funcionarios de comercio y aduanas a fin de incluir cuestiones relacionadas con las SAO en los reglamentos de control del comercio existentes a nivel regional, de manera que sea obligatorio para los países sancionar estos reglamentos a nivel de cada país. El proceso también permitiría establecer un sistema subregional para combatir el contrabando de SAO.
- 18. De conformidad con la Decisión 35/57, párr. a), el PNUMA ha incluido 226 000 \$EUA (incluidas las tasas de organismo) para sensibilización del público, tanto en 2004 y como en 2005.

Agilización de la ejecución de los proyectos

19. El PNUMA ha incluido en su plan administrativo una sección sobre la agilización de la ejecución de proyectos a continuación de una sección sobre la mejora de las operaciones de los programas a fin de responder mejor a las necesidades de los países respecto del cumplimiento. En el Anexo I a su plan administrativo, el PNUMA incluyó una lista detallada de Actividades país por país a ser ejecutadas por el personal del Programa de Asistencia al Cumplimiento en

2004. Especifica, por país, el nombre del servicio especial o proyecto aprobado del Programa de Asistencia al Cumplimiento, si la actividad era un proyecto aprobado en forma independiente o parte del presupuesto del Programa de Asistencia al Cumplimiento por número de proyecto o un servicio especial de dicho programa, anticipa las misiones del Programa de Asistencia al Cumplimiento, si la actividad se realiza en apoyo de la labor de otros organismos o Secretarías y comentarios de otros organismos (principalmente el PNUD y los organismos bilaterales). Indica que se abordarán 418 actividades independientes, incluidos 179 servicios especiales y 84 misiones del Programa de Asistencia al Cumplimiento.

Indicadores de desempeño

20. En la Tabla 1 a continuación se presenta un resumen de los indicadores de desempeño del PNUMA de conformidad con la Decisión 41/93.

- 21. El PNUMA acordó establecer objetivos de logros del 100 por ciento para dos de sus indicadores de desempeño. Sin embargo, el examen interno del PNUMA indicó que podría no cumplir con estos objetivos. El PNUMA, por lo tanto, proporcionó sus propios objetivos internos para estos indicadores.
- 22. La base de datos del plan administrativo del PNUMA indica que eliminaría 65 toneladas PAO con las actividades ajenas a la inversión aprobadas en 2004.
- 23. La Tabla 2 proporciona los objetivos para los indicadores de desempeño para el Programa de Asistencia al Cumplimiento del PNUMA de conformidad con la Decisión 41/93.

 - b) Presupuesto para escuelas en el terreno para agricultores en el nivel mundial y en el Caribe;

- c) Asistencia técnica por valor de 226 000 \$EUA en África;
- 2. Aprobar los indicadores de desempeño para el PNUMA expuestos en las Tablas 1 y 2 de los comentarios de la Secretaría del Fondo como figuran en UNEP/OzL.Pro/ExCom/42/9.

I. MULTILATERAL FUND TARGETS

A. MEETING THE OBJECTIVES OF THE MULTILATERAL FUND

1. Development of this Business Plan

In developing this 2004 Business Plan, UNEP used the revised 2003-2010 Phase-out Plan for the Multilateral Fund (as of December 2003) prepared by the Multilateral Fund Secretariat and country needs articulated to UNEP by National Ozone Units (NOUs) during the course of 2003. The regional Compliance Assistance Programme (CAP) teams played the lead in assisting countries in prioritizing their needs and project proposals through their direct interaction with the Ozone Officers through the Regional Networks of ODS Officers and other regular communication.

Upcoming compliance reduction targets in the years 2005 and 2007 for CFCs, halons, CTC, TCA and methyl bromide are the drivers for the development of this business plan.

Activities in this Business Plan address the objectives and key priorities for future operations of the Multilateral Fund as stipulated in the Strategic Planning documents adopted by the Executive Committee. This Business Plan conforms to the relevant decisions of the Executive Committee, *inter alia*:

- Decision 37/68, which established the model rolling three-year phase-out plan for the Multilateral Fund as a flexible guide for resource planning for the 2003-2005 triennium, taking into account the results generated by the compliance-oriented model reflecting approvals at the 38th meeting;
- Decision 38/66, which urged Article 5 countries and their cooperating implementing agencies to accelerate the pace of implementation during the 2003-2005 time frame;
- Decision 35/57, Proviso D and the related Decision 36/7, which established US \$12.10/kg as the interim figure to account for CFC consumption of non-investment activities in non-low volume-consuming countries (non-LVCs) other than those in national and sectoral phase out plans with LVCs being exempted from that requirement.
- Decision 35/57 (a), which established funding levels for Institutional Strengthening (IS) projects and renewals at a level that is 30 per cent higher than the historically agreed level until 2005 and provides UNEP with US\$ 200,000/year to support public awareness and directs UNEP to provide countries with enhanced direct support on policy and substantive issues through the CAP.
- Decision 35/5, which requests that funds approved annually for the CAP but not spent be returned to the Multilateral Fund for re-programming at the second meeting of the Executive Committee in the year following that for which they had been approved.
- Decision 41/38, which approved the 2004 CAP budget.
- Decision 41/93, which approved performance indicators (including specific ones for CAP) for the evaluation of the performance of the implementing agencies.

This Business Plan also reflects decisions of the 15th Meeting of the Parties related to non-compliance. Additionally, UNEP proposes to play a supportive role to several decisions related to all Parties, through, for example, the Information Clearinghouse.

Several other important sources contributed to this Business Plan: the CAP Advisory Group Meeting (Paris, 11 September 2003) and the Multilateral Fund evaluation reports related to the Regional Networks, the Information Clearinghouse, IS projects and Training.

UNEP has maximised cooperation and eliminated possible overlaps with other Implementing Agencies and bilateral agencies through:

- Participation in the Inter-Agency Coordination Meeting (Montreal, 5-6 February 2004);
- Following written and oral guidance of the Multilateral Fund Secretariat;
- Reviewing available submissions of the other Implementing Agencies and bilateral agencies;
- Direct and informal discussions with the agencies; and
- Sharing UNEP's draft Business Plans Annex I (Country-by-Country Activities to be Implemented by CAP Staff in 2004) with the other agencies for comment.

2. Funding for CAP Activities versus Funding for Country-Specific Projects

In light of UNEP's budget cycle and administrative system, the core budget for the Compliance Assistance Programme (CAP) must be approved prior to the following year (e.g. funds to cover staff salaries must be approved prior to 1 January). Hence, UNEP submitted the 2004 CAP operating budget to the 41st meeting for the Executive Committee's consideration. In Decision 41/38, the Executive Committee approved the CAP core budget¹ in the amount of US\$ 6,757,900, with support costs of US\$ 540,632, as per the basis specified in the decision.

Using these already-approved CAP budget resources (i.e. no additional funds will be requested by UNEP), in 2004 UNEP will provide:

- Special CAP services for specific countries (see next paragraph);
- South-South Assistance;
- Information Clearinghouse.

Annex 1 provides the specific special CAP services to be delivered to different countries in 2004. These services include:

- Helping develop the capacity of new Ozone Officers and supporting recently-established NOUs;
- Assistance with resolving data reporting problems;
- Assistance with understanding the implications of ratification of the ozone treaties and amendments:
- Rapid response to urgent compliance problems, including missions to countries;
- Technical assistance in refrigerant management, methyl bromide and halon sectors, including backstopping support for projects being implemented by other agencies;
- Assistance with the development, review and enforcement of policies and legislation;

Support for customs officials and initiatives related to prevention of illegal ODS trade;

- Information services and support for national information and awareness initiatives.
- Assistance with implementing previously-approved projects (e.g. IS projects, development of CPs//RMPs and sector strategies, training related to RMP implementation).

In this Business Plan, UNEP is also requesting funding for new projects for specific countries and regions based on their compliance needs. These new projects are detailed in the Database (Annex III). The funding requested for those projects includes only the resources which are directly provided to the countries required for implementation (e.g. local consultants). CAP staff (already funded under the approved 2004 core UNEP budget) will assist with the implementation of the approved new projects by providing the required external technical assistance (e.g. in the field of policy, refrigeration, methyl bromide and halon experts).

3. Planned Activities and the 3-Year Phase-out Plan

Under this Business Plan, UNEP will support the 2004-2006 phase-out plan for the Multilateral Fund primarily through:

- Providing direct technical and policy assistance to countries through the CAP to enable and sustain compliance.
- Assisting LVCs. UNEP expects to remain the agency providing the largest amount of assistance to this category of countries throughout the triennium. This assistance will include Institutional Strengthening, Country Programme (CP) and RMP update, RMP implementation and other non-investment support.
- Supporting development of Refrigerant Management Plans (RMPs), RMP updates, and training related to RMP implementation. For most of the LVCs, the refrigeration sector is the largest ODS consumption sector, and the successful implementation of these RMP activities will largely determine whether or not the countries meet the CFC compliance targets. Accordingly, RMP activities will be essential in the 2004-2005 period.
- <u>Helping Article 5 countries address small consumption</u> of carbon tetrachloride (CTC), trichloroethane (TCA), halons and methyl bromide.

4. Business Plan Vision for the Triennium

In addition to the compliance targets already passed, the critical compliance targets for Article 5 countries during 2004-6 are:

The overall vision of UNEP's Business Plan during this triennium is to:

- Enable countries to achieve and sustain compliance with the control measures of the Montreal Protocol through technical and policy assistance;
- Promote a greater sense of country "ownership" by helping countries integrate the CPs and ODS phase-out strategies into their country's national environmental plans or strategies;
- Support performance-based national and sectoral phase-out plans through policy and legislation development and enforcement, particularly for LVCs.

5. Programme Priorities in 2004

UNEP considers Article 5 countries to be the "clients" for CAP services, and accordingly will strive to increase its client focus to help countries overcome specific compliance challenges in 2004 through the following means:

- Regional Networking and Information Clearinghouse services;
- Targeted compliance assistance services as part of the CAP (detailed in Section II.A.3 and Annex I) and
- On-going and new projects for individual countries/regions (detailed in Section II B and Annex III).

In 2004, UNEP's priorities will be to:

- Assist Article 5 countries that are in actual or potential non-compliance to achieve compliance (see Annex II);
- Enable Article 5 countries to meet the 2005 control measures for CFCs, halons, CTC, TCA, and methyl bromide, and the 2007 control measure for CFCs through technical and policy assistance;
- Develop and implement programme to ensure that those countries that report zero consumption of methyl bromide, CTC, TCA and halons sustain such levels of consumption;
- Provide assistance to LVCs through implementation of RMPs;
- Expedite implementation of already-approved UNEP projects;
- Sustain the phase out already achieved in Article 5 countries through the provision of advisory services, training, support for public awareness, and the provision of a clearinghouse function.

B. RESOURCE ALLOCATION

At their 14th Meeting (25 - 29 November, Rome), the Parties to the Montreal Protocol adopted a budget of US\$ 573 million for the 2003-2005 replenishment of the Multilateral Fund². Taking into account funds approved in principle and other commitments, the resulting allocation for 2004 would be US\$ 257 million available for business planning commitments³.

In addition to the funding provided by the Multilateral Fund, the Governments of Sweden and Finland provide additional resources above and beyond their contributions to enable developing country compliance with the Montreal Protocol. Sweden supports the Regional Network of ODS Officers for South-East Asia and the Pacific (SEAP), and Finland provides assistance to support non-Parties to become Parties. UNEP assists Sweden and Finland with the implementation of those activities.

C. Special Initiatives in 2004

1. Promote Greater South-South/North-South Cooperation

Increasingly UNEP views direct cooperation between countries as a cost-effective way to meet technical and policy compliance challenges while at the same time strengthening inter- and intra-regional cooperation. UNEP will significantly increase such assistance during 2004 using resources approved by the Executive Committee as part of the 2004 CAP operating budget. UNEP's Regional CAP teams will actively identify needs for such assistance and facilitate the travel of Ozone Officers and experts for targeted missions, with priority being given to countries in actual or potential non-compliance. UNEP will coordinate the South-South missions with the relevant Implementing Agencies and bilateral agencies.

2. Help Countries Maintain Zero Consumption

UNEP will continue to provide direct policy and technical assistance through CAP staff to Article 5 countries to help ensure that those countries that have reported zero consumption of methyl bromide, CTC, TCA and halons sustain such levels of consumption. This assistance will include, *inter alia*, support for policy development and enforcement to prevent future growth of consumption.

3. Support Methyl Bromide Phase Out through Farmer Field Schools

UNEP, in partnership with the Food and Agriculture Organisation (FAO), will continue to support methyl bromide phase out through the Farmer Field School (FFS) programme that trains farmers and extension workers in Article 5 countries on alternatives to methyl bromide. These projects will be closely coordinated with the other Implementing Agencies and bilateral agencies to ensure complementarity. As part of this ongoing initiative, UNEP is submitting a proposal for one FFS project in this Business Plan. UNEP will also work with other Implementing Agencies to incorporate the FFS approach into their methyl bromide work plans.

4. Assist NOUs with Improving/Troubleshooting Data Reporting

Consistent with Meeting of the Parties' Decision XIV/13 and the recommendations of other Implementing Agencies during the Informal Consultative Meeting with Implementing Agencies about CAP, UNEP will provide additional assistance to countries that have not reported data or that have expressed difficulties in reporting annual as well as baseline data. As part of CAP, UNEP will provide direct assistance to NOUs through its regional CAP teams, and information support through the clearinghouse service. In 2004, data reporting assistance is included as two of the newly-approved CAP performance indicators (see Section III). As per Decision 40/11(b), UNEP will offer its assistance to all countries in non-compliance with data reporting obligations

or lacking baselines (UNEP will first consult the NOU and the respective Implementing Agency responsible for the country's IS project to see if such assistance is desired).

5. Promote Ratification of Montreal Protocol and Amendments

Consistent with Meeting of the Parties Decision XIV/1, UNEP will continue to use its regional CAP teams in co-operation with the Ozone Secretariat to identify and work with the remaining 6 developing countries that have not yet ratified, approved or acceded to the Vienna Convention and the Montreal Protocol and its Amendments to do so at the earliest⁴. UNEP will also help explain the implications to countries as regards HCFC supplies resulting for non-Parties to the Copenhagen Amendment (as well as continuing to promote "avoiding the double phase out" by adopting non-HCFC options when possible).

6. Support for New Parties

UNEP will provide extra CAP support and attention to new Parties to the Montreal Protocol to ensure that the capacity of the NOU is built quickly to ensure that it operates effectively. UNEP is also including requests for National Compliance Action Plans for the new Pacific Island Country Parties, i.e. Cook Islands, Nauru and Niue. Additionally, CAP will provide assistance (including but not limited to information services) to new Portuguese-speaking Parties in cooperation with bilateral agencies and other Implementing Agencies.

7. Assist with Monitoring of ODS Trade and Prevention of Illegal Trade

In response to Meeting of the Parties Decision XIV/7, UNEP will encourage Parties to (a) exchange information and intensify joint efforts to improve means of identification of ODS and prevention of illegal ODS traffic (b) make even greater use of the Regional Networks to increase co-operation on illegal trade issues and enforcement activities. UNEP, through the Executive Committee, will report to the 16th Meeting of the Parties on the activities of the regional networks with regard to means of combating illegal trade. UNEP will also continue to work with regional customs institutes to ensure that training on these subjects is integrated into ongoing curricula.

8. Help NOUs Phase out Miniscule ODS Consumption

In 2003, UNEP used the CAP to assist the countries to verify actual consumption levels of CTC, TCA and methyl bromide in countries consuming less than 10 MT per annum. In 2004, UNEP will offer assistance to NOUs in those countries through its regional teams and the information clearing-house to help them reduce this consumption. Among the approaches to be considered would include: using small-group Network meetings involving Implementing Agency experts and/or Solvent Technical Option Committee members, collecting and disseminating targeted information related to the concerned sub-sectors, and facilitating matchmaking with experts from willing developed and developed countries with expertise in the concerned sub-sectors. If such assistance is not sufficient to eliminate the consumption, UNEP will work with other Implementing and bilateral agencies to identify and develop projects/activities to eliminate this remaining consumption. UNEP will also continue to assist

countries identified in the status report as consuming small amounts but not included in any agency's 3-year business plans for the triennium, to determine the proportion of such consumption that is eligible for phase-out.

9. Support for Halon Management and Halon Banking

Most halon consumption is in high-volume consuming countries, and it is being addressed through sector plans and investment projects and it does not form part of the Fund's *Compliance-oriented ODS Phase Out Model*⁵. However, UNEP believes that there is still a need for support for halon management (even in countries that have reported zero consumption under Article 7), in particular (but not limited to) low-volume halon-consuming countries. There is also need to support halon banking initiatives being implemented by other Implementing Agencies and bilateral agencies. Accordingly, in cooperation with those agencies, UNEP will use the CAP Halon Officer as a "backstopping" technical support for halon management and halon banking projects, in addition to provision of information through the Clearinghouse.

II. PLANNED BUSINESS ACTIVITIES

A. MEASURES TO EXPEDITE IMPLEMENTATION OF APPROVED PROJECTS AND THOSE CRITICAL TO COMPLIANCE

1. Improving Programme Operations to Better Respond to Country Compliance Needs

In 2002, UNEP re-orientated its OzonAction Programme into the Compliance Assistance Programme to better respond to the needs of developing countries during the compliance period. Staff, projects and responsibilities have been devolved to the regions to provide improved and direct support to Article 5 countries. This re-orientation features regional delivery of key services and project support needed by countries to meet specific compliance targets, and location of specialized personnel in the following UNEP Regional Offices to ensure close, regular working contact with the countries:

The CAP team includes 25 full-time equivalent professional staff world-wide who provide countries with advisory and support services related to policy, refrigerant management, customs training, combating illegal trade, methyl bromide phase out, halons, and information exchange. These staff also have significant knowledge and experience of their regions. All of the CAP posts have been recruited and the staff are in place providing services to countries⁶. This team is

a common resource under the Multilateral Fund and can contribute much to national, regional and sectoral phase out plans and programmes. It is also working with other Implementing Agencies and bilateral agencies to support and facilitate their work in the regions.

2. Expediting Implementation of Approved Projects

The timely implementation of already-approved projects is critical to achieve the phase-out objectives of the 2003-2010 Phase-out Plan for the Multilateral Fund. This is reinforced by Executive Committee Decision 38/66, which urges Article 5 countries and their cooperating implementing agencies to accelerate the pace of implementation during the 2003-2005 timeframes. UNEP management will continue to accord this issue high priority, and expedite the implementation of approved projects through regular monitoring and follow up.

The OzonAction Management Information System (oMIS) operationalised in 2003 affords UNEP a clear overview of the implementation status of all UNEP-managed projects in all regions. In 2003, UNEP also established a bi-monthly Management Brief based on information provided by oMIS that is sent to all CAP staff and Regional Directors. The Brief analyses trends, emphasizes implementation priorities including those identified during Executive Committee meetings and Meetings of the Parties, and highlights critical areas that need immediate attention from CAP staff. This detailed analysis allows for closer management control and ensures rapid reaction to projects with implementation difficulties.

Since adopting this systematic approach (oMIS and Management Briefs) in 2003, project monitoring and implementation has significantly improved. UNEP therefore will continue the practice in 2004 and expects this to assist in expediting implementation of approved projects.

3. CAP Services for Specific Countries in 2004

The need for CAP services in 2004 has been identified by the regional teams through interaction with the countries during the Business Plan preparation process. UNEP has also closely coordinated with Implementing Agencies and bilateral agencies to ensure that there is no duplication of Annex I services and that mutually-reinforcing activities have been included. As a new feature for the 2004 Business Plan, this annex provides a snapshot of what UNEP is doing in each country by including not only CAP services but also individual ongoing projects approved by the Executive Committee, special compliance missions for each country and references to CAP assistance in support of projects being implemented by other Implementing Agencies and bilateral agencies.

As indicated in Annex I, in total UNEP will provide direct assistance through the CAP to 147 developing countries (including all 6 developing country non-Parties and the Palestinian Authority) in 2004. This will comprise 418 CAP services (84 of which are in support of the work of other Implementing Agencies, bilateral agencies and/or the Ozone Secretariat) plus support for approximately 160 on-going approved projects. UNEP anticipates 179 CAP missions to countries in relation to these services.

Beyond these anticipated services, CAP team members will be available at all times to respond to unplanned requests by Article 5 countries for urgent assistance, with priority given to those in actual or potential non-compliance.

4. CAP Logical Framework Analyses and Regional Initiatives

Each regional CAP team and the clearinghouse used the Logical Framework Analysis (LFA) methodology to establish long, medium and short-term objectives for their groups vis-à-vis the compliance needs of Article 5 countries. The LFAs, which are used for internal work planning purposes, are presented in Annex IV.

In response to the changing compliance landscape of Article 5 countries, the special initiatives and focus areas for the Regional CAP teams and Information Clearinghouse in 2004 are:

Regional Office for Africa: - For the Africa region, the ROA CAP team will place special focus on ensuring that new Parties do not remain behind the phase out schedule. This will be done by ensuring that all new Parties that benefited from Multilateral Fund support are able to implement more than 50% of their approved projects by end of 2004. All new Parties in Africa being LVCs, UNEP believes that intensive training of stakeholders and awareness raising combined with immediate implementation of import control will have an impact on the reduction of ODS consumption in the year to follow.

At a different level, the objective of the ROA CAP team is to ensure that countries that already completed phase out activities including training programme are fully aware of the 50% reduction target in 2005 and that measures are put in place for these countries to comply by the end of 2004. This will be achieved through a strong focus on the 50% reduction during the 2004 Region Network meetings and also through visits and working sessions with NOUs in countries where that goal is likely not to be met. Though not directly compliance-related, the ROA CAP team intend to all means available at the regional Office for Africa to ensure that Equatorial Guinea and Eritrea, the last two African countries that have not yet ratified become Parties to the Montreal Protocol.

Regional Office for Asia & the Pacific: Based on the non-compliance decisions of the 15th Meeting of the Parties, ROAP CAP will provide technical and policy assistance to those countries in actual or potential non-compliance to enable them to develop plans of action to ensure a prompt return to compliance, taking into consideration existing phase out strategies being implemented by the other Implementing Agencies.

Achieving compliance is not the same as sustaining compliance. Without the correct policies and legislation in place and without the commitment of all stakeholders, consumption can easily rise. Hence, CAP teams will develop an "early warning system" to inform the Parties of potential non-compliance situations and to assist countries to establish policies, legislation and regulations needed to comply with the control measures.

The ROAP CAP team will provide permanent capacity to backstop the operational activities to be conducted by countries and other Implementing Agencies and help strengthen the expertise

of local experts in each of the sectors. The team will take steps to improve North-South and South-South cooperation to add value to the work already going on in the region. The team will provide complementarity to the work of other agencies.

Recognizing that illegal trade could undermine the phase-out efforts undertaken by the countries in the region, the ROAP CAP team will address issues of illegal trade through awareness, information exchange, sub-regional cooperation and training.

Regional Office for Europe: Countries with economies in transition (CEITs) operating under Article 5 are distributed throughout the Pan-European region. They are surrounded by both CEITs operating under Article 2 and the developed countries members of the European Union. A blend of expertise and experience in all aspects of ODS phase-out is accumulated in the developed countries and some Article 5 countries in advanced stages of the implementation of the Montreal Protocol. This specific situation determines the focus of work of the CEECA Regional Network and services to be provided by the CAP team. The priority for the year 2004 will be to promote and enhance the regional cooperation, both within Article 5 group of countries and with Article 2 neighbours. Such cooperation will be crucial to tackle problems of common concern, in particular illegal trade. Collaboration with European Ministerial processes, including "Environment for Europe", and various regional and sub-regional initiatives and organizations, such as the Balkans Stability Pact and the Central European Initiative, will be promoted with a view to raising the political profile and awareness of the Montreal Protocol objectives. The CAP team will facilitate direct country-to-country assistance to those countries facing immediate and long-term compliance challenges through exchange of experience with Network countries, establishment of contact groups and involvement of local experts. The CAP will complement, support and backstop the work of the other Implementing Agencies in the region in areas of its comparative advantage and expertise.

Regional Office for Latin America & the Caribbean: The implementation of Montreal Protocol should be driven collectively and mutually by national authorities, private sectors, NGO's and other stakeholders given that all have important and critical roles and responsibilities in meeting and sustaining compliance. In this regard, sectorial institutional capacity building activities are focused on government officers, users of ODS and civil societies. Further, there are training and capacity building initiatives targeting the specific needs of countries and in particular those in non-compliance or having the potential of becoming into non compliance. In keeping with the theme of Sustainable Capacity Building, further initiatives will be taken to the strengthening of North-South and South-South Cooperation both interregional and intraregional, and preventing illegal trade of ODS and ODS-dependent technologies at the sub regional level.

Recognizing that this region comprises LVCs, non-LVCs and ODS-producing countries, many at different stages of implementation of the Montreal Protocol, the ROLAC CAP team will provide quality services and products aimed at strengthening and building capacities of targeted stakeholders in the countries, enabling them to comply with the provisions of the Montreal Protocol in a sustainable manner. With ODS trade restricted through national quota systems, a major effort will be directed at balancing the supply and demand side aspects of ODS phase-out strategies. All national policies and activities (i.e. legislation, enforcement, training, or awareness rising) will be synergized and improved with enhanced regional cooperation to

prevent illegal trade which will be crucial for a sustained compliance. Recognizing also, that there is a strong NGO presence in a number of countries in the region, the CAP team will leverage NGO expertise to assist the country strategies in the phase out. Due to physical proximity of some countries in the region to Antarctica, media awareness can be used as good tools for the protection of the ozone layer. The presence of experts from industry and governments will be used to promote local participation in phase out activities.

Regional Office for West Asia: The ROWA CAP team will assist with monitoring of ODS trade and prevention of illegal trade by using existing capacities in the region through coordination with regional organizations such as the Gulf Cooperation Council (GCC), League of Arab States (LAS), Regional Intelligence Liaison Office (RILO), and regional representative of the World Customs Organisation (WCO) for the North Africa, Near and Middle East to include ODS in the agendas of 2004 customs fora and exploring ways of monitoring trade of transit and deterring illegal ODS trade.

The team will also promote the use of hydrocarbons in the refrigeration and air conditioning (RAC) sector as an available alternative in the region. CAP will assist in the implementation of a comprehensive action plan for using the natural hydrocarbon resources in the region as a suitable alternative for ODS in the RAC sector. If this happens, it will help NOUs in the region to expedite the implementation of their strategies in phasing out the ODSs.

ROWA CAP will promote the formulation of unified regulations as a tool for enhancing the national legislations in the region. The CAP team will assist with the enactment of unified regulations for all GCC countries as some of them have to follow long procedures in order to enact their national legislation.

ROWA CAP will continue to assist countries and bilaterals in establishing a comprehensive regional strategy for halon management. In consultation with NOUs and relevant stakeholders, ROWA CAP concluded that some countries in the region will have difficulties in cutting their consumption of ODSs by 50% by January 2005. The lack of communication between NOUs and private sector on one side, and between countries on the other side, accounts for the absence of proper management in this ODS. Feedback from NOUs indicates that countries in the region assign importance to having a comprehensive regional strategy to organize the flow of available halons in the region between countries and to be in compliance with the obligations of Montreal Protocol.

Information Clearinghouse: UNEP Paris, in cooperation with the Regional CAP teams, Implementing Agencies and bilateral agencies, will continue its work to outreach the *Communication Strategy for Global Compliance with the Montreal Protocol* to NOUs and work with them to help ensure that the development of regional awareness projects and national awareness campaigns take place in the context of the strategy. In 2004, the UNEP clearinghouse will develop a guidance document based on the *Communication Strategy* to assist NOUs with taking a structured approach to information, education and communication (IEC) activities at the national level. The clearinghouse staff will also participate in small group Network meetings being organized by regional CAP teams to develop regional IEC strategies. As

required by Decision 41/99, in 2004 UNEP will make its second report to the 44th Executive Committee on results and progress made in implementing the strategy.

In 2004, the clearinghouse will offer prioritized information assistance to countries currently in potential or declared non-compliance, in cooperation with the Regional CAP teams, Implementing Agencies and bilateral agencies.

UNEP Paris will continue to work in cooperation with the Multilateral Fund Secretariat to harmonise information and outreach activities, and support the objectives of the Fund's *Information Strategy*. This will include promoting the "corporate image" of the Multilateral Fund as agreed with the Secretariat and the dissemination of information about the success stories/activities of other Implementing Agencies and bilateral agencies.

In addition to its ongoing core clearinghouse services (e.g. providing web sites, support for Ozone Day celebrations, conducting events and outreach activities, the OzonAction Newsletter, E-news services, query response including publication dissemination, production of CD-ROMs, development of printed outreach materials), in 2004, the clearinghouse will also:

- Initiate and/or develop on-line training initiative related to refrigeration servicing and customs training.
- Develop an electronic inventory of IEC products developed by NOUs and a contacts database of organizations with IEC expertise to promote sharing of ideas and resources between NOUs.
- Continue encouraging NOUs to mobilize resources for IEC (financial, human and intellectual) from multiple sources, and collect and disseminate examples from developed and developing countries.

B. PROGRAMME DEVELOPMENT

As indicated in Annex III to this Business Plan (Database), in the 2004-2006 period UNEP proposes project assistance for 99 Article 5 countries (of which 85 are classified as LVCs, 14 are non-LVCs, and 32 have been declared in non-compliance or potential non-compliance by the 15th Meeting of the Parties). This assistance comprises 329 ongoing and new projects valued at US\$ 42 million (including programme support costs) provided through the following types of non-investment projects:

- Preparation and updates of CPs/RMPs to help countries prepare, adopt and implement national compliance planning.
- Training related to RMP implementation in the areas of policy, customs and refrigeration technician training.
- Other training in specific technical and policy areas.
- Technical and policy assistance in specific areas: the CAP, implementation of non-investment components of National Compliance Assistance Plans (NCAPs), technical assistance and policy development related to methyl bromide alternatives, and regional and national awareness raising activities.

For the projects being proposed by UNEP for funding in 2004-6, the funding goes directly to countries with CAP staff providing the human resources required for implementation of the

projects. The funding for such services provided by CAP staff is not requested in these projects.

In addition to the planned activities indicated in the database, UNEP anticipates that the 6 remaining non-Parties to the Montreal Protocol (see footnote 4 above) will become Parties during this triennium and that they will request assistance with CP/RMP formulation, IS projects and possibly other non-investment activities (particularly training related to RMP implementation). Accordingly, these may be potential additional Business Plan activities that UNEP will submit to the Executive Committee for individual consideration as and when the Parties approach UNEP for assistance.
