STATUS/PROSPECTS OF ARTICLE 5 COUNTRIES IN ACHIEVING COMPLIANCE WITH THE INITIAL AND INTERMEDIATE CONTROL MEASURES OF THE MONTREAL PROTOCOL

This document is issued to provide the following corrections:

- **Delete** Brazil from the second sentence of paragraph 14.
- In the first sentence of paragraph 71, **replace** 22 **with** 23 and **add** Argentina to the last sentence.
- In the first sentence of paragraph 72, **replace** 30 **with** 29. In the second sentence **replace** 19,088 **with** 11,776. In the third sentence **replace** 13 **with** 12 and 30 **with** 29 and **delete** Argentina (7,371 ODP tonnes).
- In the first sentence of paragraph 73, replace 30 with 29 and delete Argentina.
- **Replace** paragraph 74 with the following:
 - 74. The Multilateral Fund had provided funding for CTC projects and activities in 6 of these 29 countries, of which 5 countries had received approved projects for CTC phase-out (Bangladesh, India, Korea DPR, Pakistan and Romania)
- In the first sentence of paragraph 77, **replace** 30 **with** 29 and 13 **with** 12. In the second sentence **delete** Argentina.
- In paragraph 135, **replace** the last sentence **with** "2003 Article 7 data on methyl bromide indicates that Uruguay is in compliance with the methyl bromide freeze."

- In Annex III, **replace** the data for completion of approved projects in column 4 for Jordan **with** "100% by 2015".
- In Annex IV **delete** the entry from Argentina in "countries that may need additional actions to ahieve compliance" and **add** the following entry to the section entitled "countries that appear to be in compliance".
