### SECTION A: ACTIVITIES RECOMMENDED FOR BLANKET APPROVAL

## **I:** Project preparation

#### Fund Secretariat's recommendation

3. The Fund Secretariat recommends blanket approval of the project preparation activities listed in Table 1 above at the level of funding indicated.

#### **II:** Renewal of institutional strengthening project

(a) Bosnia and Herzegovina (phase II)

US \$95,333

### Project description

1. The description of the institutional strengthening project for the above country is presented in Annex I to this document.

#### Fund Secretariat's comments

2. Bosnia and Herzegovina reported 2003 consumption of Annex A, Group I substances (CFC) of 230 ODP tonnes, which is below the agreed benchmark (235.3 ODP tonnes) as per decision XIV/21 of the Fourteenth Meeting of the Parties.

#### Fund Secretariat's recommendation

3. The Fund Secretariat recommends the above activity for blanket approval at the level of funding as shown in Table 1. The Executive Committee may wish to express to the Government of Bosnia and Herzegovina the following comments.

"The Executive Committee has reviewed the report presented with the institutional strengthening project renewal request for Bosnia and Herzegovina and notes with appreciation that Bosnia and Herzegovina submitted its plan of action to the Implementation Committee, as per decision XIV/21 of the Fourteenth Meeting of the Parties, with time-specific bench-marks to ensure a prompt return to compliance and that the 2003 CFC consumption level reported to the Ozone Secretariat is below the agreed benchmark. As such, the Executive Committee notes that within the framework of the institutional strengthening project, Bosnia and Herzegovina has taken significant steps to phase out its ODS consumption. Specifically, intensifying its awareness activities; organizing seminars for stakeholders; initiating the development of a system for information collection and monitoring of ODS consumption; and drafting of related environmental legislation. The Executive Committee greatly supports the efforts of Bosnia and Herzegovina to reduce the consumption of CFCs. The Executive Committee is therefore hopeful that, in the next two years, Bosnia and Herzegovina will continue with the implementation of its country programme and refrigerant management plan activities with outstanding success in the reduction of current CFC consumption levels."

### Progress Report

1. During the reporting period, the National Ozone Unit (NOU) of Bosnia and Herzegovina was established and consolidated. The NOU revised and updated the country programme for consideration by the Government. The initial steps in the creation of a system for information collection and monitoring of ODS consumption were taken. The NOU prepared a basic institutional model for an ODS import licensing system. Draft regulations are in the final stage of preparation. The NOU is also involved in the preparation and drafting of the Framework Law on Environment Protection, as well as in the creation of an Environment Agency. The NOU organized several public workshops, round tables, and presentations with significant participation and published related brochures. Several statements and interviews were also shown in various local radio and TV stations.

- 2. The NOU is located in the State Ministry of Foreign Trade and Economic Relations, which is also acting as the State Ministry of Environment and National Resources Management. A National Steering Sub-committee for the Ozone Layer Protection was established by a decision of the National Steering Committee for Environment and Sustainable Development in September 2002. The Sub-committee's (ten) members are drawn from Government institutions, ODS consumers (enterprises), NGOs and independent experts. While the Sub-committee acts as the direct supervisor of the NOU, the annual operational work-plan of the NOU is integrated within the operational work-plan of the Ministry of Foreign Trade and Economic Relations.
- 3. The NOU of Bosnia and Herzegovina was one of the initiators for the establishment of the Regional Network for Europe and Central Asia and was directly engaged in the preparation of the Network working programme and the project document for its first two years of operations.

#### Plan of Action

4. During the next IS period, the NOU of Bosnia and Herzegovina will continue its activities related to the creation of policy and legislative measures for the implementation of the Montreal Protocol. Specific emphasis will be put on ratification of the Beijing Amendment, the application of the monitoring system, the drafting and adoption of the environmental law by the State Parliament, as well as on adoption of the Act on taxes on CFCs use and of the Act on banning import of equipment containing CFCs. Awareness activities will continue to be developed, as well as the organization of training workshops for custom officers and refrigeration service technicians under the RMP.
