Progress Report

1. During the reporting period, the National Ozone Unit of Turkey was involved in the establishment of the methyl bromide (MB) National Strategy Committee, the MB Administration Committee and Inspection System. Information on MB usage and phase-out were given to farmers and the public. A set of 30,000 information posters and 3,000 brochures were published concerning the use of MB, its disadvantages and the importance of alternatives. Awareness workshops and training programmes were also organized for technical and support staff. The Ministry of Environment and Forestry (MoEF) regularly informs stakeholders on alternative substances to ODS, prospective technological applications and Montreal Protocol regulations and decisions.

2. The Ministry of Environment and Forestry is the main coordination and enforcement body for Montreal Protocol activities. The Ozone Panel mechanism, which is held every year, is composed from other concerned Ministries, industry representatives and universities. Its purpose is to develop consensus on ozone policy and to build up the Regulatory Framework component of the national ozone policy.

Plan of Action

3. During the next institutional strengthening period, the NOU of Turkey will continue its activities related to the effective phase-out of ODS consumption in the country, in compliance with the Montreal Protocol. These activities will be associated with a further increase of public awareness on ozone protection. Training programmes on the application of MB alternatives will be organized for the technical staff, farmers, pesticide distributors, and MB fumigators of soil and storage buildings. Awareness-raising studies are planned in order to reduce the servicing demand for ODS and to serve as a tool to prevent illegal trade. The cooperation between the MoEF and other government and non-governmental agencies, such as the Ministry of Agriculture & Rural Affairs (MARA), the undersecretariats of Foreign Trade, Treasury, and Customs, and the Technology Development Foundation of Turkey (TTGV), will be further developed to fulfill the obligations of the quota system and to prevent illegal trade in ODS and ODS mixes.

VIEWS EXPRESSED BY THE EXECUTIVE COMMITTEE ON RENEWALS OF INSTITUTIONAL STRENGTHENING PROJECTS SUBMITTED TO THE 44TH MEETING

Turkey

1. The Executive Committee has reviewed the report presented with the institutional strengthening project renewal request for Turkey and notes with appreciation that Turkey reported data to the Ozone Secretariat that was lower than its 1995-1997 average CFC compliance baseline. Turkey therefore appears to be in compliance with the CFC consumption freeze levels. The Executive Committee also notes that, within the framework of the institutional strengthening project, Turkey has taken significant steps to phase out its ODS consumption. Specifically, those steps are: the establishment of the MB National Strategy Committee, the MB Administration Committee and Inspection System; the organization of training sessions and the publication of educational documentation on the use of MB alternatives; and ozone awareness activities. The Executive Committee greatly supports the efforts of Turkey to reduce the consumption of CFCs. The Executive Committee is therefore hopeful that, in the next two years, Turkey will continue with the implementation of its country programme and refrigerant management plan activities with outstanding success in the reduction of current CFC consumption levels.

2004 WORK PROGRAM AMENDMENT

Introduction

- 1. The World Bank submitted its 2004 Work Program along with its 2004 Business Plan for the consideration of the Executive Committee at the 42nd Meeting in February 2004. The 2004 Work Program included two new project preparation requests for Tunisia and China, and two institutional strengthening projects for Ecuador and the Philippines, which amounted to US\$220,375 and US\$385,060, respectively.
- 2. Having considered the Bank's 2004 Work Program, the Executive Committee approved the requested US\$220,375 in project preparation funds, as well as US\$287,418 for IS projects. The Executive Committee decided to approve the renewal of the IS project for the Philippines for one year only instead of the usual two, because the country was in non-compliance with respect to Methyl Bromide, and funding for a phaseout strategy, included in the 2004-2006 World Bank Business Plan, had been approved at the 39th Meeting (Decision 42/24).

Work Program Amendment

- 3. This Work Program Amendment (WPA) includes a request for project preparation funds in the amount of US\$65,000, to prepare a Methyl Bromide Phaseout Plan for Viet Nam. The Viet Nam Ozone Office has asked the Bank to submit this request for funds, which will be used to cover the costs of: i) conducting a comprehensive, national survey of Methyl Bromide consumption; and ii) carrying out stakeholder consultation meetings, which will be critical to the development of a national strategy. It is expected that the national plan will be submitted for consideration at the last Executive Committee meeting of 2006.
- 4. A funding request to extend the support for implementation of the institutional strengthening project in Turkey, which amounts to US\$260,000. The total amount of funds requested for project preparation and IS activities, as well as the planned time frame for these activities are summarized in Table 1.
