Duration of country programme: 6 years (2004-2010)

ODS phase-out target: 50% reduction in CFC consumption by 2005; 85% reduction

by 2007;

Phase-out priority area: Refrigeration servicing sector

Cost of activities in the country \$349,176

Strategy:

The Government's strategy will be based on restrictions on the importation of ODS-based equipment and incentives for importing non-ODS-based equipment; the establishment of economic incentives for using non-ODS technologies; public awareness and training of refrigeration servicing technicians; and monitoring and control of illegal trade in ODS.

SECRETARIAT'S COMMENTS AND RECOMMENDATIONS

DESCRIPTION

- 1. According to the survey conducted in 2003 to prepare the Cape Verde country programme/RMP, total CFC consumption was estimated at 1.8 ODP tonnes, used to service refrigeration equipment. The CFC baseline for Cape Verde is 2.3 ODP tonnes.
- 2. The Government of Cape Verde is proposing to establish legislation and a regulatory system to control imports of ODS and ODS-based equipment. The Government has established a National Ozone Committee responsible for all issues related to the Montreal Protocol.
- 3. At its 36th Meeting, the Executive Committee approved the institutional strengthening project for Cape Verde for a one-year period. As a result, the Ozone Unit was established under the Ministry of Agriculture, Food and the Environment. The country programme includes a request for additional funding for this project (US \$85,000 for a two-year period). The Secretariat's comments and recommendations on this request are presented in document UNEP/OzL.Pro/ExCom/44/18.
- 4. The country programme also includes an RMP project proposal. The Government of Cape Verde is requesting a total of US \$256,400 for the implementation of this project. The Secretariat's comments and recommendations on this request are presented in document UNEP/OzL.Pro/ExCom/44/31.

SECRETARIAT'S COMMENTS

Issues related to compliance on the part of Cape Verde

- 5. At their 15th Meeting, the Parties to the Montreal Protocol noted that Cape Verde (among other Article 5 countries) had still not reported:
 - (a) Data for one or more of the base years (1986, 1989 or 1991) for one or more groups of controlled substances, as required by Article 7, paragraphs 1 and 2 of the Montreal Protocol (Decision XV/16);
 - (b) Any consumption or production data to the Ozone Secretariat (Decision XV/17); and
 - (c) Data for one or more of the years required for the establishment of baselines for Annexes A, B and E to the Protocol (Decision XV/18).
- 6. The Parties also urged Cape Verde (among other Article 5 countries) to work closely with the implementing agencies concerned (i.e., UNDP and UNEP) to report the required data to the Ozone Secretariat as a matter of urgency, and to request the Implementation Committee to review the situation of Cape Verde (and other Article 5 countries) with respect to data reporting at its next meeting (Decision XV/18).

- 7. In this regard, the Secretariat advised that, as a matter of urgency:
 - (a) The Government of Cape Verde should send an official communication to the Ozone Secretariat addressing the issues raised by the Parties to the Montreal Protocol, and reporting the relevant ODS consumption according to the data collected during the preparation of the country programme; and
 - (b) UNDP and UNEP should assist the Government of Cape Verde in submitting to the Implementation Committee the plan of action, as proposed by the Government in the country programme, to ensure compliance with the provisions of the Protocol.
- 8. The Secretariat also pointed out that the Executive Committee urged implementing agencies to provide all assistance possible to countries for which they were implementing institutional strengthening projects, in order to eliminate instances of non-reporting of data (Decision 42/17).
- 9. Subsequently, UNDP and UNEP informed the Fund Secretariat that the Ozone Officer would immediately send the Ozone Secretariat a report on the level of ODS consumption in Cape Verde based on the data gathered during the preparation of the country programme/RMP.

CFC consumption

- 10. The Cape Verde country programme provides ODS consumption data from 1986 to 2003. The Secretariat noted that most of the countries that have recently submitted their country programmes for consideration by the Executive Committee were unable to estimate CFC consumption even for the baseline years (i.e., 1995-1997) and had therefore requested through the Ozone Secretariat that they be permitted to use the latest CFC consumption as the baseline for compliance. On this basis, the Secretariat sought further explanation on how the Government of Cape Verde was able to provide detailed CFC consumption since 1986.
- 11. Subsequently, the Secretariat was informed that the 2003 ODS consumption data was gathered during the preparation of the country programme/RMP project from various CFC importers and users. Based on this consumption and an analysis of the growth of Cape Verde's economy over the period 1986-2002, ODS consumption for that period was estimated, and the CFC baseline for compliance was calculated.

ODS legislation

12. The Secretariat pointed out to UNEP that while ODS regulations have been drafted, they have not yet been enacted and enforced. Subsequently, UNEP reported that the Government of Cape Verde believes that the ODS regulations will be enacted in time to allow the training programmes for customs officers and refrigeration technicians to begin early in 2005.

SECRETARIAT'S RECOMMENDATIONS

- 13. The Fund Secretariat recommends approval of the Cape Verde country programme, noting that approval of the country programme does not denote approval of the projects identified therein or their funding levels. Approval of the Cape Verde country programme is without prejudice to any decisions that might be taken by the Parties following consideration by the Implementation Committee of the consumption data submitted under Article 7 by the Government of Cape Verde.
- 14. The Fund Secretariat also recommends that the Government of Cape Verde be requested to present information annually to the Executive Committee on progress being made in the implementation of the country programme, in accordance with the decision of the Executive Committee on implementation of country programmes (UNEP/OzL.Pro/ExCom/10/40, para. 135). Using the approved format, the initial report, covering the period 1 December 2004 to 31 December 2005, should be submitted to the Fund Secretariat no later than 1 May 2006.

J'ai le plaisir de confirmer que si le présent programme est approuvé, le gouvernement du Cap Vert prendra toutes les mesures pour respecter les différentes dispositions du Protocole de Montréal, notamment la réduction de 50% de la consommation en 2005, la réduction 85% en 2007, et le gouvernement ne sollicitera pas de financement supplémentaire du Fonds Multilatéral pour respecter ces deux échéances.

Nous avons également entrepris la préparation des textes pour contrôler les importations des SAO et des équipements en contenant. Ces mesures seront bientôt adoptées et leur mise en œuvre, dès 2005, nous permettra de respecter les échéances fixées ci-dessus.

Je vous prie de noter que le Cap Vert viens de communiquer au Secrétariat Ozone toutes les données requises au titre de l'Article 7 du Protocole de Montréal pour les années 1986 à 2003.

En attendant, nous espérons que le Comité Exécutif du Fonds Multilatéral approuvera le présent Plan de Gestion des Fluides Frigorigènes lors de sa prochaine Réunion, et financera les projets qui y sont contenus.
