2005 BUSINESS PLANS

For reasons of economy, this document is printed in a limited number. Delegates are kindly requested to bring their copies to the meeting and not to request additional copies.

## Introduction

1. In abolishing the 2 sub-committees, the Executive Committee decided that it would start each meeting with an organizational session which would examine the availability of resources, the business plans, and the status of compliance (decision 41/92).

2. This document considers business planning in the light of the approvals at the  $45^{\text{th}}$  Meeting and the submissions to the  $46^{\text{th}}$  Meeting and the allocations in the 2005 business plans. It highlights those projects in the business plans that have not been submitted but may be needed to assist those countries for whom decisions have been taken by the Meeting of Parties on compliance. The document concludes with an assessment of the forward commitments approved to-date and the additional commitments submitted to the  $46^{\text{th}}$  Meeting for approval.

## Approvals and the 2005 Business Plan

3. Table 1 presents the accounts value included by agency in the 2005 business plans and the balance of funds that could be requested at the  $47^{\text{th}}$  Meeting.

## 2005 Business Plans and Remaining Balance Expected for Consideration at the 47<sup>th</sup> Meeting (US\$)

4. At its 45<sup>th</sup> Meeting, the Executive Committee approved projects amounting to US \$2,155,007 that were not in the business plan or did not have values in the business plans. However, after taking this into account, the Executive Committee approved, overall, US \$15,068,376 less than the amount included in the 2005 business plan for these projects.

5. Submissions to the 46<sup>th</sup> Meeting also include projects amounting to US \$3,748,602 that were not included in the 2005 business plans. US \$501,400 of this amount is for HCFC surveys submitted by UNIDO. US \$840,950 of the US \$3.7 million is for chiller activities<sup>1</sup> that could be counted against the Global Chiller Programme's US \$15.2 million budget. Taking into account the approvals at the 45<sup>th</sup> Meeting, if all of the submissions to the 46<sup>th</sup> Meeting are approved at the amounts requested, the Executive Committee would have approved US \$2,388,978 more than the amount included in the 2005 business plans for these projects.

6. Another aspect of business planning is the number of projects that may have to be considered at the final meeting of the year. Table 2 provides information about new multi-year agreements and all other projects that are in the 2005 business plan that may be submitted to the  $47^{\text{th}}$  Meeting.

## Projects to be Submitted for Countries subject to Compliance Decisions

8. Implementing and bilateral agencies should be encouraged to submit these projects to the 47<sup>th</sup> Meeting as a matter of urgency.

## RECOMMENDATIONS

The Executive Committee may wish to consider:

- 1. Noting the Report on the status of the 2005 business plans as contained in UNEP/OzL.Pro/ExCom/46/5.
- 2. Noting with concern, in light of paragraph 3 of decision XIV/39 of the Meeting of the Parties that requests "that the whole of the budget for 2003-2005 should be committed by the end of 2005", the fact that US \$133 million is left to be submitted for activities in the 2005 business plans containing 12 new multi-year agreements and 205 other projects plus activities for the global chiller programme.

3. Urging bilateral and multilateral implementing agencies with projects in the 2005 business plans for countries subject to decisions of the Meeting of Parties on compliance to submit these projects to the 47<sup>th</sup> Meeting as a matter of urgency.
