Progress report

6. During the reporting period, a number of initiatives were taken to strengthen the implementation of the Montreal Protocol through public awareness, to ensure that the public are aware of both the Montreal protocol and the phase-out of ozone depleting substances. Another main focus has been to reach out to smaller service workshops in the refrigeration sector and workshops servicing mobile air-conditioners to make them aware of the CFC phase-out and the Multilateral Fund funded programme that is in place. Service shops have been identified and

received training and recycling equipment under the CFC phase-out plan implemented by the Government of Jordan with assistance from the World Bank and UNIDO. Another focus of the awareness activities has been the fire protection sector where Multilateral Fund funding has been provided to ensure that future demand for halons for critical users can be covered through a halon management and recycling programme.

Plan of action

7. The main challenge for the next biennial programme is to meet the 2007 85% CFC reduction target. While Jordan is well on its way to meeting the target, successful implementation of the refrigeration training program and implementation of the recycling activities in the refrigeration and MAC servicing sectors will be essential. The ODS policies are already in place in Jordan and are enforced by the Ministry of Environment. An import control system is also in place. As prices of CFCs and likely to increase in the coming years, additional work and coordination with the customs department is needed.

Progress Report

During the reporting period, support was provided to the National Ozone Unit (NOU) to 8. continue its successful implementation of the National CFC Phase-out Plan. maintained its coordinating role amongst agencies implementing the plan, and provided key regulatory support for the commitments outlined in the Plan. The NOU continued the implementation of the few remaining individual phase-out projects, and performed follow-up visits to beneficiary companies to ensure the sustainability of the early phase-out efforts. In 2004, the NOU took a leading role in the preparation of the National Methyl Bromide Phase-out Plan, including: adjusting the national methyl bromide baseline to accurately reflect non-QPS consumption; preparing terms of reference for all the activities involved in the development of the plan; selecting and overseeing consultants involved in project preparation activities; conducting consultation and dissemination workshops with relevant stakeholders; and finally submitting the methyl bromide plan for approval at the 45th Meeting of the Executive Committee. The approval of this plan was a major accomplishment for the NOU, which was able to rally national support for this highly sensitive strategy. Cooperation with the Department of Agriculture (DOA) has already begun, to transfer some of the lessons-learned from the implementation of the CFC plan and to ensure a quick start for the methyl bromide plan. Public awareness campaigns and training activities were carried out by the NOU throughout the 2003-2005 period, as planned.

Plan of action

9. The proposed institutional strengthening renewal project will support the NOU and its partner agencies in their efforts to implement a comprehensive ODS phase-out strategy in Thailand. These efforts include: concluding the process of ratifying the Beijing amendment; coordinating with other government agencies to ensure a consistent implementation of the CFC plan; developing a management information system to facilitate reporting of consumption data by all relevant agencies and monitoring of annual CFC reduction targets; coordinating with the project management unit to monitor the use of CFCs in the servicing sector; completing all ongoing individual phase-out projects; defining a national strategy for management of halons; controlling illegal trade of CFCs; and coordinating with the DOA to facilitate the initial phases of implementation of the methyl bromide plan. Targeted public awareness and dissemination activities will continue to be a major part of the NOU's activities in the next two years.

Annex II

VIEWS EXPRESSED BY THE EXECUTIVE COMMITTEE ON RENEWALS OF INSTITUTIONAL STRENGTHENING PROJECTS SUBMITTED TO THE 46TH MEETING

Jordan

1. The Executive Committee has reviewed the report presented with the institutional strengthening project renewal request for the Hashemite Kingdom of Jordan and notes with appreciation that Jordan reported data to the Ozone Secretariat indicating that the 2005, 50% CFC phase-out target was achieved ahead of time. The Executive Committee also notes that within the framework of the institutional strengthening project, Jordan has taken significant steps to phase-out its ODS consumption in other areas such as halons and methyl bromide. Specifically, the coordination of implementation of the national CFC, halon and methyl bromide phase-out plan; the completion of training workshops for customs officers and implementation of the import control system; the continuation of awareness raising activities to ensure stakeholders' commitment to ODS phase-out, and; development of a methyl bromide strategy. The Executive Committee greatly supports the efforts of Jordan to reduce the consumption of ODSs. The Executive Committee is therefore hopeful that, in the next two years, Jordan will continue with the implementation of its country programme and activities under the national ODS phase-out plan, with outstanding success in the reduction of current ODS consumption levels.

Thailand

2. The Executive Committee has reviewed the report presented with the institutional strengthening project renewal request for Thailand. The Committee notes with appreciation that Thailand has effectively implemented its National CFC Phase-out Plan and that it has successfully met the commitments as outlined by the plan over the past four years. The Committee also appreciates the efforts that were taken to develop the National Methyl Bromide Phase-out Plan, which will enable the country to phase out its consumption of methyl bromide for non-QPS applications. Specifically, in its submission Thailand also reports that it has taken important initiatives including coordination of all the agencies which have a role in ensuring compliance, as well as training, monitoring and enforcement activities and awareness raising campaigns. The Executive Committee greatly appreciates the steps taken by the Government of Thailand to reduce its overall ODS consumption. The Committee is hopeful that during the next two years, Thailand will continue with its strategic approach to ODS phase-out with outstanding success and will sustain and build upon its current achievements.

2005 WORK PROGRAM AMENDMENT

Introduction

- 1. The World Bank submitted the 2005 Work Program along with the 2005-2007 Business Plan for the consideration of the Executive Committee at its 45th Meeting in April 2005. The 2005 Work Program included one new project preparation request for Argentina and two for Ecuador amounting to US\$95,000, as well as institutional strengthening renewal projects for Chile and the Philippines, which amounted to US\$277,117.
- 2. Having considered the Bank's 2005 Work Program, the Executive Committee approved the requested project preparation funds, as well as the funds for IS projects renewals.

Work Program Amendment

- 3. This Work Program Amendment (WPA) includes a request for funds in the amount of US\$45,000, to prepare a MDI phaseout plan for Indonesia. The Government of Indonesia has expressed interest in preparing this plan ahead of its planned schedule, and has therefore asked the Bank to submit this request for funds to the 46th Excom Meeting. The proposed resources will be used to cover the costs of: i) carrying out stakeholder consultation meetings; ii) hiring consultants to consultants to gather relevant background data at the national level; and iii) developing the national plan. It is expected that the MDI phaseout plan will be submitted for consideration of the Executive Committee meeting in July, 2006.
- 4. This WPA also includes funding requests to extend support for implementation of the institutional strengthening projects in Jordan and Thailand, which amount to US\$147,320 and US\$346,667, respectively. The total amount of funds requested for project preparation and IS activities, as well as the planned time frame for these activities are summarized in Table 1.
