#### BILATERAL COOPERATION

This addendum is issued to reflect two additional projects received from Canada:

• Add the following to the table on the cover page:

# BOLIVIA: Project preparation for the terminal phase-out management plan (US \$30,000)

### **Background**

8(bis). Bolivia has received funding for refrigerant management plan under decision 31/48. Consistent with decision 45/54, Canada has requested funding amounting to US \$30,000 for Bolivia for the preparation of a terminal phase-out management plan (TPMP).

#### Secretariat's recommendations

8(ter). The Fund Secretariat recommends blanket approval of the activity at the level of funding shown in Table 2 above.

# BURKINA FASO: Project preparation for the terminal phase-out management plan (US \$10,000)

## **Background**

8(quater). Burkina Faso has received funding for refrigerant management plan under decision 31/48. Consistent with decision 45/54, Canada has requested funding for Burkina Faso for the preparation of a terminal phase-out management plan (TPMP). The total project preparation funds of US \$30,000 are being shared with UNEP which has requested funding of US \$20,000 for this purpose at the 47<sup>th</sup> Meeting (document UNEP/OzL.Pro/ExCom/47/14).
