# PROJECT DESCRIPTION

- 1. Germany submitted on behalf of the Government of Iran a request for funding of the fourth tranche of the National CFC Phase-out Plan (NCPP) for the Islamic Republic of Iran. The NCPP was approved at the 41<sup>st</sup> Meeting with associated funding of US \$11,250,000. It was to be implemented by Germany (lead agency), France, UNEP, UNIDO and UNDP, and aimed at phasing out a total of 3,889.4 ODP tonnes of consumption to achieve complete CFC phase out in all sectors.
- 2. The request for funding of the fourth tranche is submitted according to the Agreement between the Islamic Republic of Iran and the Executive Committee and amounts to US \$1,073,348, plus agency support cost of US \$115,750. It is accompanied by the report on the implementation of the third tranche, the annual implementation programme for the fourth tranche, and a subsequently submitted verification report. As per the agreement, funding is being requested for GTZ and UNIDO for the fourth tranche. There are no funds to be disbursed to France, UNEP, and UNDP during 2006 for this phase-out plan.

## Status

3. The plan covers activities in multiple sub-sectors. An overview of the current status is provided in the following table:

- 5. For three activities at the end of the implementation of the first three tranches expenditures were higher than originally foreseen. The Government of Iran and the agencies involved carried out readjustments of funding within the overall budget to meet the specific needs of the country. Accordingly, an overspending in the activities "Training Components Refrigeration Assembly" and "Domestic & Commercial Refrigeration Technician Training Component" is offset against all of the remaining balance in "Customs Training" as well as the remaining funds in "Domestic & Commercial Refrigeration R&R Component". The overspending in the foam component will be offset against the approval of the fourth tranche.
- 6. Other than the implementation in the MAC sector, all other implementation activities show expenditures fairly close to the levels expected. For the implementation of the next tranche, the expenditures foreseen are described in the following table:

7. As shown in the above table, Iran is aiming at spending the funding requested at this meeting almost completely until April 2007. The objective appears achievable. Beyond April 2007 Iran intends to concentrate on foam and MAC recovery and recycling.

## Verification

- 8. Initially the lead agency provided only a verification certificate. Subsequently, and upon request of the Secretariat, a verification report was provided:
  - (a) The verification report included verification that the consumption targets have been met, that the sector activities have been implemented and the annual activities completed. In addition, the changes in the use of the funding were verified;
  - (b) The verification provided for the above issues was sufficient. Upon request, the Secretariat was provided with detailed information about the licensing system, a list of licenses issued and imported quantities by licence and import;
  - (c) Difficulties were observed due to the use of the period of one Iranian new year (the Iranian new year 1383, lasting from 20 March 2004 to 20 March 2005) as a reference for the annual imports, resulting in initially inconclusive information. A consolidation of data for the Iranian new years 1381, 1382, and 1383 was necessary to obtain consistent information for the licenses and imports in the (Gregorian) year 2004;
  - (d) The verification showed a consumption of 2,145.3 ODP tonnes, which is significantly lower than the amount reported under Article 7 to the Ozone Secretariat (3,471.9 ODP tonnes). The Fund Secretariat pointed to this deviation and asked the lead agency for an indication if Iran intends to inform the Ozone Secretariat of the revision of data for 2004. The lead agency informed the Secretariat that Iran is aware of the issue, but no definite reply had been received; and
  - (e) The monitoring performed by the monitoring institutions was meant to be subject to independent verification, but only very rudimentary information was provided in this regard.

# SECRETARIAT'S COMMENTS AND RECOMMENDATION

# **COMMENTS**

- 9. The proposal has been submitted for consideration at the 48<sup>th</sup> Meeting, and the Secretariat has reviewed it accordingly. A number of clarifications were requested from Germany, in particular regarding the verification provided.
- 10. The issue of the verification of the monitoring system could not be resolved in time. Nevertheless, initial information appears to indicate that a somewhat rudimentary monitoring system exists. Both the Governments of Iran and Germany indicated in the narrative that in the upcoming year the finalisation of a monitoring set-up would be a high priority activity.

11. The total funding sought by the Government of Germany from submissions to the 48<sup>th</sup> Meeting exceeds 20 per cent of Germany's contributions for the year 2006. This issue is addressed in document UNEP/OzL.Pro/ExCom/48/20 on bilateral funding. Consequently, although all of the conditions for approval of the fourth tranche of the NCPP for Iran have been met, this request is submitted for individual consideration, since the Executive Committee's decision will need to take into account the outcome of its deliberations on the bilateral funding issue.

# RECOMMENDATION

12. Subject to the Executive Committee's conclusions on the policy issue arising from the Government of Germany's submissions to the 48<sup>th</sup> Meeting, the Executive Committee could consider approving the fourth tranche of the NCPP for Iran at the funding level shown in the table below, on the understanding that the Government of Germany as lead agency ensures that a verification of the monitoring institutions is included in the next submission of an annual tranche.
