2006 BUSINESS PLANS

Pre-session documents of the Executive Committee of the Multilateral Fund for the Implementation of the Montreal Protocol are without prejudice to any decision that the Executive Committee might take following issue of the document.

Introduction

1. This document considers business planning in the light of the approvals at the 48th Meeting, the submissions to the 49th Meeting and the allocations in the 2006 business plans. It first addresses the decisions taken at the 48th Meeting and the resulting modifications to the business plans of the agencies, and highlights those projects in the business plans that have not been submitted. It also specifies which of these projects are required for compliance as well as those activities that may be needed to assist those countries for whom decisions have been taken by the Meeting of the Parties on compliance. The document provides an assessment of the forward commitments approved to-date and the additional commitments submitted to the 49th Meeting for approval and concludes with observations and recommendations.

Decisions taken on 2006-2008 Business Plans

2. At its 48th Meeting, the Executive Committee decided to modify the bilateral and multilateral implementing agencies' business plans; to consider, as a future amendment, the methyl bromide projects that had been removed from the business plans of UNDP and UNEP following coordination with UNIDO; to request coordination on a target for policy and regulatory assistance taking into account approved projects and multi-year agreements; and to request the resolution, by the 49th Meeting, of the issue of activities required for compliance in Africa for which there were currently insufficient funds from Germany's bilateral allocation to implement. This section addresses these items.

Modifications to 2006-2008 Business Plans

3. In modifying the 2006-2008 business plans, the Executive Committee decided to remove several activities pursuant to decisions 48/5-9 and potentially add activities for an MDI pharmaceuticals project and TPMPs to the last meeting of 2006 should funds be available. Table 1 presents the results of these modifications:

5. At the 50th Meeting (the last meeting of 2006), implementing agencies may also submit terminal ODS phase-out management plans (TPMPs) for consideration, provided that the conditions in decisions 45/54 and 46/17 had been met, and on the understanding that sufficient funds are available (decision 48/4(c)). As a result, projects, amounting to a total of US \$11.5 million, may be submitted to the 50th Meeting as shown by agency in Table 3.

6. In addition to this amount, the Executive Committee decided to allow the submission of the pharmaceuticals project in China at the last meeting in 2006, for which first tranche amounts to US \$5.375 million. This amount is included in the totals for 2006 mentioned in Tables 1 and 2 above.

Methyl bromide projects removed from UNDP's and UNEP's business plans

7. At its 48th Meeting, the Executive Committee decided to remove:

"The global methyl bromide information exchange project to be submitted in 2007, on the understanding that it might be resubmitted in a future amendment to UNDP's work programme following in-depth coordination between UNDP, UNEP and UNIDO" (decision 48/6(b)(i)).

8. It also decided to remove:

"The round-table workshop on methyl bromide in light of funding for methyl bromide already provided through the CAP on the understanding that the project might be resubmitted in a future amendment to UNEP's work programme following in-depth coordination between UNEP, UNDP and UNIDO" (decision 48/7(b)(ii)).

9. During a conference call with the implementing agencies on business plans in May 2006, UNDP indicated that, following a coordination meeting with UNEP and UNIDO, the implementing agencies agreed to cooperate in the preparation of a concept paper on the subject, which would be presented to the 50th Meeting with the expectation of activities being prepared for the 51st Meeting.

Performance indicators for policy and regulatory assistance

10. During the discussion on the 2005 targets for the performance indicators that had been approved pursuant to decision 41/93, the issue of the target for policy and regulatory assistance was addressed. Implementing agencies noted the fact that another indicator for milestones completed for multi-year agreements covered this issue and there was a need to better define the indicator. Consideration was given to defining the indicator as being applicable to CAP, agencies that had individual projects to address policy and regulatory assistance, or agencies responsible for institutional strengthening. The Executive Committee decided to request UNDP, UNIDO and the World Bank:

"to work in coordination with the Secretariat to provide a target for policy and regulatory assistance to countries requesting it to reflect the efforts it planned to undertake in that regard within its approved projects and/or multi-year agreements as appropriate" (decisions 48/6(d), 48/8(c), and 48/9(e)).

11. During the conference call with the implementing agencies on business plans, it was agreed that policy and regulatory assistance was a key factor in achieving and sustaining compliance of Article 5 countries, and the efforts of all agencies should be given credit. Moreover, it was agreed that such a target should emanate from: a list of needs for policy and regulatory assistance either as identified during the annual coordination meeting on business plans in January, as activities in individual projects and multi-year agreements where such assistance was planned, or as specific requests from countries. However, in all cases, the target for this indicator should be based on the assistance that the agency planned to provide and not the action of the government. The implementing agencies and the Secretariat agreed to the recommendation for this subject as indicated in this document.

Activities in Africa required for compliance that were included in Germany's business plan submitted to the 48th Meeting

Approvals and the 2006 Business Plan

12. Table 4 shows the approvals at the 48th Meeting and the submissions to the 49th Meeting, as well as the extent to which these approvals exceed or are below the values for them in the business plan.

- 13. Table 4 shows that values of projects approved at the 48th Meeting were lower than the levels that had been indicated for these activities in the 2006 business plans.
- 14. As shown in Table 4, at its 48th Meeting the Executive Committee approved projects amounting to US \$190,783 that were either not in the business plans or were not valued in the business plans of the implementing agencies. However, even taking this into account, the Executive Committee approved (excluding chiller projects) a total value of US \$456,025 less than that included in the 2006 business plan for these projects.
- 15. Submissions to the 49th Meeting also include project values amounting to US \$22,915,048 (including US \$102,975 that were not in the business plans) that are below the amount included for them in the 2006 business plans. Therefore, if all of the submissions to the 49th Meeting are approved at the levels requested, the Executive Committee would have approved US \$149,144 less than the total amount included in the 2006 business plans for these projects.
- 16. However, since the submitted value is significantly lower than the business plan value, a more accurate appraisal will be forthcoming based on the Secretariat's recommendations that will not actually be known until nearer to the Meeting. Therefore, Table 4 will be updated based on the value of the Secretariat's recommendations as part of an addendum to this document.
- 17. Table 5 presents, by agency, the value of accounts included in the 2006 business plans and the balance of funds from projects in the 2006 business plans, which were not submitted. This table will also be updated based on the Secretariat's recommendations as part of an addendum to this document.

Value of Projects Not Submitted

18. Table 6 addresses the remaining account value of activities not submitted to the 48th or 49th Meetings that were included in the 2006 business plans.

19. Table 6 indicates that US \$65.4 million in activities required for compliance were not submitted to the 48th or 49th Meetings. The value required for compliance is defined as those activities required by the compliance oriented model, institutional strengthening, Secretariat/Executive Committee/Treasurer, CAP, core unit funds, activities maintained in the business plan by Executive Committee decision, and a pharmaceuticals project that might be submitted in 2006 if funds become available. Those activities not required for compliance include MDI activities and all other new activities. A detailed list of all remaining activities required for compliance totalling 214 and those not required for compliance are provided in Annexes I and II, respectively.

Countries subject to Compliance Decisions in the 2006 Business Plans

20. Annex III presents a list of countries that have been subject to decisions on compliance for which the required action had not been accomplished as at 26 May 2006, and where activities that have not yet been submitted are shown in the 2006 business plans. The list contains 34 projects and agreements with a total value of over US \$6.2 million. These projects and agreements should be submitted to the 50th Meeting to prevent any delays in the implementation of activities that may facilitate compliance.

Forward Commitments

[The addendum to be issued prior to the 49th Meeting of the Executive Committee will also address the section on **Forward Commitments** based on draft agreements currently under preparation. The addendum will further address the extent to which forward commitments submitted for approval at the 49th Meeting exceed the amounts associated with them in the 2006-2008 business plans.]

Observations

- 21. Following the modifications to the 2006-2008 business plans agreed at the 48th Meeting, there remains an unallocated amount of US \$39.931 million for the triennium. This does not include any decisions that might be made at either the first meeting of 2007 with respect to methyl bromide activities or the first meeting of 2008 with respect to HCFC activities.
- 22. A maximum of US \$11.5 million from the 2007 business plans for TPMPs might be submitted to the 50th Meeting pending the availability of resources.
- 23. The implementing agencies intend to submit a concept paper to the 50th Meeting on the methyl bromide activities that have been removed from UNDP and UNIDO's business plans.
- 24. Modifications to two of the performance indicators are recommended along with definitions to enable the Secretariat to carry out an agency-wide assessment of planned and completed activities developed to assist countries improve policy and regulatory measures.
- 25. Bilateral and multilateral implementing agencies should be encouraged to submit those activities required for compliance in their 2006 business plans to the 50th Meeting.

RECOMMENDATIONS

- 26. The Executive Committee may wish to consider:
 - (a) Noting the Report on the status of the 2006 business plans as contained in UNEP/OzL.Pro/ExCom/49/5 and the fact that US \$65.4 million in activities that were required for compliance had not been submitted to the 49th Meeting, and that the value of forward commitments approved at the 49th Meeting [exceeds/is below] the value in the 2006-2008 business plan of the Multilateral Fund by US \$ [to be provided based on actual approvals];
 - (b) Modifying the existing performance indicators, starting with the business plans for 2007, as follows:
 - (i) By removing the words policy and regulatory from the example for the indicator "Milestone Activities Completed" so that the example reads as follows: "Milestone activities completed/ODS levels achieved for approved multi-year annual tranches versus those planned";
 - By defining the indicator "Percentage of policy/regulatory assistance (ii) completed versus that planned" as activities to be undertaken by the implementing agencies in assisting Article 5 countries in the development/adoption/implementation of relevant policy and regulatory activities including, but not limited to: enactment of licensing system/quota system for all controlled substances under the Montreal Protocol (and not limited to CFCs only), and informing the Ozone Secretariat accordingly; ratification of remaining amendments to the Montreal Protocol, when applicable; addressing relevant decisions taken by the Parties to the Montreal Protocol in regard to specific compliance issues; enactment of legislation/regulation for the certification of technicians, when applicable; establishment of bans on the import of controlled substances as in the case of halon and ODS-containing equipment; modifications to fire/equipment codes; and legislation for combating illegal trade of ODS. These needs would be identified at the beginning of each year at the annual business plan coordination meeting and the activities to be undertaken would based upon inter alia specific requests from countries, activities already proposed in individual projects and/or in multi-year agreements, and actions associated with institutional strengthening projects; and
 - (c) Urging bilateral and multilateral implementing agencies to submit those activities required for compliance in the 2006 business plans to the 50th Meeting.
