

PROJECT IMPLEMENTATION DELAYS

Pre-session documents of the Executive Committee of the Multilateral Fund for the Implementation of the Montreal Protocol are without prejudice to any decision that the Executive Committee might take following issue of the document.

For reasons of economy, this document is printed in a limited number. Delegates are kindly requested to bring their copies to the meeting and not to request additional copies.

Overview

- 1. This document is submitted as a follow-up to decisions taken at previous meetings of the Executive Committee concerning projects with implementation delays. The reports from the implementing and bilateral agencies on projects with implementation delays are available to Executive Committee members upon request.
- 2. This document is divided into three sections. Section I addresses the projects with implementation delays for which reports were requested by the Executive Committee. Section II addresses delayed projects in countries with related compliance issues. Section III considers a project proposed for possible cancellation at the 49th Meeting that does not have an impact on compliance. There is no section on "additional status reports" since no reports were requested for this meeting.

Section I: Projects with implementation delays

- 3. Thirty-eight ongoing projects have been classified as projects with implementation delays. Projects with implementation delays are: i) projects expected to be completed more than 12 months late; and/or, ii) projects where disbursement has not occured within 18 months of the project's approval. Based on reports received from implementing and bilateral agencies, the breakdown of projects with implementation delays is as follows: the World Bank: 9; UNEP: 9; UNIDO: 8; UNDP: 6; France: 4; Italy: 1; and, Sweden: 1.
- 4. Table 1 below reflects the causes of implementation delays provided in the agencies' reports. Implementing and bilateral agencies identified the causes for implementation delays associated with these projects based on seven categories (A to G). The total number of causes for delay exceeds the number of delayed projects because in some projects there were multiple causes for delay in implementation. Table 1 indicates that delays are most commonly caused by factors associated with the beneficiary enterprise (13) and the Government (10).

Progress in resolving causes of delays

5. In their reports the implementing and bilateral agencies indicated that there have been varying degrees of progress in overcoming delays. Three of the projects listed with delays at the 48th Meeting have now been completed.

Projects with some progress

6. Twenty-seven projects were classified as showing "some progress", and the implementing and bilateral agencies indicated that the projects would continue to be monitored. Notwithstanding progress, it should be noted that projects approved over three years ago must continue to be monitored pursuant to decision 32/4 and therefore cannot be removed from the list for monitoring prior to their final completion regardless of the extent to which progress may have been achieved.

Projects with no progress—letter of possible cancellation

7. The projects for which no progress is being reported for the first time are indicated in Table 2 below. The Secretariat, UNDP and the World Bank agreed on the assessments of no progress. However, no progress could also be detected from UNEP's reports on the project listed in Table 2, although UNEP classified these projects as having experienced some progress. For a consistent assessment, the Fund Secretariat re-classified these projects from "some progress" to "no progress". Under the existing procedures, the Fund Secretariat will send notices of possible cancellation for the UNDP, UNEP and the World Bank projects that are classified below as having shown no progress.

Section II: Delayed projects in countries with related compliance issues

- 9. Part II of the Status of Compliance document (UNEP/OzL.Pro/ExCom/49/6) contains information on countries either at risk of non-compliance based on country programme data or for which decisions have been taken by the Meeting of the Parties or recommendations made by the 35th Meeting of the Implementation Committee. Section II considers the status of all projects with related compliance issues that are monitored as projects with implementation delays.
- 10. Table 4 below presents information on projects with implementation delays for countries with compliance issues and the latest information submitted to the 49th Meeting.

11. Based on agency reports, all of these projects have experienced some progress since the 48th Meeting of the Executive Committee and none of the projects are recommended for cancellation.

Section III: Project proposed for possible cancellation at the 49th Meeting and the impact of the cancelled project on compliance

12. UNIDO has requested, and the Government of India has agreed, that the methyl bromide project preparation in India (IND/FUM/39/PRP/360) should be cancelled since there is no remaining use of methyl bromide in India. Therefore, this cancellation has no impact on compliance.

RECOMMENDATIONS

- 13. The Executive Committee may wish to consider:
 - (a) Noting with appreciation the reports on projects with implementation delays submitted to the Secretariat by France, Italy, Sweden and the four implementing agencies as contained in the document on project implementation delays (UNEP/OzL.Pro/ExCom/49/16);
 - (b) Noting that the Secretariat and implementing agencies would take established actions according to the Secretariat's assessments (progress, some progress, or no progress) and report to and notify governments and implementing agencies as required;
 - (c) Noting the completion of three out of the 38 projects listed with implementation delays;
 - (d) Noting that letters of possible cancellation should be sent for the following projects:
