**BILATERAL COOPERATION**

This addendum is issued to reflect one additional project proposal received from Canada:

- **Add** the following to the table on the cover page:

PROJECT TITLE	BILATERAL AGENCY
Project preparation for the terminal phase-out management plan in Benin	Canada

- In paragraph 2, **replace** “Three” **with** “Four” and “two” **with** “three” in the first sentence;
- **Add** the following as the first bullet in paragraph 2:
  - Project preparation for the terminal phase-out management plan in Benin, to be implemented by Canada;
- In paragraph 5, **replace** “five” **with** “six” and “US \$1,032,900” **with** “US \$1,046,460” in the first sentence;

**BENIN: Project preparation for the terminal phase-out management plan (US \$12,000)**

**Background**

7(bis). Benin has received funding for implementation of a refrigerant management plan under decision 32/31. Consistent with decision 45/54, Canada has requested funding of US \$12,000 for Benin for the preparation of a terminal phase-out management plan (TPMP). The TPMP will be prepared jointly with UNEP which has requested complementary funding of US \$18,000 at this Meeting.

**Secretariat’s recommendations**

7(ter). The Fund Secretariat recommends blanket approval of the activity at the level of funding shown in Table 2 above.
