**RAPPORT SUR LES SOLDES ET
DISPONIBILITÉ DES RESSOURCES**

Les documents de présession du Comité exécutif du Fonds multilatéral aux fins d'application du Protocole de Montréal sont présentés sous réserve des décisions pouvant être prises par le Comité exécutif après leur publication. Par souci d'économie, le présent document a été imprimé en nombre limité. Aussi les participants sont-ils priés de se munir de leurs propres exemplaires et de s'abstenir de demander des copies supplémentaires.

1. Ce document présente un résumé des ajustements financiers indiqués par les agences d'exécution et approuvés par le Secrétariat du Fonds. Il inclut des données statistiques provenant des projets dont les soldes n'ont pas été retournés dans les 12 mois qui ont suivi leur achèvement, comme l'exige la décision 28/7. Les données sont présentées selon le modèle de présentation des rapports élaboré conformément à la décision 31/2 et incluent les montants des soldes engagés et non engagés. Conformément à la décision 41/92, ce document indique aussi le niveau des ressources dont dispose le Comité exécutif, en espèces et sous forme de billets à ordre enregistrés dans l'État des contributions (UNEP/OzL.Pro/ExCom/50/3), plus le montant des fonds provenant des projets indiqués dans le rapport sur les soldes.

Fonds retournés à la 50^e réunion du Comité exécutif

2. Il ressort des informations fournies par les agences d'exécution qu'un total de 423 773 \$US, plus des frais d'appui d'agence, sera retourné à la 50^e réunion. Cette somme est calculée en tenant compte des projets achevés avec solde, des fonds non-engagés provenant des projets annulés, et des remboursements provenant des projets en cours et autres ajustements (quoiqu'il n'y ait eu aucun remboursement, à cette réunion, sur des projets en cours).

3. Le Tableau 1 indique les montants des fonds retournés, par agence.

Projets avec soldes, répartis par année d'achèvement

4. Le Tableau 2 indique le nombre de projets dont les soldes sont encore détenus par les agences d'exécution, ainsi que les années d'achèvement de ces projets. Il montre que les agences d'exécution détenaient des soldes se chiffrant à un total de 24 974 734 \$US pour les projets achevés jusqu'au 30 septembre 2005 (depuis 12 mois au moins).

5. À sa 47^e réunion, le Comité exécutif avait demandé au Secrétariat de poursuivre la surveillance des tranches annuelles des projets pluriannuels dans le cadre des documents sur les retards d'exécution et les soldes (décision 47/50 b ii)). La Banque mondiale détient le solde le plus élevé (20 437 846 \$US), mais, la quasi-totalité de ce solde (20 110 497 \$US) provient des tranches annuelles des projets pluriannuels. Les soldes de l'ONUDI se chiffrent à 410 497 \$US et proviennent des accords pluriannuels. Ni le PNUD ni le PNUE ne détiennent de solde provenant des tranches des projets pluriannuels.

6. Le PNUE compte le plus grand nombre de projets avec solde (70) pour un montant de 1 933 021 US \$. Les autres agences comptent 64 projets ou moins, avec solde.

7. Toutes les agences ont des projets avec solde qui sont achevés depuis plus de deux ans. La majorité de ces fonds (11 842 484 US \$ sur US \$12 944 539 US \$) provient de huit projets de la Banque mondiale achevés depuis plus de deux ans.

Soldes engagés et non engagés

8. Les montants des soldes classés comme engagés et non engagés pour les quatre agences d'exécution sont les suivants :

Sur un total de US \$24 974 735 \$US de soldes provenant de projets achevés, annulés, en cours d'exécution, 24 411 328 \$US sont engagés, ce qui veut dire que ces fonds sont susceptibles d'être dépensés. Sur les soldes actuellement détenus, un montant de 563 407 \$US n'a pas été engagé. L'Annexe 1 fournit des informations supplémentaires sur les soldes engagés et non engagés, par agence. Les agences d'exécution sont priées d'expliquer les raisons pour lesquelles elles n'ont pas pu retourner tous les soldes non engagés (non utilisés) dans les délais requis, et d'indiquer à quel moment elles se proposent de le faire (décision 31/2 a) ii).

10. Le PNUD compte 63 projets achevés avec solde, un projet annulé avec des soldes engagés variant de 42 à 57 309 \$US. Le nombre total de projets achevés avec solde a décrû, passant de 68 projets à la 49^e réunion à 64 projets à la 50^e réunion, et le montant des soldes a diminué de 0.79 million US \$ à 0.69 million.

11. Le PNUD compte 48 projets achevés et un annulé avec des soldes engagés d'un total de 1 719 381 \$US, et 24 projets achevés avec un solde non-engagé de 213 640 \$US.

12. L'ONUDI compte 19 projets achevés avec des soldes engagés. 1 619 840 US sur un total de 1 839 949 US sur un total de 1 839 949 UUS de soldes engagés détenus par l'ONUDI sont destinés à cinq projets.

13. La Banque mondiale détient des soldes engagés de 20 166 901 \$US provenant de 16 projets achevés; 20 110 497 \$US de ce montant étaient engagés pour les projets pluriannuels. Une des principales raisons pour lesquelles les soldes provenant des tranches annuelles des projets pluriannuels figurent dans le rapport sur les soldes, est la courte durée des projets (un an), ainsi que la définition de l'achèvement de ces projets, à savoir la réalisation des réductions des SAO convenues. Ces fonds sont décaissés pour les coûts réels lorsque les coûts de projets sont présentés à la Banque mondiale pour paiement. La Banque mondiale détient des soldes engagés

totalisant 56 404 \$US d'un projet individuel achevé. La Banque mondiale détient également 270 946 des soldes non engagés qui proviennent de 7 projets achevés.

Coûts d'appui d'agence

14. À sa 35^e réunion, le Comité exécutif avait décidé de demander aux agences d'exécution de retourner tous les frais d'agence reliés aux soldes résiduels des projets. Si des dépenses ont été encourues pour des frais, les agences d'exécution devront fournir une explication et rembourser le solde des montants (décision 35/13 k)). Le Tableau 4 présente les coûts d'appui d'agence retournés à la 50^e réunion pour un total de 47 184 \$US.

Total des ressources disponibles pour la 49^e réunion

15. L'état des contributions et des décaissements au 6 octobre 2006 indique que le Trésorier disposait d'un solde négatif de 47 178 114 \$US, en espèces et sous forme de billets à ordre. Le montant total des soldes retournés par les agences d'exécution multilatérales, incluant les coûts d'appui d'agence, se chiffre à 470 957 \$US. Par conséquent, au 6 octobre 2006, le total des ressources disponibles pour les approbations par le Comité exécutif à la 50^e réunion est de 47 649 071 \$US. Cependant, la valeur totale des soumissions à la réunion, les retraits en sus, est de 121 280 830 \$US (y compris les coûts d'appui d'agence). Par conséquent, sur la base de la valeur totale des soumissions reçues par le Secrétariat du Fonds, il n'y aura pas suffisamment de ressources pour permettre au Comité exécutif d'approver tous les projets soumis à sa 50^e réunion.

RECOMMANDATIONS

16. Le Comité exécutif pourrait souhaiter :

- a) Prendre note du rapport sur les soldes et les ressources disponibles, contenu dans le document UNEP/OzL.Pro/ExCom/50/4;
- b) Prendre note du montant net des coûts d'appui retournés à la 50^e réunion par les agences d'exécution multilatérales sur les soldes des coûts d'appui de projets dont le total est de 423 773 \$US. Ce total inclut 126 160 \$US retournés par le PNUD, 213 082 \$US provenant du PNUE et 84 531 \$US de l'ONUDI;
- c) Prendre note du montant net des fonds retournés à la 50e réunion par les agences d'exécution multilatérales sur les soldes de projets dont le total est de 47 184 \$US. Ce total inclut 16 402 \$US provenant du PNUD, 21 584 \$US du PNUE et 9 198 \$US de l'ONUDI;
- d) Prendre note que les agences d'exécution détenaient des soldes totalisant 12 944 539 \$US, excluant les coûts d'appui, provenant des projets achevés depuis plus de deux ans. Cette somme inclut 341 151 \$US, plus des frais d'appui d'agence provenant du PNUD, 528 870 \$US plus des coûts d'appui d'agence provenant du PNUE, 232 034 \$US plus les coûts d'appui provenant de l'ONUDI et 11 842 484 \$US de la Banque mondiale; et
- e) Prendre note du montant de 47 649 071 \$US (à mettre à jour lors de la réunion) mis à la disposition du Comité exécutif pour les approbations à la 50^e réunion.
