SECRETARIAT'S RECOMMENDATION	For blanket approval

PROJECT DESCRIPTION

Background

1. On behalf of the Government of Ecuador, the World Bank has submitted a request amounting to US \$227,411 plus agency support cost of US \$17,056 for the fourth tranche of the national CFC phase-out plan. The World Bank has also submitted a verification report prepared by a national consulting company on follow-up of the license system for import/export of ODS and import quotas in 2006, together with the 2006 progress report and 2007 annual implementation programme.

2. The national CFC phase-out plan for Ecuador (NPP) was approved at the 41st Meeting of the Executive Committee in December 2003. The Government of Ecuador was provided with financial support of US \$1,689,800 from the Multilateral Fund to completely phase out its CFC consumption in accordance with annual targets set in the Agreement between the Government and the Executive Committee. The NPP will phase out the remaining consumption of Annex A, Group I substances over the 2004–2010 period. To achieve this target, a series of investment, non-investment, technical assistance, and capacity building activities will have to be carried out. No refrigeration management plan activities have been funded previously by the Multilateral Fund in Ecuador. Therefore, activities proposed in the NPP include support for training refrigeration technicians and customs officers, and the establishment of an import licensing system.

3. The NPP supports the Ecuadorian Government in its endeavour to ban the use of virgin CFCs in the servicing sector by 2010. The Agreement between the Government of Ecuador and the Executive Committee, approved at the 41st Meeting, established CFC consumption and annual reduction targets as shown in the project evaluation sheet.

Verification report

4. The report on the annual audit of the national CFC phase-out plan for Ecuador (verification report) has been prepared by the ENYA Corporation. The report indicates that 2006 imports quotas have been established at 79.1 metric tonnes of CFCs. The report shows records on CFC imports obtained from the Ministry of Industry and Commerce demonstrating that 2.1 ODP tonnes of CFC-11 and 60.9 ODP tonnes of CFC-12 were imported in 2006. The report shows also the source of the CFC imports. The 2006 target level for of CFC consumption in Ecuador of 80.0 ODP tonnes has therefore been met.

2006 progress report

5. The 2006 annual implementation programme, approved by the 49th Meeting of the Executive Committee, outlined activities to be accomplished and performance indicators to facilitate the monitoring of the progress achieved. The following activities have been undertaken:

(a) The import/export licensing and quota system has been further strengthened. Import quotas have been issued to national importers to maintain the import of CFCs, but not to exceed the consumption targets established in the Agreement. Altogether, 63 ODP tonnes of CFC-11 and CFC-12 have been imported by Ecuador in 2006;

- (b) Most of manufacturing companies in the foam and refrigeration sectors initially identified in the approved Plan have been found ineligible for funding since they closed down their operations or switched to non-CFC alternatives by themselves. The resources available have been diverted to other activities described below. Conversion of three eligible manufacturing companies in the foam sector has been completed and CFC-free foam manufacturing started in September 2006;
- (c) The "train-the-trainers" programme for training of 15 professional refrigeration instructors was accomplished in 2004. Since then, regular training activities have been undertaken on good practices in refrigeration servicing, including recovery/recycling operations. During 2006, 18 training workshops were completed resulting in training of 240 refrigeration technicians;
- (d) The total demand for recovery and recycling machines has been determined to be 130 in the country and; planned to be fully financed by the Multilateral Fund. The World Bank authorized the purchase of 130 recovery and recycling machines amounting to US \$676,736 to be delivered by the end of 2008. Fifteen recovery and recycling machines from the first batch of 48 machines have been delivered;
- (e) As part of the customs strengthening programme, six portable ODS identifiers have been delivered to the national customs office and a training course of customs officers was carried out in 2005. The customs office has been carrying out field tests of ODS consignments using portable ODS identifiers. The World Bank has approved the purchase of a gas chromatograph and hydrogen generator for the amount of US \$39,565 for the customs office in Guyaquil. The construction of the laboratory has been finished and the equipment will be delivered and installed in the second half of 2007;
- (f) A survey has been conducted in the chiller sector identifying 11 CFC-based chillers consuming approximately 1.78 ODP tonnes. About US \$360,000 will be allocated for the incentive programme in replacing CFC-based chillers representing about 20% to 40% of the total investments required for chiller replacement activities. The remaining funds will come from the owners of chillers; and
- (g) Information related to the Government of Ecuador's policies in phasing-out CFCs has been disseminated to the industrial sectors and public in general through a variety of media.

2007 Annual Implementation Programme

6. The phase-out targets in the 2007 Annual Programme are to ensure that CFC consumption during the year does not exceed 42 ODP tonnes. Ecuador is requesting the release of US \$227,411 to achieve this objective. The following specific activities will be implemented in 2007:

- (a) Policy measures: ratification of the Beijing Amendment; follow-up of the import/export licensing system and import quotas;
- (b) Technical assistance: development of the next phase of the R&R programme targeting selected refrigeration workshops; conducting training courses on good practices in refrigeration servicing by authorized training centres;
- (c) Implementation of a chiller replacement project;
- (d) Preparation and implementation of a CFC banking system, including the purchase of a distillation tower to increase the reclamation capabilities in the country; and
- (e) Other activities: dissemination of information related to the Government's policy to phase out CFCs in the manufacturing sector, including information on the availability of funds provided by the Multilateral Fund to support CFC phase-out in Ecuador; raising public awareness of the environmental and economic impact of ozone layer depletion to the public via newsletters, articles, seminars and radio spots; conducting awareness programmes for the general public encouraging servicing of refrigeration and MAC systems by trained technicians.

SECRETARIAT'S COMMENTS AND RECOMMENDATION

COMMENTS

7. The Secretariat noted from the verification report prepared by ENYA that the 2006 CFC imports were below the cumulative quotas issued. The World Bank provided additional information not included with the original submission. It describes how the actual import was verified and how the quota system is organized to ensure communication between Government entities involved.

8. The Secretariat noted that the report on progress with the implementation of the country programme in Ecuador for 2006 has not been received; instead, the country sent data to be reported under Article 7. The World Bank as the agency responsible for Ecuador's institutional strengthening project has been advised about the outstanding report and requested to contact Ecuador's NOU and to advise them to send the above report to the Fund Secretariat.

9. The development and implementation of legal instruments for certifying refrigeration technicians was included in the 2005 programme but could not be implemented. Upon request of the Secretariat, the 2006 progress report was amended to provide information on a certification system for the refrigeration technicians, which is administered by a government training institution.

10. The Secretariat noted that 15 sets of recovery and recycling machines, together with refrigeration servicing equipment, have been provided to training centres. Altogether 48 recovering and recycling machines are expected to be provided as a first batch to selected servicing workshops in the second half of 2007. In addition, the World Bank has already approved the purchase of another 130 recovery and recycling machines amounting to US \$676,736. The Secretariat drew the World Bank's attention to decision 41/100 which urges Article 5 countries and implementing agencies to be more selective in providing new recovery and in particular recycling equipment. The World Bank informed that the Government of Ecuador is considering the Secretariat's comments and will subsequently, through the World Bank, report any deviation from the present plan, but is currently seeking approval for the request as described.

11. The 2007 annual implementation programme did not contain full information on the financial status of implementation of the Plan. The World Bank has been requested to provide comprehensive information reflecting tranche allocations received, expenditures by activities implemented and balances forwarded, within the new format of multi-year agreement tables. The World Bank responded to queries by the Secretariat and provided the requested information.

12. The Secretariat noted that the request for the fourth funding tranche of the Plan for Ecuador is in accordance with the agreement between the Government and the Executive Committee approved at the 41st Meeting. The Secretariat also noted that the majority of phase-out activities included in the 2005 annual implementation programme have been completed. The Government of Ecuador reported to the Secretariat the 2005 CFC consumption data which are below the limit established in the Agreement.

RECOMMENDATION

13. The Fund Secretariat recommends blanket approval of the fourth tranche of the project with associated support costs at the funding levels shown in the table below:
