PROJECT DESCRIPTION

1. On behalf of the Government of the Former Yugoslav Republic of Macedonia (Macedonia, FYR), UNIDO has submitted the third tranche of the terminal phase-out management plan for CFCs for consideration by the Executive Committee at its 53rd Meeting. The total amount requested is US \$15,000 plus agency support costs of US \$1,125.

Background

2. The Terminal CFC Phase-Out Management Plan (TPMP) for Macedonia, FYR, was approved in April 2005 at the 45th Meeting of the Executive Committee. The total funds approved in principle amount to US \$279,081 plus US \$20,931 in support costs. The objective of the plan is to enable the Government of Macedonia, FYR to phase out its CFC consumption mainly in the refrigeration and air-conditioning service sectors by 31 December 2008. In order to achieve this target, a series of investment, non-investment, technical assistance and capacity building activities will be and are being implemented by UNIDO.

Annual programmes

3. UNIDO reported on the implementation of the 2007 annual programme. The Government of Macedonia, FYR has a long standing licensing system for import of ODS and equipment containing ODS. Since 2005, a system has been established imposing environmental taxes on imports of ODS and goods containing ODS. In 2006, the Government introduced legislation banning imports of used refrigeration equipment. A training programme in the refrigeration sector has continued throughout 2006 and 2007 consisting of a course for training of vocational school teachers and several courses for training refrigeration technicians. In total, 25 sets of recovery and recycling equipment have been purchased and distributed to refrigeration servicing shops and vocational schools. Two training courses for customs officers have also been carried out resulting in training and certifying of an additional 64 officers. As of September 2007, 99.5% of the second tranche (US \$79,871) has been obligated and US \$17,119 has been disbursed.

4. As determined in the agreement, the annual consumption limit for 2006 is 15 ODP tonnes. UNIDO has submitted a verification report for 2006, which describes the institutional and legal set-up for establishing import quotas, import control and a licensing system. Each year all interested importers are invited, through a call in newspapers, to apply for import permits for CFCs for the following year. The importers have to submit, among other official documents, statements from the end users on the quantity they need. According to the audit report, importers applied for 49.4 ODP tonnes of CFC-12, the Government issued licences for 13.5 ODP tonnes, which led to imports of 6.99 ODP tonnes. The reported Article 7 consumption of Macedonia, FYR, is less than 50% of the target 2006 consumption in the agreement.

5. The next tranche, at a cost of US \$15,000, is requested for management, monitoring, auditing and reporting. The Government is planning to keep and enhance control measures under the existing legislation, extending these to HCFCs.

SECRETARIAT'S COMMENTS AND RECOMMENDATION

6. The Secretariat has sought clarification from UNIDO on the operation of the recovery and recycling system and, in particular, on the specifications of recovery and recycling equipment acquired under the TPMP. The 34 machines purchased are multifunctional automatic units capable of handling CFC-12, HCFC-22 and HFC-134a. The recovery and recycling system is now composed of 34 new recycling machines, 109 recovery, and 3 recycling units made available under the RMP. UNIDO clarified that servicing workshops have been reporting on the recovered and reused refrigerants. UNIDO provided detailed information on quantities of recovered and reused material for the period 2002 to 2006 with a breakdown for each refrigerant. The total amount of CFCs recovered since 2002 stands at 8.2 ODP tonnes.

7. The verification report however shows a significant discrepancy between the requested amounts for imports in 2006 by importers (49.4 ODP tonnes), permits issued (13.5 ODP tonnes) and actual imports of 6.99 ODP tonnes. In response to the Secretariat's query, UNIDO clarified that such a difference in requested and imported quantities could be explained by a high level of taxes imposed by the Government on importers.

8. The activities foreseen for Macedonia, FYR, for future years are exclusively related to monitoring. The Secretariat has therefore agreed not to request completion of tables 8 and 9 of the multi-year agreement overview tables contained in Annex I to this document.

RECOMMENDATION

9. The Fund Secretariat recommends blanket approval of the third tranche of the TPMP for Macedonia, FYR with associated support costs at the funding levels shown in the table below:
