执行蒙特利尔议定书 多边基金执行委员会 第五十三次会议 2007年11月26日至30日,蒙特利尔

> 关于执行委员会运作问题的报告 (根据第 50/41 号决定采取的行动)

执行蒙特利尔议定书多边基金执行委员会的会前文件不妨碍文件印发后执行委员会可能作出的任何决定。为节省经费起见,本文件印数有限。请各代表携带文件到会,不索取更多副本。

#### 一. 导言

- 1. 这份最新情况报告是秘书处根据执行委员会的决定(第 50/41 号决定)提交的,该决定要求"在执行委员会第五十三次会议上参照第十九次缔约方会议提供的指导意见,重新讨论执委会的会议次数问题"。因此,该决定要求执行委员会主席寻求第十九次缔约方会议的认可,来改变执委会的职权范围,使其能够灵活地改变举行会议的次数。
- 2. 自 2004 年的第四十四次会议以来,每年的会议次数问题就一直在执行委员会的议程上。秘书处就此编写了三份讨论文件;第一份文件(UNEP/OzL.Pro/ExCom/44/69)是提交第四十四次会议的文件,探讨了把执行委员会的会议次数从三次减为两次的可能性,并讨论了有无可能在每年举行两次会议的情况下建立一个休会期间项目审批程序;第二份文件(UNEP/OzL.Pro/ExCom/45/48)于 2005 年提交第四十五次会议,对减少会议次数的做法进行了财务上的评估;第三份文件(UNEP/OzL.Pro/ExCom/50/56)于 2006 年提交第五十次会议,对执行委员会工作量进行了最新评估,并提出了一系列问题供执委会讨论,其中包括有无必要由缔约方会议修正执行委员会的职权范围。
- 3. 第十九次缔约方会议在第 XIX/11 号决定中规定,给予执行委员会"自行决定每年举行两次还是三次会议的灵活性",从而为执行委员会改为每年举行两次会议消除了法律障碍。现在有待回答的问题是,是否可以在每年举行两次会议,而不是三次会议的情况下处理执行委员会的工作量。
- 4. 为了回答这个问题,本文首先探讨了当前各项方案的现状。然后,本文讨论了第十九次缔约方会议第 XIX/6 号决定对执行委员会的工作量产生的影响,特别是在今后两年的影响。本文以此为基础提出了若干备选办法供执行委员会考虑。

### 二. 当前各项方案

- 5. 为了分析执行委员会的工作量,秘书处为提交第四十四次会议的第一份文件制定了一个方法,其中结合采用了数量指标和质量指标。这个方法在一切可能的情况下用量化数字,例如体制建设项目的数字,来评估工作量。对那些无法量化的活动,对其给予了"高"或"低"的评级,并在"说明"栏中予以简短解释。为了评估任务的复杂性,所适用的标准取决于是否可以得到既定政策和准则。如果存在明确的政策和准则,例如单个项目的供资资格,复杂性被定为"低",如果准则仍在制定当中,复杂性则被定为"高"。
- 6. 附件一提供了最新资料,显示 2006 年 11 月第五十次会议以来发生的变化。该附件显示,多边基金当前开展活动的几乎所有领域都有明确的准则和政策。唯一的例外是需要继续完善和精简对当前的多年期协定的监测工具,以便及时提供协助来减少违约情况。
- 7. 其他有待供资的活动主要是执行委员会尚未审议的低消费量国家最终淘汰管理计划项目,这些项目估计有53个,包括将提交第五十三次会议的22个。其余的供资成分将包括150个执行中的多年期协定的年度档、每年的大约70个体制建设项目、以及2007年工作方案中的大约107项活动,其中大部分是为氟氯烃调查进行的项目编制活动。

- 8. 正如提交第五十次会议的文件所解释的那样,在衡量执行委员会的工作量时,必须区分秘书处的工作量和执行委员会的工作量。费时费力,因此增加了执行委员会会议工作量的是政策、项目或方案引起的悬而未决问题。例如,向某次会议提交的 100 个项目提案衡量的是秘书处的工作量,因为秘书处必须审查每一个方案,并制定提交执行委员会的建议。如果在秘书处审查之后,只有两个项目有悬而未决问题,由秘书处建议予以个别审议,这两个项目将构成执行委员会会议上的项目审批工作量,因为它们会导致成员国之间长时间交换意见,还可能需要执行机构和秘书处提供协助。虽然其他 98 个项目是由一揽子核准的决定集体处理,但这两个项目会花费很多时间。
- 9. 然而,在这些数字背后,是多边基金需要克服挑战,来提供及时的协助,以避免各国陷入违约。这一挑战在 2008 年特别严峻,因为届时将获悉 2007 年把 CFC 削减 85%的管制措施所取得的成果。因此,无论任何在 2008 年仅举行两次会议的计划,都必须包括一个机制,用以在闭会期间满足提供援助的迫切需要。执行委员会的业务规则当中有一个在闭会期间处理供资申请的现行程序。提交第四十四会议的文件也讨论了这个程序,并讨论了以事先决定的对主任的授权程度为基础建立一个闭会期间审批程序的可能性。

#### 三. 第十九次缔约方会议第 XIX/6 号决定产生的影响

- 10. 缔约方会议第 XIX/6 号决定授权执行委员会制定供资准则,以根据经过调整的时间表加速第 5 条国家淘汰氟氯烃生产和消费的速度。正如题为"评估和确定氟氯烃消费和生产淘汰活动合格增支费用的备选办法(执行第 52/4 号决定)"的文件(UNEP/OzL.Pro/ExCom/53/60)所述,有一系列困难问题有待解决,例如:供资资格的截止日期;第二阶段改造;在衡量淘汰活动的成本效益时除了考虑到对臭氧层的保护之外,还把气候收益和环境影响的成本效率考虑在内的必要性。秘书处提议进行更多的技术性工作,以协助执委会找到解决办法,但与此同时也应该意识到,执行委员会成员为了就这些办法达成协议,可能需要长时间的讨论和谈判。如果进展情况符合计划,即,拟议由秘书处(征得执行委员会同意)召集的专家组在技术层面取得了良好的进展,而且执行委员会在 2008 年第二次会议之前经过讨论,以协商一致方式就困难问题做出了决定,那么,执行委员会可以就氟氯烃淘汰活动的供资问题制定出基本政策框架,并将做好准备来指示各执行机构开始编制氟氯烃淘汰管理计划、淘汰项目和方案。
- 11. 这对执行委员会在 2008 年的工作量带来的影响是,如果第五十四次会议无法解决氟 氯烃供资准则问题,执委会可能需要在年中的某个时间举行会议,讨论这些问题。如果执 委会决定改为举行两次会议,对氟氯烃问题的审议时间将大致相当于传统上在三次会议的格局下举行第二次会议的时间,只不过这次举行的是一次关于氟氯烃的专门会议。这可能 意味着较短的议程、较短的持续时间和较少的文件。
- 12. 然而,秘书处希望指出,无法有意义地评估氟氯烃供资方案在 2009 年以后对执行委员会的工作量产生的影响,因为这在很大程度上取决于执委会关于供资政策的审议结果,包括取决于各国编制氟氯烃淘汰管理计划以及其他活动,例如氟氯烃调查的速度,并取决于是否可以得到替代技术、供资重点和模式(个别项目、部门/全国淘汰计划)以及执行机构和秘书处的执行能力。这还取决于氟氯烃供资方案的执行速度和在每年的大致规模。一

旦在今后一、两年建立了关于氟氯烃淘汰活动的供资政策框架,所有这些问题都应变得更为清晰,届时将有可能更好地评估执行委员会每年的工作量,随后决定在 2009 年之后每年举行会议的次数。

- 14. 按固定时间表举行两次常会(第一次会议: 3 月/4 月;第二次会议: 10 月/11 月),并保留在必要情况下于年中举行一次讨论专门问题的第三次会议的可能性。

The table above provides an update of the assessment of the workload of the Executive Committee which was included in the paper submitted by the Secretariat in 2004 and 2006. The update is shown in the column "2007" while the original is indicated in the columns "2004" and "2006". The criteria used in the assessment remain the same and are reproduced below.

To assess the level of workload, quantification by number, such as the number of institutional strengthening projects, is provided where possible. For those activities where quantification by number is not possible, a "high" or "low" rating is given with a short explanation in the "comments" column. For the assessment of complexity, the criteria applied relate to the availability of established policies and guidelines. Where clear policies and guidelines exist, for instance for the funding eligibility of individual projects, the complexity is classified as "low", and where the guidelines are still developing the complexity is determined to be "high".
