执行蒙特利尔议定书 多边基金执行委员会 第五十四次会议 2008年4月7日至11日,蒙特利尔

项目审查期间所发现的问题概览

执行蒙特利尔议定书多边基金执行委员会的会前文件不妨碍文件印发后执行委员会可能作出的任何决定。为节省经费起见,本文件印数有限。请各代表携带文件到会,不索取更多副本。

提交执行委员会第五十四次会议的项目和活动

导言

1. 本文件分为三节。第一节载有执行机构和双边机构向第五十四次会议提交的报批文件的统计数字。并对照这些文件要求提供的资金评估了可供使用的资金余额,提出在资金短缺的情况下管理现金流转的解决办法。第二节提出了秘书处在审查提交会议的文件中查明的两项政策问题。第三节是第五十二次会议新增加的一节,对核定的项目或多年期协定的年度付款进行拟议修正,但在本次会议没有提出文件。

第一节 双边机构和执行机构的报批文件

- 2. 秘书处收到的供第五十四次会议审议的各种多年期协定、项目和活动的资金总额为64,188,678 美元。这一数额包括提议在原则上核准的新的多年期协定的总额。
- 3. 这个总数还涵盖 239 项供资申请,其中包括总额为 55,522,883 美元的具体年度付款和其他项目/活动(包括适用情况下的机构支助费用)。在秘书处进行审查后,转送执行委员会审议的项目和方案共有 206 项,占所收到供资申请总数的 86.2%,金额为 48,853,430 美元,占所有申请资金总额的 88 %。
- 4. 秘书处建议一揽子核准的项目清单中列有 41 项活动,总金额为 20,108,786 美元。这些活动占所收到供资申请总数的 17.2%,占所申请供资额的 36.2%。这些项目的清单载于附件一。
- 5. 秘书处基于一些理由建议进行单独审议的项目和活动共有 165 项,其中包括工作方案和工作方案修正案内的活动以及投资项目。其范围从秘书处与负责执行的执行机构对剩余的问题持续进行讨论到氟氯化碳的生产和消费量的淘汰之间取得协调以协助有关国家实现规定的裁减目标。按百分比计算,这些项目占要求供资的全部项目的 69%,或占要求供资额的 51.4%。附件二载有拟以单独审议的投资项目的清单。
- 6. 秘书处遵照要求秘书处在其提交会议的文件中将不需要履约的项目按面向履约的模式单独列出的第52/3(c)号决定的规定,在附件三中列出了这些项目,其中包括环境规划署与履约协助方案无关的活动、计量吸入器行业、甲基溴行业以及氟氯烃的项目。在这份颇长的清单中占多数的氟氯烃项目列入清单的原因是氟氯烃目前并不属于面向履约的模式,因此现在还列在清单上。这个问题将在议程项目7(a):"多边基金综合业务计划和审议2008-2010年增订三年滚动示范淘汰计划"项下进行讨论。根据要求提出国家方案执行情况的数据以便核准供资数额的第52/5号决定,厄立特里亚至今尚未遵守这项规定,因此,它的最终淘汰管理计划由于各种理由包括未提供这项数据的理由列入单独审议的项目清单。

7. 没有按照第 50/14 号决定内的定义属于内容不完整的来文。33 个项目/活动已由提出的机构撤销。

基金状况

- 8. 本文件编写之际,多边基金的资金余额为 84,352,512 美元,其中 45,007,865 美元为现金,39,344,647 美元是期票。根据资源余额和供应情况的报告,现正在把 532,906 美元退还第五十四次会议。假设供一揽子核准和供单独审议的清单上的项目都按拟议供资的数额核准,则所需的现金总额约为 4,885 万美元,按此计算所需资金约缺 330 万美元。
- 9. 显然这不是预算问题,而是现金流转问题。不过,如果从现在至第五十四次会议期间收到更多捐款,则现金余额还可能发生变化。同时,经过执行委员会会议的审查和核准,对项目资金的需求也可能减少。

第二节 项目审查期间所发现的政策问题

淘汰**氟氯烃**的投资和示范项目的项目编制工作方案和工作方案修正案

- 10. 第五十四次会议收到开发计划署、环境规划署和工发组织作为其工作方案和工作方案修正案的一部分提交的一共 148 项氟氯烃项目的申请,其中包括三个机构提出的编制氟氯烃淘汰管理计划的 108 项申请、工发组织提出的编制氟氯烃投资项目的 22 项申请和开发计划署提出的在 10 个国家进行示范项目的 18 项申请。
- 11. 秘书处向本次会议提交了执行机构工作方案文件中提出的为编制氟氯烃淘汰管理计划要求供资的申请(UNEP/OzL.Pro/ExCom/54/18、19 和 20)。秘书处提交申请的理由是依据执行委员会第五十三次会议进行的讨论和给予每一个第 5 条国家拟定国家氟氯烃淘汰计划最高优先的决定。不过,在执行委员会就这些管理计划的内容和形式作出决定之前,秘书处没有审查申请的供资数额的合理性,或对此作出任何建议。希望这项决定将在讨论载于 UNEP/OzL.Pro/ExCom/54/53 号文件的这些计划的编制准则草案时作出,因为执行委员会曾明确表示"将尽其全力在第五十四次会议上核准这些准则"。
- 12. 不过,秘书处认为,在本次会议要求为投资项目和示范项目申请编制经费的时机并未成熟,因为仍有许多政策问题需要解决,并需要执行委员会在同意这些项目的供资之前对这些问题作出决定。这些问题均列于上文提到的**氟氯烃**淘汰管理计划编制准则草案和与费用有关的问题的文件(UNEP/OzL.Pro/ExCom/54/54)。由于所有这些项目均列于综合业务计划 UNEP/OzL.Pro/ExCom/54/6 号文件,因此委员会第五十四次会议将对这些项目进行审议。秘书处曾设法使提出申请的机构即开发计划署和工发组织相信它们应利用上述论点从其工作方案中取消这些申请。开发计划署接受了这项要求,但工发组织拒绝要求,坚持把这些申请列入工作方案。因此,开发计划署的工作方案(UNEP/OzL.Pro/ExCom/54/19)没有列入这些申请,而工发组织的工作方案(UNEP/OzL.Pro/ExCom/54/20)列入了这些申请。

13. 谨提议执行委员会根据议程项目 11(a): "关于编制含有氟氯烃调查的氟氯烃淘汰管理计划的准则草案(第 53/37(h)号决定)"和议程项目 11(b): "提供关于对资助氟氯烃淘汰的所有相关费用因素的分析的初步讨论文件(第 53/37(i)号决定)"的讨论考虑这些申请的时机。

对战争造成的损失的补偿

14. 开发计划署和工发组织代表黎巴嫩政府提出了 2007 年的进度报告,说明在鲜花和烟草种植中仍然使用甲基溴的所有剩余土壤淘汰甲基溴的项目的执行情况(开发计划署),和在草莓种植中淘汰用于土壤熏蒸的甲基溴的项目的执行情况(工发组织),供执行委员会第五十四次会议审议。随同这两份进度报告,开发计划署和工发组织提出一份黎巴嫩政府的请求,要求执行委员会作为例外情况,考虑核准额外拨款 62,200 美元,用以支付由于2006 年 7 月国内的紧急情况所导致的该项目造成的损失。这些损失的细目如下:

- 15. 此外,开发计划署要求供资 4,298 美元,作为支助费用(相对于额外供资 57,300 美元),工发组织要求供资 368 美元,作为支助费用(相对于额外供资 4,900 美元)。谨建议执行委员会审议是否可提出战争造成的损失的补偿问题。有关这项申请的更加详细的说明载于附件四。

黎巴嫩:在鲜花和烟草种植中仍然使用甲基溴的所有剩余土壤淘汰甲基溴的项目 和在草莓种植中淘汰用于土壤熏蒸的甲基溴的项目的执行情况进度报告

背景

1. 执行委员会第三十四次会议原则同意拨款 4,421,945 美元(2,600,000 美元和 1,821,945 美元,分别提供给开发计划署和工发组织执行的项目),作为提供给黎巴嫩政府的全部经费,供其全部淘汰在蔬菜、鲜花、烟草和草莓种植中作为土壤熏蒸剂使用的甲基溴(236.5 ODP 吨)。在第四十三次会议上,执行委员会批准改变工发组织的项目中用于淘汰草莓种植中作为土壤熏蒸剂使用的甲基溴的技术,并对黎巴嫩政府和执行委员会订定的协定作出修正。在第五十二次会议上,执行委员会批准了一项订正案,将该协定的淘汰日期延长到2008 年。所有供资付款均已由执行委员会发放给开发计划署和工发组织,用于执行这两项投资项目。

2007年的进度报告

- 2. 在 2007 年,与从事烟草和鲜花行业的农民和农会举行了会议并展开了讨论。对鲜花行业核准使用的新的代用化学剂进行了小规模试用,也展开了采购代用化学剂所需的水泵和设备的招标进程,并进行了若干提高认识和提供资讯的活动。
- 3. 由于 2006 年国内发生的冲突以及随后黎巴嫩几乎所有农业区域发生的严峻情况,尽管烟草行业试用甲基溴代用品的试点遭到了破坏,但在 2007 年初这个项目已经恢复了活动。在黎巴嫩不同的烟草种植地区建造了数量不多的水池,以便采用浮盘系统。不过,由于在这些试点难以推动活动,并且由于气候异常恶劣,阻碍了项目的持续进行,因此没有取得具体成果。项目管理活动已在这一行业重新展开,并且与黎巴嫩烟草局和其他主要利益攸关方进行了协调,目前正在筹备进行一个新的种植季节。
- 4. 若干甲基溴代用品已作为土壤熏蒸剂用于草莓作物,包括土壤太阳能消毒、化学剂和作物轮种。不过,这些技术无法用于黎巴嫩北部的一个种植区,原因是 2007 年春季和夏季的军事行动以致无法进入这个地区。此外,也进行了若干其他活动,包括最妥善地利用甲基溴代用品和在所有相关草莓种植区划出试种区以便进行评价;编制草莓行业使用甲基溴代用品和虫害综合管理办法的技术手册和说明;和为农民举行使用甲基溴代用品和虫害综合管理办法的培训班。
- 5. 建议执行下列活动直到项目完成为止: 采购 100 台计量泵并将其分配给农民; 为采用浮盘系统采购设备和农场材料及代用化学剂;和执行提高农民的认识的活动及培训活动。

要求补偿供资的请求

6. 鉴于 2006 年事件对执行黎巴嫩甲基溴淘汰项目产生的影响,黎巴嫩政府通过其环境部已经要求执行委员会作为例外情况,考虑核准额外拨款 62,200 美元,用以支付由于 2006年7月国内的紧急情况所导致的该项目的损失。

秘书处的评论

- 7. 黎巴嫩政府提出了目前正在执行的两个甲基溴淘汰项目的第四阶段(2007年)执行情况的全面报告。
- 8. 黎巴嫩政府要求核准62,200美元用以支付在烟草行业和草莓行业造成的财务损失的请求是在第五十二次会议首次提出的。由于当时执行委员会无法对2006年危机对甲基溴淘汰项目产生的全盘影响作出评估,它要求开发计划署和工发组织提交关于这些项目执行情况的报告,并对可能产生的财务损失作出评估,供第五十四次会议审议(第52/17(g)(四)号决定)。
