- **Delete** the rows for Bolivia and Paraguay in section B1 "Project preparation for HCFC phase-out plans" in Table 1 as these will be reflected in documents UNEP/OzL.Pro/ExCom/55/18/Add.3 and UNEP/OzL.Pro/ExCom/55/20/Add.2 respectively.
- **Replace** paragraph 23 *bis* as follows:

23 bis. Following the issuance of document UNEP/OzL.Pro/ExCom/55/19/Add.1, UNDP and the Secretariat agreed on the total funding level to be recommended per country in line with Table 1 above. The costs also take into account the agreed discounting for the earlier approved surveys for Argentina, Brazil, Colombia, India, Indonesia, Islamic Republic of Iran, Lebanon, Malaysia, Mexico and Sri Lanka. With regards to India, UNDP submitted a comprehensive proposal for the full HPMP preparation that includes proposals for project preparation in each sector only at the time of writing this document. The Secretariat was therefore unable to review the submissions as it was submitted late and therefore recommends that this be deferred to the 56th Meeting of the Executive Committee. In the case of Islamic Republic of Iran, there is no agreement on the division of costs between agencies and the Secretariat likewise recommends this be deferred to the 56th Meeting.

- **Replace** paragraph 24 and 24 *bis* as follows:
- 24. In view of the above, the Executive Committee may wish to approve the preparation of HCFC phase-out management plans for the countries and their corresponding funding as listed in Table 1 of UNEP/OzL.Pro/ExCom/55/19/Add.1 and Table 1 above, bearing in mind that, in decision 54/23, US \$257,000 and US \$19,275 in agency support costs had been approved as an advance for project preparation for HPMPs.

24 *bis*. The Executive Committee may wish to request UNDP to defer the requests for the HPMP preparation in India and Islamic Republic of Iran to the 56th Meeting of the Executive Committee.
