REPORT ON BALANCES AND AVAILABILITY OF RESOURCES

Pre-session documents of the Executive Committee of the Multilateral Fund for the Implementation of the Montreal Protocol are without prejudice to any decision that the Executive Committee might take following issuance of the document.

Introduction

1. This document presents a summary of the financial adjustments indicated by the bilateral and implementing agencies agreed to by the Fund Secretariat. The document includes statistical data from projects for bilateral and implementing agencies with balances that have been held for over the allowable 12-month period following completion of the project, as required by decisions 28/7 and 56/2. The data presented are based on the reporting format that has been developed pursuant to decision 31/2 and include both obligated and un-obligated balances. Further to decision 41/92(b), this document also indicates the level of resources available to the Executive Committee in cash and promissory notes as recorded in the Status of Contributions (UNEP/OzL.Pro/ExCom/58/3). The total funds returned addressed in this report amount to US \$735,826 including support costs and interest.

Fund being returned to the 58th Meeting by Implementing Agencies

2. Information provided by the implementing agencies indicates that a total of US 340,398 excluding agency support costs will be returned to the 58^{th} Meeting, as shown in Table 1.

FUNDS TO BE RETURNED TO THE 58th MEETING (US \$)

Projects with balances by year of completion

3. Table 2 presents the number of projects with balances that are still being held by the implementing agencies and the years in which those projects were completed. It shows that for projects closed and completed up to and including 31 May 2008 (at least over the last 12 months) implementing agencies had balances that totalled US \$7,983,528 excluding support costs.

BALANCES HELD BY YEAR OF PROJECT COMPLETION

4. At its 47th Meeting, the Executive Committee requested the Fund Secretariat to continue to monitor multi-year annual tranches in the context of documents on implementation delays and project balances (decision 47/50(b)(ii)).

5. The World Bank holds the highest reported balance of US \$3,208,729 of which US \$3,181,487 is attributable to multi-year annual tranches. UNDP holds a total balance of US \$1,051,018 of which US \$99,864 is attributable to MYAs, and UNIDO holds a total balance of US \$1,384,615, of which US \$1,000,327 is attributable to MYAs. UNEP has reported a balance of US \$2,339,166 of which US \$425,750 is attributable to MYAs. UNEP has the highest number of projects with balances (103) followed by UNDP (89), UNIDO (34) and the World Bank (10).

6. All agencies have projects that were completed over two years ago and have remaining balances. Most of the funds (US \$3,181,487 of US \$5,752,304) are attributed to the World Bank's eight reported projects that were completed over two years ago. UNEP has the largest number of projects (69) that were completed over two years ago, with balances totalling US \$1,530,274.

7. Agencies have been asked to clarify why obligated balances remained for projects completed over two years ago. UNEP explained that funding provided to their implementing partners is in the form of cash advances with conditions attached to them including the provision of financial statements and inventory reports. All the conditions and requirements need to be fulfilled for the expenditures to be recorded in the financial system and subsequent payments to be made. In many of the cases the advances are paid through UNDP country offices. UNEP experienced some delays in receiving and recording disbursement reports in the past. It informed the Secretariat that it is working with the relevant Governments to meet all the pending reporting requirements. UNEP's balance for projects completed over 2 years ago has increased from US \$2.1 million to US \$2.3 million.

8. UNDP explained that balances totalling US \$519,466 resulted from projects implemented by the Governments. It advised that unless the balances are returned by the Governments, the funds

cannot be returned to the Fund or reported as un-obligated balances. Once the Governments return the funds, UNDP will then be able to return them to the Multilateral Fund based on a financially completed status of the project, or when the Government submits a financial report that would require additional expenditures to be recorded in UNDP's accounts.

9. The balance held by UNIDO for projects completed over two years ago has decreased since the 57th Meeting of the Executive Committee by almost US \$300,000. US \$191,573 balance remains for one project in Libya (LIB/REF/32/INV/03) as a result of some difficulties in transferring the funds to the enterprise. Out of the 16 projects, eight are MYAs projects with US \$88,046 obligated and US \$101,337 uncommitted balance. Remaining funds for these projects will be fully utilized before financial completion of these tranches. Remaining unobligated balances on individual projects will be returned to the MLF once all obligations have been cleared and after financial completion of the projects takes place.

10. The World Bank's overall number of projects with balances has increased from nine projects reported to the 57^{th} Meeting to ten reported to the 58^{th} Meeting, and the overall level of balances has decreased from US \$3,236,340 to US \$3,208,729.

Obligated and un-obligated balances

11. The level of balances classified as obligated and un-obligated for the four implementing agencies is as follows:

12. Of the total balance of US \$7,983,528 from completed, transferred and closed projects, US 6,503,880 is obligated (which means that these funds are expected to be spent) and US 1,479,648 has not been obligated. Implementing agencies are required to report reasons why any un-obligated balances could not be returned within the required time-frame, and to indicate when they will be returned (decision 31/2(a)(ii)).

13. UNDP has one closed, two transferred and 86 completed projects. It has no un-obligated balances. The overall number of projects with balances has decreased from 95 projects reported to the 57^{th} Meeting to 89 reported to the 58^{th} Meeting. The overall level of balances has decreased from US \$1,574,173 to US \$1,051,018.

14. UNEP has 103 completed projects, and un-obligated balances of US \$670,823. The overall number of projects with balances has decreased from 130 projects reported to the 57th Meeting to 103 reported to the 58th Meeting. The overall level of balances decreased from US \$3.7 million to US \$2.3 million. UNEP explained that the unobligated balances of US \$670,000 is prior years' unliquidated obligations. Following UNEP's internal accounting

procedures all obligations raised prior to 2008 were cancelled before the closure of the 2008 accounts and credited to the same fiscal year. These cancelled obligations are reflected as un-obligated balances in 2008 however UNEP re-obligates these balances to cover the commitments already undertaken. The obligated amounts cannot be returned to the Fund as they represent either cash advances paid to partners against which reporting requirements are pending or activities for which disbursements are pending.

15. UNIDO has 34 completed projects, and un-obligated balances of US 347,487. The overall number of projects with balances has decreased from 42 projects reported to the 57th Meeting to 34 reported to the 58th Meeting, and the overall level of balances has decreased from US 2.0 million to US 1.38 million. UNIDO explained that un-obligated balances will be returned to the MLF after financial completion of the projects.

16. The World Bank holds US \$2,747,391 in obligated balances for completed projects, all of which are for multi-year agreements. The balance of US \$2,747,391 is for tranches from the earliest annual programmes (APs) of two multi-year projects and one tranche of a production sector project. It has been obligated on the basis that when countries have met respective performance targets according to the agreement with the Executive Committee, the next tranche/AP would be approved. The World Bank holds an un-obligated balance of US \$461,338 from the HCFC Mangement Plan in Turkey that was completed in 2005. The Bank advised the Secretariat that queries on the balances in the context of preparing the 2008 Progress Report have led to the need for further reconciliation and consultation with the Government of Turkey. The Bank advised the Secretariat that it would be prepared to update the Executive Committee at its 58th Meeting on the status of the balances.

Agency support costs

17. At its 35^{th} Meeting, the Executive Committee requested that implementing agencies return all agency support costs associated with remaining funds from completed projects. If expenditures had been incurred from these costs, the implementing agencies should provide an explanation and return the balance of funds (decision 35/13(k)). Table 4 indicates that a total of US \$26,352 in agency support costs will be returned at the 58^{th} Meeting.

ADMINISTRATIVE SUPPORT COSTS RETURNED TO THE 58th MEETING (US \$)

Funds being returned to the 58th Meeting from bilateral agencies

18. Under decision 56/2(b) and (c) the Committee requested bilateral agencies "to report to the Executive Committee at its 57th Meeting on their proposed disposition of balances from completed projects," and the Secretariat "to continue monitoring completed projects with balances for bilateral agencies and to report to the Executive Committee thereon". As a follow-up the Secretariat asked bilateral agencies that have projects with balances for over the allowable 12-month period following completion of the projects to advise on their intent on the usage of these balances.

19. Table 5 provides the feedback received on returns of balances from projects completed from the Governments of Canada, Denmark, Italy, Finland and Germany. It indicates that a total US \$369,076 comprising project cost, agency support cost, and interest, will be returned to the 58th Meeting.

FUNDS RETURNED FROM BILATERAL AGENCIES

20. Table 5 shows that the Government of Canada returned a balance of US \$47,460 for two cancelled projects: a project preparation for a Terminal Phase-out Management Plan (TPMP) for Benin (BEN/PHA/49/PRP/15) and a Technical Assistance phase-out Methyl Bromide project in Trinidad and Tobago (TRI/FUM/49/TAS/08). The Government of Canada informed the Secretariat that UNEP was able to complete the TPMP project in Benin without the additional funds from the Government of Canada. For the Technical Assistance phase-out Methyl Bromide in Trinidad and Tobago, the project agreement with the Government had not been signed for two years and half after the project was approved and is unlikely to be signed in the near future. Canada is also returning to the Fund the unspent balance of US \$122 in project cost and US \$16 in support costs for a technical assistance project in Santa Lucia (STL/REF/41/TAS/08) that has been completed. Canada took necessary action to transfer the amount of US \$47,598 to the Fund's account.

21. Denmark returned US \$103,310 balance on two completed projects to the 58th Meeting. This amount, which includes US \$59,363 in interest, had been returned to the Fund through UNDP as the implementing agency for the project.

22. UNEP, as the implementing agency for the bilateral projects for Finland returned to the 58th Meeting a balance US \$76,855 on project NIC/REF/25/TAS/06 and advised that the return of the remaining balances on the Finish completed projects will be made when all payments are done and recorded in UNEP's accounts.

23. Germany is returning to the 58th Meeting a balance of US \$55,630 on project cost and US \$7,232 in support costs against project URT/REF/36/TAS/14, which had been completed. Germany advised the Secretariat of its intent to use these funds for future bilateral projects.

24. Italy returned to the 58th Meeting the amount of US \$72,196 in project cost and US \$7,753 in support cost against project YUG/REF/34/INV/13. However it reported an overpayment to UNIDO on project ROM/FUM/34/INV/19 which had been returned to the 57th Meeting, resulting into a credit to Italy of US \$1,499, (US \$1,282 in project cost and US \$217 in support costs). This credit has been netted off from project YUG/REF/34/INV/13 unspent balance resulting into a total return from Italy to the 58th Meeting of US \$78,451. Italy informed the Secretariat of its intent to return this amount to the Fund.

25. Spain advised the Secretariat that there is no remaining balance against the project LAC/FUM/47/TAS/37, which had been completed in 2007.

26. The details for returned projects to the 58th Meeting from Canada, Denmark, Finland, Germany and Italy are shown in Annex II of this document.

27. Table 6 presents the balances that are being held by bilateral agencies and the years in which those projects were completed. It shows that for projects completed up to and including 31 May 2008 (at least over the last 12 months) bilateral agencies had balances totaling US \$205,939 including support cost. France holds balances for projects completed over two years amounting to US \$162,319.

BALANCES HELD BY BILATATERAL AGENCIES

COMMENTS

28. Annex I presents additional information on obligated and un-obligated balances by agency.

29. Of the US \$8.1 million in projects with balances in this report, about US \$4.7 million is for MYAs and of that amount about US \$3.2 million is under the World Bank's implementation programme. As was the case in the last report on balances, the issue of balances from MYAs is mostly one for the World Bank. This report also indicates a balance of US \$162,319 withheld for bilaterals projects completed over two years.

30. The status of contributions and disbursements as of 27 May 2009 indicates that the Treasurer had an available balance amounting to US \$89,461,196 in cash and promissory notes. The total level of balances returned by implementing agencies including agency support costs is US \$366,750 and the total balance returned by the bilateral agencies is US \$369,076 including support cost and interest earned. The total level of resources available for approvals by the Executive Committee at its 58th Meeting, after taking into account the Fund balance as contained in document UNEP/OzL.Pro/ExCom/58/3, and the total return from IAs and bilateral agencies (excluding Germany who wishes to use the balance of US \$62,862 for bilateral projects) is US \$90,134,159.

31. Considering the total level of funding of projects and activities being considered by the Executive Committee amounting to US \$27,886,816 there are sufficient resources available for the 58th Meeting, in light of the value of potential approvals, (UNEP/OzL.Pro/ExCom/57/16).

RECOMMENDATIONS

- 32. The Executive Committee may wish to:
 - (a) Note the report on balances and availability of resources contained in document UNEP/OzL.Pro/ExCom/58/4;
 - (b) Note the net level of funds being returned by the implementing agencies to the 58th Meeting amounting to US \$340,398 against projects. This includes the return of US \$59,829 from UNDP, US \$209,562 from UNEP, and US \$64,015 from UNIDO, US \$6,992 from the Wold Bank;
 - (c) Note the net level of support costs being returned by the implementing agencies to the 58th Meeting amounting to US \$26,352 against projects. This includes the return of US \$4,396 from UNDP, US \$14,621 from UNEP and US \$6,426 from UNIDO, and US \$909 from the World Bank;
 - (d) Note the net level of funds and support costs being returned by the bilateral agencies to the 58th Meeting amounting to US \$309,713 against projects;
 - (e) Request the Treasurer to reduce bilateral funding by US \$47,598 for Canada, US \$43,947 for Denmark, US \$76,855 for Finland, and US \$78,451 for Italy; and to record US \$59,363 in interest accrued;
 - (f) Request the Treasurer to apply US \$62,862 for future bilateral projects against Germany's bilateral contribution to previous triennia;
 - (g) Note that implementing agencies had balances totalling US \$5,752,304 excluding support costs from projects completed over two years ago. This includes US \$519,466 from UNDP, US \$1,530,274 from UNEP, US \$521,077 from UNIDO, and US \$3,181,487 from the World Bank;
 - (h) Note that France had balances totalling US \$165,917 including support costs from projects completed over two years;
 - (i) Request the World Bank to update the Committee at its 58th Meeting on the return of the un-obligated balance of US \$461,338 against the HCFC management plan in Turkey that had been completed in 2005.
