Addendum

2009 BUSINESS PLANS AND ANNUAL TRANCHE SUBMISSION DELAYS

• **Replace** paragraph 8 **with** the following:

8. Submissions to the 59^{th} Meeting also include project values amounting to US \$53,283,880 (including US \$9,842,833 that were not in the business plans), which exceed the amount included for them in the 2009 business plans. Those activities not included in the business plan are: HCFC preparation for 13 projects (US \$909,875), two technical assistance projects (US \$256,736), one training project (US \$160,178), three NPP projects (US \$608,968), four investment projects (US \$6,943,364), three institutional strengthening projects (US \$274,062) and 11 ODS disposal project preparation (US \$689,650). If all of the submissions to the 59^{th} Meeting are approved at the levels reviewed, the Executive Committee would have approved US \$11,385,168 more than the total amount included in the 2009 business plans for these projects.

Pre-session documents of the Executive Committee of the Multilateral Fund for the Implementation of the Montreal Protocol are without prejudice to any decision that the Executive Committee might take following issuance of the document.

• Add paragraphs 24 (bis) and 24 (ter) and Table 9 under the section on Forward commitments as follows:

24 (bis). Forward commitments *inter alia* consist of funding for multi-year agreements (MYA) and "other standard activities" such as institutional strengthening, budget of the Fund Secretariat, Treasurer and Executive Committee meeting costs, UNEP's Compliance Assistance Programme (CAP), and the core unit costs for UNDP, UNIDO and the World Bank. Funding for "other standard activities" is based on projections in the 2009-2011 ODS phase-out plan of the Multilateral Fund.

24 (ter). Table 9 presents the total amount of forward commitments assuming that the request submitted to the 59th Meeting is approved at the level requested. Only one request for a multi-year agreement is before this meeting. If the request is approved at the value submitted to the 59th Meeting, an additional US \$1.6 million would be needed to cover forward commitments. This request also constitutes the first forward commitments for a MYA for the HCFC sector. The total amount of existing commitments for the period 2010 to 2014 is US \$110.5 million.
