ANNUAL TRANCHE SUBMISSION DELAYS

- 1. This report emanates from a history of late submissions of annual tranches that resulted in delays in transferring funds and in fulfilling obligations to fund the activities required by the tranches. It is intended to enable the Executive Committee to encourage countries and relevant agencies to enhance their efforts to submit annual tranches as soon as possible and to address difficulties in meeting deadlines with respect to their submissions.
- 2. This report has addressed delays in the submission of tranches that were due to the current meeting and those annual tranches that have been withdrawn after review because of slow implementation or lack of the required verification reports. It highlights those terminal phase-out management plans (TPMPs) and national phase-out plans (NPPs) due to be submitted to meetings after the 61st Meeting. It also presents recommendations for consideration by the Executive Committee.
- 3. Thirty-two annual tranches were due for submission to the 61st Meeting: all are NPPs or TPMPs except one methyl bromide annual tranche and one accelerated CFC production. Fourteen tranches, all of which were TPMPs or NPPs, have not been submitted. These are broken down as follows: UNDP (2), UNEP (8), UNIDO (3), and World Bank (1). There were two multi-year agreement (MYA) tranches submitted to the 61st Meeting that were withdrawn.

Annual tranches not submitted to the 61st Meeting

- 4. At its 60th Meeting, the Executive Committee decided:
 - (a) To allow the submission of outstanding funding tranches of national phase-out plans (NPPs) or terminal phase-out management plans (TPMPs) in Article 5 countries to the 61st Meeting of the Executive Committee on the understanding that the governments concerned, with assistance from relevant bilateral and implementing agencies, would consider implementing agencies to sustain zero consumption of CFCs and other activities to facilitate the phase-out of HCFCs; and
 - (b) That funding tranches of NPPs or TPMPs not submitted to the 61st Meeting should be integrated into the relevant HCFC phase-out management plans of the countries concerned. (decision 60/11).
- 5. Consequently, the TPMPs that were not submitted to this meeting listed in Table 1 should be integrated into the relevant HCFC phase-out management plans (HPMPs) in line with decision 60/11(b). The Executive Committee may wish to note the reasons for the non-submission to the 61st Meeting and request the Secretariat to inform the relevant Article 5 Governments and implementing agencies to take actions to integrate the funding tranches of the NPPs or TPMPs indicated in Table 1 into the relevant HPMPs pursuant to decision 60/11(b).

6. Table 2 presents those annual tranches that were submitted to the Fund Secretariat but withdrawn after review. The Executive Committee may wish to note the reason why the tranche for the CFC phase-out plan in Suriname was withdrawn from consideration at the 61st Meeting and request the Secretariat to inform the Government of Suriname and UNEP to take actions to integrate the funding tranches of the TPMP indicated in Table 2 into the relevant HPMP pursuant to decision 60/11(b).

- 7. The World Bank submitted the 2009 work programme and verification report for the final tranche of the Accelerated CFC production sector phase-out plan in India. However, due to the need for internal clearance for the release of the customs data to the auditors required by decision 59/18, the request was subsequently withdrawn.
- 8. The Executive Committee may wish to note that the 2009 tranche for the Accelerated CFC production sector phase-out plan in India was withdrawn from consideration at the 61st Meeting after discussion with the Fund Secretariat to enable the release of Customs records to the World Bank auditors for review as required by decision 59/18, Annex V of document UNEP/OzL.Pro/ExCom/60/54.

NPPs and TPMPs due to meetings after the 61st Meeting

9. Pursuant to decision 60/11(b), all NPPs and TPMPs due to meetings after the 61st Meeting should also be integrated into HPMPs. Table 3 lists those projects. The Executive Committee may wish to request the Secretariat to inform the relevant Article 5 Governments and implementing agencies to take actions to integrate the funding tranches of NPPs and TPMPs indicated in Table 3 into the relevant HPMPs pursuant to decision 60/11(b).

RECOMMENDATIONS

- 10. The Executive Committee may wish to consider:
 - (a) Noting with appreciation, the information on annual tranches submission delays under multi-year agreements (MYAs) submitted to the Secretariat by France, UNDP, UNEP, UNIDO, and the World Bank as contained in the document UNEP/OzL.Pro/ExCom/61/5;
 - (b) Further noting that 18 of the 32 annual tranches in MYAs due for submission had been submitted on time to the 61st Meeting, but the remaining 14 have not been;
 - (c) Requesting the Secretariat to send letters for the annual tranches, indicated in Table 1 of document UNEP/OzL.Pro/ExCom/61/5, with the reasons indicating why the annual tranches were not submitted to the 61st Meeting and informing the relevant Article 5 Governments and implementing agencies to take actions to integrate the funding tranches of these national phase-out plans (NPPs) or terminal phase-out plans (TPMPs) into the relevant HCFC phase-out management plans (HPMPs) pursuant to decision 60/11(b);
 - (d) Requesting the Secretariat to send a letter for:
 - (i) The 2009 annual tranche for the CFC phase-out plan in Suriname noting that it was withdrawn from consideration at the 61st Meeting after discussion with the Fund Secretariat due to low disbursement and slow implementation, and informing the Government of Suriname and UNEP to take actions to integrate the funding tranches of the TPMP into the relevant HPMP pursuant to decision 60/11(b);
 - (ii) The 2009 tranche for the Accelerated CFC production sector phase-out plan in India noting that it was withdrawn from consideration at the 61st Meeting after discussion with the Fund Secretariat to enable the release of Customs records to the World Bank auditors for review as required by decision 59/18, Annex V of document UNEP/OzL.Pro/ExCom/60/54; and
 - (e) Further requesting the Secretariat to send letters for the annual tranches, indicated in Table 3 of document UNEP/OzL.Pro/ExCom/61/5, that had been due for submission after the 61st Meeting, informing the relevant Article 5 Governments and implementing agencies to take actions to integrate the funding tranches of these NPPs and TPMPs into the relevant HPMPs pursuant to decision 60/11(b).
